






# 911 Emergency System Topic Of Program

Sheriff Jim Rice and Chief of Police Joe Hester of Denver City presented a program recently for members and guests of State Line Extension Homemakers Club. The system was implemented in Yoakum County Sept. 17.

### **Time To Control** Weeds & Grasses

"Most annual winter grasses and weeds that plague lawns in late winter and early spring are ready to germinate now," says Terry J. Millican, Yoakum County Extension Agent - AG. The best way to stop them in the lawn is to apply a pre-emergence herbicide promptly, before their seeds germinate.

One of the worst pest plants that needs to be targeted now is henbit - a common lawn invader that brightens up the lawn with blue, but seldom-appreciated blossoms in late winter and early spring. Winter grasses, including winter rye, also germinate now. Most of our most beautiful spring wildflowers also sprout in the fall and need to be targeted now if they are considered top be "weeds" in a well manicured lawn

Pre-emergence herbicides are chemicals that kill weed seedlings as they germinate. They are ineffective against weeds and grasses once they grow beyond the seedling stage. Apply a pre-emergent herbicide as a uniform, broadcast treatment to problem areas of the lawn. At least one-half inch of water - irrigation or rain - is needed after application to move the herbicide into the soil where it is activated.

Labeled pre-emergence herbicides for lawns include XL, Betasan, Balan and Princep. All of these materials will do a measurably good job of stopping winter weeds and grasses if applied accurately and in time.

All of these herbicides are available in granular formulations while Betasan, Princep and other pre-emergence herbicides labeled for lawn use also are formulated for spray application. Most home gardeners can do a more accurate job by using a granular formulation and broadcasting it as they would fertilizer. Spray application of a pre-emergence herbicide should be attempted only if you have a sprayer that is capable of applying a uniform, blanket spray (a hand pump-up sprayer is not acceptable). The sprayer also must be accurately calibrated.

Read and follow herbicide label directions carefully. Under application





can result in no weed control while over application may risk damage to the lawn.

Remember that pre-emergence herbicides can't distinguish "good seed" from "bad seed". Don't use them in a lawn or garden where you intend to plant seed this fall or next spring. The rate of the herbicide breakdown varies. Balan deteriorates rapidly and seed can be planted within two months after application, while XL deteriorates slowly and can prevent seed germination as long as a year after application.



## **Suggestions Offered For Gopher Control**

One of the best ways to control the gopher pest problem is fumigation, according to information obtained from Plains Library.

Location of all entrances to the gopher's tunnel system must be made. Find a piece of hose material that can be attached to the exhaust of a power lawn mower. One end of the hose should be placed into the gopher tunnel, then seal the opening with soil. Next drop some oil onto the inside of the hot exhaust pipe to create smoke, attach the other end of the hose to the smoking pipe. After a few minutes, smoke can be seen coming from all other entrances to the tunnel system.

Once the entrances are located, they may be sealed with piles of soil. Continue to blow exhaust from the power mower into the tunnel, killing the inhabitants with carbon monoxide fumes.

Or sulphur may be placed in the holes. Again seal the entrances. One of the cheapest sources of sulphur is an emergency highway flare that comes with auto safety kits or may be purchased in auto supply stores. Cut through the emergency flare with a sharp knife (not saw). Dig into the tunnel runway, pour the flare powder directly into the tunnel. Cover this hole, as well as all exit holes you have discovered. The more airtight the tunnel system is, the more anxious gophers will be to leave. Once the gophers have fled, seal the tunnels with soil. You can know the gophers are gone when there are no longer fresh mounds around your property.

Still another option is to place small, ammonia-soaked sponges into each gopher hole, then seal them all. Gophers will abandon their burrows quickly.

The best time to use any of these controls is early spring when the gopher tunnel complex is lease developed.


