## An Address to the Voters of Runnels County.

A Probibition Election for Runnels county has been ordered by the Commissioners Court to take place on September 10th.

It behoves every voter of this county to make a special effort to be at the polls on that day and record his vote. The one sole question that will be before you on that day is: will you, the qualified voter of Runnels county, legalize the existance of saloons. The state of Texas has said both in her laws and in the decisions of her courts that saloons have no right to exist save the right they purchase with the high price of the license, and that even this right will not be sold to them unless the voters of the territory in which it is sought to establish the saloons say to the state by their votes, sell them the right. Saloons have no natural right to exist and their legal right to existence is a mere temporary privilege granted to them by the people at a stipulated price and this privilege can be removed whenever the people see fit.

The question then before the voters of Runnels county in this campaign and the one you will decide at the ballot box the 10th day of September is: Do you wish saloons and are you willing and do you agree to seil them the legal right to exist? If not then you will vote for prohibition.

Saloons or no saloons-that is the question. In this contest you are not asked to choose between saloons and "blind tigers" for prohibitionists in general join with the officers of the county in saying that if prohibition carries in the coming election there will be no "blind tigers" in this county.

According to the Supreme Court of the United States the saloons produce more crime and misery than any other agency on earth. He who votes to perpetuate the saloons cannot escape the responsibility of being a partner with them in the production of this crime and misery.

In this county for the past two years and a half, to go back no further, the saloons have been the cause of more than one-third of the criminal cases that have been recorded on the criminal dockets of our courts. Surely the voters of this county will not vote to sell the right to exist to institutions that are doing so much to blacken the otherwise fair name of our county.

The question is before you to decide. The responsibility for the results of the decision will also be on you.

Friends of prohibition are urged to be earnest and active. Avoid strife and bitterness, yet as citizens responsible for the public policies of your county be zealous. Appeal with persuasion and entreaty to your neighbor, yet do not become offended at him if he does not agree with you. Let brotherly love continue. Be firm even if you are assailed with abuse, and do not be terrified by the cry that you are causing strife. As one consciont that you are armed with the right to go boldly on. Allow yourself to become offensive to no one. Abuse and boycott may be used by others but prohibitionists rest their case only on the merits of facts and the inevitable logic of the situation and thus expect to Runnels County Prohibition Campaign Committee. win.
