



## YOUNG WOMAN ENDS LIFE

### Mrs. Lula Bishop Commits Suicide by Drinking Carboic Acid.

Ballinger received another sensational shock Monday, when Mrs. Lula Bishop destroyed her own life by drinking carboic acid. Tired of life filled with trouble, she prepared a note telling that her trouble was more than she could bear, and giving instructions as to what disposition to make of her trunk and personal belongings, the woman deliberately gulped down the death-dealing liquid and in a few minutes was in the clutches of death and beyond all aid of the physicians.

The unfortunate woman came to Ballinger from Llano some time ago, and was up to the day before her death working for Santa Fe Agent Holt. It is reported that she was separated from her husband at Llano, having quit him because he went blind, and that one child, the only one she had, was given to her husband's people at the separation. She has relatives at Mason and Llano, and they were notified of her death, and they gave instructions that her body be buried here. It was carried from the Ostertag Furniture Co. undertaking parlor, where it was moved soon after death, and laid to rest in the Ballinger Cemetery.

The woman had done nothing to lead anyone to believe she contemplated taking her own life, and the note she left gives no particular reason for the act, only stating that her trouble was more than she could bear. She came down town last Thursday and had some pictures of herself made, and Monday afternoon about one o'clock she went to the Walker Drug Co. and purchased twenty-five cents worth of the deadly acid, and returning to Agent Holt's house she swallowed the acid about four o'clock.

Not a tear shed, not a head bowed in grief, not a friend to lay a flower upon the grave; buried in the potter's field where no stone will ever mark the resting place. Then at last to wake in eternity and give account of the awful act. A sad thought, indeed.

## RAILROADS FOR WEST TEXAS

### McCauley of the Orient Says Much Building Will be Done.

Encouraged by the magnificent crop prospect of the west, R. L. McCauley of Sweetwater Texas a heavy stockholder in the Orient railroad and a general Texas booster, made the prediction while in Fort Worth yesterday that the next ten or twelve months would see half dozen railroads projects in this state completed.

The fiscal year beginning June 1, thinks Mr. McCauley, is going to be an eventful one in the railroad history of West Texas.

Mr. McCauley interred the Texas field with his capital in time to invest a large part of it in the construction of the Orient and in the subsequent financing of extensions of the same road. His reputation as a railroad projector is not limited to Texas alone: it is known beyond the confines of this state.

The returning railroad activity says the Sweetwater capitalist, is manifested nowhere more forcibly than in Nolan and other counties along the Orient road. The road is being pushed at a rapid rate towards the north.

He expects the Santa Fe to run its projected line across the plains from the neighborhood of Armadillo striking somewhere in the vicinity of Sweetwater. It is predicted that the Texas Central will begin to build westward as soon as the crops are assured beyond all shadow of doubt. Mr. McCauley states, too that Abilene will get a railroad to the south.

He bases his optimism upon the fact that the crop and range outlooks are both so splendid all over the Sweetwater country. The cotton acreage in Nolan county is larger than ever known before, the grass on the pastures is unexcelled and the corn promises a bumper yield.

Whatever good can be said of Sweetwater and Nolan county, stated Mr. McCauley yesterday, can also be said of the entire Orient territory.—Fort Worth Record.

## CLEAN UP CAMPAIGN JUNE 16, 17, 18

### Board of Health Calls on people to Devote Those Days to Cleaning up Premises

Whereas, the season of the year being upon us when cleanliness is essential to the health of our people.

Therefore be it resolved by the City Board of Health of the City of Ballinger that the 16, 17 and 18 days of June 1908 be and are designated as the days on which the citizens of Ballinger are requested to clean their premises, which includes the adjacent alley and sidewalks, of all weeds, trash tin cans and filth of all kinds, and to remove the same to the city dump grounds.

All agents of non-residence owners of property in the city are requested to have said property so cleaned on said days.

It is further resolved that the city marshal and city scavenger

report to the city attorney the names of all citizens and agents whose premises are not so cleaned on said dates in order that such citizens may be fined as provided by ordinance.

### Kill The Flies

We again call the attention of our citizens to the importance of waging war against the abominable, filthy germ-laden house fly. Some of the leading cities in the United States are making a vigorous and systematic effort to exterminate these dangerous and obnoxious pests. The New York Board of Health recently made a report in which it stated that during last year 7,650 deaths in that city were directly traceable to the common house fly and they claim it is the greatest menace to health that the people have to contend with. Every kind of filth upon which these disease-breeders thrive and produce multiplied millions of their kind annually, should be destroyed and all cow pens, hog pens and stables should be liberally sprinkled with lime. All houses should be properly screened and every effort made to keep food where the flies cannot have access to it. Yet, with all these precautions in the home, there is still another source of contagion, and that is from fruit of different kinds, that is exposed to the flies and then offered for sale. Fruit thus exposed if eaten by you may mean a spell of typhoid fever or some other serious sickness. We do not claim to have a corner on information upon this subject, but we believe that all of our physicians will bear us out in the statement that the common house fly is the most dangerous disseminator of disease germs—especially that of typhoid fever and intestinal troubles—that is known. If this be true, it is a matter which should concern everyone and everything possible be done to exterminate the pesks. A general cleaning up of the town would go a long way toward attaining the desired results.

### Abeline Banker must go to Pen

Dallas, June 2.—James G. Lowden of Abeline, former president of the American National bank of Abeline, Texas must go to the United States penitentiary at Atlanta, Ga., for a term of five years. Although twice convicted of having violated the national banking laws in connection with the late Otto W. Steffens vice president of the bank he fought his case to the last through some of the ablest lawyers in the state. Advice was received today in Dallas that the United States supreme court has denied the writ of certiorari, which is equivalent to a writ of error, and this is the last hope the convicted man has to depend on. United States Marshal George H. Green is in receipt of advice from Attorney George E. Miller of Fort Worth, to the effect that Lowden will come to Dallas and surrender himself as soon as the mandate from the United States circuit court of appeals at New Orleans is received. He will then be taken to Atlanta. Lowden is now at his home at Abeline on \$25,000 bail. Steffens died at Abeline last March.

### Children Charter Members of Christ's Kingdom

We must believe that Adam was made pure and clean, he being the direct work of Gods own hands. And when by transgression he fell from his holy estate then was when the scriptures say as in Adam all die, even so in Christ shall all be made alive." And "Wherefore by our own sin and so death passed upon all men for that all they have sinned." And "But the scriptures hath concluded all under sin; that the promise by faith of Jesus Christ might be given to them that believe."

So then as Jesus Christ was a Lamb slain from the foundation of the world, the remedy for our fallen nature was at hand, Then by the atoning merit of the blood of the Lamb slain from the foundation of the world our inherited sin was lifted off of us, and we were reinstated to the purity of Adam before the fall. Hence Ezekiel says in the 18 Chapter 1-4. "The sword of the Lord came into me again saying, what message that ye use this proverb concerning the land of Israel saying "The Fathers have eaten some grapes and the children's teeth are set on edge?"

As, I live saith the Lord God, ye shall not have occasion any more to use this proverb in Israel Behold all souls are mine, as the soul of the father, so also the soul of the son is mine, the soul that sinneth it shall die. Notice that Ezekiel call it a proverb, or, in other words it was an old saying, "that the father had eaten some grapes and set the children's teeth on edge" and plainly gives us to understand in verse 4th that it is the soul that sins that dies, and not the child because the father had sinned. Please read from the first to the twentieth verses of the 18 chapter of Ezekiel. Now if Christ made a full atonement for our sin in Adam then it plainly follows that we do not inherit any sin.

If it is true that we are "born in sin" as some say and a child grows up to manhood, and even to old age, and dies a sinner, and confession in death that its never knew Christ in the pardon of his sins, which some people do Please tell me where in that man life he was a live through Christ? if all died in Adam then were made alive in Christ, then some where in every man's life, is he alive through Christ. Then it clearly follows that we are not born in sin.

See 1st. Tim. 4-10. For there fore we both labor and suffer reproach because we trust in the living God, who is the Saviour of all men, specially of those that believe. Now then in order to keep in harmony with the word of God, all men are saved some where in life this being the case we are forced to again fall back to the infant to find where they are saved. And for those who sin themselves out of the Kingdom like Adam there is a special provision for them, by coming back by faith and repentance. I agree that every child is born into the world a charter member of Christs Kingdom, and it is our duty as parents to "train them up in the way they should go and when it is old it will not depart from it." But we are told that while a child is born in sin, (which the scriptures do not say) that if they die in infancy that they are saved by the blood of Christ. The book does not say so. We are told in the language of Christ that "Except ye be converted and become as little children ye shall not enter into the Kingdom of Heaven. Now he says in another place "Of such as little children is the Kingdom of Gods Work. Now we see, as I said that the child is a charter member of Gods Kingdom.

Now then if a child dying in its infancy needs a change by an application of the blood of Christ and we are barred out of the

Kingdom unless we are converted and made like a little child I would like to see some one untangle that kind of theology, because we have to be made pure by regeneration to be fit for the Kingdom of God, and also like

his forces. Taft will not carry  
the labor vote of the republican  
states.

The Brownwood Bulletin is  
devoting a great deal of space  
to the oil boom at that place. A  
regular oil department, telling of  
the visits of oil experts and test  
wells. We wish them success,  
and will rejoice when we read  
that a gusher has been brought  
in.

When the panic struck Ballin-  
ger it put a quietus to several  
propositions that the town then  
had under headway, among  
which was the park and flower  
garden opposite the depot. The  
panic is over now, and why not  
start this move again? It will  
be money and time well invested.

With four prohibition ques-  
tions placed on the ticket in the  
Democratic primary, the voter  
will have a chance to pick his  
choice. Summed up, the ques-  
tions submitted are: For State  
Prohibition. Against Local Op-  
tion. Against State Prohibition.  
For Local Option. Which do you  
want?

One local firm expects to ship  
at least fifty cars of oats this  
season. That's not bad for a  
grain crop, and when we stop to  
consider that only a small per-  
cent of the crop has been put on  
the market. The farmers have  
learned a thing or two about  
selling their feed crop and having  
to buy back again at double the  
price. Just a part of the sur-  
plus crop goes this time.

The Business Men's Club of  
Rowena is out with a neat little  
booklet, illustrated with attrac-  
tive cuts, telling of that country  
and the growing little city of  
Rowena. That place is sur-  
rounded with as fine farming  
land as there is in Texas. A. C.  
Homan, Secretary of the Club  
and Cashier of the Rowena Bank,  
deserves credit for the get-up of  
the book. The booklet is being  
placed where they will do a great  
deal of good in advertising Run-  
nels County.

The various churches of Bal-  
linger should join in and build a  
large tabernacle. The town  
badly needs something of the  
kind. The skating rink does  
very well, but is far from com-  
fortable and the price paid for  
rent would soon build a suitable  
place for such gatherings. Then  
too, it interferes with the danc-  
ers to use the rink for religious  
purposes, as the dancers have no  
place to dance when the rink is  
being used by the churches.  
Somebody start the move and it  
will be no trouble to push it  
through.

State Wide Prohibition Will be Voted on at  
the Coming Primary in July.

A sufficient number of names  
has been secured by those favor-  
ing State wide prohibition to  
have the question placed on the  
ballot in the coming primary in  
July, and that question will be  
voted on on that date.

The strangest thing in the  
starting out of this fight is that  
those who are fighting the "Sub-  
mission Question" term them-  
selves "Local Optionists." Among  
those who class themselves as  
such are John G. Willacy of  
Nueces County and Jake Wol-  
ters of Harris County, and these  
fellows succeeded, in placing  
on the ballot four propositions,  
instead of two—an artful  
dodge, as you will see later.

Now every one who is acquaint-  
ed with the local option fights  
in Texas know that the above  
named two gentlemen have al-  
ways been against the local op-  
tion movement in Texas, and  
lent the liquor interests every  
assistance possible in every fight,  
and now they come before the  
people and say they are "in  
love" with the local option sys-  
tem and want legislation to per-  
fect and strengthen same.

Following are the four propo-  
sitions that will be placed on the  
ballot in the coming July pri-  
mary:

1. "For the submission, by  
the 31st Legislature of the State  
of Texas, of a constitutional  
amendment to the people of the  
State of Texas for their adoption  
or rejection, prohibiting within  
the State of Texas, the manufac-  
ture, sale, gift, exchange, and  
intra-state shipment of spiritous,  
vinous or malt liquors and medi-  
cated bitters capable of produc-  
ing intoxication, except for  
medicinal and sacramental pur-  
poses."

2. "Against the submission,  
by the 31st Legislature of the  
State of Texas, of a constitution-  
al amendment to the people of  
the State of Texas for their

adoption or rejection, prohibiting  
within the State of Texas the  
manufacture, sale, gift ex-  
change, and intra-state shipment  
of spiritout, vinous or malt li-  
quors and medicated bitters cap-  
able of producing intoxication,  
except for medicinal and sacra-  
mental purposes."

3. "For the system of local  
option and appropriate enactment  
for the perfection of our laws so  
as to prevent the barter sale or  
exchange of intoxicating bever-  
ages or liquors in local option  
districts."

4. "Against the system of  
local option and appropriate en-  
actment for the perfection of our  
laws so as to prevent the barter,  
sale or exchange of intoxica-  
ting beverages or liquors in  
local option districts."

Now study the four propo-  
sitions above and see if you can  
not detect the fine "Italian hand"  
of the liquor interests in disguise  
by injecting the local option issue  
or question into the campaign  
for the purpose of misleading  
voters.

Heretofore there has been  
some few who claimed to be  
"local optionists," but against  
State wide prohibition, and on  
the other hand some who claim  
to be for State wide prohibition  
but against local option. Now  
these two latter propositions  
were injected to create strife  
between these two named fac-  
tions who oppose the liquor traf-  
fic, and if they can succeed in so  
doing, they will defeat State  
wide prohibition.

As we have said before, it is  
strange indeed that Texas now  
has so many who favor "local  
option" when in the local option  
campaigns the speakers for the  
antis claim that the local option  
laws on our statute books were  
unconstitutional, and now they  
are falling "head over heels" in  
love with it.

Voters of Runnels County, do  
not be misled by these subter-  
fuges of the liquor interests, but  
go to the polls and vote for  
"Submission and give the people  
of Texas a chance to amend the  
Constitution, if they desire, and  
eliminate the liquor traffic in the  
fairest state in all the Southland.

As the four questions now ap-  
pear on the ticket it will be nec-  
essary for the voters to post  
themselves thoroughly before  
casting their vote. Can a man  
vote for both the submission  
question and for better local op-  
tion laws, or against both—can  
he vote for more than one of the  
questions? We will have more  
to say about this later.

### Speaking on Streets.

Hon. J. F. Cunningham, of  
Abilene, candidate for congress  
from this district, was here  
Thursday enroute to Miles and  
San Angelo on a trip in the in-  
terest of his campaign. Judge  
Cunningham will return to Bal-  
linger Saturday and at 2:30 in the  
afternoon he will speak at some  
suitable location on the streets  
making a short talk in placing  
the questions at issue before the  
people. He spent the most of  
Wednesday in Ballinger and met  
several hundred voters while  
here and left a card with the  
principles upon which he is mak-  
ing the race printed on same  
with each voter.

### Out on Bond.

\$1000. He gave bond and was  
released to await the action of

Perhaps the best ball game  
ever played on the Ballinger  
diamond was pulled off yester-  
day between the White Sox of  
San Angelo and the Ballinger  
Sensibles in which it was neces-  
sary to play fifteen innings to  
decide the game

With Griffin in the pitcher's  
box and Crews behind the bat  
for the Ballinger team the game  
started off without a score up to  
the third inning when Ballinger  
scored one. In the fourth inning  
Angelo made two runs and Bal-  
linger one. This tied the game  
and it remained in this condition  
up to the last half of the fifteenth  
inning when Baker made a  
two base hit, stole third and  
came home on a safe hit from  
Gressett winning the game after  
a hard fought battle by a score  
of three to two.

As will be seen, the game run  
from the fourth to the fifteenth,  
eleven innings without either  
side making a score. Yet each  
team experienced some lucky  
strikes and then failed to get  
home with a single man during  
this period of the game. The  
most exciting time was in the

At Waxahachie a negro, while under arrest, overpowered Constable Tom Conger, getting his gun and shooting him four times. The constable is in a dying condition and the negro is being pursued by an enraged mob.

A big prohibition rally is to be held in Texas on June 25. The city in which it is to be held is not yet named. Governors Glenn of North Carolina, Noel of Mississippi and Guthrie of Oklahoma are on the program for speeches.

From present indications, Brown County will again have a big pecan crop this year. It is something unusual for two good pecan crops to come together, but from prospects along the Pecan Bayou there will be a good crop on that stream this year.

On account of the Red River bridge of the Santa Fe being washed away, over one hundred passengers were laid out at Gainesville for about a week. The railroad company paid hotel bills for all those who were water bound.

The Fort Worth Record says hardly a day passes but what the police matron is called upon to take charge of a baby that has been discarded by its mother, and the baby question is puzzling the authorities. The supply from this source is greater than the demand.

Ray Garrett of Santa Anna, who has been assisting his father in harvesting grain, was painfully hurt one day last week by his hand coming in contact with the rapidly oscillating cycles of a binder. He had been driving the team and had gotten down in front of the machine for some purpose, when the team started, throwing him on the cycle bar. His clothing was torn and one hand was severely cut.

Austin, Texas, June 9.—Considerable chagrin is felt today among anti-prohibitionists here as a result of the action of the state democratic executive committee regarding the prohibition issue on the official primary ballot. Antis claim they were outwitted as under the present status a person may vote on the proposition for state prohibition and also for the provision favoring enforcement of the present local option laws and strengthening same. This omission, it is claimed by the antis gives the pros the advantage as they can vote for state prohibition and also for the enforcement and betterment of the present local option laws.



He further said that the school district at that time was large and the scholastic census would only show 36 pupils enrolled, while some of them came as far as ten miles to attend the school at Miles, the only one in this part of Runnels, Tom Green, Coke and Concho counties. Now the old district has been cut so as to form three districts and the census will show more than 600 pupils. Farming in this county eight years ago was a thing not even dreamed of. No one tried to raise a crop for the market, only such thing as actually used on a ranch being planted. It was then too that most any of this land could have been purchased at from \$1.50 to \$2.50 per acre. Gerome Shield said that he actually refused to pay a lease of two cents an acre of several sections and would of thought a man crazy if he had looked like he wanted to sell it to him at any price.

My how the times have changed and in such a short time. Land that couldn't have been given away ten years ago is now worth from \$10. to \$60. per acre and some of it not on the market at any price. Instead of great herds of cattle roaming the prairies we find fine farms with all the modern conveniences scattered all over this country. In stead of a heavy coat of grass, we see field after field of growing crops, that now promise a most bountiful yield. Our people are happy and prosperous, and the onward march has just begun. The next ten years will show us greater advancement than has the past eight. Speculations as to the results are a thing of the past. The adaptability of the soil in this section

Kelley of Ballinger acted as judge, and after viewing the colts the blue ribbon was given A. E. Kornegay's colt, the red ribbon to Joe Thiele's and the white one to G. S. Schovajsa's. The colts were all good and everyone entitled to a prize. The number was not as large as was expected, but so many of the farmers were busy in their crops they did not take time to come in.

The Johnson Brothers were also in town with a number of good colts, but they had not offered a prize at this time and no decision was rendered as to who had the best one in this lot.

There is no mistake about it, the farmers in this country are beginning to realize that it costs no more to raise a good colt than it does a scrub, and the time is coming when every horse in this country will be blooded and have a pedigree subject to registration.

John Hammond, chief consulting engineer of the Guggenheim mining interest, draws a yearly salary of \$500,000. Judged by the standard of earning capacity, Mr. Hammond stands at the head of the list, his salary being the largest in the world, leaving out of the account a few monarchs who are not expected to earn their pay. Although this is an era of big salaries, none of the chief executive officers of the railroad and banking systems are known to get exceeding \$100,000 a year, and compared with the salaries of public officials, Mr. Hammond wages are as a mountain to a mole hill. The president of the United States gets only \$50,000 a year and the chief justice of the supreme court but \$13,000. Only three of our state Governors receives 10,000 a year, and the Governor of Grand Old Texas is paid only, \$40,000, and has to put up with a slight of nagging on the part of the anti-Baileites besides. England pays the lord high chancellor \$50,000 a year while the archbishop of Canterbury worries along on \$75,000. The lord lieutenant of Ireland gets \$100,000 and the viceroxy of India \$85,000.—Ex.

The Highest Point in Texas  
Popular impression places the  
great commonwealth of Texas  
in the list of plains states, prob-  
ably because of the well-known  
extensive prairies along the Gulf  
coast from Beaumont to Browns-  
ville and the equally well-known  
Llano Estacado of the so-called  
Panhandle. It is not so generally  
realized that another section of  
the State is so high and rugged  
that the old Lone Star republic  
may well boast of being almost a  
part of the backbone of the con-  
tinent. This section is the  
sparsely settled and semi-arid  
trans-Pecos region. Here are  
the Davis Mountains, Livermore  
Peak, the Chanati, the Chisos,  
and the glistening white peaks  
of Sierra Blanca. For all of  
them many different elevations  
have been published, but the  
figures were determined either  
by guess or by a slightly more  
refined means—the aneroid bar-  
ometer—and the question as to  
which is the highest of the tower-  
ing peaks of West Texas has  
until lately remained unan-  
swered. That the honor would  
rest with the Guadalupe Moun-  
tains, a timber-capped range in  
the northern part of El Paso  
County, not far from the New  
Mexican boundary line, has long  
seemed probable. In describing  
these mountains, Prof. Robert T.  
Hill, in his monumental treatise  
on the Texas region, pronounced  
them the highest in the State.  
Notwithstanding an error of  
nearly a thousand feet in his  
published elevation—an error  
resulting from the uncertain  
aneroid—his statement was cor-  
rect.

During the summer of 1904,  
while Van Horn County was be-  
ing mapped by the topographers  
of the United States geological  
survey, careful observations were  
made to determine the elevation  
of the Guadalupe range. The  
work was conducted by Mr.  
Arthur Stiles, who has recently  
worked out his field notes and  
has conclusively determined the  
highest point in his native state.  
The elevation is 8,690 feet above  
the sea, and the peak—the high-  
est in the Guadalupe range—is  
significantly called by the Mexi-  
cans El Capitan.

The Presidents Salary.  
It is safe to say that a very  
few of the people living in this  
country know how the president  
of the United States draws his  
salary of \$50,000 a year. Of  
those few who may have given  
the matter a thought a large  
majority do not know whether  
he receives his salary monthly,  
quarterly or semiannually. As  
a matter of fact, the salary due  
the president is taken to the  
White House by a trusted mes-  
senger from the office of the  
treasures of the United States  
on the last day of each month  
and handed over to the official  
whose business it is to look after  
it. The president receives his  
salary in shape of a check, the  
\$50,000 being divided into eight  
checks of \$4,166.67 each and  
four checks of \$4,166.66 each.  
Thus one month out of every  
three he gets 1 cent less on his  
check than he does the other  
two. Some such arrangement  
as this is necessary, as \$50,000  
is not exactly divisible by twelve.
