Basketball is back big time in Bovina. The Fillies and Mustangs took on Morton's Indians and Maidens to open the season at Mustang Fieldhouse in Bovina Tuesday night.

The Fillies, under new coach Wes Weems, treated the big crowd to a thriller before losing a squeaker to the Maidens 43-42. Coach Weems has instilled a new system and a new attitude for the 2000 Fillies and it was evident in their play.

Junior point guard Christen Stowers, who has been on the varsity squad from her freshman year, led the Fillies in scoring with 13 points, including a three-pointer in the fourth quarter to tie the score. She fouled out with less than one minute to play.

K'Leigh Scroggins, senior forward, added 10 points. Other scores were by Marissa Rodriguez, 9; Maritssa Salazar, 8; and April Martinez, 2.

The Mustangs are also under direction of new coach Shawn Holmes. Coach Holmes has installed a new offensive scheme and has furnished each player with a

playbook for the season.

The effects are obvious, at least in game one. The Mustangs outran and outscored the 2A Morton Indians to win the opener 54-48. Bovina outscored Morton in each quarter, led by sharpshooter Jason Stone with 22 points.

Stone had 4 two-pointers, three-point goals and 2 free throws. Guard Tyson Kerby popped 2 three-pointers in the fourth quarter and ended with 12 points on the evening. Chris Antillon came with 9 points, also including a three-point goal.

The Fillies and Mustangs are participating in the Morton Tournament this weekend, November 16-18, then host Adrian at home on November 28.



"The Court of Public Opinion"

Last Monday when I went to lunch at the Friendship House, Billy Joe Mercer jokingly asked me what I was going to write about this

I loaded my plate with enchiladas and thought about it. I told Billy Joe that for the duration of this vote mess we need to turn our paper into a daily paper so I could write a column everyday instead of once a week.


