
Dorothy Harris Wins Week 11 FB Contest



Radio Scoreboard Show Has Friona Connection

If you are a Friday night football fan at an out-of-town game, chances are you tried the car radio to find area scores on the way home.

You might have come across one of the 22 radio stations that are syndicated out of a 9 X 9 studio at KFLP Radio in Floydada, Texas, population 3,676. The State Farm Friday Night Scoreboard Show is the brainchild of Tony St. James and Nick Long. Their show started 7 years ago as a local show for Floyd County. This year they broadcast over a 22-station network in 15 towns including Amarillo, Lubbock, and Abilene and KPAN in Hereford.

St. James owns the radio station and Long is a Floydada insurance agent and former Whirlwinds play-by-play announcer. In order to provide scores for the 100-110 games reported on each Friday night, the two utilize a network of fans, relatives, parents, and Allsup's and Dairy Queen employees that report scores. Three special stringers search the Internet for scores also.

BIONIC RETINA TO END BLINDNESS

The age of bionics has arrived. These manmade devices are put into the body to generate electrical pulses to nerves and muscles for the treatment of disabling conditions. A newly developed bionic retina may restore eyesight in people blinded by degenerative eye diseases and grant vision to children born blind. The device, which is placed on top of the retina, is about one-third the size of A contact lens. It consists of a sliver of silicone and platinum and is studded with 16 electrodes



The bionic implant electrically stimulates remaining healthy retinal cells, which pass on the visual information to the brain through the optic nerve. It can be used by patients to detect light or, in some cases, to distinguish between separate objects. It is especially designed to help people suffering from eye diseases such as retinitis pigmentosa and macular degeneration, the leading causes of blindness in the elderly. Eventually, the bionic retina might be used like a cochlear implant that restores hearing in children who are born deaf. These inserts contain electrodes positioned in the inner ear, or cochlea.



Mustangs End Season With 46-7 Farwell Loss

Was it the Farwell jinx or a good old-fashioned whipping? Or both?


In a season-ending contest to determine a playoff berth, the Farwell Steers stampeded from the opening kickoff. The Steers scored on their first five possessions and built a 33-7 halftime

Farwell QB Jason Johnson threw for three first half touch-downs and sophomore running back Matthew Edwards totaled up 168 rushing yards and two touchdowns in the game. The Steers (8-1, 3-1) will meet Wheeler (6-4) in a bidistrict match.

Bovina finished a good season

with a record of 6-4, 2-2 in district. The only score against Farwell came late in the second quarter on an 8-yard pass from quarterback Jeff Casas to Mathew Villarreal. Senior running back Jonathan Chisom finished his excellent Mustang career with 148 yards rushing against the Farwell rivals.

After a fine positive season, the Mustangs were obviously disappointed. "The kids are hurt bad by it, and that's a good thing," Coach Kent Torbert said in a Clovis News-Journal interview. "They worked so hard this year. This is a good group; we'll miss the seniors."

It just so happens that the Mustangs were in the same 4-1A District with two of the most talented 1A teams in the area, Nazareth and Farwell, both of whom whacked Bovina in the final two games. The Mustangs accumulated

2114 rushing and 962 passing yards for a season total of 3,074 offensive yards, a per game average of 307.4, while holding opponents to a 196.7 yard per game average on defense. They scored 200 points on the season and gave up 163.

Ouarterback Jeff Casas completed 48 of 98 passes, had 5 interceptions, and 6 touchdowns for 962 yards. Casas also gained 357 yards rushing on 91 carries and 5 rushing TDs.

Workhorse running back Jonathan Chisom gained 1,503 rushing yards on 196 carries. He scored 11 touchdowns.

Receivers were led by Raymond Chisom with 15 catches for 214 vards and one touchdown. Matthew Villarreal and Claude Tamez each had 5 catches and Alfredo Martinez had 3 receptions.

Raymond Chisom also had 25 carries out of the backfield for 132 yards and 2 TDs. Eddie Segovia carried 23 times for 107 yards.


On defense, Claude Tamez, Michael Ortiz, and Matthew Villarreal each had 3 interceptions, Alfredo Martinez had 2 and Hugo Aguillon and Javier Guevara had one each.

Chiefs knock Lopes Out Of AA Playoffs

The FHS Chieftains ended a frus- most of the season. trating season on a positive note here last Friday, upsetting Abernathy, 19-

Friona played by far its best defensive game of the season. The drive. Chiefs forced seven turnovers, most at vital junctures, and outgained the potent Antelopes, 313-237.

The win knocked the Antelopes out of the post-season playoffs, before a Parents' Night crowd at Chieftain Field.

The score shouldn't have been that close, but Friona failed to take advantage of several scoring opportunities, a trait that haunted this team lead at 16-13, with 3:17 left in the

Linebacker David Mendez gave Friona an early break, when he caused and recovered a fumble at the Abemathy 35 on the game's opening

Pedro Ramos crashed through the line for a 26-yard gain, almost breaking for a score. Ruben Alvarado moved the ball to the Abemathy four. But three plays later, Brock Field fumbled the snap, and the 'Lopes

had dodged an early bullet. The drive didn't go completely wasted, as Mendez, determined to get some points for Friona, tackled the Abernathy runner in his end zone for a safety, and the Chieftains led, 2-0 with 6:30 left in the opening quar-

Friona took the free kick at its own 47, and two plays later, Field rolled out for a nice gain, but fumbled as he was tackled, and Abernathy recovered at their own 39.

This time, the Antelopes settled down for a scoring drive. Pass plays gained 12 and 20 yards, and running back Jared Brock gained 15 and five, the latter carry being for a touchdown. The PAT kick was wide, but the visitors had taken a 6-2 lead with 3:15 remaining in the first.

Amador Rocha returned the kickoff 20 yards, and Abernathy was flagged for a face-mask penalty on the tackle, setting Friona up on the Antelopes' 46 yard line to start their

Freddy Reyes broke for a 18-yard gain on first down, to the Abernathy

Field hit Ramos for a 20-yard passing gain, and on the next play Field neared the goalline on a keeper at the visitors' 42 yardline. play, but fumbled as he was hit.

However, lineman Mark Hernandez recovered the ball in the end zone-every lineman's dream, and Antonio Monreal kicked the PAT, giving Friona a 9-6 lead with 2:30 still to play in the opening quarter.

Abernathy put the ball in play at their 20, and put together the longest drive of the game. The 'Lopes went 80 yards in 13 plays, making five first downs and using up over five minutes of clock time.

Antelope quarterback Derek Brown faked to (Jared) Brock, and ran six yards for the touchdown. Brock had runs of 27 and 19 during the drive. The PAT kick gave Abernathy a 13-9 lead with 9:40 left in the second quarter.

Friona came back with a sustained drive of their own a little later in the quarter. Reyes had 13 yards in two carries, and ripped off a nifty 38 run for an apparent touchdown, which was called back due to a holding penalty against the Chiefs.

A roughing the passer penalty against Abernathy moved the ball to their 16, and two plays later Ramos bulled his way 10 yards up the middle for a touchdown. Monreal's kick was true, and Friona had regained the

The Chieftains held a fourth down play on their own 39, but three plays later Field's long pass, intended for Matt Gammon, was intercepted at the Abemathy 16.

Safety Steffan Busch got an interception for Friona as time was running out in the half, which ended with a Friona lead, 16-13.

The Chieftains took the second half kickoff, and Sergio Saenz had a nice return to the Friona 41.

Ruben Alvarado gained 20 yards on two straight carries, and Ramos had a 15-yard gain as Friona moved the ball to the Abernathy 25.

QB Field converted a vital fourth down with a 10-yard run to the Abernathy 13, and runs by Ramos and Alvarado gave Friona a first and goal at the two.

Three plays found Friona back at the five, and Monreal was called upon to kick a field goal. His 23-yard boot, "iffy" snap and all, was true, stretching Friona's lead to 19-13.

Friona held on the next drive, and got the ball back at their own 39 after a nice defensive play by Marc

The Chieftains again drove with the ball. The running of Ramos and Alvarado moved the ball to the Abernathy 13, but after a pair of incomplete passes, Monreal was called in to again try a field goal.

The kick, against the wind, was just wide. A 22-13 lead would have made the team and fans feel a bit more comfortable, but it was one of Monreal's few misses of the season.

Before Abernathy could get a drive going, Saenz recovered a fumble

Friona couldn't move, and Abernathy held on their own 16. Friona had gotten inside the Antelopes' 20 three times without scor-

But linebacker Rudy Gonzales intercepted a pass that had hit the intended receiver and bounced toward him, giving Friona the ball at the Abernathy 21

Ramos had given Friona an apparent first down which was erased by a holding penalty. A fourth down pass appeared to be complete, but was called incomplete.

Abemathy QB Brown hit a receiver for a gain, but the receiver was hit hard by the Chieftain defender, fumbled, and Friona recovered. It was the Antelopes' third turnover of the quarter. Friona took over with 2:30 left in the game. Reyes had gains of four and six, for a first down with 1:30 remaining. Ramos and Field each had short gains, mainly protecting the ball.

On fourth down, Field ran into the end zone, giving Abernathy a safety with just seven seconds left on the

Monreal's long kick was fumbled by the Antelopes, and Willy Castillo recovered, and that was the game.



CRACKS DOWN ON SEAT BELT VIOLATORS Aim Is To Surround Teens With A Strong Safety Belt Enforcement Message Wherever They Turn

The seat belt use rate increased as a result of stepped-up enforcement around the May 2003 seat belt crackdown, but that still leaves many drivers unbuckled and breaking the law. That's why this November's crackdown will target teenagers and young adults, who are most likely to ride unbuckled.

The Friona Police Department will join more than 13,000 law enforcement agencies in the national Click It or Ticket Mobilization, which runs from November 17-30.

"Failure to wear a seat belt is against the law in this state. We enforce this law because it's the best-proven way to save lives. If you won't buckle up to save your life, then buckle up to save yourself a ticket."

"The only proven way to get significant increases in belt use among young people and ultimately save lives is through high visibility enforcement. Teens and young adults are killed at far higher rates in crashes because they are caught in a lethal intersection of inexperience, risk taking and low safety belt use. These tragedies are predictable and therefore preventable, using proven techniques like high visibility enforcement mobilizations."


According to the National Highway Traffic Safety Administration (NHTSA), 5,341 teens, ages 16-20, died and hundreds of thousands more were injured in traffic crashes in 2001. Fatality rates for teens are twice that of older drivers and the risk of crashes for teens is four times that of older drivers. Two out of five deaths among teens are the result of a traffic crash. In 2000, the estimated economic impact of police-reported crashes involving drivers between 15 and 20 years old was \$32.8 billion.

"While national seat belt use is at an all-time high of 79 percent, we know the remaining 21 percent who don't wear their seat belts are disproportionately teens and young men ages 18-34. And at 69 percent belt use rate, restraint use for teens and young adults ages 16-24 continues to lag behind the rest of the population."

During the national Click It or Ticket Mobilization, officers will intensify enforcement of safety belt laws and child passenger safety laws. Drivers failing to restrain themselves and their child passengers will be ticketed according to law.

"This year, nearly 8,000 Americans-adults and children-will die In crashes because they failed to buckle their seat belts. Traffic fatalities, especially among teens and young adults, are an ongoing tragedy we must do something about and that is why we've joined this effort."

The Friona Police Department participates in the Mobilizations because they work. The U.S. Department of Transportation (DOT) reported recently that child fatalities from traffic crashes have declined by 20 percent since 1997, when the Mobilizations began. The DOT has credited the Mobilizations for significantly contributing to this decline and for dramatically increasing child restraint use.

Senate approval of the FY2004 Agriculture Appropriations Bill (H.R. 2673) November 6 means the next step towards final passage of the agriculture spending measure is completion of a House-Senate conference. The Senate passed the Bill by a vote of

The Senate also named the following Senators to serve on the Conference Committee: Robert Bennett (R-UT); Thad Cochran (R-MS); Arlen Specter (R-PA); Christopher Bond (R-MO); Mitch McConnell (R-KY); Conrad Burns (R-MT); Larry Craig (R-ID); Sam Brownback (R-KS); Ted Stevens (R-AK); Herb Kohl (D-WI); Tom Harkin (D-IA); Byron Dorgan (D-ND); Diane Feinstein (D-CA); Richard Durbin (D-IL); Tim Johnson (D-SD); Mary Landrieu (D-LA); Robert Byrd (D-WV).

The effort to finish the USDA spending bill fortunately avoided getting bogged down by issues like Country of Origin Labeling (COOL) and also avoided having any detrimental amendments added on that would have made changes to the current Farm program, specifically in the area of payment limits.

One of the contributing factors that encouraged quick completion of the Ag Bill was it allowed the Senate to move on to consideration of a new Continuing Resolution (CR) to keep the government operating.

The current CR, under which the government is operating, expired November 7. Failure to pass the Ag Bill November 6 because of a drawn out debate could have caused the Senate to lay aside the measure in order to pass the next CR before the Veterans Day

One of the interesting amendments offered during Senate consideration November 5 was put forth by Senator Mark Dayton (D-

The Dayton amendment would have included language to extend emergency disaster assistance to agricultural producers. While the amendment was eventually ruled out of order and not included, it does point out an understanding by legislators that many areas of the country, including West Texas, have suffered crop losses in

For High Plains producers the fact that 2003 disaster assistance is being talked about at all should be considered positive. The Dayton amendment's failure to be included also illustrates a situation that PCG has encountered time and time again when putting forth the idea of a 2003 disaster program.

PCG has repeatedly heard that the Congress understands that significant crop losses have occurred in 2003. One of the key arguments against doing anything now, however, is that the full scope of the losses across the country is still essentially unknown.

A second stumbling block to getting a 2003 disaster assistance package lies in the fact that the tight budget landscape will likely require spending offsets to pay for any package, much like what occurred to secure passage of the 2001-2002 Crop Disaster Program.

Producers and producer groups will eventually be asked to make

some hard choices in terms of program funding and in which areas they will accept spending cuts to offset the added cost of any 2003 disaster assistance program.

In the end, passage of the FY2004 Agriculture Appropriation Bill closes another door through which the 2002 Farm Bill can be attacked. It also secures funding for key programs to move forward in 2004.

With Senate action complete, the Bill will go to a conference committee to reconcile it with the House of Representative's already approved FY2004 Agriculture Appropriations spending Bill.

Colder Weather Necessary To Curb Southern Weevil Movement


By Roger Haldenby The Panhandle and Northern half of PCG's 25-county area have experienced some chilly temperatures this week, but in the Permian Basin it's not been chilly enough to call a much-needed halt to boll weevil spray operations.

Weevils from the St. Lawrence area, and other parts of Glasscock County not involved in active eradication, have moved into the edges of the Permian Basin Boll Weevil Eradication Zone, as well as the Rolling Plains Central Zone and Southern Rolling Plains

The cost to growers in the three eradication zones being affected by migrating boll weevils is amounting to millions of dollars. The latest report from Texas Boll Weevil Eradication Foundation shows 309,562 acres were treated in these three zones in the week Tony Lopez, Rosemary Palacios, Carlos Duran, Manuel ending November 2. The same report shows that 1,951,667 cumulative acres have been treated in the Permian Basin alone this

At an estimated average treatment cost per acre between \$3.25 and \$3.50 it can be easily surmised that the three zones have spent over a million dollars in just one week combating an expansive insurgence of weevils from St. Lawrence.

The Southern Rolling Plains Zone was declared functionally eradicated of boll weevil in September 2000. No weevils were caught in 2001 but apparently a few snuck in from St. Lawrence, which is west of the zone, during 2002. SRP Zone recently celebrated becoming debt-free but now faces mounting costs to maintain their eradicated status.





APPLICATION Excel Corporation has applied to the Texas Commission on Environmental Quality (TCEQ) for an amendment to Air Quality Permit No. 40299 which would authorize modification to Boiler Number 2 on the Methane Biogas Recovery System located 3 miles west of Friona, on US Highway 60, Parmer County, Texas. The facility will emit the following air contaminants: organic compounds, carbon monoxide, nitrogen oxides, sulfur dioxide and particulate matter less than 10 microns in diameter.

This application was submitted to the TCEQ on September 19, 2003. The application is available for viewing and copying at the TCEQ central office, the TCEQ Amarillo regional office, and the Friona City Hall, 123 Main, Friona, Parmer County, Texas. The facility's compliance file, if any exists, is available for public review in the Amarillo regional office of the TCEQ.

The TCEQ executive director has determined the application is administratively complete and will conduct a technical review of the application.

PUBLIC COMMENT/PUBLIC MEETING You may submit public comments, a request for a public meeting, or request a contested case hearing to the Office of the Chief Clerk at the address below. The TCEQ will consider all public comments in developing a final decision on the application. The deadline to submit public comments is 30 days after the newspaper notice is published.

The purpose of a public meeting is to provide the opportunity to submit comments or ask questions about the application. A public meeting about the application may be held if the executive director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

If only comments are received on the application, the response to comments, along with notice of the executive director's action on the application, will be mailed to everyone who submitted comments or is on the mailing list for this application.

If a hearing request is timely filed, the executive director will complete the technical review, issue a preliminary decision on the application, and a Notice of Application and Preliminary Decision will be published and mailed to those who are on the mailing list for this application. That notice will contain the final deadline for submitting public comments.

After the final deadline for public comments following any required Notice of Application and Preliminary Decision, the executive director will consider the comments and prepare a response to all relevant and material, or significant public comments. If comments are received, the response to comments, along with the executive director's decision on the application, will then be mailed to everyone who submitted public comments or is on a mailing list for this application.

OPPORTUNITY FOR A CONTESTED CASE HEARING You may request a contested case hearing. A contested case hearing is a legal proceeding similar to a civil trial in state district court. Unless a written request for a contested case hearing is filed within 30 days from this notice, the executive director may approve the application. If no hearing request is received within this 30-day period, no further opportunity for hearing will be provided. A contested case hearing will only be granted based on disputed issues of fact that are relevant and material to the Commission's decision on the application. Further, the Commission will only grant a hearing on those issues raised during the public comment period and not withdrawn.

A person who may be affected by emissions of air contaminants from the facility is entitled to request a hearing. If requesting a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number, and fax number, if any; (2) applicant's name and permit number; (3) the statement "[I/We] request a contested case hearing"; (4) a specific description of how you would be adversely affected by the application and air emissions from the facility in a way not common to the general public; (5) the location and distance of your property relative to the facility; and (6) a description of how you use the property which may be impacted by the facility. If the request is made by a group or an association, the one or more members who have standing to request a hearing, and the interests which the group or association seek to protect, must also be identified. You may also submit your proposed adjustments to the application/permit which would satisfy your concerns. Requests for a contested case hearing must be submitted in writing within 30 days following this notice to the Office of the Chief Clerk, at the address below.

If a hearing request is timely filed, additional notice may be provided. Following the close of all applicable comment and request periods, the executive director will forward the application and any requests for contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact relating to relevant and material air quality concerns raised during the comment period. Issues such as property values, noise, traffic safety, and zoning are outside of the Commission's jurisdiction to address in this proceeding.



A Life Lesson At IHOP

Her name was Charlie. She was our waitress at the I

She was our waitress at the IHOP in Lewisville on a Sunday morning two weeks ago. More about Charlie and the IHOP in a minute.

It's one of parenting's great pleasures to teach responsibility to your children. You know the feeling.

For example, you buy your son a watch when he is ten years old. He straps it on the wrist, walks proudly out of the house, and you never see the watch again.

A few days later.

"Where is your watch, son?"
"Ummmmmmm.....I guess it is in my
room....no, I remember. It is in my
locker at school."

"You don't have a locker at school.
Where's the watch?"

"I don't know."

And on it goes through his life with watches, sunglasses, sweaters, or keys. They will always lose them. Learning to be responsible is not without cost.

My son Zac is 14. He is a freshman at Wichita Falls Hirschi High School, a math and science magnet school. It is for bright kids that are good in math and science and want a whole bunch of college credits by the time they get out of high school.

No, he didn't get his math and science talent from me. But he has landed a spot on the staff of the school newspaper, The Hirschi Howl, and a part in the school thespian production

He has always been the kind of kid that likes to be given some authority and responsibility over his own life. A couple of weeks ago, I bought him what is probably his 15th or 16th watch. We are still trying the responsibility thing.

We were in Dallas two weekends ago for my daughter Kirsten's wedding. She is Zac's half-sister.

Zac was a junior groomsman. I walked Kirsten down the aisle and "gave her away" (which I always felt is a rather cruel thing to do to a daughter). Zac wore a tuxedo for the

first time and felt grown up and responsible.

We went together to pick up the rented tuxes and I gave him a tux lesson, including some tux history and the proper way to button and buckle the studs and cufflinks and vest. I gave up trying to explain the benefits of a cummerbund.

At the fancy wedding reception, I let him use my expensive Nikon digital camera without supervision. I had explained the camera settings and told him how to frame photos, etc. Off he went around the room, proud and responsible. I had faith that my camera would not wind up in the same twilight zone as his first 15 watches.

Teaching responsibility and pride go hand-in-hand with faith. It is hard to explain the emotions a parent feels when one of their kids demonstrate learned responsibility.

Zac might have dropped the camera or spilled punch on it. Even if he had, which is more important, the camera, or the lesson to be learned about the consequences of being irresponsible?

Later in the evening, he brought the camera back to me. I'm proud to say it was intact and he was busting a tux button over the pictures he had taken. I could tell he was proud of himself and I made sure he knew I was proud of him too.

Now back to Charlie the waitress.
On the way out of town Sunday morning, we stopped at the IHOP in Lewisville for breakfast. Me, Zac, my

mother, and my daughter Megan.
You just knew Charlie was a veteran IHOP waitress. She was fast, efficient, and friendly. Older than the average waitress, Charlie knew what she was doing.

She brought the coffee, four it." glasses of orange juice, four glasses of water, and balanced the egg and pancake plates flawlessly up her arm. She even helped us pick out which bottle was the maple syrup. Megan said we had 13 glasses on the table

at one time. No matter what the price, it is hard to beat an IHOP breakfast.

The bill was \$31.92. I handed Zac two \$20s and the check and told him to go pay the cashier while I went to the men's room before we hit the highway home. He slid out of the booth, I put four dollars on the table for Charlie.

When I went outside, Zac was standing by the car beaming and smiling like a possum. Up to that point, I had forgotten that once at K-Bob's I had explained to Zac how to figure percentages when you tip a waitress. He attends a math magnet school. It wasn't hard for him to comprehend.

That morning on the curb outside the IHOP, he proudly handed me two one-dollar bills and some change. "She was a good waitress, dad, so I tipped her 20%." He had left her \$6.

I had not told Zac to leave the tip.
He took that responsibility on himself.
Charlie made \$10 on a \$31.92 check that morning. Zac's smile turned to fear and tension when I told him I had already left Charlie \$4. Kids do seek approval for the responsibility they show.

Messing up can show up so fast, just when you think you did your best. It is a kid thing.

Zac offered to go retrieve the money from Charlie. I wouldn't let is him. He felt bad and sought my approval. He felt responsible. To me it was worth the \$6 but I didn't tell him that.


We worked it out. I told him maybe Charlie really needed the money to help out a sick relative or buy a new dress so fate had led us to help her out.

Kathy and her family returned to their homes on November 4 to bitter cold, as there was no electricity. The next morning they were lucky enough to get the last generator on the mountain and were more comfortable.

They still had telephone service and their post office and bank were spared. One of the churches gave them some food and juices as they had lost a lot of food due to the lack of electricity.

They cannot believe how close the devastation is to their home-like one street away in every direction. Some of the children's schoolmates and friends have lost everything!

The kids should be able to go back to school November 17 and there will be counselors available for them to talk with.

We didn't have much time for fun because we worked hard. On the 4th of July, and on other occasions, we went to Roaring Springs for a picnic and celebration. Roaring Springs had a spring that ran into a reservoir and that ran into a river.

Going to town was a special treat for us. We sometimes got to go to the show and see our friends. The show cost 10 cents; if it had been any more we would not have gotten to go.

We started dating in December of 1931 and married on March 28, 1932. Edward was a farmer and also sold real estate.

I went to church in Afton, Texas with Edward Hicks for a long time.

We had two sons, Larry and Gary, and later we moved to Friona. I always enjoyed doing work in my church.

Edward and I went back to Acworth, Georgia to visit my family there. It sure did seem like a different world than what we were used to in Texas.


Edward passed away in 1968 from a heart attack.







We enjoy these trips so much and invite everyone who likes to travel to come join us. At Friona State Bank, our customers are still very important to us!









From The Desk Of Bovina **City Manager Ernest Terry**

We had a problem with dogs this week. I'd like to write a few comments pertaining to the Bovina City Ordinance concerning dogs and the responsibility of their owners.

It is unlawful for any dog to run at large. Failure to control your dog is a violation of the city ordinance and you can be fined not less than \$10 and not more than \$500 for each offense.

What is meant by control? That is a secure fence or leash restraining the dog. The police or animal control personnel do not have to catch the dog for the citation; they only need to see the dog running free. If the dog can be captured, the dog will be impounded, and the owner will be responsible for all fines and/or fees attached to the dog.

Vaccination of all dogs over four months old is required. Failure to vaccinate a dog annually is a violation of the ordinance and you can be fined not less than \$10 and not more than \$500 for each offense.

Now, what happens if your dog attacks (acts in an aggressive manner) or bites another animal or human? If the dog bites, scratches, slobbers, or attacks a person or another animal, the dog could be impounded for a minimum of ten (10) days for observation. The owner will be responsible for all fees and/or fines attached to that dog.

Let's take a hypothetical situation where a dog (non-vaccinated) runs free, attacks another dog (dog fight), and bites a human. The dog will be impounded for a minimum of ten days, and the owner will be cited for failure to control the dog, failure to vaccinate the dog, attacking another animal, and dog biting a human.

That is four citations for violations of the ordinance and you can be fined not less than \$10 and not more than \$500 for each offense, possibly \$2,000 of fines plus the bill for capture and impounding of the dog for ten days. That doesn't include the owner's responsibility for medical costs. The dog could be euthanized to check for rabies, and that cost is also the responsibility of the owner.

Finally, any dog deemed to be a vicious animal as a result of attacking or biting a human may be put to death on the order of the Municipal Judge.


A dog deemed dangerous must be confined within a secure enclosure, keep the City notified of the dogs location at all times, restrain the dog at all times on a leash, and obtain liability insurance of at least \$100,000 to cover any and all damages resulting from an attack.

A "dangerous/vicious dog" is a dog that:

(1) Makes an unprovoked attack on a person that causes bodily harm/injury and occurs in a place other than an enclosure in which the dog was being kept and that was reasonably certain to prevent the dog from leaving the enclosure on its own; or

(2) Commits unprovoked acts in a place other than an enclosure in which the dog was being kept and that was reasonably certain to prevent the dog from leaving the enclosure on its own and those acts cause a person to reasonably believe that the dog will attack and cause bodily harm/injury to that person.

Bottom line, take care of and be responsible for your dog. They deserve your best.



Economy Looking Better

Have you ever hung a picture before? You just stare at it with your head tilted and a look of confusion on your face. It's crooked. Then you tweak it a little to the left and to the right and suddenly it looks perfect. Now, I'm a particularly cheery individual. I like to look at the bright side of things. My attitude is "if it's not great we're going to make it better".

Well, this week we're going to talk about the status of the economy, how it's hanging on the wall, and whether or not we're looking at it with the right perspective. Many people would like to think that it continues in a downward spiral, when in fact things are slowly moving in the right direction. Proof once again that it's all about the attitude you have.

The fact is the economy is in an upswing. These are just a few of the recent newspaper headlines: "Payroll Numbers Grow Again", "Greenspan Sees Job Market Poised for Growth", "Productivity Rises, Jobless Claims Fall", and "Unemployment Claims at Lowest Level in 2 1/2 Years".

In the month of September, the U.S. economy netted 57,000 new jobs-the first gain in non-farm employment since January. Since the 2003 tax relief plan became law, initial claims for unemployment insurance have declined by more than 10 percent. The four-week moving average has stayed below 400,000 claims four straight weeks, indicating a stabilizing labor market.

Unemployment claims for the week ending November 1, 2003, fell to over 348,000 from the previous week's 391,000, the lowest claim since January 2001.

Numbers released by the Bureau of Economic Analysis show an increase in Gross Domestic Product (GDP)-the nation's output of goods and services-grew from 3.3 percent last quarter to 7.2 percent this quarter-the largest jump since 1984.

Consumer spending increased

6.6 percent in the third quarter of 2003. This is largely attributable to lower tax withholding on paychecks and child tax-credit checks that put more cash into shopper's hands. This is the biggest increase in consumer outlays since early

Home sales continue to grow as well. More than one million single-family homes had been sold by September. That's the highest rate on record.

In a district heavy with colleges and universities, I know that labor market woes are a common reality for students who say even their well-educated family members are struggling to find work. A number of students who barely considered a post-graduate degree are finding ways to extend their education after college, saying it is their

this week the nation's unemployment rate stands at an even 6 percent and 126,000 new jobs were added in the month of October alone. So the fear of leaving school is dissipating.

The U.S. economy is resilient. The economy is now in a position to recover from the many shocks it has endured the past few years. The stock market surge in the late 1990's, the slowdown and recession of 2000-01, and unbelievable economic shock of the War on Terror, have all been upsets to the economy. Despite all of this the U.S. economy is rebounding with improving markets and jobs growth.
