The Parmer County Junior Livestock Show has been an annual event for the past fifty-two years and is once again scheduled for next weekend, January 20-22 at the Friona Community Center-Showbarn.

Youngsters from Friona, Farwell, Bovina and Lazbuddie will compete in the 53rd county-wide event.

Judging will be held all day Friday, January 21, concluding on Saturday morning with the steer and heifer shows. The premium auction sale will begin at 6 p.m. Saturday at the showbarn, with preliminary sale events starting at 5:30 p.m.

Weigh-in and classification of all animals will be held from 1-5 p.m. Thursday, January 20. Barrows will be classified as they are weighed in. Steers will be classified beginning at 5 p.m. Thursday, followed by the lambs.

The lamb show kicks off the judging Friday at 8 a.m. followed by the goat show. The barrow show is scheduled to begin at 12 noon.

Steer judging will begin at 8 a.m. Saturday morning, followed by the heifer show.

Judges for this year's County Show will be Bryan Reynolds of Tahoka, barrows and cattle; and Kevin Newsom, sheep and goats.

EVERY YEAR WE are astounded by the number of Bull "famous folks" who pass away, and the past year was no TOWN exception.

In Ye Editor's case, he Bulleprobably identifies with more of these individuals than many of tins our readers, since he "grew up" watching or hearing about many of these "stars."

Probably the number one favorite of many of us whom we lost in the final year of the 1990s was Joe DiMaggio, the Yankee Clipper, one of nine children of immigrants. I was too young to get in on many of his accomplishments, but my high school buddies and I were probably more impressed with the fact that he married Marilyn Monroe than any of his baseball records. His 56-game hitting streak should stand until the year 2100 at least.

Other sports stars the nation lost in '99 included baseball greats Pee-Wee Reese, 81, who led the Brooklyn Dodgers to seven World Series appearances and Catfish Hunter, who was only 53 and was the first multi-million dollar player; an even younger Walter Payton, at age 45, who is the NFL's all-time leading rusher with 16,726 yards, and never did a tacky dance in the end zone.

Wilt "The Stilt" Chamberlain was another all-star we lost. He is the only player to score 100 points in an NBA game-another eye-popping feat. Golfer Payne Stewart was another who died while in his prime. He was one of his sport's most respected players.

Of all the "public people" the nation lost in 1999, John F. Kennedy, Jr. was probably our most tragic, given his young age, 38, with so many possible triumphs in his future. The first baby to live in the White House since the Grover Cleveland term which started in 1885, he didn't live to run for office or to have a child. He didn't even live as long as his famous father, John F. Kennedy.

Movie stars who died in the past year included 1930s actress Sylvia Sidney and George C. Scott, who many considered the best actor of the last half century. Scott, who was 72, won an Oscar for "Patton," but never attended the ceremonies. Victor Mature, an early Hollywood "muscle man," died at age 86. He was best remembered for his role in "Samson and Delilah."

seconded and the motion passed unanimously.



View From The Bovina High School Principal's Window

We are off and running in the second semester at BHS. This semester a couple of new areas are being addressed.

First, there was much community discussion last year about the need for a good drug awareness program. There was talk of drug testing and all sorts of draconian measures. We are putting together a comprehensive program to teach our students and family members about the hazards of doing drugs or being around those that do drugs.

Second, as anyone knows that watches or reads the news knows there is too much violence in schools and--in some communities--that violence has been deadly.

We are working those two problems--drugs and violence-this year and in the years to come. We have begun an advisory period in which each student will have a teacher mentor assigned. This mentor will stay with the same student throughout their high school career. If your son or daughter is a ninth grader, they will have their mentor until graduation. Our intent is to give the kids another adult role model and sounding board and one that will be available throughout high school.

The following information is food for family thought. These are ideas or areas in which you--the parents--can help us keep our school safe and drug free.

Be on the Lookout for Warning Signs of Violence in Your Teen

Could your teen turn violent? Here are some warning signs. If your teen shows any of these signs, you should talk with them, a doctor or a counselor. Ask them to suggest ways you can work with your teen to prevent violence.

Teens who are at risk of being violent:

* Consistently do not listen to those in authority.

* Pay no attention to the feelings or rights of others.

* Mistreat people or others.

* Often rely on physical violence or threats to solve their problems.

* Often say they believe life has treated them unfairly.

* Do poorly in school.

* Often skip class or are absent from school.


* Join a gang or get involved in fighting, stealing or destroying property.

* Drink alcohol or use inhalants or drugs.

Valor Telecommunications of Texas, LP, ("Valor"), formerly known as dba Texas Operating Co., LP, has entered into a contract with GTE Southwest Incorporated to purchase the following exchanges in Parmer County: Bovina, Friona. On December 13, 1999, Valor filed an application with the Public Utility Commission of Texas ("Commission") requesting approval of the acquisition and issuance of a certificate from the Commission to provide telephone service to the listed exchange(s). If approved, GTE will cease to be the local telephone service provider in this area and Valor will assume the responsibility of providing local exchange service in this area. The Valor application has been assigned Docket No. 21834. GTE's application to remove the exchange(s) from its certificate has been assigned Docket No. 21830. The Commission intends to investigate the acquisition and its impact on the public interest pursuant to Sections 14.101 and 54.051-54.054 of the Public Utility Regulatory Act.

Valor does not propose any increase in charges to customers in this application. If, In the future, the Company proposes a rate change, customers will be given notice at that time.

In addition, Valor seeks designation by the Commission as both an eligible telecommunications provider ("ETP") and as an eligible telecommunications carrier ("ETC") within the service area acquired from GTE, to permit it to receive state and federal universal service support. The Valor applications have been assigned Docket Nos. 21832 and 21833. GTE also seeks to remove the service area sold to Valor from the area in which it has been designated as an ETP and ETC. The GTE application has been assigned Docket No. 21831.

additional studies or evaluations of natural recharge in the region should not be made, but rather to point out that during periods of average precipitation, it appears that a significant amount of natural recharge occurs, for which we are very thankful.

The amount of natural recharge that occurred during 1998, a drought of record year, was likely near zero. In contrast, 1999 provided precipitation amounts of more than six inches above the long-term average in a portion of the area, with two to four inches above average for the entire region.

Depth-to-water measurements made in observation wells in January and February 2000 will likely indicate rises in water levels in a large number of the wells, as compared to measurements in January and February 1999.

Some of the rises will likely be a result of the filling of the cones of depression around measured wells as a result of below average pumpage in 1999. Some of the rises will probably be a result of natural recharge. Only time will tell.






Attitude, to me, is more important than facts. It is more important that the past, than education, than money, than circumstances, than failures, than successes, than say or do.


