THE voters of Nacogdoches county should vote for the erection of a new court house and jail for Nacogdoches county this fall.

THE Farmer's Union of Nacogdoches county will have their warehouse erected in time to take care of the cotton crop this season.

WHAT do the members of the Farmers' Union think of erecting cotton mills on the same plan as they are erecting cotton warehouses?

NOTWITHSTANDING the fact there has been a few sections of the county reporting the appearance of the boll weevil, yet a majority of the farmers report that they have an average prospect for a good crop.

THE only excuse Mr. Cooper can offer the people of the second district for running for congress is his insatiable desire for office. While he may have served the people for twelve years, and delivered a speech on the "tariff" and "free silver" yet that is the only work that he boasts of in his speeches.

HOME comings are becoming one of the drawing cards for state fairs and gatherings. Kentucky just pulled off a successful event of this kind, and now Georgia proposes to have a home coming in Atlanta during the state fair next October. There are many Georgians in this part of the state and doubtless East Texas will have a fair representation at the Georgian home coming.

IF the people of the second congressional district desire to have a representative in congress that will fight for their best interests, M. L. Brooks is that man. Bear the fact in mind that Mr. Cooper is being run in this campaign by the trusts and combinations. Mr. Kirby of the Kirby Oil Co. and the printing trust, and Mr. Geo. Carroll of Beaumont, another member of the printing trust.

THE trusts and combinations pushing the candidacy of Mr. Cooper for congress would have the people believe that there was a law upon the statutes of Texas requiring the railroads to maintain separate waiting rooms for white and negro passengers. There is no such law on the Texas books. This is a matter that comes under the jurisdiction of the railroad commission of the state.

Now then the papers advocating the election of Mr. Cooper on the labor platform can take a look at the records of the meeting of the labor unions in Beaumont. Congressman Brooks was voted "fair," while a vote of 19 to 31 was voted on placing Mr. Cooper on the "unfair" list. Now what do you think of that? Thirty-eight per cent of the representatives of the Legislative League are opposed to Mr. Cooper and call him "unfair."

### FOR STATE TREASURER.

From the papers received at this office the fact is very evident that Mr. T. S. Garrison of Timpson, is the favorite candidate for the nomination of state treasurer. Those who have the pleasure of an acquaintance with Mr. Mr. Garrison know him to be a man worthy of every confidence of the people of Texas. He has been a success as a business man and is one of the foremost financiers of the state. He is moral, upright, and honest. Is loved and esteemed by his friends and even his opponents admire him. His life is an open book, and such papers as oppose his candidacy can find no other charge to bring against him, save only that he is a member of the Methodist church. The Sentinel endorses the candidacy of Mr. Garrison, because he is worthy and well qualified, and such a thing as nepotism will never be laid at his door. Mr. Brooks says that if he is returned as the congressman, that he will introduce measures giving the people of East Texas relief. Congressman Brooks has made good during his first term, and for this should be returned.

HAVE you noticed how the papers that are supporting some of the other candidates are now turning their batteries upon Tom Campbell of Palestine? One enthusiastic paper says Campbell should not be elected because he has no political record to boast of. Bless your dear soul, that is just why the common people are a solid unit for him. They have had enough of the long timed politician as governor of Texas. By the election of Mr. Campbell the people will get a new deal and a "square deal"

plus? If the farmers would try and produce enough feed for their stock and keep the money that is now being sent to Kansas and other places the hard times story would soon become an ancient joke.

CONGRESSMAN BROOKS can point out his record in congress for the entire time he was there. All that Mr. Cooper can point to with pride is fact that twelve years ago he delivered a speech on the "tariff question" and the "free silver question." These are questions that every debating society of the country schools have discussed from time to time. Really there is not much record in that. What the people of the second district want is measures introduced for the good of the district. Mr. Cooper during his entire twelve years has not gone on record as having introduced a meritorious measure for this district. Congressman Brooks has and the people are going to return him to continue the good work he has started.

THE friends of Mr. Cooper hardly know what to say since the convention of the Labor Union Legislative League took a vote as to whether Mr. Cooper was fair. There were fifty delegates in the convention hall and the vote was 31 FAIR and 19 UNFAIR. Congressman Brooks was voted FAIR. This is a matter that the Farmers' Union in the second district should take heed of when the time comes to vote.

IN the literature issued by the Kirby-Carroll-Cooper-Houston Oil Co. et al, combination to defeat the re-election of Congressman Brooks, they have the audacity to say: "Be as fair as the 'unsigned pamphlet' by giving the book and page." The quotation is intended to be serious, and is put out as a piece of dope to catch the unsuspecting voter. To the knowing ones it will go down in the political history of the second congressional district as the best joke of the campaign of 1906. The facts, and the truth, of the whole thing is that during the entire twelve years Mr. Cooper was in congress he done nothing to be recorded, therefore there is no "book and page" for the voter to refer to. This is straight goods and there is not a paper in the district that can truthfully deny it. Now will the Kirby-Carroll-Cooper-Houston Oil Co. and other trust schemers be good?

THE power behind Mr. Cooper's candidacy for congress appears to be John Henry Kirby and Geo. W. Carroll. Mr. Kirby is a member of one of the largest trusts and combinations in Texas, Kirby Lumber Co. and is a member of the printing trust. Mr. Carroll is also a member of the printing trust and is also connected with other combinations. Can the unions of the second district support a candidate for congress or any other office that is the candidate of the corporate powers? The Sentinel may possibly be mistaken, but

believes that the labor organizations, and the Farmers' Union throughout the second district will do their duty in the premises.

Judging from the press reports the moral tone of the A. and M. College has greatly improved in recent years. ## Proposed Amendment to the State Constitution Relating to Certain Exemptions from Taxation.

JOINT RESOLUTION to amend Section 2 of Article VIII of the Constitution of the State of Texas, relating to certain exemptions from Taxation. Be it resolved by the Legislature of the State of Texas: Section 1. That Section 2, of Article VIII, of the Constitution of the State of Texas, be so amended that the same shall read as follows, to-wit: "All occupation taxes shall be equal and uniform upon the same class of subjects within the limits of the authority levying the tax; but the Legislature may, by general laws, exempt from taxation public property used for public purposes; actual places of religious worship; places of burial not held for private or corporate profit; all buildings used exclusively and owned by persons or associations of persons for school purposes and the necessary furniture of all schools, also the endowment funds of such institutions of learning and religion not used with a view to profit and when the same are invested in bonds or mortgages, or in land or other property which has been and shall hereafter be bought in by such institutions under foreclosure sales made to satisfy or protect such bonds or mortgages; that such exemption of such land and property shall continue only for two years after the purchase of the same at such sale by such institutions and no longer, and institutions of purely public charity; and all laws exempting property from taxation other than the property above mentioned shall be null and void."

Section 2. The governor of the State shall and he is hereby directed to issue the necessary proclamation for the submission of this amendment to the qualified voters of the State of Texas at the next general election for State and County officers.

Section 3. The qualified electors for members of the Legislature of the State of Texas shall vote upon this amendment on the day of \_\_\_\_\_, at which election all persons favoring said amendment shall have written or printed on the ballot as follows: "For amendment to section 2, Article 8 of the Constitution exempting from taxation endowment funds used exclusively for school purposes." And those opposed to said amendment shall have written or printed on the ballot as follows: "Against amendment to section 2, Article 8, of the Constitution exempting from taxation endowment funds used exclusively for school purposes."

Section 4. The sum of \$5000 or so much thereof as may be necessary is hereby appropriated out of any funds in the treasury of the State of Texas, not otherwise appropriated to pay the expenses of such publication, proclamation and election. [A true copy] O. K. SHANNON, Secretary of State.

## Proposed Amendment to the State Constitution Fixing Salaries and Per Diem of Legislators.

HOUSE JOINT RESOLUTION authorizing the submission to a vote of the people of the State of Texas of a proposed amendment to Section 24, Article 3, of the Constitution of the State of Texas, fixing the salaries and mileage of members of the Legislature, and preventing the acceptance, for themselves or for others, by members of the Legislature of free passes, franks, rebates, privileges or advantages from certain persons and corporations. Section 1. Be it resolved by the Legislature of the State of Texas: That at the next general election of the State of Texas, or at any previous election, in case an election for the State shall be had or ordered by the Governor for other purposes, there shall be submitted to the electors of the State of Texas, for their approval or disapproval, the following amendment to the Constitution of the State of Texas, as provided for in Section 1, Article 17 of said Constitution, relating to proposed amendments thereto, it being intended to amend Section 24, Article 3, of said Constitution, relating to the pay of members of the Legislature, so that the said Section shall read as follows: "Sec. 24. The members of the Legislature shall receive from the public treasury such compensation for their services as may from time to time be provided by law, not exceeding one thousand dollars for the year succeeding their election, payable in equal installments, on the first days of January, February, March and April of the year succeeding their election, and five dollars per

day for each day of every special session held during the second year of the term for which said members shall be elected. In addition to said compensation the members of each house shall be entitled to mileage going to and returning to the seat of government, which mileage shall not exceed three cents per mile, the distance to be computed by the nearest and most direct route of travel by land, regardless of railroads or water routes; and the Comptroller of the State shall prepare and preserve a table of distances to each county seat, now or hereafter to be established, and by said table the mileage of each member shall be paid; but no member shall be entitled to mileage for any extra session that may be called within one day after the adjournment of any regular or called session. It shall be unlawful for any member of the Legislature during his term of office to accept any free transportation over any railway line or lines in this State, and any member of the Legislature violating the provisions of this Act prohibiting the acceptance of free transportation shall forfeit the office to which he has been elected. And it shall be unlawful for any of such members to accept, receive, have, use or enjoy, directly or indirectly, for themselves or any other person, any free pass, frank, rebate, privilege or advantage not accorded to the general public from any railroad company, telegraph company, sleeping car company, or other corporation, or any persons, firm or corporations acting as a common carrier in this State. Any member of the Legislature violating this provision shall forfeit his office. And the necessary laws shall be enacted to carry out the provisions of this Article. [A true copy.] O. K. ## Proposed Amendment to the State Constitution Authorizing the Levy of a Tax to Pay Jurors.

JOINT RESOLUTION amending Section 9, of Article 8, of the Constitution of the State of Texas, providing for the levying of a tax of not exceeding fifteen cents on the one hundred dollars valuation, to pay jurors. Section 1. Be it resolved by the Legislature of the State of Texas: That Section 9, of Article 8, of the Constitution of the State of Texas, be so amended as to hereafter read as follows: Section 9. The State tax on property, exclusive of the tax necessary to pay the public debt, and of the taxes provided for the benefit of the public free schools, shall never exceed thirty-five cents on the one hundred dollars valuation; and no county, city or town shall levy more than twenty-five cents for city or county purposes, and not exceeding fifteen cents for road and bridges, and not exceeding fifteen cents to pay jurors, on the one hundred dollars valuation, except for the payment of debts incurred prior to the adoption of the amendment September 25th, 1888, and for the erection of public buildings, streets, sewers, water works and other permanent improvements, not to exceed twenty-five cents on the one hundred dollars valuation, in any one year, and except as in this Constitution otherwise provided; and the Legislature may also authorize an additional annual ad valorem tax to be levied and collected for the further maintenance of the public roads; provided, that a majority of the qualified property tax-paying voters of the county voting at an election to be held for that purpose shall vote such tax, not to exceed fifteen cents on the one hundred dollars valuation of the property subject to taxation in such county. And the Legislature may pass local laws for the maintenance of the public roads and highways, without the local notice required for special or local laws. Sec. 2. The governor is hereby directed to issue the necessary proclamation for submitting this amendment to the Constitution to the qualified voters of the State of Texas, on the first Tuesday after the first Monday in November, 1906, at which election all voters favoring this amendment shall have written or printed on their ballots, "For the amendment to authorize the levy of a tax to pay jurors." The voters opposed to this amendment shall have written or printed on their ballots, "Against the amendment to authorize the levy of a tax to pay jurors." [A true copy.] O. K. ## NEW HOTEL BUILDING.

### The Architect Drawing Plans for a Modern Hotel Building.

It is current talk on the streets that the plans for a modern hotel building have been submitted to the company which was recently formed for the purpose of building the hotel.

Remember it has been said that "whom the Gods would destroy they would first make mad". By standing shoulder to shoulder we can add another star to the crown of our noble order before the coming fall will have passed. From present indications everything points toward an overwhelming crop and all warehouses possible should be built to prepare for eventualities. It is very possible from present prospects that the 1906 crop will range between thirteen and fifteen million bales of cotton. Some 130 years ago people went forth with one mind and one purpose to battle against the tyranny of the British and overcome them. That same time has arrived again not for the people of the United States to overthrow foreign oppression—but twenty times the population the United States contained at that time must battle with the remaining

class; not with sword and torch, but with a co-operative working organization which shall give to the producer a just share of the returns from his labors! An organization that will enable him to follow a peaceful, industrious life, and while he produces the bread of the nation at the same time enable the man who follows the plow to command an equitable division of the products of his toil with the speculator and millionaire.

The constitution of the United States guarantees to every citizen of the civilized world a happy home within our borders, peace, harmony and plenty, provided they will work earnestly, and will protect him in his speech and liberties. The constitution of the Farmers Union guarantees to the members of the same all the freedom from graft and avarice and selfishness, and will help all industrious farmers to free themselves from the mortgage system which has kept the people in a class almost equal to slavery.

When laws become oppressive the people have and do possess a just cause to right those wrongs. Let the farmers and all liberty loving people of this great and glorious country stand together as one, and let the war cry be for the next twelve months, warehouse, warehouse, warehouse, and you will see something happening in the New York and New Orleans cotton pits.

FARMERS CONTROL COTTON

Warehouse Scheme Will Be Carried Out Quite Generally.

Austin, Texas, July 11.—Captain W. C. Day, one of the leading citizens of Hays county, was here yesterday from his home at Dipping Springs. Captain Day had filed with the secretary of state the charter of the Hays County Farmers' Union Warehouse Company of Kyle and Buda.

There has been an unusually large number of these warehouse charters filed in the state department during the past several months, coming from various parts of the state, and in each instance the Farmers' Union was interested in the matter.

Captain Day was asked about the matter, and he said that it was the purpose of the Farmers' Union of Texas to eventually control the cotton output and the market. These warehouses, he said, are going up all over the state, and the farmers are going to put their cotton in them, after these warehouses have been properly bonded and keep the cotton there until the market is suitable, and then sell the cotton.

If a farmer gets hard up, he can borrow money from his banker on the cotton stored away and repay it when he finally disposes of the staple. Captain Day declared that it was also the intention of the farmers to sell directly to the spinners and thus stop speculation in cotton and also regulate the supply and demand. It is expected to have at times upward of 1,000,000 bales of cotton stored in these different warehouses.


