A SPLENDID SHOWING.

Nacogdoches Cotton Oil Company Elect New Officers.

The annual meeting of the stockholders of the Nacogdoches Cotton Oil company was held in the city council chamber Monday afternoon.

The books of the company and the affairs of the oil mill were thoroughly gone over, and they were found in an entirely satisfactory condition. In fact, the reports of the manager, superintendent and secretary showed that the past season's business was the largest in the history of the mill with one exception. Seven thousand and two hundred tons of seed were crushed, and over \$12,000 was paid out for labor. The stockholders declared a dividend of ten per cent, and elected the following board of directors for the ensuing year:—E. A. Blount, John Schmidt, D. K. Cason, Chas. Perkins, Ben T. Wilson, Chas. Hoya, E. M. Dotson.

The Directors then met and elected the following officers: Charles Perkins, president; E. M. Dotson, vice-president; Ben T. Wilson, secretary; John Schmidt, treasurer.

E. F. Walling was re-elected superintendent of the mill for the next season.

The mill will be thoroughly overhauled and repaired during the summer for which something near \$3000 will be expended.

Five Brothers Coming.

Secretary Hawkins of the Business League is in receipt of a letter from parties in Ohio who desire information in regard to Nacogdoches county. The latter states there are five brothers in the party who are thinking of locating out this way. They state they have sold their farms at \$100 per acre, and they intend investing from \$5,000 to \$10,000 each in farm lands and some kind of business.

The desired information has been forwarded, together with a copy of the recent special edition of The Sentinel.

CONSTITUTIONAL AMENDMENTS.

Governor Without Power to Veto or Approve Joint Resolutions.

The Austin Statesman calls attention to the fact that the governor has been sharply criticised in certain newspapers of the state for permitting two of the proposed constitutional amendments to be submitted to the people and for approving them. The two proposed amendments referred to are: One increasing the salary of the governor from \$4000 to \$8000 a year and fixing the compensation of the lieutenant governor at \$2500, and the one increasing the salary of the members of the legislature to \$1000 a year for the first year and \$5 a day for extra sessions.

In the first place the governor did not approve or sign either one of these two proposed amendments, but filed them in the state department, as he is required to do under the law. The chief executive has no jurisdiction over constitutional amendments and even were he disposed to either sign or veto these two resolutions, he would have no power to do so. Proposed amendments to the state organic law is a matter between the legislature and the people, and over which the governor has nothing to do. In the event the legislature passes a proposed amendment to be submitted to the people, the governor can not take any action in the premises, however much he should like to do so.

The governor's position on these two resolutions is well known. When these two resolutions were introduced in the legislature the governor expressed his disapproval of them at the time, and he still has the same views on the subject. Consequently the attacks which have been made on Governor Campbell for "signing" the two proposed amendments and "approving" them are directly opposite to the facts in the case and contrary to the views of the chief executive of the state.

The people of Texas will express themselves on these two important propositions at an election to be held on August 6 of this year. It has been long contended that the salary of the governor of Texas was not sufficient when it is taken into consideration the great amount of work there is to the office and the executive ability required from the man who is the official head of this great state. The salary was fixed many years ago when Texas was in infancy and the duties of the chief executive have multiplied considerably since that time.

THE commissioners court of Sabine county has recently created the office of county road superintendent.

A SOLID block of modern two story brick business houses going up at once in Nacogdoches would indicate there is plenty of life in the old town yet.

WHEN the commissioners court meets next Monday a petition should be presented asking for an election on the question of issuing bonds to build a new court house and jail.

THE papers are having much to say these days about "the strike in the oil fields" of South Texas. It is not an oil strike, however, but a strike among the operatives for better wages.

NEW potatoes of the finest quality are plentiful in Nacogdoches, and have been for several weeks. While there is no shortage in the supply they find ready sale at \$1.50 per bushel. That is some profit to the producer.

NACOGDOCHES is rebuilding the burned district that occurred in that city recently. That speaks well for the business men of that town, who are always looking to the upbuilding of her city.—San Augustine Vidette.

THE pastor of a Fort Worth church has resigned his pastorate because several of the members of his church voted the anti ticket in the recent local option election in Tarrant county. A very forcible example of consistency.

AFTER having devoted thirteen years in making the Leonard Graphic one of the best weekly newspapers in the state, Hon. J. A. Thomas has sold his plant to Mr. J. T. Green, who is said to be an excellent newspaper man. Mr. Thomas retires on account of ill health.

THE Austin Statesman says that Senator Senter says East Texas has razor back hogs. ROAD SUPERINTENDENT.

Article 4763 of the Revised Statutes of Texas says that the commissioners' court of any county in this state may appoint one road superintendent for such county, or one superintendent in each commissioners' precinct, and such courts are authorized by an order made at any regular term thereof to determine whether there shall be one road superintendent for the county or one for each of the commissioners' precincts therein.

Article 4764 provides further: "In case such commissioners' court shall determine that there shall be one road superintendent, as provided in the preceding article, such court shall appoint a competent road superintendent for such county, and in case it is determined that there shall be four superintendents, then such court shall appoint a competent person as road superintendent for each commissioner's precinct in such county."

The commissioners court of Nacogdoches county has arrived at the conclusion that a road superintendent for the entire county is necessary, and very wisely too.

THE newspapers are having much to say of late about the success of the Bonham cotton mill. There are other successful mills in Texas, of course, but the Bonham mill has succeeded almost phenomenally. The Sentinel has mentioned this mill once before recently, but it will not be out of place to refer to it again. The mill originally cost \$100,000 and was paid for in 5 per cent assessments on the stock. Since erection the mill has added \$75,000 worth of improvements from its earnings. They have on hand \$30,000 in cloth and assets and have orders ahead for twelve months. They employ 285 operatives, who occupy 40 tenant houses belonging to the company. And what Bonham has done Nacogdoches can do. Suppose we try it!

THE grand jury of Nacogdoches found three bills against the old dilapidated court house and jail, and recommends building new and more modern structures for prisoners and records.—Lutkin Tribune.

And both structures with appalling emphasis mutually plead guilty to the charge.

Truck Growers Meet.

The Fruit and Truck growers met Saturday, and after hearing reports on the potato crops, it was decided to meet next Saturday for the purpose of agreeing on a date to dig and to place orders for bags, and to elect an inspector. All who want to order bags with the association should be prepared at this meeting; either be present or have a representative. It was also agreed to charge 10 per cent on all stuff handled for parties not belonging to the association. We expect fair prices, as we are assured of one or more cash buyers on the ground. J. B. EIGHT MORE BILLS.

Governor Has Approved Laws Passed at Regular Session.

Governor Campbell has approved the following important bills passed during the regular session of the 30th legislature:

House Bill granting a right of way to the Texas Midland railroad through the North Texas State Insane Asylum at Terrell.

Senate Bill appropriating \$10,000 for the erection of a granite monument over the grave of General Sam Houston at Huntsville.

Senate Bill to provide for revising, digesting and publishing the laws, civil and criminal, of the state of Texas. Effective July 12.

Senate Bill creating the sixty-seventh judicial district court in Tarrant county and providing for the appointment of a district judge for that court.

Senate Bill prohibiting insolvent corporations, domestic and foreign, from doing business in the state of Texas, and providing for quo warranto proceedings to have the charter or permit of such corporations forfeited.

House Bill amending the Terrell election law of the Twenty-ninth legislature, providing for a blanket primary for the nomination of state and district officers, also providing that before a platform demand is adopted by a state convention it shall have been petitioned and voted on by the people.

House Bill creating a state mining board, providing for a state mine inspector and fixing his salary at \$1,500 a year and expenses not exceeding \$500 a year. The new act regulates mines so as to require safety appliances for all mines. Effective in ninety days.

Senate Bill authorizing the loan of \$150,000 out of the permanent school fund of the state to extend the state's railroad out of Rusk to make connections with the Texas and New Orleans and International and Great Northern railways.

New Autos Arrived.

Capt H. H. Cooper and Dr. A. A. Nelson received their new auto cars this morning, and already their honk honks are heard on the streets. Captain Cooper has been able to get to the post office but once today, and only for a short time then, and Dr. Nelson will have to work overtime to catch up with his practice.

The machines are beauties and are the synosures of all eyes as they go spinning through the streets.

BIDS ON BONDS.

The Commercial National Bank the Highest Bidder.

City Treasurer E. H. Blount opened the bids for the purchase of the \$50,000 city water works bonds Saturday afternoon in the office of the Commercial National bank.

There were present when the bids were opened, Mayor R. T. Shindler, City Secretary and Alderman Ben T. Wilson, Alderman T. E. Baker, ex-Secretary and Alderman W. S. Beeson and The Sentinel man.

There were several bids submitted, the best offer coming from the Commercial National bank of Nacogdoches, made by its president E. A. Blount. This bid was for a premium of 1.31-10 per cent, or in round figures \$1550 cash premium over and above the \$50,000.

This will enable the city to realize \$51,550 on the \$50,000 in bonds.

The next highest bid was from J. B. Oldham of Dallas, who offered a premium of \$608 on the bonds.

A Cleveland, Ohio, firm offered to take the bonds at par, less \$500 for attorney's fee, or in other words, they offered to take the bonds at a discount of \$500.

Treasurer Blount has submitted the bids to the State Comptroller, and will give him the statutory ten day's option on the bonds, and if the board of education fails to take the bonds at the price offered by the highest bidder before the expiration of the time fixed by law, they will be awarded to the Commercial National bank of Nacogdoches.

The premium offered by the Commercial National is considered quite liberal, and City Treasurer Blount is to be commended for his splendid disposition of the bonds.

BAPTIST COLLEGE COMMITTEE.

Distinguished Visitors in the City Inspecting Sites.

Dr. S. P. Brooks, president of Baylor University at Waco, Rev. D. I. Smyth, pastor of the Baptist church at Grand View and president of the Baptist Education commission, and Dr. J. E. Ward, president of the North Texas Baptist college at Decatur, arrived in the city Sunday afternoon.

These gentlemen are a special committee selected by the State Education Commission of the Baptist church to select a location and site for the East Texas Baptist college, and they have been shown every desirable plot of ground in the city today.

Dr. Smyth preached at the Baptist church last night. This morning the visitors were taken in charge by E. M. Dotson, Robert Lindsey, Rev. A. J. Miller and J. H. Summers and shown over the city.

They left over the T. & N. O. this afternoon for Tyler to inspect that location, when they will make a definite report to the commission. They expressed themselves as being very favorably impressed with Nacogdoches.

May be Made a Felony.

A bill has been introduced in the State Senate making it a felony, punishable by confinement in the penitentiary from one to three years, for any person who may be convicted by selling or giving away intoxicating liquors in local option districts.

This bill is in accordance with the governor's recommendation in his special message to the legislature.

IMPRESSIVE FUNERAL.

Remains of Hon. C. B. Short Buried by Woodmen.

The funeral service over the remains of Hon. C. B. Short were consummated this morning, and constituted one of the most impressive funerals in the history of the city.

With the Woodmen in charge, the body was borne to the Methodist church, of which deceased was a member, where a large concourse of sorrowing relatives and friends had gathered, and where the pastor reviewed briefly the life of the deceased and offered such spiritual consolation as was appropriate, supplemented with appropriate musical selections under the direction of Mrs. O. L. McKnight. At the conclusion of the religious services the Woodmen took charge of the corpse and bore it to the grave, followed by the family, relatives and a long file of friends. Arriving at the cemetery the beautiful ritualistic service of the order was observed in the burial, and altogether it was one of the most beautiful and impressive funeral services in the history of the city.

DR. PAUL SURRENDERED.

Waived Examining Trial and is Released on Bond.

Report from Center today is that Dr. Buck Paul, who is alleged to have killed Attorney C. B. Short Tuesday evening, came in this morning and surrendered to the officers. He afterwards waived examination and was released on \$5,000 bond.

The remains of Mr. Short were buried this morning under the auspices of the Woodmen of the World, of which order he was an honored member.

The statement was made in The Sentinel's account of the killing yesterday that the negro, who killed Dr. Mike Paul last fall, went to the home of H. B. Short, where he received protection. ELECTION PROCLAMATION.

People Asked to Vote on Constitutional Amendments August 6.

Governor Campbell has issued the following proclamation, which is of general interest:

Whereas, The Thirtieth legislature at its late regular biennial session, which adjourned on the 12th day of April, A. D. 1907, passed the following joint resolutions in the manner prescribed by the constitution of this state, proposing certain amendments to the constitution of this state, to-wit:

Then follows the full text of the resolutions, and the proclamation continues as follows:

Whereas, The state constitution requires the publication of any proposed amendments once a week for four weeks, commencing at least three months before an election; and,

Whereas, Each of said joint resolutions requires the governor to issue his proclamation ordering an election for the submission of said joint resolutions to the qualified electors of this state for their adoption or rejection on the first Tuesday in August, A. D. 1907, which will be the 6th day of said month;

Now, therefore, I, T. M. Campbell, governor of Texas, in accordance with the provisions of said joint resolutions, and by the authority invested in me by the constitution and laws of this state, do hereby issue this my proclamation ordering that an election, as required by said joint resolutions, be held on the day designated, to-wit: On Tuesday, the 6th day of August, A. D. 1907, in the several counties in this state, for the adoption or rejection of said several proposed amendments to the constitution of the state of Texas.

Said elections shall be held at the same polling places of the election precincts of the several counties of this state, and will be conducted by the officers holding the same in conformity with the laws of this state, and in accordance with the provisions of this proclamation.

In testimony whereof I hereto sign my name and cause the seal of state to be affixed, at the city of Austin, this 2nd day of May, A. D. 1907.

T. M. Campbell, Governor of Texas.

In brief, the six proposed constitutional amendments are: Establishment of a home for wives and dependent widows of Confederate soldiers and sailors; fixing the pay of legislators at \$1000 for first year and \$5 a day for extra sessions; establishment of a state printing plant; creating the office of commissioner of agriculture; creation of improvement districts in cities of more than 5000 inhabitants; increasing the amount of taxes that may be voted on for road purposes.

The Sentinel has received from the Secretary of State copies of the proposed amendments, which will be published in The Weekly Sentinel, beginning with the issue of May 9.

COL. R. D. GRIBBLE, the dean of Texas lumbermen, died suddenly at the Central passenger station in Houston Tuesday morning, while enroute to his home from Mineral Wells. Col. Gribble was one of the oldest and best known lumbermen in Texas, if not in the South, and all who knew him was his friend.

THE Philadelphia Inquirer observes that the fruit crop has been killed so early this year there may be time to grow another—just as good. That is what the Texas fruit growers are doing. Some are growing potatoes, some tomatoes, some cantaloupes, some tobacco, some melons, and some are growing other crops. No sensible farmer will depend on one crop alone.

THE Nacogdoches Sentinel thinks there is absolutely no excuse for sending to foreign mail order houses or any other institution outside the state for goods, wares or merchandise of any character.—Austin Statesman.

That is exactly what The Sentinel thinks about it, and this thought applies as forcibly to county officials as it does to other individuals.

THE STATE'S REVENUE.

The question of taxation is the one that is most seriously concerning the governor and the legislature at this time. Not so much the question as to how the tax is to be levied as is the problem of how much to levy and upon what classes of property should be placed under the ban of the assessors in order to raise sufficient revenue to place the wheels of the State government upon a perpetual cash basis.

In discussing this question, the Austin Statesman says: "In answer to the inquiry of Representative Reedy as to the estimated revenue of the state for 1907 from certain sources, the comptroller has furnished Mr. Reedy with the estimates which are as follows: Ad valorem tax valuation, \$1,700,000; franchise tax and charter fees, \$375,000; gross income tax, \$410,000; intangible assets tax \$320,000, total \$2,805,750. These figures are not based on any of the probable revenue which may be derived from any of the tax measures now pending in the legislature, but from the laws which are now in effect. This does not represent, however, all the sources of revenue which the state will get under the present laws. It takes about \$3,500,000 a year to run the government, and the purpose of Mr. Reedy was to show that it was not necessary to pass so many tax measures in order to get enough revenue with which to run the government."

THE Nacogdoches Sentinel thinks a solid block of modern two story brick business houses going up at once in Nacogdoches would indicate there is plenty of life in the old town yet.—Austin Statesman.

Mr. Tucker is favorably known in this section of the country as a man of rare business accomplishments, and his acceptance of this position is very gratifying to the stockholders of the institution."

A FISH STORY.

The fish story season has opened up, and the Nimrods have already started the ball to rolling. The most remarkable story so far comes from Brenham, and is as follows:

"Mr. L. F. Ammons, who is one of the most reliable and substantial farmers of the county, while fishing at the Brenham Rod and Gun club lake at Stone, three miles east of here Saturday, witnessed an unusual sight that illustrated the size of the bass in here as well as the avidity with which they strike. Some dogs near by jumped a rabbit and the rabbit being closely pursued leaped into the lake to escape the dogs, and a bass made a strike for it and swallowed it by the time it had commenced swimming for the other side shore. Mr. Ammons was never more astonished and he says the dogs looked equally astonished as they saw the rabbit disappear."

Some of the Nacogdoches fishermen are somewhat skeptical on the subject of fish stories, but if Mr. Ammons will state that he held the bass in his hands while it caught the rabbit and swallowed it, and then extracted the cotton tail from the fish, they agree to take the matter under consideration. But whether or not this is true, the piscatorial pilgrims in these diggings want more proof on the subject.

They were Dennis Dixon, given 20 years, and Wash McCoy, given six years, for the murder of George Rhodes in this city March 30, last. They were carried to Huntsville by the way of Houston.

PEACH CROP KILLED.

Jacksonville Attorney Talked to an Austin Reporter.

R. O. Watkins, a well known lawyer of Jacksonville, Cherokee county, was here yesterday on business with the executive department. Mr. Watkins lives in the midst of the fruit belt of the state, and declared yesterday that the peach crop this year is entirely ruined, and there will be no Elberta peaches this year from Texas. The mild winter which prevailed this year caused the trees to bloom prematurely and not bear any fruit to speak of, and then the crop was reduced 75 per cent, according to Mr. Watkins, and the recent cold snap which prevailed over the state has wiped out the other 25 per cent of the peach crop. He said that there were approximately 10,000 acres of peaches growing, and promised to yield nicely in Cherokee and tributary territory, and out of that large amount of acreage he does not think that one car load of peaches will be shipped out of East Texas this season.

The tomato crop has also been materially damaged. Indeed, Mr. Watkins said that the early crop of tomatoes has been ruined, but then the truck growers can plant a second crop and still come out all right. The unusual weather conditions this year will cost the fruit and truck growers of that section of the state many thousands of Dollars.

The fruit trees, according to Mr. Watkins, could not thrive with the weather conditions that prevailed last winter, and many of the trees have died outright and will have to be replaced by others. The fruit and truck growers, however, are not at all discouraged, and will begin as soon as possible to replace the crop, but in the meantime the people will have to look elsewhere than East Texas for peaches this year.

Death of Percy Fleishel.

News reached Tyler at an early hour yesterday morning that Percy Fleishel had died suddenly at Omaha, Neb. The news was a shock to his relatives and friends here. His mother, Mrs. Florence Fleishel was in Louisiana visiting relatives, a son or a daughter, when the news of her son's death reached Tyler. It was several hours before relatives in the city could get into telephone connection with her.

Percy was reared in Tyler, leaving here only a few years ago for Omaha where he was married. He had located and established himself in a business capacity at that place, was prospering and had made many friends.—Tyler Times.

The deceased was a brother of Mrs. J. M. Seale of this city, and the sad news of his death was a great shock to her. The bereaved ones have the deepest sympathy of The Sentinel and all other friends.

Patrick's Next Move.

It is stated that A. T. Patrick, now serving a life sentence for the murder of Millionaire Rice in 1901, is contemplating applying for a habeas corpus on the ground that he was tricked into withdrawing his appeal to the United States supreme court and accepting life sentence during the term of the late Gov. Higgins.

The announcement is made on the authority of Mrs. Patrick in a long signed statement. In this statement there are charges that the court, jury and prosecutor were prejudiced against her husband and that a great sum of money was spent to railroad the defendant to the electric chair.

Tobacco Growers Discouraged.

The recent cold and excessive rains have seriously affected the tobacco. A number of growers are not through transplanting their plants, their fields being so wet and boggy they could not run their planters. With few exceptions the plants already out are not doing well, and the stalks may have to be cut down to prevent them buttoning out. One large tobacco grower is seriously considering the idea of setting out plants. The future of the Nacogdoches tobacco crop depends largely on the weather conditions for the next few days.

No More Stenographers.

The state senate Tuesday finally passed Chambers' bill repealing the present court stenographer's law and giving such stenographers \$5 per day at home when actually engaged and \$5 per day while attending court away from their resident county. No stenographer shall be employed by a private law firm and report officially. Lawyers have the privilege of preparing their own statements of facts, and get a transcript of testimony or any part thereof at 10 cents per 100 words. The bill was made optional with the courts, empowering the latter to appoint a stenographer if deemed necessary.

Proposed Amendment to the State Constitution Providing for the Creation of Improvement Districts in Certain Cities.

JOINT RESOLUTION amending Section 9, of Article 8, of the Constitution of the State of Texas, providing for the creation of improvement districts in cities of more than five thousand inhabitants, and charging the cost of certain improvements made therein against the abutting property.

SECTION 1. Be it Resolved by the Legislature of the State of Texas: That Section 9, Article 8, of the Constitution of the State of Texas, be so amended as to hereafter read as follows:

Sec. 9. The State tax on property, exclusive of the tax necessary to pay the public debt, and of the taxes provided for the benefit of public free schools, shall never exceed thirty-five cents on the one hundred dollars valuation; and no county, city or town shall levy more than twenty-five cents for city or county purposes, and not exceeding fifteen cents for roads and bridges; and not exceeding fifteen cents to pay jurors, on the hundred dollars valuation, except for payment of debts incurred prior to the adoption of the amendment September 25, A. D. 1883, and for the maintenance of public buildings, streets, sewers, water works and other permanent improvements; not to exceed twenty-five cents on the one hundred dollars valuation, in any one year, and except as is in this Constitution otherwise provided; and the Legislature may also authorize an additional annual ad valorem tax to be levied and collected for the further maintenance of the public roads; provided, that a majority of the qualified property tax-paying voters of the county voting at an election to be held for that purpose shall vote such tax, not to exceed fifteen cents on the one hundred dollars valuation, of the property subject to taxation in such county. And the Legislature may pass local laws for the maintenance of the public roads and highways, without the local notice required for special or local laws.

In addition to the foregoing, cities of more than five thousand inhabitants may lay out within their corporate limits, improvement districts in which they, by and with the consent of a majority of the taxpayers owning real estate therein, may build sidewalks and charge the cost thereof against the abutting property, and may build sewers and pave streets and charge one-third of the cost thereof against the abutting property on either side of the streets upon which such improvements are made in such district, and the amount charged against all such abutting property shall be deemed and held to be a tax against and a lien upon such abutting property, and the Legislature is required to enact laws prescribing the means for ascertaining the amount properly chargeable against each parcel of abutting property, and providing for the enforcement of its collection.

Sec. 2. The Governor is hereby directed to issue the necessary proclamation for submitting this amendment to the Constitution to the qualified voters of the State of Texas, on the first Tuesday in August, A. D. 1907, at which election all voters favoring this amendment shall have written or printed on their ballots: "For the amendment to Section 9 of Article 8 of the Constitution, permitting property owners in cities of more than five thousand inhabitants to create improvement districts, one-third of the cost of which to be charged against abutting property on either side of the street." And the voters opposed to said amendment shall have written or printed on their ballots the following: "Against the amendment to Section 9 of Article 8 of the Constitution, permitting property owners in cities of more than five thousand inhabitants to create improvement districts, one-third of the cost of which to be charged against abutting property on either side of the street."

Sec. 3. The lateness in the session, the crowded condition of the calendars of both houses, and the importance of this proposed amendment, create an emergency and an imperative public necessity demanding that the constitutional rule and Senate Rule No. 37, requiring bills to be read on three several days be suspended, and the same are hereby suspended.

Proposed Amendment to the State Constitution Fixing the Salary of Members of the Legislature.

AN ACT to amend Section 24 of Article III of the Constitution of the State of Texas, relating to the compensation of members of the Legislature.

Be it enacted by the Legislature of the State of Texas:

SECTION 1. That Section 24 of Article III of the Constitution of the State of Texas be amended so as to hereafter read as follows:

Section 24. The members of the Legislature shall receive from the Public Treasury such compensation for their services as may from time to time be provided by law, not to exceed one thousand dollars for each year in which a biennial session of the Legislature is held under the provisions of this Constitution, and five dollars for each day of any Special Session held during the subsequent year, and in addition thereto, they shall receive mileage in going to and returning from the State Capitol, not to exceed three cents per mile; the distance to be computed by the nearest railroad route, and the Comptroller shall prepare and preserve a table of distances for each county seat now or hereafter to be established, and by such table the mileage of each member shall be paid; no member shall be entitled to mileage for any extra session that may be called within one year after the ad-

Journal of a Regular or Called Session.

Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of the State at an election to be held throughout the State on the first Tuesday in August, 1907, at which election all voters favoring said proposed amendment shall have written or printed on their ballots, the words: "For the amendment to Section 24 of Article III of the Constitution relating to the salary of the members of the Legislature," and all those opposed shall have written or printed on their ballots, the words, "Against the amendment to Section 24 of Article III of the Constitution, relating to the salary of the members of the Legislature."

Sec. 3. The Governor of the State is hereby directed to issue the necessary proclamation for said election and to have the same published as required by the Constitution and laws of the State, and the sum of \$1000 or so much thereof as may be necessary is hereby appropriated out of the general revenue of the State not otherwise appropriated to pay the expenses of such publication and election.

Proposed Amendment to the State Constitution Authorizing the Establishment of a State Printing Plant.

JOINT RESOLUTION authorizing the submission to a vote of the people of the State of Texas of a proposed amendment of Section 21, Article XVI, of the Constitution of the State of Texas, relating to printing, publishing, stationery, paper and fuel, and making an appropriation therefor.

Be it Resolved by the Legislature of the State of Texas:

SECTION 1. That Section 21 of Article XVI of the Constitution of the State of Texas be so amended as to hereafter read as follows:

Section 21. All printing and publishing, and all stationery, paper and fuel for the various departments, and for all offices, whether created by this Constitution or by law, shall be done and supplied as may be provided by law, and for the accomplishment of these objects and purposes the Legislature may provide and establish a requisite means and agencies, invested with such powers as may be deemed adequate and advisable.

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of the State at an election to be held throughout the State on the first Tuesday in August, A. D. 1907, at which election all voters favoring said proposed amendment shall write or have printed on their ballots the words "For the amendment to Section 21 of Article XVI of the Constitution, relating to stationery, printing, paper and fuel."

Sec. 3. The Governor of the State is hereby directed to issue the necessary proclamation for said election and to have the same published as required by the Constitution and existing laws of the State.

Sec. 4. That the sum of two thousand (\$2000) dollars, or so much thereof as may be necessary, is hereby appropriated out of any funds in the Treasury of the State of Texas not otherwise appropriated, to pay the expenses of such publication and election.

Proposed Amendment to the State Constitution Authorizing the Levy of a Road Tax.

JOINT RESOLUTION amending Section 9, of Article 8, of the Constitution of the State of Texas, by adding thereto a section to be known as Section 9a, increasing the amount of tax that may be voted for the purpose of improving public roads, and to allow counties or political subdivisions of counties by a majority vote of the qualified property tax-paying voters of the county, or subdivision thereof, voting at all elections, to be held for that purpose, to adopt same.

Be it Resolved by the Legislature of the State of Texas:

SECTION 1. That Section 9 of Article 8 of the Constitution of the State of Texas be amended by adding thereto Section 9a, which shall read as follows:

Section 9a. A majority of the property tax-paying voters in any county or one or more political subdivisions thereof, in this State, voting at an election held for that purpose may vote a tax for road and bridge purposes not to exceed 20 cents on the \$100 valuation of the property subject to taxation in such county or political subdivision of such county, or may issue bonds not to exceed 20 per cent of the assessed value of the real property in such district, for such road and bridge purposes, provided that such tax or proceeds of such bonds, shall be expended in the territory in which it is voted, and no other, and this provision of the Constitution shall be self-enacting without the necessity of further legislation.

Sec. 2. The Governor of this State is hereby directed to issue the necessary proclamation submitting this amendment to the qualified voters of Texas at the next general election held in this State, or in case any previous election shall be had in the State for other purposes, then this proposed amendment shall be submitted to the qualified tax paying voters. And the sum of \$2000, or so much thereof as shall be necessary, is hereby appropriated out of the treasury of the State of Texas for the purposes of submitting this proposition to a vote of the people of the State of Texas.

Proposed Amendment to the State Constitution Creating the Office of Commissioner of Agriculture.

JOINT RESOLUTION proposing an amendment to Article four (4) of the Constitution of the State of Texas, by adding thereto a section to be known as Section 27, providing for a Department of Agriculture, with a bureau of labor.

Be it Resolved by the Legislature of the State of Texas:

SECTION 1. That Article four (4) of the Constitution of the State of Texas, be amended by adding thereto Section 27, when a majority of the qualified electors for members of the Legislature of Texas at an election for that purpose shall vote in favor of the amendment, shall read as follows:

Section 27. The Legislature shall provide for the office of Commissioner of Agriculture, who shall be either elected by the qualified voters of the State, or appointed by the Governor with the advice and consent of two-thirds of the Senate, as the Legislature may provide; whose term of office, duties and salary shall be prescribed by law; in which department there shall be established by the Legislature a bureau of labor, when required by the public interest.

Sec. 2. The Governor of this State is hereby directed to issue and have published the necessary proclamation for the submission of this resolution to the qualified voters for members of the Legislature of the State of Texas, as an amendment to the Constitution of Texas, to be voted upon on the first Tuesday in August, 1907. All persons favoring said amendments shall have written or printed on their ballots, as follows: "For the amendment to the Constitution, providing for a Department of Agriculture and a Bureau of Labor." And those opposed to said amendments shall have written or printed on their ballots as follows: "Against the amendment to the Constitution, providing for a Department of Agriculture and a Bureau of Labor." And the sum of (\$2000) two thousand dollars or so much thereof as may be necessary is hereby appropriated out of any funds in the Treasury of the State of Texas, not otherwise appropriated, to pay the expenses of such publications, proclamations and election.

Proposed Amendment to the State Constitution Providing for the Establishment of a Home for Confederate Widows.

JOINT RESOLUTION to amend Section 51 of Article 3 of the Constitution of the State of Texas, as amended in 1903, so as to authorize the grant of aid in the establishment and maintenance of a home for the disabled and dependent wives and widows of Confederate soldiers and sailors and such women as aided the Confederacy, and making an appropriation.

SECTION 1. Be it Resolved by the Legislature of the State of Texas: That Section 51 of Article 3 of the Constitution of the State of Texas, as amended in 1903, be so amended as to hereafter read as follows:

Article 3, Section 51. The Legislature shall have no power to make any grant or authorize the making of any grant of public money to any individual, associations or individuals, municipal or other corporations whatsoever; provided, however, the Legislature may grant aid to indigent and disabled Confederate soldiers and sailors who came to Texas prior to January 1, 1880, and who are either over sixty years of age or whose disability is the proximate result of actual service in the Confederate army for a period of at least three months, their widows in indigent circumstances who have never remarried and who have been bona fide residents of the State of Texas since March 1, 1880, and who were married to such soldiers anterior to March 1, 1880; provided said aid shall not exceed eight dollars per month, and provided further, that no appropriations shall ever be made for the purpose hereinbefore specified in excess of five hundred thousand dollars for any one year. And also grant aid to the establishment and maintenance of a home for said soldiers and sailors, their wives and widows and women who aided in the Confederacy, under such regulations and limitations as may be provided by law; provided the grant to aid said home shall not exceed one hundred and fifty thousand dollars for any one year, and no inmate of said home shall be entitled to any other aid from the State; the Legislature may provide for husband and wife to remain together in the home; and provided further, that the provisions of this section shall not be construed to prevent the grant of aid in case of public calamity.

Sec. 2. The Governor of the State is hereby directed to issue the necessary proclamation for the submission of this amendment to the qualified voters of the State of Texas on the first Tuesday in August, 1907.

The sum of \$5000, or so much thereof as may be necessary, is hereby appropriated to pay the expenses of carrying out the provisions of this resolution.


Died in Fort Worth.

C. A. Bryant of Dallas, editor of the Texas School Journal, was here yesterday on business with the state department of education. One of the most important bills, according to Mr. Bryant, is the county supervision act which requires the appointment of county superintendents in all counties having 3000 scholars.

He said that he will advocate in his paper the adoption of the constitutional amendment proposed by the present legislature and which will be voted on next August. This proposed amendment authorizes the voting of a 50 cent school tax by any county or independent or common school district. He said that those who are opposed to such an amendment to the constitution should not vote against its adoption as many other counties or districts might want the proposed tax. He will do all in his power to have this proposed amendment engrafted in the organic law of the state of Texas.



FEARED A LYNCHING.

Willis McLain Carried to Houston for Safe Keeping.

Houston Chronicle.

Willis McLain, the negro charged with quadruple murder and captured some weeks ago by Deputy United States Marshal Spradley, has been brought to Houston for safe keeping. He is now lodged in the Harris county jail. Since his arrest and until last night he has been confined at Livingston. Sheriff Chapman and Deputy Sheriff Garvey removed him from the country town in the dead of last night upon the receipt of information that violence was contemplated by the residents in that vicinity.

Before his capture McLain ranged for more than a week, living on berries and terrorizing residents in the vicinity. He is alleged to have slain Jack Darden, Ann Darden and Robert Johnson, all colored, and a white man, Mr. Spurlock, during the period.

Ann Darden was the nurse of John H. Kirby when he was a child, and the head of the great lumber company traveled to East Texas to offer, by his presence, encouragement to the hunters. At the same time he added to the amount of the reward already posted by the local authorities for the capture of the man this morning brought to Houston.


The case is one wherein desperation combined with passion is said to have driven McLain to murder lust, and sent him like an animal to the canebrakes and the thickets, an avowed enemy to residents in the vicinity, bent upon maintaining his freedom in spite of the overwhelming force arrayed against him.

Fully armed and well supplied with ammunition, he is said to have killed two men bent upon his capture, Robert Johnson, colored, and Mr. Spurlock, the white victim. In a preliminary fight he stood off the members of a posse and escaped after having been surrounded. At that time he received his first wound and was forced to use his guns as crutches. Later he is believed to have encountered Spurlock, whose dead body was found where the victim fell. Again when apprehended by John Spradley and Dr. Shine, he showed fight. Spradley advanced, firing, and in the face of a shower of bullets, Dr. Shine brought the negro finally to earth, and capture was reported.

According to Sheriff Chapman, who this morning brought the negro to Houston, McLain was crazed by murder lust and makes no denial of his guilt in the slaying of Jack Darden, Ann Darden and Robert Johnson.

It is stated that McLain had difficulty with his wife and that her relatives interfered. Angered beyond control, he set out bent on the death of Preston Scott, another negro. Scott was at the house of Jack Darden and the two was seated together. Just as McLain fired Darden moved and received the load.
