

> Bronte's firemen were on the job within minutes, and began fighting the blaze which threatened the entire north side of the block. Robert Lee's fire truck arrived in a short time and took over the fire fighting job at the back of the buildings. The two volunteer departments were able to slow the spread of the fire to the roofs of Bronte Furniture and West Texas Utilities buildings. Other fire fighting units from Blackwell, Ballinger, Winters and San Angelo arrived shortly and flames were brought under complete control.

Only person reported injured in the fire fighting operation was Tommy Lee, son of the feed store owner. He collapsed from inhaling too much smoke and was given first aid by Sam Williams who was present with a Clift ambulance. San Angelo Emergency Corps members brought their equipment out to help in the battle. Highway patrolmen were also present. Smith was out early Wednesday morning making plans to reopen his sportswear factory. He said he had obtained the former Pruitts grocery building, owned by Mrs. Willie Mae Glenn and would order materials and new machines for immediate delivery. He said he hoped to be back in operation Monday morning. Lee and Jones said their plans for re-opening the feed and furniture stores are indefinite now.

Operators of other stores on the north side of main street considered themselves lucky to be in business Wednesday morning. It looked for several minutes as though the flames would encompass the entire block, before firemen brought them under control. Merchandise, furniture, records and other valuables were removed from First National Bank, White Auto Store and The Bronte Enterprise. A great deal of the merchandise in the furniture store was moved up the street into the Rawlings building immediately west of the Enterprise office. Plenty of volunteers were on hand to help with the moving. The items removed from White Auto, The Enterprise and First National Bank were taken back into their buildings after the fire was under control.

County and Precinct Results In Demo Primary

(Editor's Note: Well, we really goofed on the election story. We lost the first part of the story on page 1 when we were making up the page, and didn't know it until the paper was all printed. If you will take this small sheet out and read it before you start reading the election story, it will all come out all right.)

Nearly 1400 voters went to the polls last Saturday to vote in the Democratic Primary held that day. This was considered a good turnout by election officials. The two largest boxes in the county, Robert Lee and Bronte, polled 447 and 443 votes, respectively. Heavy interest in local races, as well as those on the district and state level, brought out the big voting crowd.

In the county judge's race W. W. (Bud) Thetford was re-elected to a second term, defeating his opponent, Charlie Boecking, 853 to 506. Likewise, in the county clerk's voting, the incumbent, J. L. (Chilly) Tinkler was re-elected over Pauline Roe Holland. Count was 944 to 435.

A newcomer was elected to the office of county treasurer. Inez Burns received the greatest number of votes given any candidate when she defeated Gertrude Gray, the incumbent, 1003 to 371.

In the commissioners race for the two east side precincts, the present commissioner, Howard Brock, was re-elected in Precinct 2, defeating C. E. McGuire, 334 to 185. The only runoff in the county developed in Precinct 4, where a 4-way contest was being waged. Jack Corley came out as top man with 46 votes. He will run in the second primary against Robert I. Brown who received 27 votes. J. D. Huffaker received 19 votes and four votes were cast for E. J. (Gene) Halamicek.

Roy P. Ross and J. T. Liles were unopposed in their bid for second terms of justice of the peace in Precincts 1 and 2. Liles received 509 votes and Ross, 590.
