## HUGE IRRIGATION PLANT

FIGURES SUBMITTED TO WATER 140,000 ACRES—PRIVATE CORPORATION TO HANDLE PROPOSITION IN CASE GOVERNMENT PROJECT FAILS OR DELAYS

Mr. J. A. Fairly has received an estimate from Burns & McDonnell, hydraulic engineers of Kansas City, Missouri, with other valuable suggestions which the Herald is glad to submit to our readers. The letter is as follows:

Kansas City, Mo., June 9, '09.  
 Mr. J. A. Fairly,  
 Portales, New Mexico.

Dear Sir:—From what we have been able to learn of the matter, it occurs to us that this project is entirely feasible and would be a meritorious one that would appeal very readily to the people of the county.

We have estimated just roughly of course, as best we can in the absence of actual surveys, that the work can be installed ready for distribution of power to the entire one hundred sixty thousand acre tract at approximately the following figures:

Steam plant	\$2,500,000
Chimney, boiler house and other buildings	500,000
Steam turbines and gears, etc.	1,000,000
Condenser and cooling water	500,000
Switch board	500,000
Overhauling machinery & cranes	500,000
Pole lines and complete system of wiring for distribution	4,000,000
Total	10,000,000

These figures are based on a basis of pumping machinery of sufficient capacity to pump water

to irrigate to a depth of four inches every month over a tract of one hundred sixty thousand acres. The largest item of cost is the pole line and distribution system. We have assumed that it would be necessary for one well to be located at the highest point of each forty acre tract. The above estimate would be sufficient to deliver the current complete to each individual consumer except that an estimate is included in the above for the individual transformers and motors which each farmer would thus be called upon to supply for himself. It would seem to us that with the climate and other favorable conditions that you have for agriculture, the entire tract would really stand a charge of four or five dollars per acre per year for irrigation. If so, this would work out as a very good investment and it appears to us as an attractive one from a financial standpoint.

The above information is just of a general nature and we believe that the details could be worked out in such a way as to make it possible to finance the undertaking.

We would like to discuss this matter more fully with you on our next trip to Portales.

J. Mollinari writes Mr. W. O. Oldham from Washington, where Mr. Mollinari had gone to investigate our chances to secure the \$300,000 power plant for irrigation for the Portales community. Mr. Mollinari writes that he was able to clear up a very serious misunderstanding which the authorities had received from the report of a geological survey made here in 1903, and also to present the claims of our shallow water district round about Portales as to secure the definite promise of Mr. Newell, chief of Reclamation Service, also of the chief of the Geological Department to recommend the appropriation. Mr. Mollinari says, however that the bill can not be considered before the winter session of Congress and that in the meantime it is very necessary that EVERY FARMER IN THIS SHALLOW WATER DISTRICT SUBMIT TO MR. FAIRLY A DIAGRAM OF HIS LAND, giving description by numbers, together with depth of his well and the number of gallons that can be pumped by steam or electrical power. From these several descriptions IT IS PROPOSED THAT WE DRAW A MAP OF THE WHOLE VALLEY and submit it as soon as possible to Mr. Newell.

Meantime Mr. Mollinari has gone on to New York City, where he is elisting eastern capitalists in the matter, so that in case the Government project is turned down or delayed, we can secure a much larger plant by means of a private corporation.

### Bond Reduced

The hearing of H. A. Irwin and wife, Lelia Irwin, was finished before Judge Wm. H. Pope in district court at 9:30 last night and the defendants were ordered held for the investigation of the first grand jury of the new county of Curry and their bond was fixed at \$1000.00 apiece, which will be easily furnished according to a statement of the attorneys for the defense. The new bond comes as a big reduction, since the prisoners had been ordered held by the justice of peace under a bond of \$5,000.

The trial was a habeas corpus procedure, brought in the so called Black Hand case from Clovis, by which Mrs. Irwin and husband hoped either to be discharged from the charge entirely or to secure the reduction in bond which was granted.

The hearing last night was attended by a good sized crowd in spite of the war weather. There were several women in the audience. Mrs. Irwin was on the stand much of the evening, and gave a cool and straightforward account of the whole transaction. She showed some emotion during the cross questioning and later in the evening when Judge Pope gave his decision, could no longer refrain from tears. She

created no scene, however, and did not give herself up to sobbing until court was adjourned and nearly all the attendants had left the court room. She was almost carried by her husband to the Grand Central hotel where they have been stopping with an officer always present, during their stay in Roswell.

The following is an exact copy of one of the letters that was introduced as evidence in the case, with miss-spelling and improper capitalization the same as in the original and shows the nature of the proposition:

"D. K. . . . J. S. Fitzhugh Use Your Anfluence to give Irwin . . . Wire Freedom at once. Will give you to June 15. Fail it means Death for Convicting They are Innocent. Do This You Will Never Be Annoyed Again fail to do so your days are Numbered."

"BLACK HAND"

It develops that Mrs. Irwin has been connected with the courts before, but not in the place of defendant. She is none other than pretty Lelia Flannery, formerly of Dennison, Texas, who was for some time court stenographer under Judge Townsend at Ardmore and later deputy clerk of Johnson county, Oklahoma. She is an accomplished young woman and is also a school

teacher. She is 26 years old. Her husband, who is under arrest with her, is H. A. Irwin and they were married at Wichita Falls, Texas, October 9, last year. He is a son of W. I. Irwin, a wealthy and highly respected citizen of Sulphur Springs, Tex. No evidence has come out so far to connect Irwin with the case, but it is conceded by everyone that, in the nature of things generally, if Mrs. Irwin is guilty, he must be in the plot.—Roswell Daily Record.

### Jail Breakers Caught

Monday night a few of the jail boys decided that the air was fresher outside and, by means of some improvised tools, had about succeeded in making a way of escape when Charley Duncan unexpectedly called out to them and asked if they hadn't better postpone further operations. Four men were on the point of making good their escape.

Mrs. Sterling Moody reports that a cyclone struck Eldorado, Texas, recently, destroying four houses, but not hurting any one seriously.

### The Portales Plan.

Much interest attaches to the movement that is on foot for the establishment of a central power station at Portales for the dissemination of electric energy to be used in pumping for irrigation. It is especially worthy of note from the fact that if the government can not see its way clear to install the works, a number of individuals have signified their intention of doing so just as soon as it becomes apparent that Uncle Sam is not going to take hold of the scheme. Of course it would be preferable all around to have the government do it, as the experiment would have a deep significance to this phase of the reclamation service, which has infinite possibilities beyond that attainable by the principle of irrigation from streams. In all likelihood no other portion of the southwest offers such favorable conditions for a test of the plan. All over the rich Portales valley, there is an underlying sheet of the finest kind of water at from eight to forty feet, and the soil is royal in its richness. There are no engineering obstacles in the transmission of power, and seemingly no reason why the plan should not be a success from the start, the pessimistic conclusions of The Tenderfoot to the contrary notwithstanding.

The truth of the matter is that the Portales country has reached that point where the work must be done, either by the government or by private capital. The land is so rich and productive that there is an enormous waste every time a dry year comes along and the crops fail. Portales valley will this year lose more than enough to install the system in short crops, and while this may not occur again for years, it is quite possible that it may occur again in 1910. The risk is too great to be longer taken. It is not good business to take it, when a nominal investment will make that land produce an average of \$100 per acre in orchards, and as much or more in diversified crops under careful tillage. Even supposing that the installation of the work placed a lien of \$25 an acre on every foot of land involved, it would be well spent, and would add many times that sum to the basic values. It would change \$30 to \$50 land, and make Portales one of the leading cities of the southwest, simply because no other city has such a remarkable body of contiguous agricultural land.

The people of Portales seem to be wise to these facts, and it certainly is well that they are. They have come to the parting of the ways, and if they have the wisdom we think they have, they will keep up steam on this power proposition. There are millions in it, while on the other hand is the stagnation of uncertainty, the instability of rain dependence and the perpetuation of primitive conditions of chance in place of highly productive certainty. No wonder the intelligence of the Portales country sees the point.—Register-Tribune.

## Heading Off Prohibition.

Good people have the right to enjoy the discomfiture of the liquor interests. That there is trembling and panic in the camp of the brewers and distillers there is no sort of doubt. They are aware of the growing prohibition sentiment, and are suffering the keenest distress. Every day they are being more and more circumscribed by the enactment of prohibitory laws. Something must be done. Prohibition must be headed off. But the enemies of prohibition have found that they lose more than they gain by a straight-out fight against prohibition. Expediency requires that they shall change their tactics. Accordingly they are proposing a new policy. This new program was outlined the other day by Rudolph J. Shaefer, president of the New York Brewer's Association. The plan is to favor reform in the liquor selling business. People generally will not be deceived by such pretensions. Even if the organized liquor interests should lend hand in eliminating some of the grosser and deadlier features of the business, their motives will be clearly understood. There is abundant proof of the fact they would not favor any reforms in the business but for the hope that by this means they might, may be, save their business from utter ruin. And again if they were to undertake this reform business with all sincerity they would have a hopeless task. The business is too hopelessly bad to be capable of reform. It is the manifest and inherent and universal depravity of the business that has waked the people up to the fact that it is impossible to regulate it. There can not be found one saloon in a thousand that will pay decent respect to reasonable laws of regulation.

Prohibition has gained too much headway to be headed off by the puny and pretentious efforts at reform by the liquor power.—Word and Way.

### TAFT GROWS DEMOCRATIC

Asks for 2 Per Cent Tax on Corporations, Also Income Tax, Amendment to Constitution, Etc.

Wednesday, June 16, President Taft brought on a new crisis in the politics of the United States, by adopting outright the Democratic principles of an income tax and a direct tax on corporations; and he is insistent upon the income tax to the point of asking for a constitutional amendment. The following is the text of the epoch-making message to Congress:

"With my inaugural address I called attention to the necessity of the revision of the tariff this session and stated the principles upon which I thought the revision should be effected. I referred to the increasing deficit and pointed to the obligation of the framers of the bill to arrange for a duty for an adequate income. "The decision in the income tax cases takes from the government the power which it was supposed the government had. It is undoubtedly power the government ought to have. I therefore recommend that both houses of congress by two-thirds vote propose an amendment to the constitution conferring the power to levy an income tax, upon the national government, with apportionment among the states, according to population. This is much the better course than to re-enact the law once declared unconstitutional, for congress to suppose the court will reverse itself and to enact legislation on such an assumption is not to increase confidence in the stability of the courts."

"It is said that the difficulty and the delay in getting the consent of three-fourths of the states will destroy all chance of adopting the amendment. While none can speak with certainty on this point, I believe the majority of the people favor vesting the national government with the power to levy an income tax. The second condition in the Pollock case left the power in the national government to levy an excise tax. I therefore recommend an amendment to the tariff bill imposing on all corporations and joint stock companies for profit, except certain banks, otherwise taxed, an excise tax, measured by two per cent of the net income of such corporations. If enforced such a tax will bring in a revenue of not less than twenty-five million dollars."

**Taft Grows Democratic**

**Asks for 2 Per Cent Tax on Corporations, Also Income Tax, Amendment to Constitution, Etc.**

Wednesday, June 16, President Taft brought on a new crisis in the politics of the United States, by adopting outright the Democratic principles of an income tax and a direct tax on corporations; and he is insistent upon the income tax to the point of asking for a constitutional amendment. The following is the text of the epoch-making message to Congress:

"With my inaugural address I called attention to the necessity of the revision of the tariff this session and stated the principles upon which I thought the revision should be effected. I referred to the increasing deficit and pointed to the obligation of the framers of the bill to arrange for a duty for an adequate income. "The decision in the income tax cases takes from the government the power which it was supposed the government had. It is undoubtedly power the government ought to have. I therefore recommend that both houses of congress by two-thirds vote propose an amendment to the constitution conferring the power to levy an income tax, upon the national government, with apportionment among the states, according to population. This is much the better course than to re-enact the law once declared unconstitutional, for congress to suppose the court will reverse itself and to enact legislation on such an assumption is not to increase confidence in the stability of the courts.

"It is said that the difficulty and the delay in getting the consent of three-fourths of the states will destroy all chance of adopting the amendment. While none can speak with certainty on this point, I believe the majority of the people favor vesting the national government with the power to levy an income tax. The second condition in the Pollock case left the power in the national government to levy an excise tax. I therefore recommend an amendment to the tariff bill imposing on all corporations and joint stock companies for profit, except certain banks, otherwise taxed, an excise tax, measured by two per cent of the net income of such corporations. If enforced such a tax will bring in a revenue of not less than twenty five million dollars."
