In fact, it has, no doubt, been told to the public in general that this was to be done soon by our real estate firm, but for the benefit of those we have been unable to see in person we wish to state that this is absolutely false, untrue and unjust, that such a statement be made against our firm, and we will further state that before we would impose on the moral, law-abiding white citizens of this community by settling amongst them a bunch of black, African bred, raping, NIGGER class, we will retire from the real estate business and embark in the scavenger business, or some other that we consider clean, healthy and moral, rather than handling black, low bred "COONS." And we will also state that we are not dictating to the people who shall settle or who shall not settle in Roosevelt county, but simply want the public to know that it is not our business to settle "coons" and we don't intend to do it.

At present our county is populated with a class of moral, law-abiding, white citizens, and on our county record of criminal docket you are unable to find a single RAPE case, not even a case of lynching has ever gone on record in our county, and some may ask why? The answer is, no NIGGERS to cause such trouble. So you will find Joe Howard & Sons at the same old stand, doing a general real estate business with white people.

**In Hall's Behalf.**

From Roswell Record.  
W. A. Mitchell, a deputy sheriff at El Paso and formerly well known in this section of New Mexico, was here yesterday circulating a petition addressed to the governor of New Mexico, asking him to pardon Will Hall, who was sent to the penitentiary for life for killing a man named Crump, in Roswell, nine years ago. Mr. Mitchell was seeking only the names of old timers who were here at the time of the killing. He secured several of them. The older citizens all well remember the tragedy. Crump went to a house where Hall was quartered and when Crump broke open the door Hall shot him. They had been having trouble earlier in the day. The case was tried in Roswell and Hall found guilty. He secured a new trial and took the case to Lincoln on change of venue. He was again convicted and sentenced to the penitentiary for life. Among the signers to his petition in Lincoln county were the members of the jury that found him guilty. They are nearly all Mexicans, as indicated by their Spanish names.

Hall was an old friend of Mitchell; also of W. R. Cummins, of this city, who went with Mitchell yesterday and helped secure signatures to the petition.

**High Living and High Prices.**  
The Wichita, Kansas, Eagle publishes an article to the effect that this nation was more likely to suffer from the the price of high living than it was from the high price of living. It says: We think the assertion is susceptible of proof. Seventy-five per cent of the people today have

forgotten now to deny themselves and put aside their own fancies. While few may live beyond their incomes, thousands who ought to know better are living up everything they make. The man who scoots around in an automobile for the joy of it while paying for it on the installment plan because he hasn't the money to pay for it outright, would do well to pause and consider his habits. The men and women who put their wealth to the last cent on their backs or spend it on their table ought to take account of their mental habits. Folks who are building homes out of all proportion to the size of their families and from motives of shoddy and pride, would do themselves a service by making an inventory showing the recent growth of their tastes and the increasing difficulty of meeting their own requirements.

Extravagance may sometimes be a necessity; it is most frequently a habit, a mental process where the luxury becomes a seeming necessity. Few people retrace voluntarily the road of luxury. Nearly every one who returns over that path is led back by a guide who holds failure in one hand and humiliation in the other, and the return trip usually results in life-long bitterness to him who takes it.

No one these days speaks of frugality. But frugality is still a virtue, just as much as it was one hundred years ago. And the doctrine of penalties, upon which this world has run for good many centuries, has a clause covering its violation.

**Oklahoma Legislature to Meet.**

Late at night on November 16, Governor Charles N. Haskell issued a call for the legislature for the new state to meet on December 2. The place where the session will be called is left open. This gives reason for fear at Guthrie that the legislature might be called to meet at some other place than Guthrie, if the city does not offer a place for the legislature to meet at a figure to suit the governor and the legislators. Shawnee has offered quarters for the state officers and a place

for the legislature to meet free of charge. The Oklahoma legislature is composed of one hundred and nine representatives and forty-four senators. The republicans have only seventeen members of the House and five members of the senate. Governor Haskell does not outline any proposed legislation in the call.

On November 7, the president announced the following appointments for the new state of Oklahoma:

John H. Cottrel, judge; John Embry, United States attorney, and John Abernathy, United States marshal, for the western district. Ralph E. Campbell, judge; Wm. Gregg, United States attorney, and G. A. Porter, United States marshal, for the eastern district.

The poorest way on earth to  
practice economy is to starve  
stock to save feed.

The scarcity of coal has greatly affected the progress of the burning and manufacture of brick at the territorial penitentiary of late. The books of the institution show orders for over 1,000,000 brick which could be promptly disposed of as soon as ready for delivery.—New Mexican.

Most of the railroads operating in Oklahoma put the 2-cent passenger fare in effect November 16th. This action is in compliance with a provision of the constitution requiring roads to carry passengers for 2 cents a mile unless they could show to the corporation committee that they could not make a reasonable profit on that rate.

Nineteen New Mexico veterans have been made happy as the result of the unceasing and unselfish labors of Delegate to Congress W. H. Andrews, who has presented their claims before the pension office and secured pensions for them. These are the latest to be benefitted by the delegate's good and timely work.—New Mexican.

The work of marking the line of the Santa Fe trail in Kansas has been completed. The Daughters of the American Revolution have placed ninety-five monuments along the route of the trail, at least one in every county through which the trail passed. These monuments were made of Oklahoma granite and contained a suitable inscription to show its purpose. The state and the D. A. R. furnished the money to buy and have the monuments dressed. The Atchison, Topeka & Santa Fe road hauled them free and the county organizations had them placed in their proper positions. The D. A. R. in Colorado are now at work placing similar monuments to those used in Kansas along the trail in Colorado.

"Alfalfa is a great feed," says Doctor D. F. Luckey, State Veterinarian of Missouri. "It will not be long until the leaves and stems will be ground into a meal and alfalfa bread made from it. This bread will in a great measure take the place of milk in a well balanced diet. I know a man will not think favorably of such food for himself and family, but it can be made very palatable. It may, to some extent, take the place of cornbread. I know a man who has fed bread of this kind to some game chickens and they were placed in fine shape; dog bread has often been made out of it. If for any reason a scarcity of breadstuffs should occur in the United States and the price of flour and meal should go up extremely high, I believe that alfalfa bread would be used extensively, provided, of course, that the alfalfa crops were not a failure at the same time."

## A LITTLE LAY SERMON.

Last week a man arose in a big Presbyterian conference in Cincinnati and said that he had come all the way from Albuquerque, New Mexico, to find out how to become a christian. He declared that he did not believe a man could be a christian and work for a big corporation that forced him to lie and steal. The brief dispatch narrating the circumstance said that the question created something of a sensation, though the reasons therefor were were not given. Possibly the conference was surprised that anybody would come to Cincinnati to find out how to become a christian, or that anybody from Albuquerque wanted to be a christian, or that anybody working for a corporation had any hope of becoming a christian.

But this poor inquirer is troubled with the same trouble that troubles a lot of other people. While it must be admitted that the business world is not conducted in every respect according to the letter of either the Decalogue or the Golden Rule, yet the assumption that any big corporation forces its employes to lie and steal, or that a man cannot be a christian and be connected with a corporation or any other commercial institution of recognized methods, is simply nonsense. This man, taking him at his word, wasted time and railroad fare in going all the way from New Mexico to Cincinnati to find out how to become a christian. The answer to the question is much easier now than it ever was before, for it depends more upon the spirit than the letter of creeds and dogmas. The world is growing more tolerant every day, and the religious world is sharing in this widening liberality. Even the strictest of doctrinaires will admit a greater latitude in the matter of doctrinal requirements. It is becoming increasingly common for the various denominations to join in revival services, the gross results being distributed among the various sects according to the personal preferences of the converts.

So far from business institutions forcing men to lie and steal, the business world is demanding an ever-rising standard of personal morals on the part of its employes. The moral code of the business world was never higher. The store upon whose products implicit reliance may be placed enjoys the largest share of the public patronage, and the employe whose personal honesty is above suspicion is regarded as an asset above price. Every business man knows that the employe who will steal for him will steal from him, and that the employe who will lie for him will lie to him, and he doesn't want that sort of employes. The smirking, smug "goody-goody" fellow will not necessarily receive the highest degree of favor, but every employer not only wants, but demands, absolute reliability and all the other cardinal virtues of christian morality. The man who is known as a sincere, earnest, modest and consistent christian, who doesn't spend too much time telling how good he is, but who shows his goodness by being good, can get a job any day in the week, for that is the kind of man the business world is looking for—and that means women, too.—Kansas City Journal.

## NEW STATE BORN.

Born, at the White House, at 10:16 a. m., on November 16, 1907, a new state, christened Oklahoma, the product of long controversy, suffering and strife, finally vitalized by the pen of Theodore Roosevelt.

This is the forty-sixth member of the family of states, and its birth will be celebrated by the addition of a new star to the flag of the Union on July 4, next, the birthday of the nation.

The ceremonies attending the birth of Oklahoma were very simple. At the hour stated, a small crowd of newspaper men and statesmen assembled in the cabinet room of the White House. Secretary Loeb appeared upon the scene, carrying the proclamation, in typewritten form, and an eagle quill sent to the president by Oklahoma friends. President Roosevelt followed closely, took his seat at the head of the cabinet table, grabbed up the eagle quill, jabbed it into the ink well, and then dashed off his signature at the bottom of the proclamation.

As he finished running a blotter over his name to dry the surplus ink, the president smilingly remarked:

"Oklahoma's a state."

"Will you please give me that blotter as a souvenir?" asked Albert Hammer, an Oklahoma man, who lost a day from work at the land office to see the "immortal document" signed. The president tossed it to him. Mr. Loeb took charge of the eagle quill and will send it to the Oklahoma Historical Society.

## TO RELIEVE PANIC.

On Monday, Secretary Cortelyou made the important announcement that as a means to relieve the present financial situation, there would be issued \$50,000,000 of Panama bonds and \$100,000,000 certificates of indebtedness, or as much thereof as may be necessary. The certificates will run for one year and bear three per cent interest. It is hoped this will greatly help to restore confidence and cause money to circulate in the usual manner. It seems the east has its grip on a large volume of western money, as well as its own, and refuses, because of its local conditions, to release this currency so that the normal movement of crops, due at this time, may occur. This Wall street paroxysm occurred at the only time it could do much harm, at just the time when the great crops were to be moved, and required all the available funds to move them. Crops were good and the business conditions sound, but there has been a stoppage in financial centers, which President Roosevelt proposes to relieve by a dose of castor oil in the form of certificates of indebtedness.

President Roosevelt says, "It is absurd for the people to permit themselves to get in a panic." In fact, the people have been remarkably level-headed, considering the apparent panic among the financiers. The president says what everybody knows to be true, that "there is more currency in the country today than there was a month ago, when the supply was ample."

There are many people who believe that this Wall street affair was deliberately planned, but it hardly seems possible that "high financiers" would do such a thing, and there is no question but what there has been over speculation.
