**Star Lites**

IN OUR COVERAGE of Friona High School activities, I doubt that I've ever encountered a group with the intensity and dedication which was exhibited by the cast of "I Never Saw Another Butterfly," the school's area-winning one-act play.

Faculty director of the group, Joy Morton, told me that in her 20 years on the FHS faculty, she has never worked with a group which had such a strong feeling of "togetherness."

This is the state of camaraderie and dedication that every athletic coach attempts to instill in his team, but is rare, indeed, when they find it to this degree. It is something you can't necessarily teach, but must come from within the group.

Theirs was a labor of love, and as one member of the group commented, "There were no stars, yet everyone had his part and no one is forgotten..."

Unless you have been connected to a group such as this by being a parent or in some other capacity, it is difficult to realize the hours and days which go into the preparation such as these young people put into "Butterflies."

But their accomplishment, aside from the medals won and acclaim by their critics, can be measured in the growth, and the strong feeling which developed among the group. This is something no judge's decision can take away.

The tragic thing for this group is that they should have had the opportunity of doing "Butterfly" at the state UIL meet. Yours truly observed the four regional one-act play finalists, and Friona's was clearly state calibre if ever there was one.

It is unfortunate that this interscholastic event rests solely in the hands of one judge and one alone. I have felt for some time that when you get into the area of advancing plays to state, perhaps a two out of three vote would be more fair.

If a particular judge preferred comedy, or had a bias against a certain playwright, or maybe had a bias against Jews, etc., then you'd at least have two other votes to try to win.

Not to take anything away from our "Butterfly" kids, because they're winners in every respect. You did a great job for Friona and for FHS. We're proud of your accomplishments, and we'll long remember your work, and longer still your teamwork.

THE CURRENT SITUATION in the Falkland Islands is a touchy one for the United States. The confrontation between England and Argentina has put America on the spot with its various allies.

Historically, England is one of our nation's oldest allies, while the United States is tied to Argentina through the Organization of American States treaty. A move was underway early this week to more or less force our hand on this latter treaty.

Millions of people are hoping that the England-Argentina situation will not blossom into a shooting war, which would be carried on right here in our own hemisphere.

Secretary of State Alexander Haig has been laboring almost since the disturbance began, in an attempt to get the situation resolved without bloodshed. But at this point, it has become problematical as to whether or not Haig, or any other individual, can settle the issue.

Since the country of Argentina has such a small military, and compared to England, very little in the way of machinery with which to wage war, one suspects that they are being backed by the Soviet Union, which is continually trying to stir up trouble in this hemisphere.

This being the case, we can all join President Reagan in his advice to the Soviets, when he said he wished they would "Butt out" of the situation.

## Commissioners Okay Payment For Pickup

County commissioners, meeting in regular session Monday, April 12, approved payment of \$11,488.70 to Friona Ford Sales, Inc. for the pickup purchased for the County Extension Agent at a previous meeting, in which the county Ford agency submitted the lowest bid.

Payment of a bill for boarding care of five Parmer County children, in the amount of \$1,271 was approved. This amount will be re-imbursed.

County Treasurer Benna Felts' quarterly report was approved, with the added stipulation that the report be published in the county's three newspapers.

Approval was granted to pay Bickerstaff, Heath and Smiley \$54 for services through March 15 regarding the reapportionment of commissioners' precincts.

A motion was approved to pay a fee of \$25, as the county's part of the planning for the dedication of the Running Water Draw Watershed Project in September.

Approval was granted to purchase an "Information Guide to County Government" for the county attorney, at \$65.

Requests were approved to (1) help pay a county woman's prenatal aid due to circumstances involved in the case and (2) help another county citizen pay their gas and drug bill, on a one time only case.

Easement was granted on a request to cross a county road with a water line.

County agent Seth Raiston reported that he has been busy doing soil tests. He also noted that there would be a 4-H Club District Livestock Judging and rifle contest in Lubbock on April 24.

Approval was granted for soil conservation work for 20 separate individuals when county machinery is in their area, for which the county will be re-imbursed.

## Assn. Gives \$1,000 For Cemetery

The Friona Cemetery Association met April 13 and voted to donate \$1,000.00 to the City of Friona for the care and upkeep of the cemetery for 1982.

"City Manager Jerry Lewis met with the group and outlined some of the plans he has for the cemetery and we are excited about it," Roy Miller, president of the association, said.

"Our Association has assisted the city each year in the upkeep of the cemetery and also in making some improvements as the money is available. We were pleased with the response from our annual letter mailed last year, and plans are underway to mail a similar letter in the very near future for 1982," Miller said.

New directors will be chosen and these names will be listed in the letters that will be mailed.

Present members of the board of directors are Roy V. Miller, president; Russell O'Brian, vice president; Geneva Williams, secretary-treasurer; Loraine Welch, Juanita Reed, Betty Smith, Lora Mae McFarland and Leland Hutson.

"The Friona Cemetery Association invites any and all suggestions for ways to improve the cemetery. The pest control for 1982 has been started and we trust that this will be a successful project," Miller said.

The Cemetery Association has made improvements during the past years and we plan to continue this type work as the needs arise and as suggestions are made. Your full cooperation would be appreciated in this work," Miller concluded.

## Polling Sites Given For Primaries May 1

Next Saturday, May 1, is primary election day, and local election officials are doing their best to assist voters in knowing where they will cast their ballots, due to a redistricting of the county's precincts and voting precincts earlier this year.

Precinct and voting precinct boundary lines are detailed in maps presented on Page 3 of this issue.

In the Democratic Primary, the polling place for voting precinct 2 is the Friona Junior High School; for precinct 2-1 it is Friona High School, south entrance. Precinct 2-2 votes at Friona Community Center. Polls will be open from 7 a.m.-9 p.m.

Also, due to the redistricting situation, voters in the Friona area will be electing two additional precinct chairmen, and these chairmen will have to be written in.

Jay Beene, a resident of voting precinct 2-2, is the only precinct chairman candidate on the Democratic ballot. Otherwise, Danny Kendrick has indicated that he would serve if elected as chairman in Precinct 2-1 (high school box), and Fred Florez is a write-in candidate for voting precinct 2 (junior high box).

County Democratic Chairman Richard Collard, whose name is also not on the ballot, has indicated that he would serve another two-year term if elected, but his name likewise will need to be written in by voters in the Democratic primary, if they so desire to re-elect him to that office.

"We realize that the situation at the local precinct elections is bound to be confusing, due to the boundary changes, but if voters will consult the maps being published, they should have no trouble finding the right place to vote," Collard said. Larger scale maps are posted on the bulletin board at the Friona Star office, for anyone wishing to inspect them more closely.

### REPUBLICAN POLL SITE

There will be only one Republican polling place in Friona, as it now stands, and it will be for residents in voting precinct 2-1 (those represented by Ernest Anthony under the

redistricting process). The poll will be at the northwest entrance at Friona High School, on Etta Street.

Those living in voting precinct 2 or 2-2 would have to drive to Bovina or Lazbuddie in order to vote in the Republican primary.

The Friona GOP precinct will hold its precinct convention at 2 p.m. at the polling place.

Precinct conventions also are to be held election day by both parties. The Democratic party conventions will be held at the various polling places, beginning at 2 p.m.

Highlighting the Democratic Primary ballot will be the governor's race, where six candidates are seeking the nomination. The best known of the six are present attorney general Mark White, present land commissioner Bob Armstrong, and industrialist Buddy Temple.

A runoff in June appears to be virtually certain for this race.

The attorney general's race also looks to be interesting, due to the re-emergence of Max Sherman into the political arena. Jack Ogg is his principal opponent in the primary, although two other Democrats are running.

The state treasurer's race also drew four candidates, principally Lane Denton and the incumbent with the famous name, Warren G. Harding.

On the county level, two county-wide offices are contested. Benna Felts, the incumbent treasurer, is opposed by Anne Norton of Farwell.

For District Clerk, where longtime clerk Dorothy Quickel is retiring,

Cynthia Thigpen and Marjorie Watkins, both of Farwell, are the candidates.

In commissioner's precinct four, which now includes a portion of Friona (east, southeast and northeast), incumbent Raymond McGehee and a former commissioner, Raymond Treider, Jr., both of Lazbuddie, are the candidates.

In commissioner's precinct two, which also has been redrawn to include the portion of Friona north and west of Highway 60 and north Highway 214, incumbent commissioner Jack Patterson is opposed by Tommy Williams and Radford Venable, both of the Bovina area.

Other county officials, including Judge Porter Roberts, Charles Aycock, clerk Bonnie Warren, and district judge Jack Young, are unopposed.

In the Republican primary, there are only four contested races. The race drawing the most interest is that

# Friona Flashbacks

....from the files of The Friona Star

### 50 YEARS AGO--APRIL 15, 1932

Through the efforts of a few of our businessmen, Friona now has a regularly organized golf club, which organization was completed last week. The new organization now has a membership of 35, with R.R. Wills as president and Howard G. Morris, secretary, F.A. Spring, treasurer, and O.F. Lange, chairman of greens committee.

Last Saturday afternoon as Chester Sheets of the Farmers Produce Company of Friona was enroute to Lubbock with a new cargo of eggs, cream and poultry, his truck was capsized and his cargo badly scattered. The accident occurred south of Hale Center on the state highway at 3 p.m. when the truck collided with a car, coming onto the highway from a side road.

### 40 YEARS AGO--APRIL 10, 1942

J.A. Blackwell Tuesday was elected mayor of Friona in a quiet city election which saw no other change in the list of present city office holders. Blackwell defeated the present mayor F.W. Reeve, by a vote of 65 to 31. For commissioner F.A. Spring and Carl Maurer were re-elected, and Logan Symson was again chosen city clerk. Jones was re-elected as night-watchman.

Friona citizens have always been proud of their city, and home town patriotism took a jump this week in the splendid response for a 100 per cent "close up" and "all out" for the monster Army Day Parade at Amarillo, where one of our most highly esteemed citizens was one of the guests of honor. Friona's wholehearted cooperation was prompted by the honor being done to Mrs. George M. Baker, Six-Star Mother, and one of the honor guests in Amarillo.

### 35 YEARS AGO--

### 30 YEARS AGO--APRIL 10, 1952

Friona Star was one of three weekly newspapers cited for Community service at the annual meeting of the Panhandle Press Association as it met in Amarillo last Friday and Saturday. Papers

receiving recognition for service were The Canadian Record, the Paducah and the Star.

Voters of the Friona School District last Saturday made their choice for three board members, selecting C.V. Potts, George Jones and Roy Clements. Trustee at large selected was W.M. Sherley. The school election was closely followed by the interest in the straw vote for presidential choice, with General Eisenhower accorded the greatest vote, followed by Taft and MacArthur.

### 25 YEARS AGO--APRIL 11, 1957

Sale by Bert Chitwood to Rockwell Bros. Lumber Company of the lots just south of the firm in Friona was announced this week. The location was originally occupied by the Friona Locker Plant.

With the arrival of a 180-pound meeting table--the last piece of furniture ordered to go into the building--the City of Friona will have its oft-delayed open house for the new city hall Saturday. The hall, which cost the city in the neighborhood of \$36,000, will be officially presented to the public for the first time, although many citizens have already been in the building's offices, and some have toured the entire hall. The building joins the fire station at the corner of Eighth and Main.

### 20 YEARS AGO--APRIL 12, 1962

A raging fire consumed approximately two-thirds of a 16 by 100 foot barn on Eric Rushing's farm one mile west of Friona at 10:30 Friday night. Firemen arrived in time to extinguish the inferno and save part of the structure. Damage was estimated at approximately \$700 by Rushing, owner of the barn.

The April report from Friona State Bank show that deposits have increased almost one million dollars since January 1 to set a new all-time high. Total deposits at present are shown at \$6,307,398.91. Deposits on January 1 were reported as \$5,447,336.28 which allows an increase of \$860,062.53 in three months.

Ellis Tatum and Walt Mabry were

elected to the Friona School Board in the lightest voter turnout of any district in the county Saturday.

### 15 YEARS AGO--APRIL 13, 1967

An explosion of unknown causes destroyed the farm home of Mr. and Mrs. Billy Bates Tuesday, but the family was all out of the house at the time and escaped injury and possible death. The farm home belonged to Jack Moseley, and was located some nine miles southeast of Friona on land belonging to Ranza Boggess.

Hi-Plains Feed Yards, Inc., with a future capacity of 50,000 head of cattle, became a reality this week with the hiring of a manager and awarding of its construction contract. Located four and one-half miles northwest of Friona on land purchased from Bill Baxter, plans call for complete facilities for feeding, including mill, ensilage pits, feeding equipment and pens properly engineered for drainage and anti-pollution. Construction is slated to begin within two weeks and is scheduled to be in operation by the middle of September. The mill will be built and erected by Brown-McKee, Inc., Contractors and Engineers of Lubbock.

### 10 YEARS AGO--APRIL 13, 1972

The Friona Chamber of Commerce set out to coordinate a local drive for a livestock showbarn as a highlight of its monthly board meeting Tuesday morning at Earl's Parmer House Restaurant. The matter of the showbarn has been under considerable discussion since the recent Parmer County Junior Livestock Show.

Girl and Boys State delegates were named the past week by Friona American Legion and Auxiliary. Sharon Smith is the delegate to Girls State, with Darlene Harper, alternate. Gary Mingus is the delegate to Boys State with Carl Evans, alternate.

### 5 YEARS AGO--APRIL 17, 1977

Nine Friona High School students qualified for the regional meet in literary and science events. They are Mark Edelman, Jan Mason, Larry Gore, Jay Jarboe, Sheri Noah, Bryan Johnston, David Whitaker, Melodi Dixon and Linda Anthony.

# Sorghum Farmers Get Deficiency Pay

Grain sorghum farmers will receive deficiency checks of 48 cents per hundred pounds on their 1981 production. Commodity Credit Corporation will mail checks totalling approximately \$232 million. Texas sorghum producers will receive the largest share with \$71.5 million, while \$65.4 million will go to Kansas growers and \$44.8 million to Nebraska.

"USDA has informed us that the checks will be mailed on, or about, April 10," reported Elbert Harp, executive director of Grain Sorghum Producers Association (GSPA). The payment is the difference between the national average loan rate and the sorghum target price. The 48 cent payment is the maximum amount permitted by law because the average price to farmers during the first five

months of the marketing year (October 1, 1981-February 28, 1982) was below the loan level.

The payment is a result of a provision written and sponsored by GSPA in the 1977 farm bill. This provision sets sorghum target prices in relation to corn according to the relative cost of production.

Payments are determined by multiplying the rate (48¢/cwt.) by the

farm acreage by the farm yield (48' x acres x cwt. per acre). A farm with a 1981 planted acreage of 100 acres and a yield of 6000 pounds per acre, would receive \$2,880.

There will be an allocation factor of 99 per cent for those who planted more sorghum in 1981 than previous years. When the allocation factor is applied to the example above, the payment will be \$2,851.

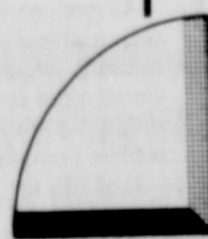

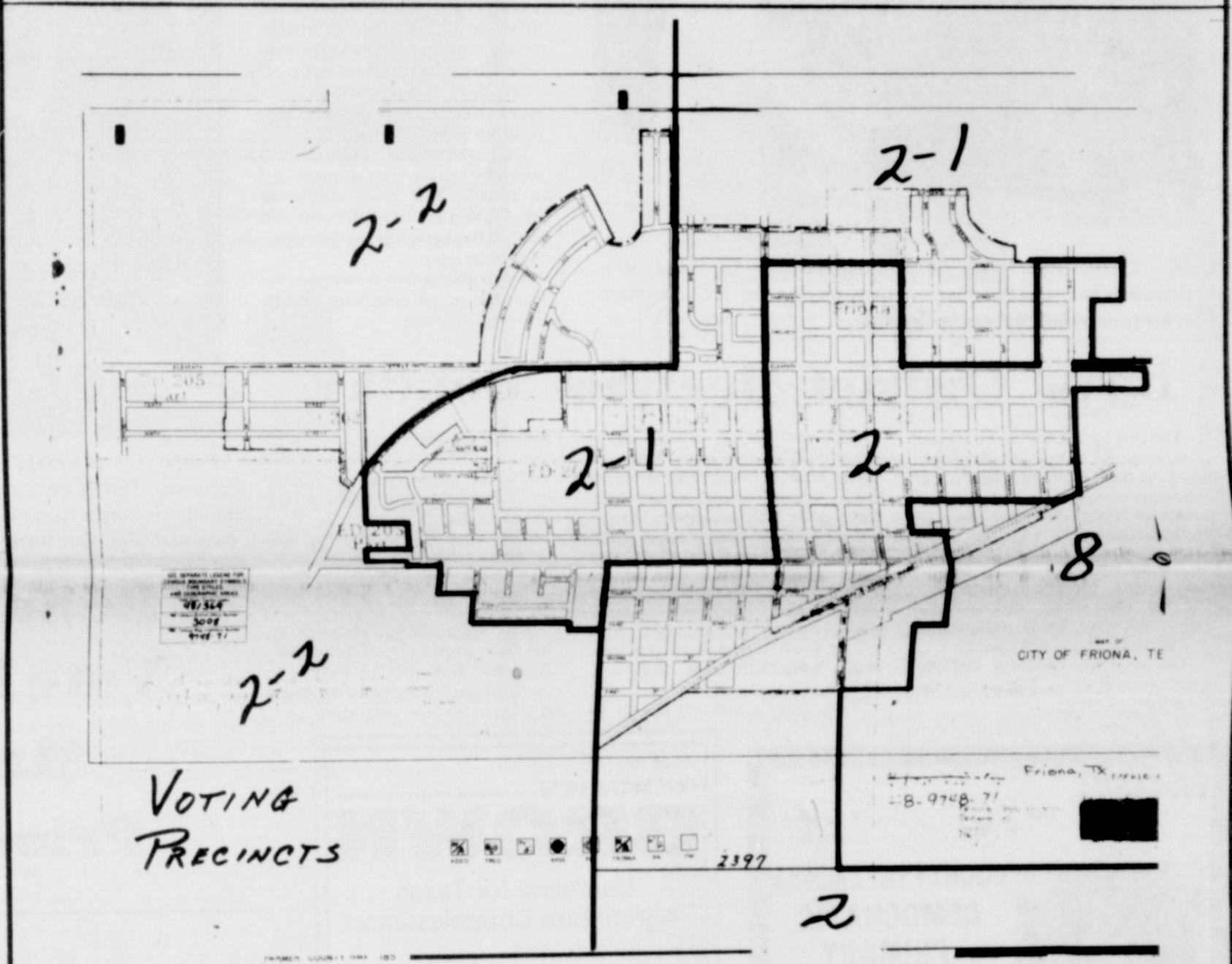

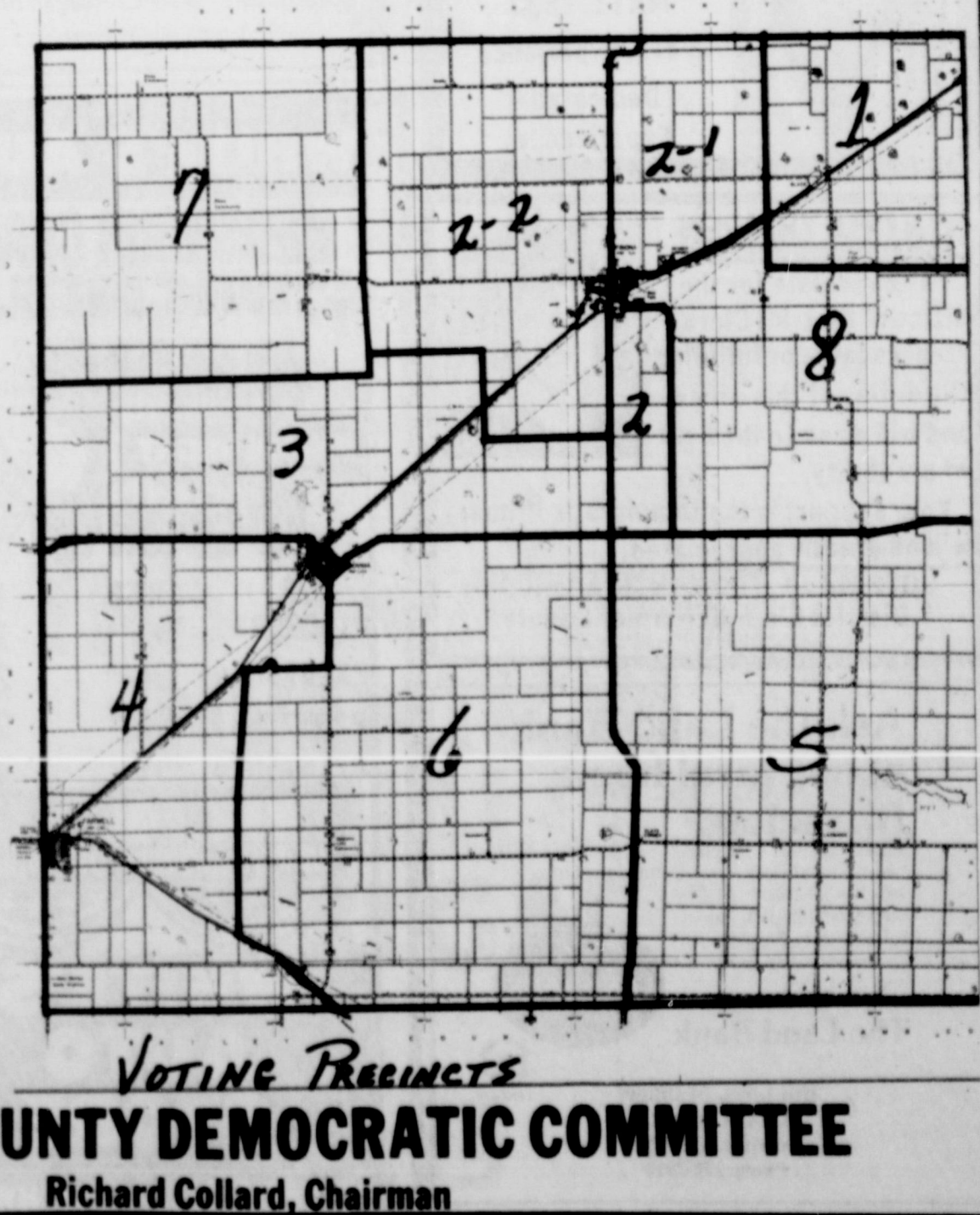

# Squaws Competing In Regional Meet

The Friona Squaws turned in some of their best marks of the season at the Regional Qualifiers' meet last Saturday at Plainview, in a tune-up for this week's regional meet.

However, the only point-winner for the Squaws in the meet, which was open to qualifiers from all

schools, regardless of classification, was Sherry O'Brian, who placed third in the 400-meter dash in 59.82. The event was almost a photo-finish among the top three girls.

Marcy Cole of Canadian won the event in the time of 59.38, and Kelly Smith of Abilene Cooper was second

Reeve Duffey also competed in the shot put.

The Squaws are competing in the Region 1-AAA track and field meet Friday and Saturday at Lubbock.

Miss Duffey will enter the shot put beginning at 11 a.m. Miss O'Brian's high jump event starts at the same time.

Running preliminaries are Friday afternoon, with the 400 meter relay running at 1:30, Shawn Osborn in the 800-meters at 2:10, Miss O'Brian in the 400 meters at 3:10, and the 1600 meter relay team running at 4:10 p.m.

Saturday finals involving the Squaws will start at 11 a.m. with Miss Johnston in the long jump.

Running finals which will hopefully feature team members are as follows: 1:40 p.m., 400 meter relay; 2:10 p.m., 800 meter run; 2:40 p.m., 400 meter dash; and 3:20 p.m., 1600 meter relay.

Those placing first or second at the regional meet will qualify for the state track and field meet.

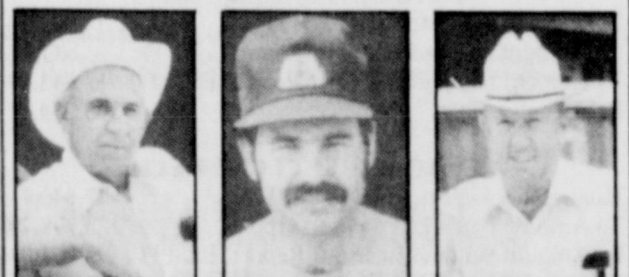

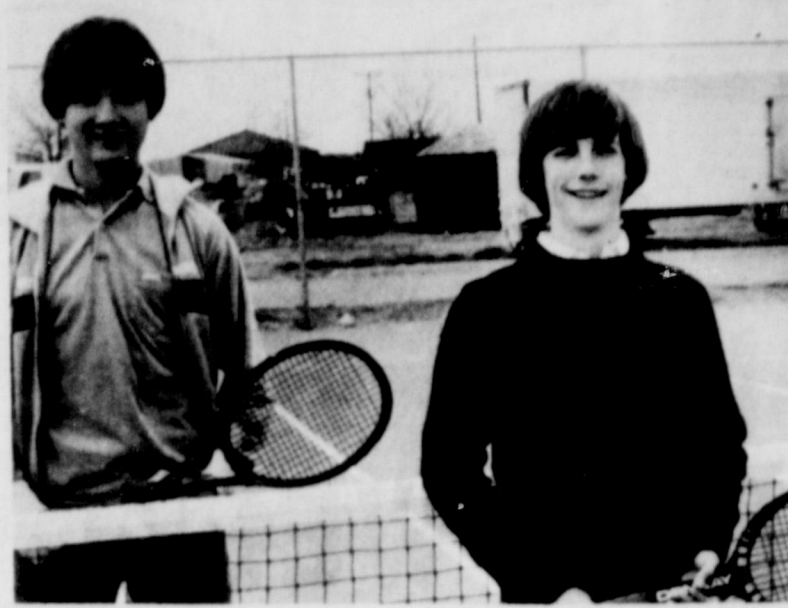

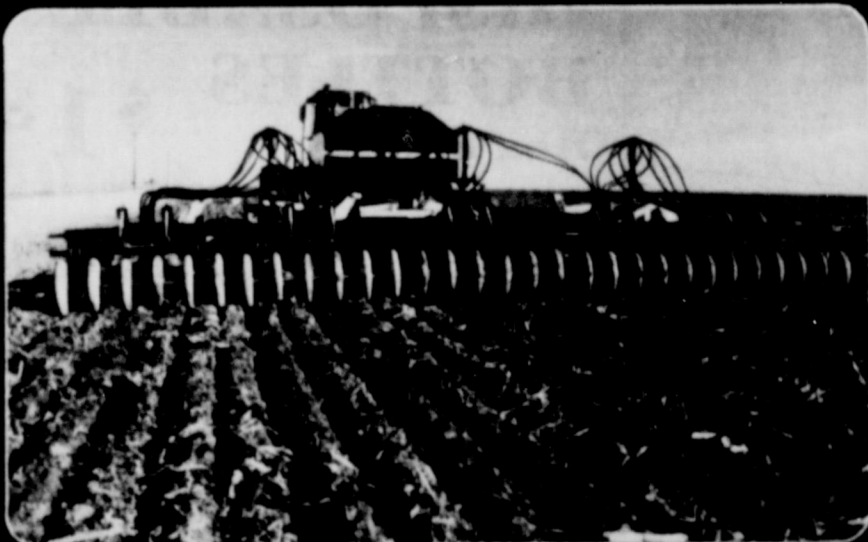

**City's Tax Receipts Lead '81**

State Comptroller Bob Bullock Friday sent checks totaling \$31.8 million to 962 cities as their share of the one-per cent city sales tax for April.

Friona's check for April amounted to \$3,315.48, compared to \$3,725.39.

However, Friona's year-to-date payments amount to \$31,975.24, which is up 28.2 per cent from the \$24,944.59 that had been received as of April 14, 1981.

"Total payments we have sent to these cities so far this year are running more than 19 per cent ahead of last year, which means sales of taxable merchandise in these cities are running that much more than 1981," Bullock said.

Houston received the biggest check, \$7 million, up 27.9 per cent from the April 1981 check.

Dallas received \$3.8 million compared to \$2.7 million last April. San Antonio received \$1.6 million, compared with \$1.2 million last April.

The City of Fort Worth got a check for \$1.1 million, up 37.9 per cent from April of last year.

Austin's check was for \$1 million, compared to \$878,000 last April and El Paso received \$809,000, up 38.1 per cent from the \$586,000 check that the city received last April.

In the fast-growing City of Bryan, where this year's total received is running 42 per cent ahead of last year's total, the city received \$149,000, compared with \$92,000 last April.

Bullock also forwarded April rebates to the state's two Metropolitan Transit Authorities. The Houston MTA received \$8 million and the San Antonio MTA got \$914,000.

The city and MTA sales taxes are collected along with the state sales tax by merchants and businesses and rebated monthly to the cities in which they are collected by the Comptroller.

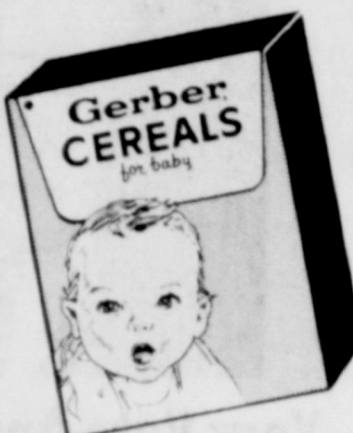

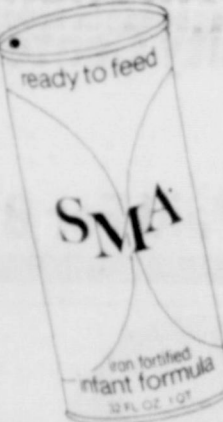

# Quadruplets Spread Blindness Message For Texas Society

The importance of early childhood vision screening is being highlighted during April, Prevent Blindness Month by the bright-eyed Tyson quadruplets of San Antonio. The message that four-year-old Kendra, Kelly, Nicholas and Aimee bring is that all children should have an eye test by the age of four.

"One child in 20 has an eye problem that can be best corrected if detected in the preschool years," says R.E. Margo, M.D., State Medical Chairman of the Texas Society to Prevent Blindness. "If the child's problem is amblyopia or 'lazy eye' it must be corrected by the age of six or the child may lose all functional sight in that eye.

"Unfortunately parents can't detect a problem just by looking at the child. Unless a child has a condition such as crossed eyes, there is seldom an external sign to indicate that an eye problem exists."

Dr. Margo explained further that a child has no way of knowing if he is seeing poorly. If a child sees a tree down the street as a green blur, he

thinks trees look like that to everyone.

"This underscores the need for an eye test," he said. "Even the simplest one can help detect vision problems such as amblyopia or refractive errors.

Many parents think that a child's vision can't be tested until the child is old enough to read the letters on the eye chart, Dr. Margo went on. That is erroneous. Doctors can readily test a baby's sight and Prevent Blindness looks forward to the day when every child's eyes will be examined by a professional at birth and during the preschool years.

"That, however, is still the impossible dream," he said, "so special eye charts have been devised for screening young children. In the Prevent Blindness and Texas school programs a 'Tumbling E' chart is used. The 'E's' are faced in four different directions on the chart and the child is asked to indicate which way the 'E's' are pointing. It's a simple test, often played as a game with the children, yet it can detect major problems. Failure to pass the

test has also led to such diagnoses as traumatic cataracts and retinal detachments.

"If a child has not had a professional eye examination or been tested in a vision screening program, Prevent Blindness and the Tyson quadruplets encourage the parent to write for the Society's free Home Eye Test for preschoolers. This test will give the parent an opportunity to play this important 'game' at home," Dr. Margo said.

Delegates get the opportunity to see government in action by visiting the state capitol.

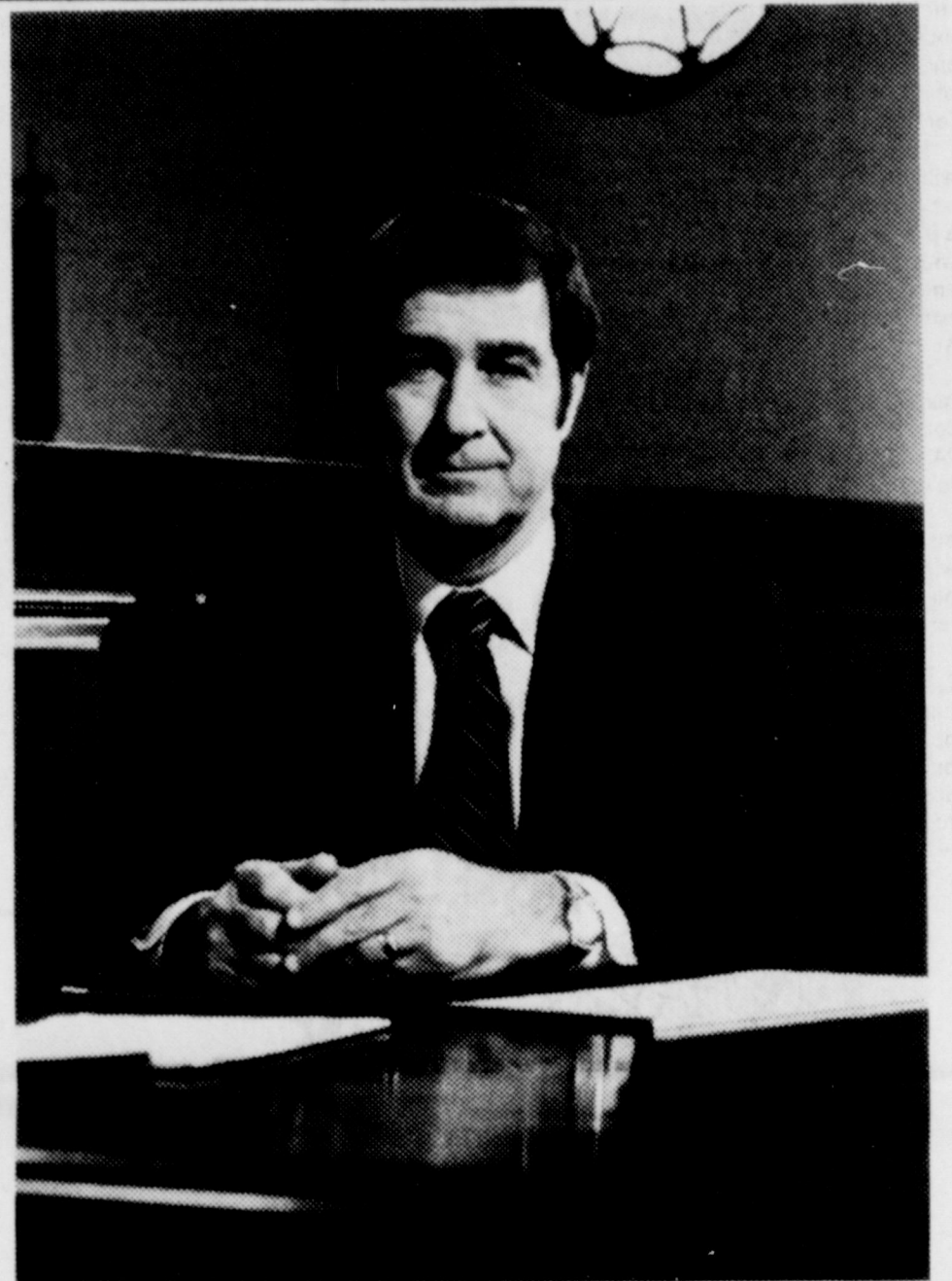

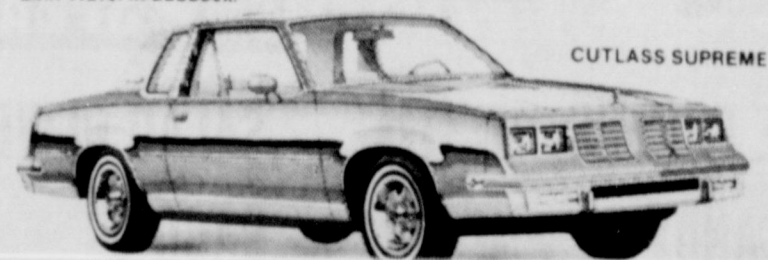

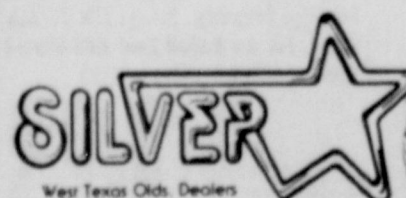

## Library Still Needs \$\$\$

With the conclusion of National Library Week this week, it is noted that work on Friona's new library is progressing as scheduled. The projected occupancy date is sometime in May.

The library building is being built through the donations of local businesses, citizens, the city of Friona, and two foundation grants. Approximately \$73,000 in funds have been raised in this manner.

It is pointed out by a library spokeswoman, however, that additional funds are needed in order to furnish the new facility.

"The \$73,000 paid for the building," she was quoted as saying, "but now we have fixtures to purchase." Of immediate need is a circulation desk, which will be located near the center of the building and which, due to the absence of an office, will double as a work center for the library.

The centrally located work area will enable the librarian to better serve library patrons. The desk will be a permanent built-in fixture designed with drawers, doors, filing cabinets and abundant storage and is estimated to cost between \$1,000-\$1,200.

Donations can be taken by or mailed to the present library. Or any contributor may call the library at 247-3200 and a volunteer will be glad to call for the donation.

"The names of all persons and businesses contributing \$500 or more will be engraved on a permanent plaque and displayed in the library," reminded the spokeswoman.

The Friona Library currently serves 2,332 registered readers and this number is expected to grow with the opening of the new facility. The new building is designed to house approximately 25,000 books, with room to expand.

# Monday Hearing To Determine Agency Fate

A hearing conducted by the Texas Railroad Commission will be held Monday, April 26 at the Hilton Inn in Amarillo. The main purpose for the hearing will be to allow Santa Fe Railroad and its Santa Fe customers an opportunity to give their opinions to the proposed closing of several freight offices across the Texas Panhandle.

Two of these offices include the ones in Bovina and Friona.

According to Susan Metcalf of Santa Fe in Amarillo, closing the offices will not provide a hardship on shippers in the area, as most of the work which is being done from the freight offices is already being done by computers in Amarillo.

Metcalf said if the proposed changes take place, the only differences in service would be that shippers would have to call Amarillo, on what will be a toll-free line, open 24-hours daily, and place their orders or take care of whatever business they have.

By using computers, the regional freight offices will be able to better handle the needs of the customers by knowing almost instantaneously where the cars are located, as well as where the trains are located.

Additionally, Metcalf said that the reason Santa Fe was interested in revamping their operations was because the job of the station agent has drastically changed from what it was 40 years ago.

"Most agents are no longer required to perform the duties they did, say 40 years ago, and if this proposed change takes place, a Santa Fe official can come out to Bovina or Friona at any time to do inspections, etc. These employees will be on call out of Amarillo at all times to assist

the customers."

Metcalf added that Santa Fe is still concerned about the quality of service that their customers receive, no matter whether their customers order one car a year or one hundred cars a year, and that this was the main reason for the proposed changes...to provide better service for all customers.

When asked if the closings would displace many Santa Fe agents, Metcalf replied that all of the agents will have an opportunity to bid on other jobs, and she said she felt no employee would have a problem finding a job with the railroad.

The main purpose of the hearing will be to allow Santa Fe to state its case, as well as allow customers of Santa Fe to voice any opposition to the proposals.

A Texas Railroad Commission examiner will be conducting the meeting, and this meeting will be run by TRC, not Santa Fe, stressed Ms. Metcalf.

In a few months a transcript of the hearing will be reviewed by the TRC examiner, and he will then make a recommendation to the TRC commissioners.

TRC will then take a few months to make a final ruling on the case.

Should TRC rule in favor of the proposed changes, then they would instruct Santa Fe that the railroad would have a set period of time in which they could operate on the new concept, so that TRC could monitor the results of the proposed changes for this period of time.

After that trial period, and should there be no changes or problems, then Santa Fe would be allowed to go ahead and dismantle the depots at the various locations.

However, none of this would take

place if Santa Fe could not prove that they could provide better service by making the changes, or if problems arise.

According to the proposal, there would be four regional freight offices in the panhandle: Plainview, Amarillo, Lubbock, and Perryton.

If this new pact is approved by the TRC, the following local stations in the Panhandle would be closed: Kress, Floydada, Hale Center, Lockney, Happy, Tulia, Canadian, Pampa, Kings Mill, Panhandle, Hereford, Friona, Bovina, Dumas, Etter, Kerrick, Stratford, Muleshoe, Sudan, Littlefield, Anton, Shallowater, Lorenzo, Ralls, Crosbyton, Brownfield, Seagraves, Levelland, Abernathy, Slaton, Snyder, Tahoka, Lamesa, Follett, Darrouzett, Booker, and Spearman.

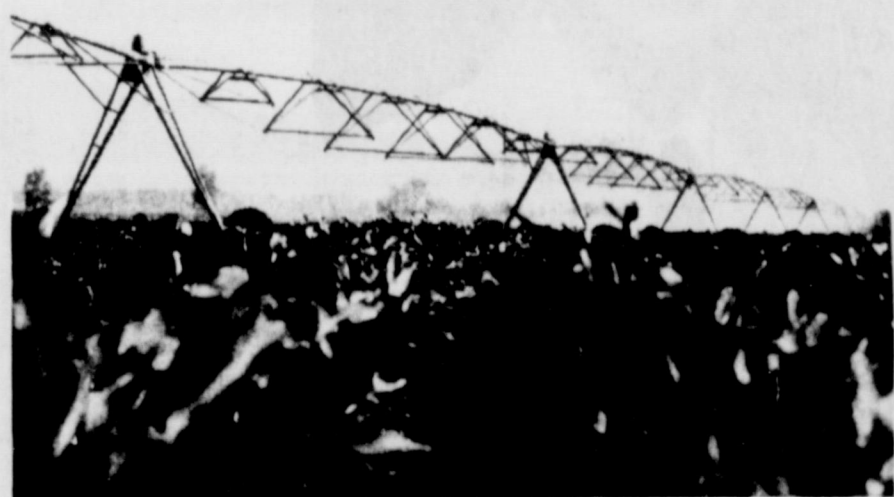
For this area, all of the accounting and train operations would be conducted from Amarillo's regional freight office, with some of the train operations possibly being conducted at Hereford, which will serve as a regional yard office.

According to Ms. Metcalf, there has been no real opposition to these proposals, as far as she knows.

"From the meetings regarding the closings that I have been to, most of the businessmen and shippers who have been concerned about how their needs would be met in the future were reassured when they found out how the new operations would work to better serve them. As far as I know, there have been no complaints lodged with the TRC."

Ms. Metcalf also pointed out that Santa Fe would not close any offices until they were absolutely sure that they could provide better service and could handle their business under the new concept.

## Living Bank To Register Donors

The First Annual Organ Donation Awareness Week will be held April 26-May 1, and is a special national project of the Texas Medical Association Auxiliary and the other state auxiliaries. Mrs. George Bush has accepted the National Honorary Chairmanship for this drive to increase awareness of the importance of the need for people to register as organ donors with The Living Bank.

The Living Bank, founded in Houston in 1968, is a non-profit service organization which coordinates the anatomical donations of donors throughout the United States. The organization is the only national donor registry. At the present time, approximately 100,000 people are registered with The Living Bank.

The purposes of The Living Bank are to (1) educate the public about the importance of organ and/or body donations; (2) register those who wish to be donors; and (3) when death occurs, refer the donations to the appropriate medical facilities closest to the place of death.

The Living Bank provides a donor registration form and a Uniform Donor Card--the only legal document needed in 50 states under the Uniform Anatomical Gift Act. The member should fully discuss his wishes to be a donor with his family since at the time of death, the medical personnel will not remove any organ for transplant without the consent of the next of kin.

The organization maintains a 24 hour telephone service, (713) 528-2971, to refer donations to medical schools, eye banks, kidney transplant facilities and other organ banks wherever the donor is throughout the United States.

There is only a limited time following the death of a donor in

which to retrieve organs: vital organs (kidneys, hearts, lungs, livers, etc.)--minutes after death. Donor must be maintained on life support system; eyes--4-6 hours; bone--8 hours; and skin--18 hours.

The most awesome medical era of all--the transplant era--continues to advance remarkably. There are many among us who are so critically ill as to be in need of an organ transplant. 1981 figures indicate that approximately 62,000 Americans are on kidney dialysis with 10,000-12,000 people waiting for transplants; 25,000 cornea transplant operations were performed in 1981 but some 50,000 people were waiting.

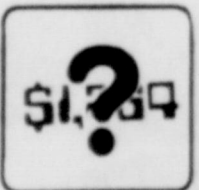

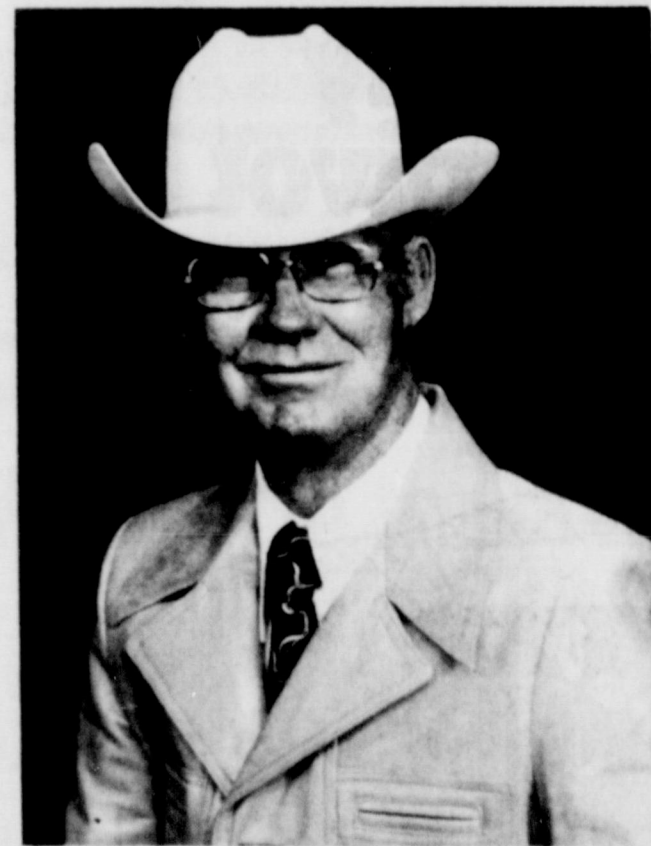

in the Civil War and later fought with the American Cavalry against the Indians of Texas and New Mexico. At the conclusion of their skirmish his regiment walked from San Antonio to New Orleans.

Ernest came to Friona from Iowa in 1908, at age 13, with his parents and twin brother. Bessie came to Friona by train in 1901. Her father and stepmother, George McLean and Ollie Whitaker, were the first couple to be married in Parmer County.

The Whitakers were pioneers in Parmer and Curry counties, having a farm and ranch southwest of the Rhea community. After Ernest and Bessie married in 1917 they moved into Friona where they raised their seven children, all of whom attended the Friona school systems.

Houlette related other pioneer experiences including the great prairie fire of 1906 and the depression days and the dust bowl days of the 1930s and 40s, and of early courtship days. The Houlettes established one of the early businesses in Friona, a full service laundry, which they opened in the early thirties, and operated until the mid-fifties. They also founded the Friona Pentecostal Church in 1939. He served as the pastor until 1958 and has since served as pastor to churches in Plainview, Littlefield, Albuquerque and Clovis.

Mr. and Mrs. Houlette are the parents of Kenneth of Dumas, Ted of El Paso, Betty Gore of Clovis, N.M., Dale of Friona, Wayne of Plainview, Jerry of Lubbock, and Pearl Hutchins (deceased).

Mr. and Mrs. Houlette currently live alone and enjoy reading, gardening, raising chickens and visiting with family and friends. In 1977, at age 83, Ernest undertook the task of paying off a church note by making and selling peanut brittle candy.

In four months time, with one volunteer to help him, he had earned more than \$3200, enough to clear the debt and pay for all the necessary supplies. Both Houlettes are still active in their church where he serves whenever the pastor needs to be away and Mrs. Houlette occasionally plays the piano.

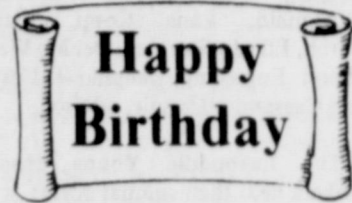

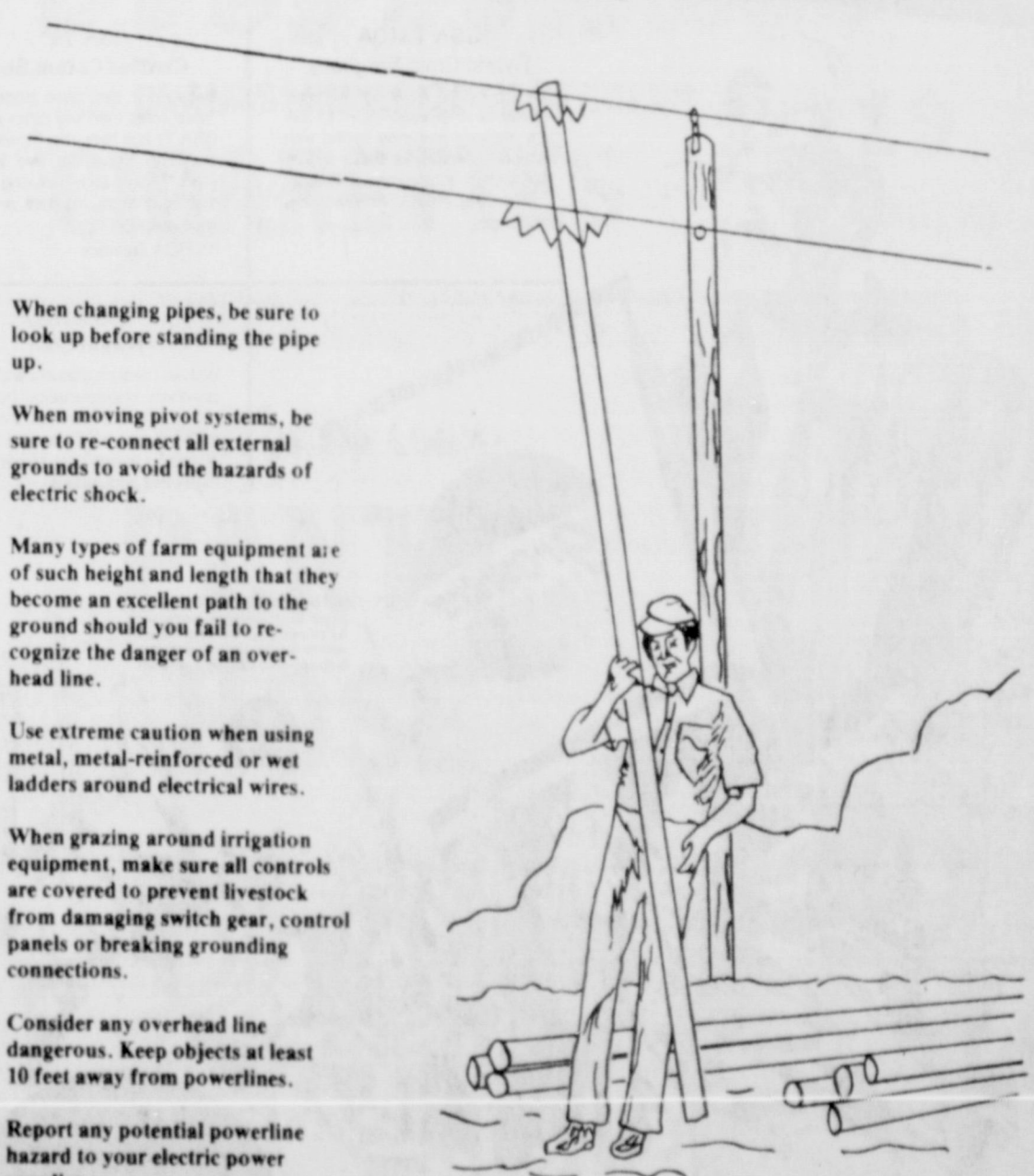

## Safety Tips From Bailey County Electric



When changing pipes, be sure to look up before standing the pipe up.

When moving pivot systems, be sure to re-connect all external grounds to avoid the hazards of electric shock.

Many types of farm equipment are of such height and length that they become an excellent path to the ground should you fail to recognize the danger of an overhead line.

Use extreme caution when using metal, metal-reinforced or wet ladders around electrical wires.

When grazing around irrigation equipment, make sure all controls are covered to prevent livestock from damaging switch gear, control panels or breaking grounding connections.

Consider any overhead line dangerous. Keep objects at least 10 feet away from powerlines.

Report any potential powerline hazard to your electric power supplier.
