Expanding United Fund Sets '66 Plans, Officers Named

Muleshoe Area United Fund will make ready for its 1966 season at two busy sessions tomorrow evening.

It will

1. Stage its annual election banquet, and
2. Discuss admission of two new agencies.

These important developments were announced by Marie White, president, who says the banquet tomorrow evening in Fellowship Hall of the First Methodist Church "is expected to be the biggest affair yet" for the young (it's only three years old) United Fund organization.

New officers are to be accepted.

As a matter of fact, two busy sessions are slated preceding the dinner. At 6:45

the members of the Budget and Admissions committee will meet in the church's game room to consider the application of the Bailey County Historical Society for Admission to the U. F. They are asking for a \$247 interim allocation. Robert Hooten, B&A chairman, will preside at this committee session.

Afterward he will present the committee's recommendation to a full meeting of the board of directors, slated for the same room at 7 p.m.

Previously given approval by the budget group was an application by the Muleshoe Area Senior Citizens Organization (MASCO) for \$900. The B&A recommendation also must be approved by the board.

Cecil Davis, president of the Bailey county society, and the Rev. J. Frank Peery, advisor to the oldsters group, have been asked to be present.

Dog Poisoning Reported, Warning Issued to Tots

Strychnine that has caused death of several dogs and serious illness in others may be a threat to the young to hunting Easter eggs today, especially in the Laneau addition.

That grim warning was sounded by Dr. Jerry Gleason,

veternarian, who said that the real danger lies in the fact that the strychnine is usually concealed inside a raw meat ball, tossed into the back yard. "I'm afraid small children will get hold of these balls and eat them," he explained.

He said that the strychnine-poisoned dogs have been found mostly in the Laneau addition, but he added that "poisoned dogs also have been found in other parts of the city."

He said several who have lost their pets recently have found

the dogs dead or in a dying condition. "If we get to them in time, usually we can save them by simply giving them a very strong anaesthesia which prevents the pet from going into convulsions and thus he sleeps the poison off."

Officials could not determine whether the poison outbreak is

Enoch Baptist Church will have a fish fry tomorrow evening, it was announced Friday. The fish are being furnished by

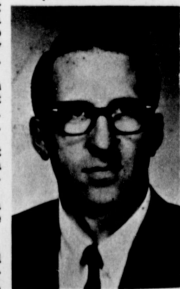

Industry-Seeking

MAIF Names Directors, Signs up New Members

MAIF (Muleshoe Area Industrial Foundation) is in orbit now, and industry-seeking for Muleshoe is already underway.

This became apparent Thursday night after the new organization named its first directors and launched well into a membership campaign to sign up members at \$100 a throw.

The directors were named at a membership meeting in the community room of the Muleshoe State Bank. Afterward, all members went to a dinner to hear Harry Clark, head of the Texas Industrial Commission, again tell the men steps necessary to take to secure industry. He had delivered a similar speech to the group two weeks earlier. Again he pointed out that a strong local organization is the "only way to secure industry in this highly competitive race for industry."

He pointed again to areas which have "slept at the switch and let other towns secure industry which they should have had." Eastland county was one of the areas thus pointed out. In the other hand, he pointed to such towns as Brownwood, Paris, Hereford and Plainview as examples of cities which had sought industry and succeeded in securing it.

Jim Casey, the temporary chairman of MAIF, presided at the Thursday night sessions, and speakers in addition to Clark included Dr. Charles Lewis, president of the chamber of commerce, and Harmon Elliott, vice-chairman of the steering committee. Elliott pointed out that the old "cotton economy which has controlled our area for so many years, is no longer sufficient, adding "the days when we could see cotton sacks and knee pads and make a living out of it, is gone; now we need new industry, new methods of making a living."

MAIF is being set up to promote industry for this area. In literature given the members and prospects at Thursday night's session, MAIF was pointed to as "a corporation formed to undertake and finance a program to aid the city of

Muleshoe and the Muleshoe area to grow and diversify through economic development."

It proposed to get the job

More Registration Periods Are Sought

AUSTIN—Federal authorities think Texans should get two more chances to register for voting in this year's elections. Department of Justice motion before a three-judge U. S. court requests supplemental registration periods of April 8-19 for primaries; and August 22-October 8 for the November general election.

Justice Department attorneys consider the March 3-17 registration period "inadequate." Although federal attorneys commended Texas officials for "diligence and good faith" in meeting their responsibilities under the initial free registration, they made these complaints:

Forty-four per cent of Texas counties opened no substations for registration outside courthouses; 67 per cent of county registration offices did not remain open at night; and 47 per cent of counties added no deputy registrars.

Most of the 635,600 voters who registered last month, the Justice Department calculated, signed up during the second week of the March 3-17 period. Many more would have signed up in another week, the motion contended.

Although there are now 2,975,000 Texans registered (or 56 per cent of total potentially eligible adults), about 2,000,000 more remain unregistered, the Justice Department said.

"Frivolous harassment" or an attempt by the federal agency to destroy all state authority over voting procedures, said Gov. John Connally.

"A deliberate, shocking attempt to abuse Texas," charged Atty. Gen. Waggoner Carr. He plans to challenge the right of the Justice Department to delve into such details of election operation as registration dates.

Road Beauty Bill Hit—Outdoor advertisers, motel owners, tourist attraction operators and salvage dealers at a public hearing here vigorously attacked standards for implementing new federal legislation aimed at beautifying highways by policing billboards and junkyards.

In two days of testimony before Paul E. Warren, U. S. Bureau of Public Roads Examiner, 61 witnesses hammered at the detailed standards, although many said they supported the original intent of the bill.

Most said the regulations proposed by the U. S. Department of Commerce would destroy or seriously damage their businesses.

In addition to witnesses' testimony, the examiner received 84 written statements.

Final regulations will not be adopted until hearings have been concluded in all 50 states and Puerto Rico.

Courts Speak—State Supreme Court will review on May 4 a suit to force reappointment of Midland County commissioner's precincts to require substantially equal population in each. A district court ordered the reappointment, but El Paso Court of Civil Appeals reversed the decision.

Supreme Court refused for second time to hear an appeal from a judgment against the S. W. Richardson estate for failure to pay state, county and school property taxes on 32,750-acre St. Joseph Island in 1960 and 1961.

Austin District Court temporarily enjoined operations of Marketmakers Inc. of Beverly Hills, Calif., three Texas-organized corporations and eight individuals. Attorney General Carr has described the operations as a "pyramid club scheme" (similar to old chain letter clubs) which has defrauded hundreds.

Texas Grows—Texas is 13,700,000 acres, but only 2,975,000 are under cultivation. A study of Texas' area in 20 years was completed by Land Commissioner Jerry Sadler. Report shows the state contains 177,052,700 acres, or 276,600 square miles.

However, Alaska's 571,065 square miles and about 40 million Texans live in the second largest state in the Union.

Brucellosis—Texas Animal Health Commission reports 11 more counties are testing for brucellosis in the drive to eradicate brucellosis among Texas cattle.

Atascosa, Brooks, Coryell, Falls, Hamilton, Hood, Jack, Limestone, McLennan, Milam and Roberts Counties are the latest to test. No counties qualified in February, but four—Comanche, Moore, Sherman and Deaf Smith—did qualify for retesting.

U. S. Department of Agriculture and the Texas Commission list 55,676 cattle back-tagged in markets during the month. There were 12,997 tagged cattle originating in Texas at slaughter and 16,326 cattle tested at markets for return to county with 258 brucellosis reactors discovered.

Business Activity Up—Texas business activity index resumed an upward trend in February after three months of "approximate stability," U.S. Bureau of Business Research reports.

Hand-in-hand with business gains, non-farm employment soared to new heights with South and West Texas out in front. Overall, the state showed the smallest jobless percentage for February in 14 years—3.6 per cent.

Construction industry scored a big 16 per cent increase in February over January. Total construction for the first two months of 1966 was 24 per cent above the same period in 1965, a record year.

Major cities showing sharpest growth rates were Dallas, Beaumont, San Angelo and Amarillo.

Oil Discovery Period Extended—Onshore oil discovery allowable period has been extended from 18 to 24 months by order of State Railroad Commission.

Commission will hear proposals to increase the number of onshore wells which are given discovery allowable status. Limit now is five wells in any one reservoir.

A commission spokesman said the agency is trying to encourage exploratory drilling to increase oil and gas reserves.

In Washington, Attorney General Carr told Federal Power Commission that a proposal to import Canadian natural gas to U. S. would create unfair competition with Texas gas, particularly in the state's Permian Basin area.

State Aid Received—Federal grants totaling 2,476,728 to assist 9,244 Texas college

students at 70 institutions have been approved by U. S. Office of Education.

Grants are part of the work-study program under which Federal funds provide 90 percent of payrolls for student jobs, with local colleges and agencies providing 10 percent.

(continued from page 1) a malicious attempt to destroy dogs, being put on by a dog hater, or whether it is accidental.

Dr. Gleason pointed out that strychnine is used in "old fashioned" rat poison treatments, and that it is possible some of the dogs which have been poisoned may have got hold of such rat poison. However, Dr. Gleason pointed out, "it is seldom used as a rat poison these days, since it is too dangerous. Besides, there are other rat poisons that are more effective."

He recommended that parents be careful to see that children hunting Easter eggs do not wander into territories "where some crank could have tossed poison."

At last report the police department told the Journal there are eight known dog deaths due to poisoning in the Leneau addition and they advise that any Easter eggs that might come in contact with the poisonous meat could possibly cause death to children coming in contact with them.

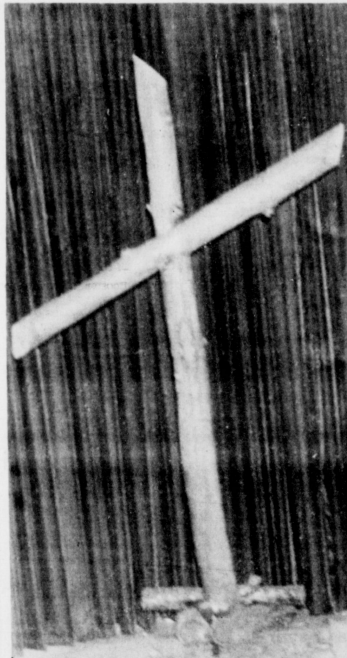

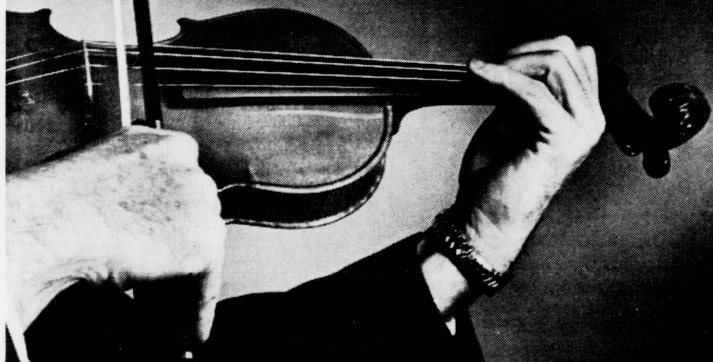

To develop between education and the general public such united efforts as will secure for every child the highest advantages in physical, mental, social, and spiritual education.

The Value Of Good Reading

It is a pleasure to support any effort toward creating a more wholesome climate and providing better educational advantages for the children of our community. And, as requested, I am happy to present my views regarding the widespread circulation of undesirable reading material.

This problem is one of serious concern and it has apparently reached epidemic proportions in certain areas. It is difficult to legislate against it without infringing upon sacred rights, and hurting innocent people. It is therefore hard to fight. Perhaps arousing a public awareness of its seriousness is the better approach at this time. If parents, educators, merchants and children can be properly impressed with the importance of providing good reading matter, and of discouraging the use of obscene literature, then we may correct the situation ourselves. After all, I believe it was Abraham Lincoln that said "He who can mould public opinion yields more power than they who make laws."

Plato said "There is nothing great in the world except man, and there is nothing great in man except mind." Shakespeare said "It is the mind that makes the body rich." The gifted and talented Earl Prevette said that "Man is a mind with a body," and St. Paul said "With the mind I serve the law of God."

Every invention, every achievement, all advancement, each step of progress and learning that man has ever accomplished had its origin in the mind, and through the working processes of the mind, was brought into reality. Thus happens im-

possible to over emphasize the importance of the mind.

In this connection Napoleon Hill in his great book THINK AND GROW RICH says "thoughts are 'things' and that thoughts have a tendency to clothe themselves in their physical or spiritual equivalent. It has also been said that man is the sum total of his thoughts, and Solomon said "As he thinketh in his heart so is he."

Now if these statements be true, and they are, then Earl Nightingale, one of America's most talented and successful men, was right when he said "Men become what they think about. If men become what they think about, then children too will become what they think about. It is therefore extremely important to see that they are given good things to think about. A great lot of what people think about is placed in their minds through reading. If they read good material they will think good things and will become good, or, if they read bad material they will think bad things and will have a tendency to be bad. It is their simple.

I would encourage everyone to read, especially our children, but I would encourage them to read good books and not waste their eye sight and time on low quality material. The great and successful people of the world are, and always have been, almost without exception, men and women who read a lot. In fact Napoleon Bonaparte once said "Show me a family of readers, and I will show you a family that rules the world."

And now from HOW TO TURN YOUR ABILITY INTO CASH by Earl Privette, I copy as follows:

"Good books are the brick and mortar that hold civilization together. They keep alive the past and they also enlighten the present. Therefore, by reading you come in contact with the great minds of the past and of the present. You learn to comprehend Shakespeare, to reason with Plato, to meditate with Emerson, to observe with Burroughs, to weigh and to concentrate with Bacon, to think with Socrates, to share Lincoln's compassion, to feel the stir and the drama of Churchill, and generally to profit spiritually from minds deeper and broader than your own.

thought, inspires meditation, engenders reflection, aids deliberation, and gives you greater power to concentrate on the job. It increases your understanding, gives you an insight into the thinking of others. It helps you to form a pattern of thought and will help you to influence and motivate others to think and act. It helps you to analyze and visualize. You learn to think around, and through, things. It opens up new vistas, ripens judgment, stabilizes thought, and teaches you to be tolerant and considerate of others. It helps you to grow and expand."

Conversely reading low quality or obscene literature can do nothing other than poison and debase the mind. Especially is this true with children. It brings them in contact with depraved minds and evils of every description. It places bad things in their minds that eventually becomes a part of them, and it moulds their character the wrong way. It just can not be good for anyone, especially children, to read of extreme human ungodliness, and moral infidelity.

It is known that many crimes and sex offenses can be directly attributed to the reading of such literature. And no doubt there are many, many more that may be indirectly or subconsciously attributed to the same thing. That type reading should be discouraged, and the minds of our children directed into better things.

I know the merchants of our community and the are good Christian minded people. They are no doubt as interested in the proper training of young people as any of us. They would not intentionally hurt children for the profit that might be made on a few books. So I am sure their cooperation can be depended on.

As pointed out before, this matter is hard to control by legislation. But by coordinated effort on the part of all of us I feel we can control it in our area. And thus we will solve our own problems. To that end I pledge my support and cooperation.
