**Dove Census Points To Good Season**

Austin — Preliminary observations of mourning dove census reports presage another good shoot in Texas this year, according to the Assistant Director of Wildlife Restoration for the Game and Fish Commission.

He said the data was obtained through 65 census lines established throughout Texas and that the analysis shortly will be available from the United States Fish and Wildlife Service which has final authority on hunting of doves since they are migratory birds.

Field reports likewise will be studied by the Commission at its July 13 meeting in Austin, when recommendations for most major harvest regulations will be made.

The Assistant Director said that while population estimates are favorable, the final statistics might not permit the extra five days allowed last fall when Texas had an extraordinary mourning dove hunt.

Ordinarily, a forty-day season is allowed, with the state divided into a north and south zone. The shooting period for years has begun on September 1 in the north zone which comprises about three-fourths of the state.

Population of the mourning dove in Terrell County is equally as large as last year since the birds wintered in the protection of the headers of deep canyons prevalent over the entire area. The short cold season also caused the birds to mate sooner than ordinarily and a bumper crop of birds is expected for local nimrods.

**HEAT WAVE NOT YET BROKEN**

The heat wave which has scorched Texans farm and ranch lands for the past several months continues with no relief in sight.

Mercury has hit record heights at official recording stations to add to the dilemma of agricultural men who are daily and continually searching the skies for wet weather and cool shady clouds.

Nights have been relatively cool in Terrell County but there has been no relief from the heat of a scorching sun during the day.

The continuing drought over Texas has dampened the belief of correctness of weather men and weather maps which have strongly indicated showers and moisture for this area several times during recent weeks when no clouds were evident in the Terrell County area.

**ABSENTEE VOTERS CAST 111 BALLOTS BY NOON TUESDAY**

Absentee balloting was extremely heavy in Terrell County up to Tuesday of this week when 111 ballots had been cast.

According to County Clerk Kuel Adams, the absentee balloting was heavier than for many years.

Most of the absentee ballots result from those planning vacations later in the summer and by employees of the railroad company who are on the road and do not know if they will be in town on July 28, the date for the Democratic primary.

**Humble Products To Be Sold Soon In Local Station**

Humble gas and oil products will be sold in Sanderson soon at the James Word Service Station. The station now sells Texas Co. products.

Plans are being made to terminate preliminary work necessary for the change-over by the middle of next week, James Word, operator, stated.

Current work in process is the burial of two storage tanks for gasoline which will increase the storage capacity to 13,000 gallons. Plans also include the erection of signs, and painting the station in the Humble colors of dark brown and green trim.

Further announcements of the progress of work will be made later.

**New Type Tax To Be Paid By Some Businesses**

Business firms subject to the new floor stocks tax on products included in the recently passed Highway Act may now obtain copies of Form 2265 from the district office of Internal Revenue at Austin. District Director R. L. Phinney said this week. Returns, with payments, are due by October 15.

Floor stocks taxes will have to be paid on inventories in the hands of dealers (defined to include a wholesaler, jobber, distributor, or retailer) on July 1, 1956, the start-in date of the new or increased taxes under the bill. These taxes will fall on the following kinds of inventories:

(1) Trucks, truck trailers, buses, etc., held for sale by a dealer on July 1. The dealer will have to pay the tax either on the price he paid or on the price for which the article was sold by the manufacturer, producer or importer.

(2) Tires of the type used on highway vehicles and held for sale by dealers on July 1. The floor stocks tax would also apply to such tires installed or held for installation on such date by manufacturers, producers, or importers of highway vehicles.

(3) Tread rubber held by any person, other than the manufacturer, producer or importer, for sale or use in the recapping or re-treading of tires of the type used on highway vehicles on July 1.

(4) Gasoline held for sale on July 1 by a dealer (but not retail stocks of gasoline held in tanks at the place where they are intended to be sold at retail through pumps directly to the consumer, nor gasoline held by a producer or importer.)

The floor stocks tax rates would be equal to the difference between the present rate and the new July 1 rate. The new tax on tread rubber is three cents a pound.

An instruction sheet accompanies the new form. It further explains and defines inclusions and exemptions in the products listed as taxable on the form itself.

Continuing taxes called for under the Highway Act will be paid as part of regular quarterly excise tax returns. A 16-year road-building program to cost about \$5 billion dollars will be financed by the taxes set forth in the new act.

## State Capitol NEWS

Austin — Reunions. Rodeos. Fishing trips. From now until school starts, vacationing Texans will take to the highways by the thousands.

They are likely to find the roads more crowded than at any time in the state's history.

From year to year, total traffic volume has climbed steadily. Highway Department surveys indicate. In addition, vacation time brings a steep jump.

August especially is a headache for the Department of Public Safety. Accident rates climb sharply. During the past 5 years August accident rates have been from 3 to 27 per cent higher than in July.

"People try to over-drive on a long vacation trip," says Asst. Chief C. G. Connor of the Texas Highway Patrol. "Fatigue is a particular problem. Speed is another."

They can't do much about people who drive when they're too tired, Connor admits. But something can and has been done about speed.

"Installation of radar detection devices has had a tremendous impact on driving practices," said

Connor. Studies made before and after radar use was begun on state and federal highways in November of 1954 show: (1) excessive speeding dropped from 21 to 15 per cent, (2) accidents dropped 3.4 per cent and (3) deaths dropped 1.9 per cent.

During the same period accidents on the non-radar-patrolled stretches — farm to market roads and city streets, etc. — climbed 13 per cent. A similar increase could have been expected on state and federal highways, Connor believes, especially since total mileage increased also — nearly 5 per cent.

Had normal trends continued, 181 more lives would have been lost in 1955.

**Operation Alert Scheduled**  
 Would Texans know what to do if atomic bombs fell? To find out a full-scale drill will be held on July 20.

Five key areas, Houston, El Paso, Austin, Waco and the Fort Worth-Dallas area — will be assumed hit by bombs between 11 a. m. and 1:30 p. m. that day.

Smaller, towns and rural areas also will participate in Operation Alert. Many have been designated as reception centers for evacuees from cities.

State Civil Defense and Disaster Relief Headquarters in Austin has asked all mayors, county judges and other local civil defense officials to cooperate.

Strategic industrial centers such as Beaumont-Port Arthur, will practice vacating plants and schools. Military bases will test their full-scale emergency measures.

Purpose of the drill is to show up any flaws in the plan whereby federal, state and local officials and trained volunteers would cooperate to cope with a major catastrophe.

Nationally, Operation Alert will presume 32 cities bombed. FCC has ordered all radio and TV stations off the air at 3:10 p. m. on July 20. Special civil defense frequencies, 640 and 1240 will be used for test broadcast of disaster instructions.

Physical Ed Teachers Reassured  
 Physical education teachers

won't be out of jobs if proposed law high school graduation requirements are adopted.

Commissioner of Education J. W. Edgar clarified the plan for alarmed teachers. Physical education and health courses still are required by state law, he said.

A State Board of Education Study Committee recommended they no longer be counted among the 16 units required for graduation. Committee suggestions were part of an overall effort to strengthen high school curricula academically, especially in scientific studies.

**Vaccine for Adults Seen Soon**  
 Texans over 20 may be able to get polio vaccinations within "a month or two".

But, said State Health Department officials, his is still "purely speculative." Actual timing will depend on when the vaccine supply exceeds that needed for youngsters and expectant mothers.

In Texas, polio takes its heaviest toll among tots under four years old. They have 51.2 per cent of all cases, 69.1 per cent of paralytic cases.

Persons over 20 account for only 17 per cent of total incidence, 6.8 of paralytic cases.

Forty-one cases were reported in the state last week, bringing the '56 total to 440.

**Worse and More Of It**  
 More and more Texans have less and less water. In its monthly report, the State Water Board listed these gloomy details:

Texas reservoirs were down 17 per cent, and observation wells and springs at all-time lows.

Storage in Trinity River Basin lakes was at 27 per cent of capacity; in Red River lakes, 55 per cent; in Lake Texoma, 51 per cent.

Famous Comal Springs near New Braunfels ceased to flow for the first time in history.

Ground water levels, below average in almost all areas, hit record lows in four areas.

No general area of the state could claim normal rainfall. State wide precipitation was 46 per cent of normal.

**Short Shorts**  
 Texans had approximately 7 million acres of cotton under cultivation as of July 1, reported the U. S. Dept. of Agriculture. This was one per cent less than 1955, 20 per cent less than the 10-year average.

Though the primary election is not until July 28, thousands of Texans already have had their say on who goes into office next year. Absentee balloting began on July 9, continues through July 24.

Texas will get a 22 per cent increase this year in funds for its public school lunch program, announced the U. S. Department of Agriculture.

The state acted to make Duval and Jim Wells Counties safer for voters on election. Three Rangers were stationed at Alice after boss George Parr stormed into the Duval County courthouse, armed with a rifle, in search of his political foe Tom Molha. He was disarmed and faces a misdemeanor charge.

"How do you like being in a picture with a kid star?" they asked pointedly. The reference was to little Tim Hovey, who co-stars with Chandler and Laraine Day in "Toy Tiger".

It's part of the folklore of Hollywood that adult stars hate to be in pictures in which children have prominent roles and also that child actors steal every scene in which they appear.

As to the first, Jeff informed all his questioners that he eagerly sought the role in "Toy Tiger" and that he had become very fond of little Tim, both personally and professionally. As a matter of fact, this liking was very evident, for Jeff spent most of his time between scenes chatting and playing with the youngster.

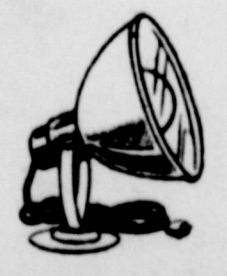

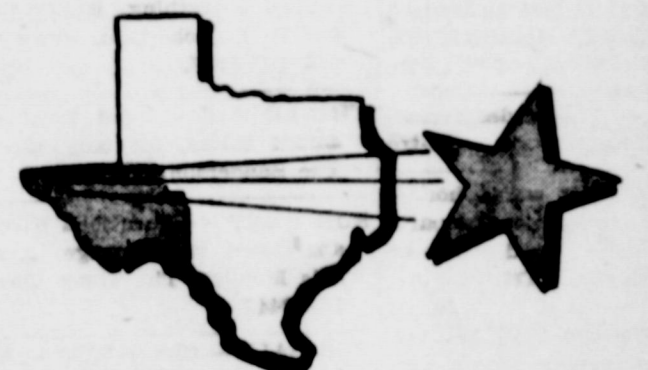
