Varied reports come as to the predictions for more rain during the rest of the summer. We are going to go along with those that say that there will be more than normal rainfall.

According to information we have, the use of the Terrell County Public Library has been good this summer and those who have worked so hard in getting the facility going are gratified with the results.

The library is a busy information center where persons of all ages can seek knowledge. A library makes it possible for all of us to share the experiences of others by reading their thoughts and achievements. It is a place where the knowledge of the past can meet the needs of the present. Your library is a vehicle to adventure, education, peace of mind, information, and knowledge of all kinds.

The use of the library by the young people has been a boon for them in giving them a worthwhile occupation this summer and can be a big assist for adults this winter to help fill a gap in activity.

We are very happy to publish the letter below, written on 23 July.

"Dear Mr. Gilbreath, I don't know if you remember me or not, I am the son of Mrs. Iva Lee Rogers from Dryden. I was sent to Viet-Nam to serve my country last November. I was in the 5th Mechanized Infantry of the 25th Infantry Division for six months, and now since I have been wounded three times, I have been pulled off the line, and am serving with the 2nd Brigade Headquarters Aviation. My job here now is flying door gunner on a helicopter. The job of this helicopter and its men is to fly recon missions. It is a very exciting duty. "My main reason for writing to you is to thank you very much for The Sanderson Times, which I receive once a week. It really does me good to pick up this paper and see how my county and little city is really progressing. Although I do wish you all could get some of this rain we get over here. We get not less than 97 inches of rain a year here. More rain than I have ever seen.

"Over here we hear of all the racial violence they are having back in the United States. It really makes us sick. What really makes us feel bad are these anti-Viet-Nam demonstrations. We sometimes wonder what we are fighting for. This war is a hard war to understand but even harder to understand is the way people act in a free nation like ours. I think they would thank God they are alive if they would have to go through with what we have been through over here. After you have seen your buddies lying there suffering and dying you know you must finish what he had been fighting for - Freedom. It's a beautiful word, if continued to back page

## Ellenburger Gas Is Found In Mitchell Well

An Ellenburger gas discovery was indicated in Terrell County with the flowing of gas at the maximum rate of 6.7 million cubic feet daily at Pan American Petroleum Corp. No. 1 Keith Mitchell, in 7-1-CCSD&RGNG, unidentified prospect, 22 miles northwest of Sanderson and 1 1/4 miles southeast of the one-well Little Canyon (10,000-foot Strawn gas) field and 12 miles west-northwest of Ellenburger production in the Brown-Bassett multipay field.

On the six-hour test at 17,410-850 feet, the nitrogen blanket bled back in 45 minutes and fluid surfaced in 48 minutes and gas in 52 minutes, flowing at the rate of 5 million cubic feet daily on a 24-64-inch choke. Tubing pressure was 1,500 pounds.

Changed to a 32-64-inch choke, it flowed at the rate of 6.7 cubic feet daily with tubing pressure of 1,500 pounds. Recovery was 510 feet of fresh water blanket.

Flowing pressure was 5,799-4,277 pounds; one hour in shut-in pressure was 7,895 pounds; and one-hour final shut-in pressure, 7,360 pounds.

Drilling continued below 18,035 feet on an 18,500-foot contract.

Production was indicated in an unidentified zone with the flowing of gas for 16 hours at the rate of 2.7 million cubic feet daily when drilling reached 9,365 feet.

The Little Canyon opener, Mobil Oil Co. No. 1 George K. Mitchell, was finished Dec. 3, 1963, for a calculated, absolute open flow of 3.1 million cubic feet of gas daily through perforations at 10,106 to 11,670 feet. Official potential was filed Sept. 22, 1966.

## NEW BORDER PATROL S. I. COMES FROM EL PASO

Albert Pagitt arrived in Sanderson last Friday to assume his duties as senior inspector of the local Border Patrol officers, coming here from El Paso. There are now five patrolmen in Sanderson. He has been in the immigration service for eleven years.

Mr. Pagitt has a wife, a six-year-old daughter and a year-old son. The family is residing in the Sudduth rent house vacated by the Binegar family when he was transferred to Fort Stockton.

## FORMER GAME WARDEN LOSES LEG IN ACCIDENT

Word was received by friends here that Woody Smith, a former warden here with the Parks & Wildlife Service who went into the Border Patrol, lost a leg in a freak accident recently.

The report is that he and his partner were checking a car in the lower Rio Grande Valley where he is stationed. He and some of the occupants of the car were between the cars and Smith saw another car approaching and shoved the others from between the parked cars. His leg was caught between the two cars and crushed.

He is reported to be hospitalized in Harlingen.

Deputy Sheriff Dalton Hogg stated that he followed Lopez in a red pick-up for several miles in an effort to stop him, but was unable to because of the erratic driving. Hogg stated that he was going from side to side and about 80 miles an hour through the cuts and on the curves between Sanderson and the Dryden flat and he made several efforts to get Lopez to pull over, but evidently Lopez did not hear or see the deputy's car.

The pick-up finally went off the road and into a ravine, throwing Lopez out and wrecking the pickup. Hogg sent word in for the ambulance and helped to get Lopez out of the ravine and to a Fort Stockton hospital for treatment.

Hogg reported that several travelers who had been scared off the highway or forced off scene of the accident to give their names and addresses for future reference, if needed.

## Appaloosa Show Draws Contestants From Over State

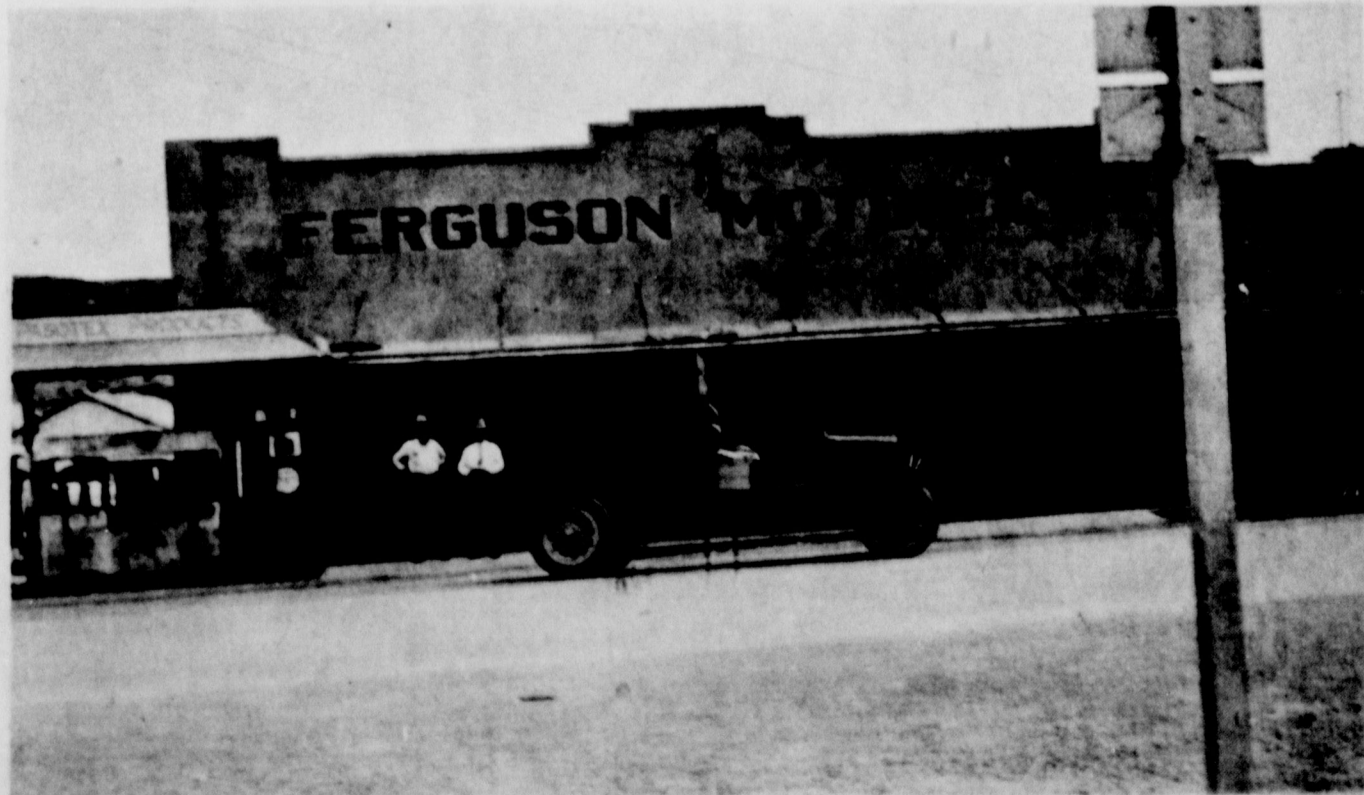

Dear Mr. & Mrs. Sanderson:

Last Friday I purchased all the shares of stock held by Mr. Goldwire and as of right now the undersigned is 100% owner of the Terrell County TV Cable, Inc. Some other parties have indicated an interest in buying into the company and this will probably happen, but henceforth I will remain the majority stockholder.

As a result of this new management arrangement Terrell County TV Cable will be providing even more and better service than ever before.

One subject I am often asked about concerns the fact that there are two cable systems operating here. Since it is rare to find two CATV companies competing with each other, many times I am asked by people here what my feelings are.

ALL MY LIFE I HAVE HELD A FIRM CONVICTION THAT COMPETITION IS GOOD FOR EVERYBODY.

Some people think such a philosophy doesn't make sense. But for myself personally I really do believe that maximum good results from clean business competition. It does make a man have to work harder, but who's to say that hard work is bad. Just look at what competition has done for the TV situation here in Sanderson. Before Terrell County Cable came along all there was available here was one good channel and that part time. Now look! Three network stations available from either of two systems and everything maintained to much higher standards than were even thought of during the previous eight years. Starting from the day I first learned that this stock transaction was going to take place, I have been searching for ways to bring in additional service. One bright prospect concerns the fact that there is a micro-wave company now building network of relay stations to bring the El Paso and Juarez stations to the Pecos, Odessa, Midland area.

As some of you may have heard, I am now General Manager of the Ft. Stockton Cable Company which is being rebuilt and expanded. The developments of bringing additional TV into the Pecos area is being eyed very closely because the Ft. Stockton system has every intention of obtaining these additional stations for itself, just as soon as possible after Pecos.

What this company wants to do is use this isolated community to conduct tests of the impact of their film products. Therefore, they will furnish most of the equipment and films virtually gratis. The films they are intending to provide will be full length feature movies actually made in either Mexico or Argentina. It will be Terrell County's part of the bargain to furnish the use of its wires AND a minimum of 300 homes on the cable.

This is the only possible catch in the deal. We are actually 30 short of the minimum they require to qualify. But, I have high hopes that we can get 30 more hook-ups right away. They are not attaching any qualifications --just 30 more homes.

What this means is that if you should like to help out but are presently using the other signal service--alright! Just ask for a free demonstration on Terrell Cable anyway. The president of this Hollywood film distributing company explained that one of the things they wanted to test was whether or not people will tune out the regular TV fare to watch their movies. He also said that as soon as we had the 300 homes hooked up they would have the films and equipment here for us to start within one week.

How about that? So--if you are not yet on the Terrell Cable, now is the time to help out. It needn't cost you anything. You don't have to sign anything. You don't have to promise to stay on. All it takes is a call to DI 5-2623 and say "Give me a free demonstration please".


