... three local youths at Boys' State this week

The thirty-first annual American Legion Boys State sponsored by the Department of Texas and held on the Campus of the University of Texas, got under way Saturday as 840 high school boys from all parts of Texas, and two from Mexico, began registration.

Among those registering from Sanderson were Steve Litton, Ronnie Stewart, and Randy Louwien, who were sponsored by the Clarence Hallie Mulkey American Legion Post.

Following registration, each citizen was assigned to one of two political parties - the Nationalist or Federalist. Each citizen then functions as a member of his party, he attends its precinct, county votes in its primary.

In Boys State, The American Legion provides the type of program where the young citizen has the opportunity to learn for himself that his government is just what he makes it. The boy "learns to do by doing."

The program takes an added significance this year as the vote is extended to 18 year olds. Most Boys Staters are in the 16 to 17 age category.

Highlight of Boys State will be a trip to the capitol of Friday morning where each elected Boys State Official will be given an opportunity to serve in his respective office for a day, followed by the Governor's Ball Friday evening.

Boys State enrollment this

year brings the total to 15,779 high school junior boys who have attended since 1940, when Boys State was first inaugurated in Texas.

Mrs. T. J. Stewart and Sheryl took the boys to Austin.

While the basic function of American Legion Boys State is to teach high school youngsters the basic principles of city, county, and state government, the program also includes athletic competition between the 840 Juniors in eighteen Boys State cities, according to E. B. (Tex) Hanna of Borger, Boys State Athletic Director.

Each city consisting of a-bout 50-60 boys will elect a Recreation Director as one of its city officials and it will be his responsibility to organize a team to represent his city in such sports as touch football, softball, basketball, volleyball and tennis. In ad-

The annual event is held on the Campus of the University of Texas in Austin each summer and this year's program will be held, June 5-12, 1971.

Hanna stated that each city team will participate until eliminated in competition and the final two teams in each sport will meet on Friday afternoon, June 11, for the championship.

According to Hanna, facilities for the recreational part of Boys State are made available by Coach Darrell Royal and his staff on the Campus of UT.

Recreation is an important aspect of Boys State. Ten or fifteen minutes of calisthenics help wake the boys up each morning before breakfast and that comes mighty early, especially with daylight saving time in effect at this time of year. "In fact," Hanna said, "it is so early in the morning that it is necessary to turn on the lights of Freshman Field so we can see. " He went on to state, "The boys grumble about having to get up so early and exercise, but actually once they get out there, I think they enjoy it and afterwards, they can sure put away

The tax rate is set by the Board of Trustees.

Any person who feels that there is some inequality in the assessed value of his property for tax purposes is invited to have his complaint heard by the Board of Equalization.

Weigand, Austin Chriesman, Sid Harkins, and Clarence Chandler, are the members of the Board of Equalization for the county taxes and valuations and they will convene at 10:00 a.m. on June 24 at the court house to determine, fix, and equalize the value of any and all taxable property in the county for the purposes of taxes for 1971.

to any reader when his expiration was, and the payments for renewals now are only for those months to June of 1972. If you haven't paid your renewal notice which was mailed recently, your paper will stop at expiration - the same as the "big city" papers and "metropolitan" magazines. Please help us keep you as a reader, we are very anxious to do so, but we have rules that we must follow.

We would like to have every household a reader of the paper, but we are not allowed to mail the papers under our second class permit unless they are paid subscribers. It's just that simple. Our mailing permit governs what we mail, how it is mailed, and we must give an accounting of how the permit is used. And the second class permit is not "second rate" in any sense of the word. It just means that we do not pay first class postage rates for mailing the paper.

We used to mail a "first notice", then a "second notice" and sometimes a "third notice" of expirations. But that was in the days of 3¢ stamps. At 8¢ a notice, now you only get one, and after we get everybody's expiration date on June 1st, you won't get any mailed notice, you will ge advised in an advertisement of this fact in the paper - a general statement of expiration!

#### JUNE 10, 1971 New Amateur Ruling Sept. 1

The new amateur rule and the awards rule will not be effective until September 1 and students participating in rodeo events this summer should take notice of same. The old rule still stands and will stand until September 1.

The following notice was received from the University Interscholastic League director concerning amateurs.

"This is official notice that the change in the amateur and awards rules. lative to eo events participation in will not be effect we until September 1, 1971.

In other words, any pupil, 15 years of age or older, who accepts cash or valuable consideration prior to September 1, 1971, for participation in a rodeo event, will be ineligible to participate in athletics for the 1971-72 school year if proved before a proper committee.

"The same effective date and interpretation as above is true relative to officiating for cash or valuable consideration under the amateur rule.

"The widest possible dissemination of this information will be appreciated so as to avoid having any pupil lose eligibility through ignorance of this ruling.

#### 14 Proposals To Be Voted In November

The Texas Legislature has agreed on 14 proposed amendments to the Texas Constitution to be submitted to the voters for approval or disapproval in November of next year.

One that is receiving most attention at the present is the proposal that would authorize the 1973 Legislature to serve as a constitutional revision convention. This proposal is known as HJR 61.

Two other proposals would provide for increase in the salaries of legislators to \$8, 400.00 and the lieutenant governor and House speaker to \$22, 500.00. They are HJR 58 and HJR 59 respectively.

Other amendments that will be on the general election ballot in 1972 will be:

SJR 1: Providing four-year terms for the governor and other statewide officials that are now limited to two-year

SJR 16: Guaranteeing that no rights will be abridged because of sex, race, color, creed, nor national origin.

SJR 7: Permitting local govermnents on popular vote to exempt \$3,000.00 of assessed value of resident homesteads of persons 65 or older from all ad valorem taxes.

HJR 68: Providing for advertising (twice) of proposed constitutional amendments in clear, concise language in all legal newspapers in Texas.

HJR 35: Authorizing a tax exemption for disabled veterans and a partial exemption for partially-disabled veterans.

HJR 57: Permitting county commissioners to reduce the county permanent school fund and provide for payment of money to independent and common school districts on a per-scholastic basis.

SJR 29: Providing that state employees can serve o nonpaying school boards and city governing bodies without for-

feiting state pay. SJR 20: Exempting soil and water conservation district directors from dual office-hold-

ing prohibitions. HJR 61: Relating to rates of interest to be borne by bonds. HJR 41: Requiring that justices of the peace be compen-

sated by salary. HJR 31: Abolishing Lamar County hospital district.
