The picture that we are publishing this week as an "oldie" is the first of several that we have that were loaned by Carlton White and are the first ones that we have ever had showing the activity around the air base that was west of Sanderson after World War I.

We will have more history of the air base that we are going to be using as soon as we get it all, but we know and can say that the air station was built by the 464th Aero Construction Squadron which arrived in Sanderson November 3, 1919, and was engaged in the construction until July 1, 1920.

The 90th Aero Squadron arrived in Sanderson between November 26, 1919 and June 30, 1921.

There is no history of an air station located here before or after the dates mentioned in the information above.

Our thanks to Cong. Richard C. White for the above information and putting us in touch with the proper authority for some additional information about the two squadrons that were stationed here.



# More Rain Falls During Past Days

About two inches of rain fell during the past several days in Sanderson and a large damaging hail fell on Friday night.

The rain began falling about 8:00 p.m. Saturday night and the large hailstones damaged cars, pickups, trailers, etc., at the roping arena north of town, and did some damage to mobile homes and shrubs and trees over town, with some possible roof damage.

Ropers from over this area had just begun the final series of events at the Sanderson Rodeo Club's arena on US 285 when the hail hit. The animals and people had some lumps as a result of being hit by the hailstones. The roping events were postponed due to the high water in the arena after the rainfall.

Two and 2/10ths inches of rainfall were reported at the Charles Stegall ranch in 45 minutes.

Heavy hail and rain was reported to the west of Sanderson and Sanderson Canyon ran on Saturday night, but the water was contained within the creek bed.

Heavy winds moved some rather large items in town, including the trash receptacle at the rear of the C.G. Morrison Co. store, a trailer parked by Jolly Harkins' barn, and much debris and trash.

There was more slow-falling rain here Sunday afternoon and Sunday night with very little run-off.

Heavy clouds continued on Monday and there was some more moisture received in intermittent showers Monday.

Light showers continued all day Monday and Monday night with drizzle and mist continuing intermittently with more light showers on Tuesday morning at this writing. Sanderson Canyon has not flowed since Saturday night.

### CTOBER 7, 1971 Tom Parsons, 101, Former Resident, Dies In Christoval Tom E. Parsons, 101, a res-

ident of Christoval, died Friday in Schleicher Hospital in Eldorado.

Parsons was born June 1, 1870, in Texas and was reared along the Texas -Mexico border. He moved to Terrell County in 1911 and ranched south of Sanderson for many years prior to his retirement in the 1940s. He was deputy sheriff in Terrell County for two years - 1921-22.

Parsons moved to Christoval in about 1945 where he has lived since that time. He recently entered the Schleicher County Medical Center Nursing Home and celebrated his 100th birthday there last year.

# George Baker To Go To Seminar On Animal Waste

State Representative George Baker of Fort Stockton has been named by Texas House Speaker Gus F. Mutscher as a delegate to a national symposium on animal waste management September 28-30 in Warrenton, Va.

The symposium is co-sponsored by the Council of State Governments, the United States Department of Agriculture, the Environmental Protection Agency, and the National Association of State Universities and Land Grant Colleges.

"The symposium, " said Baker, "will concern itself with the problems livestock and poultry producers are facing with the advent of new laws and regulations relating to animal waste abatement."

In addition to Baker, Mutscher also named Rep. Steve Burgess of Nacogdoches and Rep. Bill Clayton of Springlake as conference delegates. Baker served as vice-chair-

man of the Engrossed and Enrolled Bills Committee during the 62nd session in 1971. In 1969 he was a member of the House Committee on Agriculture for the 61st session.







That was a public notice. Since the beginning of time, men have found it necessary to to others, communicate information of importance to all.

When America was young, life was simple. People, of necessity, lived close together. When one man had a message for several others, he usually knew where to find them. If the message must cover a wider area, the town crier was employed to inform one and all. The system was adequate.

But then America began to grow. People moved out over a wider and wider area. The spreading of vital information became more difficult. For a time the accepted means was the posting of notices in public places. If the persons concerned happened to pass the proper place, and the notice was still hanging, and they happened to read it, objective was accomplished.

But America grew more-and more-beyond its founders' wildest dreams. Problems having to do with land ownership, debts, estates, purchases, elections, improvements, began to arise, as America became big business.

Then was born the "Public Notice." As they always have, when needs regarding the public welfare have arisen, the newspapers of the country took on an added chore.

Today's newspaper is the chief medium for Public Notices of all kinds. Those notices are there for your information and protection and your guidance. They contain news-of your friends and their purpose. neighbors, of public affairs that affect you as an individual and as a member of your community. NOTICE OF CANCELLATION OF LIVESTOCK BRANDS AND MARKS

All brands and marks on Texas livestock must be rerecorded with the County Clerks after August 30, 1971, according to a new law passed during the last session of the Texas Legislature. Producers will be given a six-month period (August 30, 1971 through February 29, 1972 in which to register these brands and marks and the location on the animal which they are currently using, after which time any unrecorded brand will be available for use on a "firstcome" basis.

The law further states that all such brands and marks must be rerecorded every 10 years. Each County Clerk records for his given county only, so many producers may need to record their brands in additional counties if their operations are extensive. The owner shall have the right during this six-month period to file the mark and brand now recorded in his name. In the event it cannot be determined from the records who first recorded the brand and mark in the county, then the person who

has been using such mark and brand the longest shall have the right to have the brand and mark recorded in his name. It should be noted that it is illegal to brand livestock without first properly recording the brand with the County Clerk in the county in which the live-

stock are held. When the brand or brands are recorded, the location on the animal on which the brand is to be applied must be designated. If the brand is to be applied to more than one location on the animal, it must be so recorded and each additional location for the brand on the animal shall constitute a separate recording of that brand.

There is no limit to the number of brands and/or marks which may be recorded in a county by a person as long as requirements of this law gov erning the recording and rerecording of livestock brands are met. Minors may have marks or brands separate from that of their father or guardian, which must be recorded or rerecorded as provided by the new law. The County Clerk of each county shall have this act published in some newspaper of general circulation in the county for a period of 30 days. The act shall be published on the effective date, August 30, 1971, and thereafter for 30 days. It is the obligation of the County Clerk to assure that no more than one brand of a kind be recorded on the same location of the animal in each . county. Therefore, no two people in a county may record the same brand in the same location. It is also the responsibility of the County Clerk to make certain that in recording any brand for a person, that the part of the animal on which the brand is to be placed be designated.



# **Grass Effective** In Ecology

Grasss is one of the most effective pollution control and air conditioning devices that nature has to offer.

"One acre of grass releases about 2, 400 gallons of water or. a summer day through evapora-tion and transpiration, " according to Herb Senne, head of the U.S. Department of Agriculture Soil Conservation Service of fice in Sanderson.

This much evaporation equals the cooling effect of a 70-ton air conditioner", Senne continued. "And grass is ideal for erosion control, beautification, and animal forage. "

Senne said grasses vary widely within individual species. There may be dozens of strains of side-oats grama, for example, growing within an area of only a few counties. These variations are caused by differences in climate, soils, elevation, and other factors.

SCS conducts a constant search for superior strains of grasses and other plants, Senne Said.

"What we're looking for are strains of grasses that will help solve some specific environmental problems, " Senne explained. "In Texas, we need

grasses that will thrive on several drouthy soils; cool season plants that will extend the grazing season; and plants that will provide for age for livestock while also providing better food and cover for more kinds of wildlife."

Semme added that conserva tionists also need salt tolerant grasses that will grow on a wide variety of problem sites, forbs and woody plants useful to wildlife and livestock that can be planted in range seeding mixtures, and water-tolerant plants that will curb wave action on earthen dams.

To help coordinate the search for better plants, SCS operates 20 plant materials centers in the United States. One is located in Texas at Knox City. Scientists at these centers grow and evaluate plants from all over the world to help find strains that will solve specific problems.

The most recent grass selected and put into use by SCS plant materials work in Texas is Selection 75 Kleingrass. Released in 1968, the plant is a leafy, highly palatable grass that is now being grown widely in Central Texas. It is used mostly in tame pastures where high rates of fertilizer are used. A number of active field plantings have been made in

recent years in the Rio Grande- OCTOBER 7, 1971 Pecos River SWCD. Plantings were made to further test several species of grass to deter mine their adaptibility in and around the Sanderson area. Producers who are helping SCS with these tests currently, according to Senne, are: Bob Allen, A&A Ranch, Sid Harkins, Felix Harrison, and the Texas Highway Department.




