Coach To Be At Red Devil Banquet



"Coona" Gilstrap, head coach and athletic director of Upton State College, will be the special speaker at the Rankin Red Devil football banquet to be held in January. Gilstrap is a noted speaker all over the state and Rankin coaching staff that they are fortunate to have him for this event. Gilstrap was an end at Kerrville and the University of Texas at Austin. He played football for Jack Chevone at the University of Texas. He started his coaching career in 1937 at Leakey high school. Subsequently he coached at high schools, Cleburne high school and Schriener College.

Gilstrap coached from Schriener to Upton State in 1953. Gilstrap has coached teams which have won state titles in 1953, 1954 and 1955. In 1953, he coached the Pioneer Conference championship, tied for third place in the runner-up to champion in 1955; and in 1954, he coached at San Angelo and won 8, losing 1. In regular season the Rebels climaxed with an upset victory over the University of California in Pasadena Junior Rose Bowl giving the West Coast championship in 37 games.

Gilstrap steered his Rebels to a straight scheduled victory in the Conference championship in 1955 and was the first undefeated and untied team in the school's history. He brought a second state championship to the Junior Rose Bowl in 1956. The 1956-57 Rebel victory in the Junior College of North Texas.

In 1958, Gilstrap was named as a conference 2nd

ranked sports writers.

Aliens Must Register After January 1 1960

Registration cards on which aliens in this area are required to report their addresses during January of each year will be issued at the Rankin Post Office after January 1, 1960, Grace Roach, postmaster, has said.

Every alien must report his address during January of each year. The reports go to the Commissioner, Immigration and Naturalization Service.

Any alien who is temporarily absent from the United States during the reporting period must report his address within 10 days after his return to the U. S.

Any alien who willfully or inexcusably fails to report as required is liable to be taken into custody and deported. In addition, imprisonment or fines may be levied before deportation.

One-Day Closing Set By Most on New Year

A short holiday is planned by most Rankin business firms for the New Year with a majority scheduling only a one-day closing. Exceptions will be those firms which are normally closed on Saturday and Sunday such as the First State Bank and the County Offices.

Several firms have indicated that they will not close for New Years but will remain open to serve the public.

After a couple of weeks of washing, scrubbing, trimming and blocking lambs, the members of the Upton County 4-H Club are ready to present their annual livestock show on Saturday afternoon and night, January 2.

Weighing in of entries will start at 3:00 p.m. and all lambs must be at the Junior High Gym, site of the show, by 4:30 p.m.

There will be two classes of fine wool lambs, two classes of South-downs and a pen of two in each of the above breeds.

Superintending the show will be ex-club members now home from college. They will include James McDonald, Ellis Helmers, Bud Poage and Bobby McAden.

The public has been invited to attend the show without charge.

IT'S THE WILL OF BUREAU HEADS, NOT OF PEOPLE...

"If people demand more and increased benefits from government, people must be prepared to pay increased taxes."

That cliché has been the prime political prop of our state and national politicians for years, and it was knocked into a cocked hat last Thursday night at the Ralls Tax Institute.

State Senator Preston Smith was asked in a question and answer period just who are these people who march on Austin to demand more and increased government services.

It developed that "the people" aren't involved at all. There are no "people" making demands for greater government expenditures, in Austin or in Washington. On the contrary, the "people" are at home demanding economy in government. In Texas, not a single daily or weekly newspaper exists that has not clamored loud and clear for reduced services, never for increased services. These newspapers probably represent more accurately the will of the "people" than do a handful of bureau chiefs in Austin, who actually make the demands upon the Legislature for increased taxes.

Here is how demands for increased government services arise, and it has nothing to do with people:

Take the Texas Department of Welfare. It has a head. This man is interested (if he's human and has any ambition at all) in seeing his department grow, provide more services to more people, necessitating more employees, thus increasing his power in the state, and his annual income. It is to his advantage to expand and extend his work to embrace as many Texans as possible. The more people dependent

upon him, as recipients of aid, the better his position. The more people dependent upon him for salaries and wages, the greater his power and authority.

This bureaucrat prepares an annual budget. He has one standing rule: "Always ask for more than is needed". If the Legislature approves the budget, there's a lot of extra "fluff" to be bought with the

additional funds. If the cuts a bit off, there's than is actually needed.

There is no such thing as a bureau getting along on the same money it had last year. Asking for less is here for less would bring suspicion upon the chief as to whether he is performing his job. He would be labelled a... (Continued to Page 2)

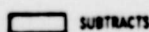
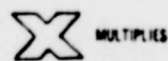
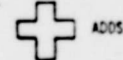

Tax Regulations Benefit Some

taxpayers may overlook re-
gulations in income tax regula-
tions that could reduce their 1959
tax. A new feature is the twenty
percent first year depreciation al-
lowance on tangible personal prop-
erty and ranch operators

should know the limitations on this
depreciation option in order to de-
cide whether to use it, according to
C. H. Bates, extension farm man-
agement specialist at College Sta-
tion.

To be eligible for the first-year
write-off, the property must have
a useful life of six or more years.
Usually a tractor or combine will
qualify. Also, the property must
have been purchased. Bates said
any asset acquired by gift or in-
heritance does not qualify.

The maximum amount on which
this depreciation can be taken is
\$10,000 on a separate return and
\$20,000 on a joint return. However,

explained the specialist, this limi-
tation may include several items
of property to make up the total.

The full 20 percent additional
depreciation can be taken on equip-
ment bought in December so it en-
ables quick recovery of this much
of the cost. Then, the regular year-
ly depreciation can be set up for
the remaining cost, less salvage
value. For example, a tractor bought
on December 5 for \$4,200, would be
allowed \$840 first year depreciat-
ion. In addition, one month's reg-
ular depreciation would be allow-
ed. If a salvage value of \$160 is
set up, the annual straight line de-

preciation on an eight-year basis
would be \$400. Depreciation for the
month of December would be \$33.
So the total depreciation allowance
on this tractor for 1959 would be
\$873 (\$840 plus \$33). In 1960 the
depreciation allowance on the straight
line method would be \$400.

Some situations in which this
additional first year depreciation
might be beneficial tax-wise are: In
years of unusually high net income,
and in periods when considerable
borrowed capital is needed for be-
ginning or expanding operations.

Also, in case of casualty losses in-
volving considerable equipment, such

as a fire, windstorm or flood. Bates
said the advantage of larger depreci-
ation allowances would "cushion"
the financial shock of re-investing
the equipment needed.

For a complete explanation of this
and other newer features of the tax
regulations, obtain a copy of the
1960 Farmer's Tax Guide. It is a-
vailable from your local county ag-
ricultural agent and from the In-
