'Destiny' cage season arrives

Well, it has finally arrived — Basketball season, that is. Since last March, Morton Indian roundball fans have been counting the days until the state-semifinalist Tribe would return to the hardwoods with all starters back from last year's highly successful season.

Morton hosts tough Lubbock Christian High School Friday night for two games, the first beginning at 6:15 p.m. in Indian gym.

Monday night the Indians will travel to Farwell and then host Plains on Tuesday for a pair of games.

The Morton Indians of 1970 advanced all the way to Austin on the virtue of big wins over Dimmitt, McCamey and Quanah in bi-district and regional play, but lost to a tall Taft team in the opening round of the state classic. The Tribe went 7-1 in district play, losing to Post, and squeaking by Denver City to claim the conference crown.

Although the Indians lost no starters from last year's regional champ squad, the team will be facing a whole new district slate by tangling with tough basketball opponents in conference 3-AA, a league that has a reputation for producing top teams. Dimmitt, Floydada, Lockney, and Friona are all expected to be looking to knock the Indians out of contention.

But district play in nearly two months away. In the meantime, Ted Whillock's Tribe will face tough opponents in the Denver City, Friona, and holiday Caprock tournaments. Morton may have an opportunity to face either Dimmitt or Floydada in the Caprock affair over the Christmas holidays.

Remembering last year's 25-point loss to LCHS, Whillock warned fans to expect the worst Friday night. "We won't be up to expectations," he related early this week, "we may get our ears rapped."

Whillock's pessimism is not without justification as lingering football injuries have crippled several players and have hampered this week's workouts. All-star Terry Harvey may miss action with an injured ankle. Senior Eddie Lewis is favoring a leg injury received in the Olton football game. M. C. Collins suffered a toe injury in last week's football workouts and has been hobbled.

Twenty-one boys will make up the A and B squads this year, a number that includes six seniors, four juniors, and eleven sophomores and freshmen. The ten varsity players are all in the top two grades and include seniors Harvey, Collins, Eddie Lewis, Stan Coffman, George Pritchett, and Eddie Turney. Rounding out the varsity will be juniors Bryant Lewis, Keith Embry, Elton Patton and Willie Holland.

School board relaxes dress policy

A recent request by students of Morton High School for a change in the dress code for classroom attendance has been granted.

The board of education, by unanimous vote Monday night, approved the wearing of coordinated pant suits to class on a trial basis. The request had been made to the board by a delegation of students at the last regular meeting and had been under advisement since that time.

Chief objection to the proposal by members of the board appeared to be that they feared that this relaxation of the rules would lead to further inroads on the code and a deterioration in the general appearance of the students. The "trial" basis approved by the board could serve as a test to see if there will be any lowering of the standards.

In other business, Superintendent Bob E. Travis advised the board of changes being made in the national school lunch program which will have an effect upon reimbursements to local schools paid by the federal government under the program. To continue in the program, the local schools will be required to follow the more stringent guidelines than they have in the past. These guidelines will be provided by the Texas Education Agency, Travis said, and will increase the reimbursements paid to the schools.

A textbook committee for the 1970-71 school year, to study and pass upon books that will be up for adoption into the school system next year was appointed by the board. The committee consists of Dorothy Rose, custodian and members,

Evelyn Seagler, Ina Fern Gray, John Coffman, Cassie J. Benham, Naomi Thompson, O. A. Graves, Peggy Silhan, Margaret Masten, Inez Knox, Elizabeth, Leavitt, Dennis Howell, Helen Crone, Jeanette Young and Owen Young.

A discussion was held by the board concerning the possible purchase of the Production Credit Association office building at Taylor and SE First street to house the administrative and tax office of the school district. Crowded conditions in their present location and increased administrative and records keeping requirements indicate a strong need for more space and this could be an economical solution to the problem, Travis stated. No action was taken by the board at the meeting.

The first grade rooms in the Morton school are at or above the capacity allowed by the state and Supt. Travis requested that the board consider the addition of one first grade teacher. He advised for the present, however, that two teachers aides be hired to assist the first grade teachers until after the Christmas holi-

days and that the situation be re-evaluated at that time. The board voted to hire the two teachers aides for this purpose and decide after the holidays whether another degreed teacher is needed.

Dallas architect will speak at Methodist Laymen's Day

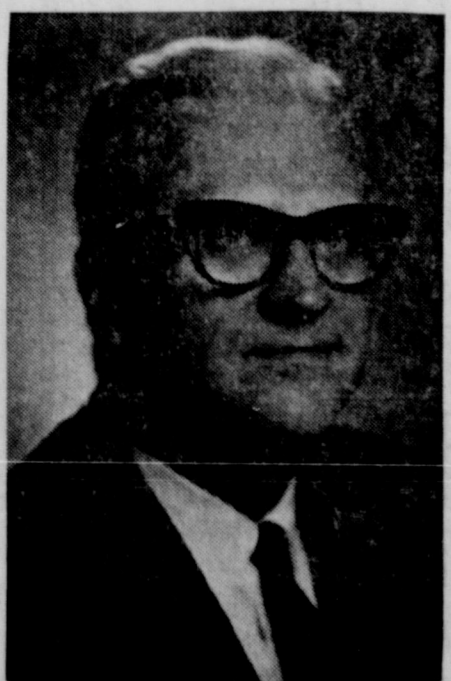
J. Herschel Fisher will be the speaker Sunday, November 22, at 10:55 a.m. at the First United Methodist Church in ob-

Special music will be brought by the Morton High School Choir under the direction of Don Chandler.

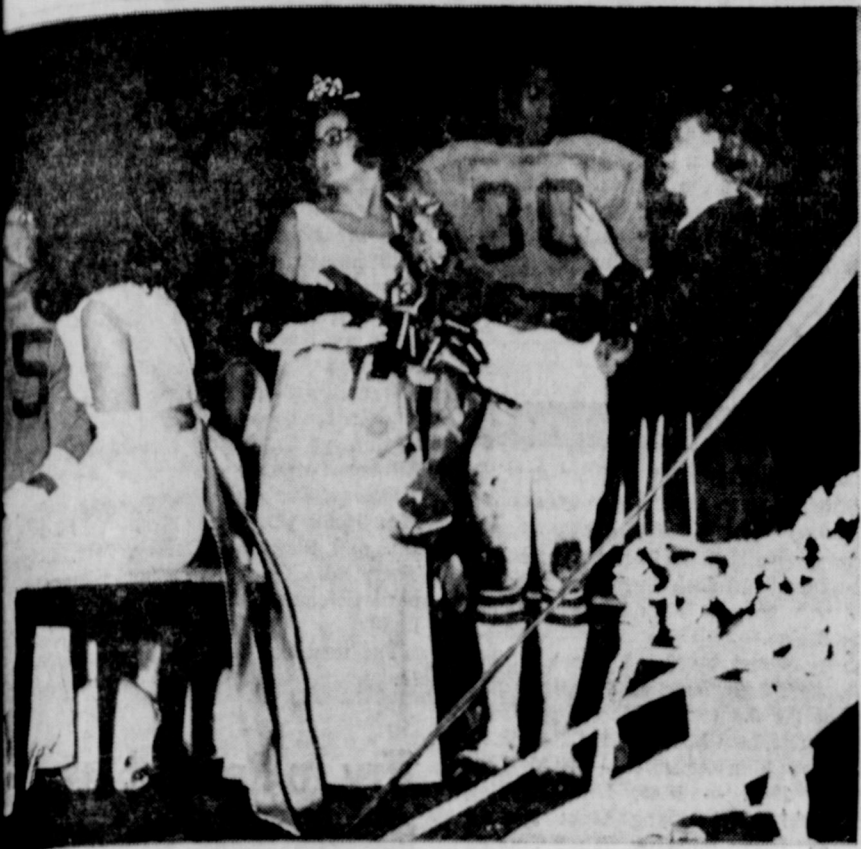
The offering received will go to the Morton Area Ministerial Alliance to be used in their annual distribution of Christmas baskets for the needy.

City break-in suspects nabbed in NM; some of loot recovered

Two men suspected in connection with burglarizing of four buildings in Morton on the night of November 7-8 are being held in Portales, New Mexico, according to information released by Cochran county sheriff Hazel Hancock.

Lennie Ray Coker and Carl George Davis were apprehended on other charges by Roosevelt county sheriff's deputies November 13 in Portales, Hancock said. Warrants were issued here November 14 by Justice of the Peace Joe Gipson where a hold was put on the two later action by Cochran county law enforcement agencies.

The two are facing charges on nine counts in New Mexico and it will only be after those are disposed of in the courts that Cochran county can receive them into custody and press the charges, the sheriff stated.

The four burglaries in Morton included Taylor & Son Furniture Store, Ike's Farm Store, Burlington Paint and Supply and offices in the Professional Building owned by the Fred Payne accounting office, the Retail Merchants Association and Chamber of Commerce office. Cash and merchandise valued into the hundreds of dollars were taken in the break-ins.

Acting upon clues uncovered in the Portales arrests, Sheriff Hancock and Lubbock officers searched a house in Lubbock that is believed to be occupied by the wife of one of the suspects and re-

covered some of the items taken in the Morton burglaries. Among the items were torn up checks bearing the Taylor and Son signature and an electric coffee pot that is identifiable as being taken from the store.

The investigation is continuing and the sheriff's office has leads on other suspects who may be implicated in the Morton burglaries, Hancock concluded.

Weather interrupts area cotton harvest as it reaches peak

The Cochran area cotton harvest was at a peak until halted by the unfavorable weather, according to C. R. Wharton, in charge of the U.S.D.A. Cotton Classing Office in Levelland. However, this interruption will enable gins and the local classing office to catch up on their backlogs of cotton to be ginned and classed.

Samples from 16,100 bales were classed at the Levelland office during the week ending Friday, November 13th. His brought the total classed this season to 27,000. Through November 13th last year only 1,900 samples of the 1969 crop had been classed.

Quality continued good on these early harvested bales. Strict Low Middling Light Spotted was the predominant grade at Levelland last week with 30 per cent of all cotton classed. Strict Low Middling made up 20 per cent, Low Middling 7 per cent and Middling Light Spotted 15 per cent.

Staple length improved slightly and averaged between 15/16 and 31/32. Eighty-six per cent stapled 15/16 and longer compared to 66 per cent the previous week.

Seventy-eight per cent of all cotton classed at the Levelland office last week had micronaire readings in the premium range of 3.5 to 4.9, 10 per cent "miked" 3.3 through 3.4 and 8 per cent "miked" 3.0 through 3.2.

Ninety-one per cent of the cotton classed at Levelland last week had Pressley readings of 80,000 pounds and higher.

Morton's Indians displayed one of the patented come-from-behind touchdown flurries for the scattered fans at Littlefield last Friday, but failed to stem the Wild- cats' 19-point output during the final half, and dropped a 33-22 decision.

The loss left the Tribe with sole posses- sion of the cellar spot in district 4-AA with an 0-7 mark, one notch behind Little- field. The Indians finished the 1970 season at 2-8.

The game was the last for 10 Morton seniors. Suiting out for the final time were M. C. Collins, Monte Dewbre, Stan Coffman, Eddie Lewis, Terry Harvey, Jackie Watts, Haskell Lamar, Kirby Gresh- am, Gerald Grusendorf, and Darrel Betts. In addition, seniors Tommy Lewis and Dwight Horton closed out their high school careers in Thursday's B game at Farwell, and manager Eddie Turney chalked up his final tally sheet.

The Indians staged their biggest one- quarter output of the season during the second period Friday night as they roared from a 14-0 deficit to bang out three touchdowns and 133 yards to take a 22-14 halftime lead.

Stymied by the bull rushes of Little- field's huge backfield, the Tribe watched the hosts rack up two first quarter touch- downs before they could get untracked. But late in the initial quarter, the Indians started rolling as Kevin Kuehler and Keith Embry racked up big gains. Embry capped an 80-yard drive with a 14-yard run for Morton's first TD early in the second period. Willie Holland ran for the two extra points.

And just two minutes later, the Indians tied the game at 14-14 as Kuehler romped 46 yards on first down for the score, sprung loose on a good block by sopho- more end Ted Thomas.

After a Littlefield punt, Morton put it all together for the final time that night, with four minutes left in the first half. Runs of 23 and 14 yards by Kuehler powered the Indians over for their third

score. Holland's two point conversion gave the Tribe a comfortable 22-14 halftime lead, and the Indians appeared headed for their first district win.

But the second half was a different story. Littlefield's giant defense stopped Morton cold. Kevin Kuehler, who racked up 135 yards during the first half, was held to just nine yards in five tries during second. The Indians had run up 213

yards during the first half, but managed only 24 during the second and two first downs.

Meanwhile the Wildcats played catchup football well. With half the third period gone, a Danny Estrada touchdown narrow- ed Morton's lead to 22-20. During the fourth, the Wildcats capitalized on a block- ed up and drove in from the Morton 45. Minutes later, they added the insurance TD after taking over at the Indians' 44.

Kuehler's 144 yards led all rushers in Friday's game and gave the Morton full- back top rushing honors for the 1970 In- dian season. Kuehler racked up 512 yards on 96 tries, topping Terry Harvey who was favoring an injured ankle and did not see action Friday. Keith Embry picked up 68 yards on nine tries Friday night.

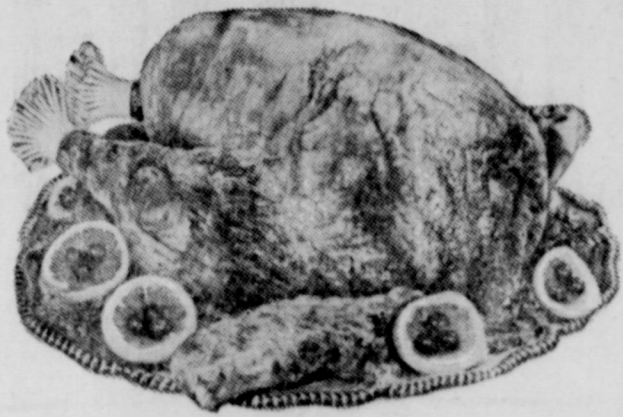

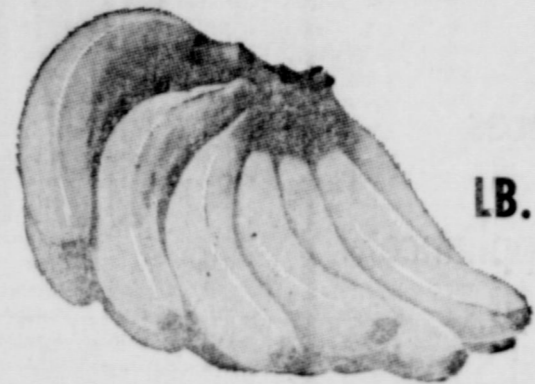

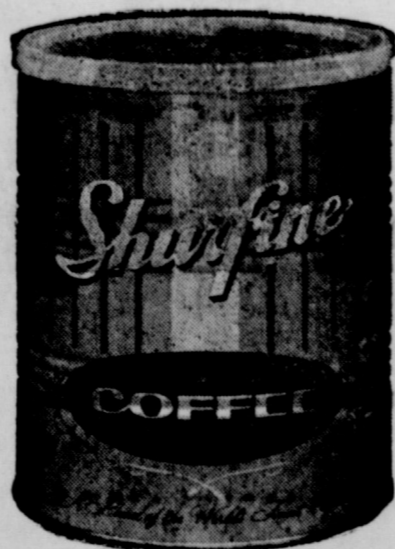

Local art teacher attends conference at Texas Tech

Mrs. Evelyn Seagler attended the "Young at Art" conference held in Lubbock Saturday at Texas Tech University.

The conference was under the direction of Dr. Clarence Kincaid, Bill Lockard and Ray Helbert of the University art department.

Dr. Reid Hastie spoke at the luncheon and presented slides of children's art work while lecturing on space exploration in "child art." He pointed out that adults should not impose space limitations on children's art. "To a child the big thing means an important thing. If he is important to himself, he may draw himself much larger than another person or house in a picture," Dr. Reed stated.
