

Quite a bit of excitement was occasioned here Monday morning when Nightwatchman C.M. Jones released himself from his gag and hookwink and the post to which he has been tied, and gave the alarm of burglars. It appears that Mr. Jones had just driven up town from the south side of the railroad in a car with Reeve Guyer, and had alighted from the car about the middle of Main Street near the T.J. Crawford store, when Mr. Guyer had driven on to his home at the north end of Main Street. They had seen three men sauntering along the street and Mr. Jones went to find out their business. They were looking for a bed for the night and it was already 1:30 a.m. When he told them there were no beds or jail to sleep in they gagged him and tied him up. They broke into the Crawford store and took about \$6.00 from the cash register.

NOVEMBER 5, 2002

Explanatory Brief for HIR 2

HJR 2 would amend the constitution to allow the commissioners court of a county to declare the office of constable dormant if that office has been vacant for at least seven consecutive years. The records of a constable office that is declared dormant will be transferred to the county clerk. If the office is declared dormant, the previous officeholder does not continue to hold the office. The office may not be filled by election or appointment unless the commissioners court votes to reinstate the office or a majority of votes cast in an election held on the issue favor reinstatement. The reinstatement election may be held if the commissioners court on its own motion orders such an election, or the reinstatement election must be held if the commissioners court receives a petition signed by 10% of the registered voters of the constable precinct.

The proposition will appear on the ballot as follows: "The constitutional amendment authorizing the commissioners court of a county to declare the office of constable in a precinct to be dormant if the office has not been filled by election or appointment for a lengthy period and providing a procedure for the

You can also get lenses with light-filtering tints that are designed for sports use. They enhance certain colors such as the optic yellow of tennis balls by muting other colors. Because of the color enhancement, the ball stands out against the background and is easier to target. Since companies also make these lenses without prescriptions, spectators who do not need glasses can also wear them. In the

future, you will see lenses for other sports enthusiasts.
