THE TOWN'S REPRESENT-ATIVE

Have you ever thought how thoroughly representative a newspaper is of its home town?

A newspaper is the only home institution that travels around to distant cities. Buildings and streets cannot be seen unless one visits a place. The newspaper goes as far as the mails.

The home newspaper furnishes a means by which distant people gain an idea of the place where it is published. If a newspaper is newsy and clean typographically, and has liberal advertising, every man from Los Angeles to the Atlantic who sees it gets an idea that the town is alive.

People have no idea how news papers circulate away from their home town, says the Meriden (Conn.) Journal. Every publisher has a considerable list of subscribers who formerly lived where it was published, or are interested in the place for business reasons. And people send away many papers.

If you want your town to cut subscribe to the home paper, and advertise as much as your business will fairly warrant .-Publisher's Auxiliary.

The Messenger is very much interested in good roads, and especially would we like to see the work continued on the west side of the railroad. We strongly favor another bond issue, setting aside a certain portion of it for maintenance purposes, and extending the roads further in the rural districts. The district could very easily issue more bonds and what it would mean to that section of the country -cannot be measured in dollars and cents. The time to act is now, for it would be next summer before the bonds could be disposed of, and we could devote the idle months to road building. The experience gained in building the present roads would be valuable and many items of expense could be trimmed down and better roads built., Let's go after another bond issue. What say you?

No doubt this immediate section of the country has suffered greatly on account of the continued drouth, and as a natural result some people are going to become dissatisfied. No doubt a great many are now considerwing the feasibility of hunting a mew location-a place where "times" are better. Our advice

you are. A man never makes anything running around over the country hunting a snap-a sure thing-for he will not find it. It is the man who sticks to a certain thing that wins out in the end. Now is the time to show your metal. If you leave, the country will suffer the loss of a citizen and you will not be much on account of the drouth, but there are other things that bring disaster. The Messenger knows of a man in this community who says he has moved ev ery year for the past three years and every time there has been a drouth, and the places he left had good seasons. So you see it does not pay to hunt the good places. The Messenger has unshaken faith in this country, and sincerely believes that next year will bring things around alright. It is not long until another crop time, so live in the hope that the future will bring good things.

Tax Warning

For the past two months the adminstration at Austin have been warning the tax payers of the State against an increased tax rate for the State, on the property values needed to relieve the State's enormous deficit, and to meet its embarrasing financial obligations. This being so, each county in the State should look well to its own interest at home first, and not contribute any more than its share to the State's relief, and give to the State its pro rata part only-that our county may not be burdened too heavy with the State's debt, and the State's obligations. It is better then to lower our property values for this year, and if necessary raise the county rate to meet each and every obligation the county may need, than it would be to raise the value of our lands and property for this year, and lower the county rate, and for the reason that Houston County has no deficit debt, and is not in the least financially embarrassed. Our county's value for last year was \$7,820,590. 

BIG DISAPPOINTMENT IN OHIO

Buckeye State Failed to Pass Appropriation of \$50,000,000 to Improve Its Roads.

The greatest disappointment of last year was the vote of Ohio on the constitutional amendment to authorize the general assembly to issue bonds of the state in an amount not to exceed \$50,000,000 for the purpose of constructing and maintaining an intercounty system of wagon roads. The vote was: for, 272,527; against, 274,-618; majority against, 2,091. This close vote was all the more unfortunate, because the issue was not decided on its merits. Forty-two amendments were voted on, and in the zeal to defeat some of them, thousands of voters slaughtered all. So, under the circumstances, it was probably surprising that the vote in favor was as large as it was. But it is a shock to find that such a state af Ohio out of 1,250,000 qualified voters less than 600,000 took the trouble to go to the polls to vote on constitutional amendments, and not all of these paid any attention to good roads.
