Friona's 45th annual Maize Days celebration heads for its final weekend, with a number of events on tap. The Chieftains host the Dimmitt Bobcats in Friona's Homecoming game Friday night. Pre-game ceremonies, which will include the crowning of the FHS Homecoming Queen for 2001, begin at 7 p.m. Kickoff will be 7:30.

Also in conjunction with Homecoming, the Excel Corp. is hosting their free hamburger and hot dog cookout at the Stadium. Serving will begin about 6:30. First event on Saturday will be the annual Dixon Six-Mile Run and two mile run and walk, from north of town to the city limits on State Highway 214. Runners

## Americans Asked To Fly Flags For 30 Days

Americans have been asked to fly their flags for 30 days in support of democracy, Congressman Larry Combest announced Thursday.

In a conference call with some of the news people in his area early Thursday, including this writer, Combest said it had been heart-warming to see how Americans are reacting to the tragedy in New York and Washington, through donation of blood, and many other things.

The Congressman said that the House had been in session until 1 a.m. Thursday, and was to re-convene later Thursday to consider a number of resolutions.

Foremost will be a resolution to support the administration in its efforts to discover the perpetrators of these acts, and to punish them in a reasonable manner.

"We cannot refuse to respond to this terrorist act, and whoever is responsible needs to be brought to their knees, not to justice. I was glad to hear the president say that the countries who support and harbor terrorists are just as guilty as those who actually committed the acts," Combest told us.

Combest said that he had never seen Congress as unified during his stay in Washington as it is on this cowardly act. "It's far more unified than it was during the Gulf War. I think whatever the president requests will pass by a huge non-partisan vote. We may have bickered over details of certain legislation in the past, but that won't be the case here," he said.

President Bush has asked for \$20 billion to assist the New York loss alone, and this will be granted, Combest said, along with whatever else might be needed.

"This has put the argument as to 'what to do with the surplus' to bed. And anything we might borrow from any other fund will be repaid. Thank goodness the country is in a fiscal condition to have the means to rebuild whatever has been lost," he stated.

As to the question on Tuesday of whether to bring President Bush back to the White House, Combest said there was a huge concern that the terrorists had planned to down Air Force One (the president's plane), and that they might have sharpshooters in the White House area.

"I'm a little bit furious with Peter Jennings for his hints that the President 'hid in a cave' until it was safe. We got a call to our office at one point that there was a plane in the air that would be in Washington in 20 minutes," Combest told the reporters.

The congressman said he was confident that Pres. Bush and vp Dick Cheney will think things through before acting.

"We need to send a signal to the world that while Americans may fuss among themselves, that when you hit us, we'll stand together and respond. We don't need to over-react without thinking things over, but we need to deliver the message that this was a BIG MISTAKE, and I think Congress will pass a resolution along these lines as early as tonight (Thursday)," he said.

Responding to the question of how long the airlines, the Stock Market, etc. would be shut down, Combest said "We would rather err on the safe or cautious side rather than going back too soon." Combest said he thought the decision to ground all air traffic immediately Tuesday was a brilliant decision. "At that time, we didn't know how many planes had been hijacked," he said.

As to the lack of intelligence on the tragedy, Combest said we had suffered considerably from the Clinton administration's policy of not having intelligence work in Baghdad. "He didn't think we needed to 'dirty our hands' in places like that," he said.

At the conclusion of his report, the newsmen all thanked Combest for his good work, and asked him to convey to the president our best wishes as he deals with this tragic situation.

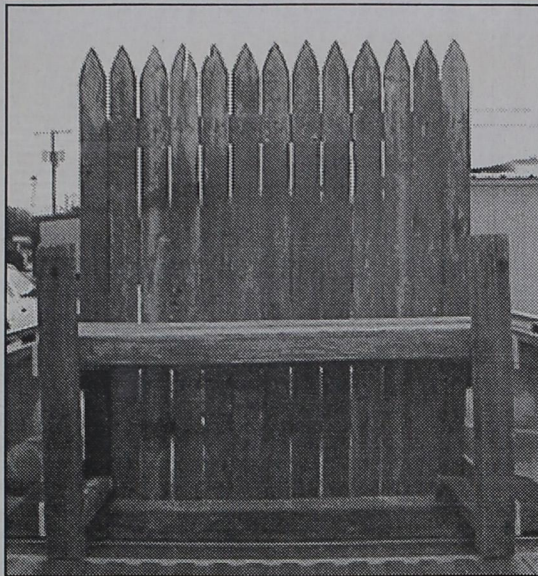

# Friona Flashbacks

...from the files of The Friona Star

**70 Yrs. Ago-Sept. 28, 1931**

In spite of the fact that a heavy rain fell over the Friona territory and much adjacent country on the night before the Wheat Growers' picnic, there was an immense crowd here, variously estimated at two to three thousand people.

J.W. Parr, one of Friona's most extensive wheat grower's, has at this time, about 400 acres of his 1932 wheat crop sowed, much of it up and growing.

**65 Yrs. Ago-Sept. 25, 1936**

Logan Simpson and Dan Ethridge have rented the room adjoining the north side of the Post office in the T.J. Crawford Building, and have had it nicely fitted up and redecorated with fresh paint and are now occupying it as their respective offices. Mrs. Simpson represents West Texas Gas Company and has charge of the city's water department. Mr. Ethridge is now conducting the only insurance agency in Friona.

**60 Yrs. Ago-Sept. 26, 1941**

During the latter part of last week, several units of heavy dirt-moving machinery for various purposes, belonging to Cook & Ransom, of Ottawa, Kansas, have been unloaded at the Santa Fe yards here for the purpose of building the large levy that is being built by the railroad company, for the prevention of future flood damage to its tracks and

**50 Yrs. Ago-Sept. 27, 1951**

Bids for construction of a fire station in Friona will be let quite soon, according to announcement this week by Mayor Mack Bainum. Plans are for construction to begin before cold weather of the two-truck station. Location will be on the city-owned lots just north of the park on Main Street.

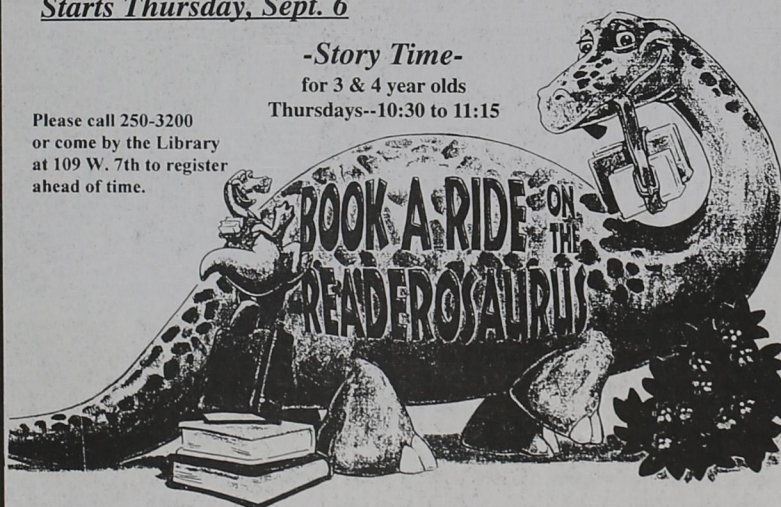

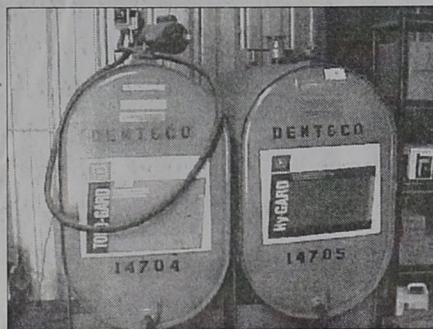

**Caballero Art Exhibit Begins**

Beginning September 15, the Panhandle-Plains Historical Museum at Canyon, Texas, will open a retrospective of long-time Texas artist, Emilio Caballero. Emilio Caballero: Artista y Maestro en el Llano will celebrate the artist's unique contributions to the cultural life of Texas and include works from private and public collections across the United States, in several media, including oil, watercolor, and copper enamel.

Born in 1917 in Newark, New Jersey, to Spanish parents who immigrated to the United States via Cuba, Caballero came to the Texas Panhandle in 1937. He studied first at Amarillo Junior College and West Texas State College. Caballero then served in the United States Army infantry in both Europe and the Pacific during World War II.

Following the war, Caballero taught art in Amarillo public schools before receiving a master's degree from Columbia and beginning his tenure at West Texas State University in 1949. In 1955 he received his doctorate from Columbia and was appointed full professor and art department head at West Texas. One of the most versatile and acclaimed artists to work in the area, Dr. Caballero taught at West Texas State from 1949 to 1979.

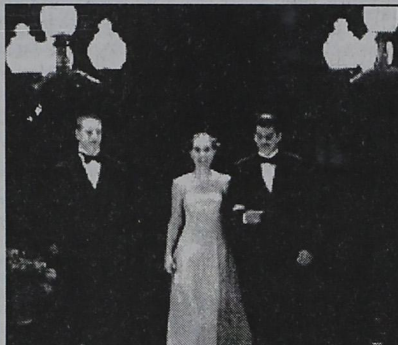

# Dimmitt: 'Most Met' Opponent

Although the Chieftains played the Muleshoe Mules four years before they ever played Dimmitt, for sheer numbers the Bobcat-Chiefs rivalry shows more times met-65-going into Friday night's game.

Also, the Bobcats and Chieftains have met on the gridiron 43 consecutive years, something no other team on the schedule can match.

The two teams first met in 1930, and back before the days of ten-game seasons, Friona and Dimmitt played twice a year, home and home, in at least two years, 1942 and 1943.

And although the Chieftains hold a personal best of seven straight wins over Dimmitt prior to Friday, don't feel too sorry for the Bobcats. They beat Friona 14 straight times from 1944 through 1962.

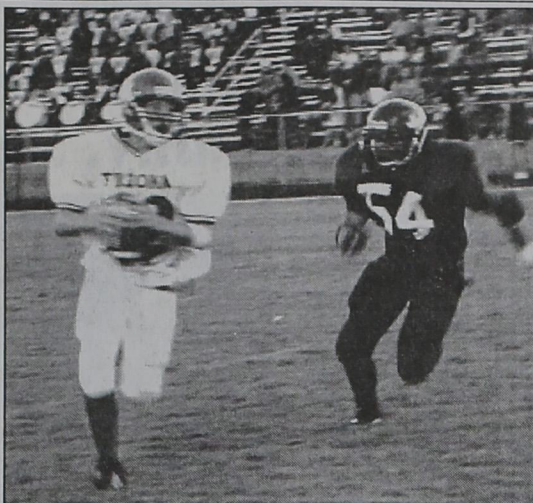
The Bobcats lead the all-time series with 40 wins to 24 for Friona plus a tie, a 62 per cent winning ratio for Dimmitt. The 'Cats were holding a 40-17-1 edge (70 per cent) before Friona started its current winning streak, in their district-winning 1994 season.

Friona holds a 20-18 lead in games played since 1963, Don Light's first year as Friona head coach. As a matter of fact, Coach Light directed a 20-0 win at Dimmitt in 1963, which broke the 14 straight loss streak mentioned above.

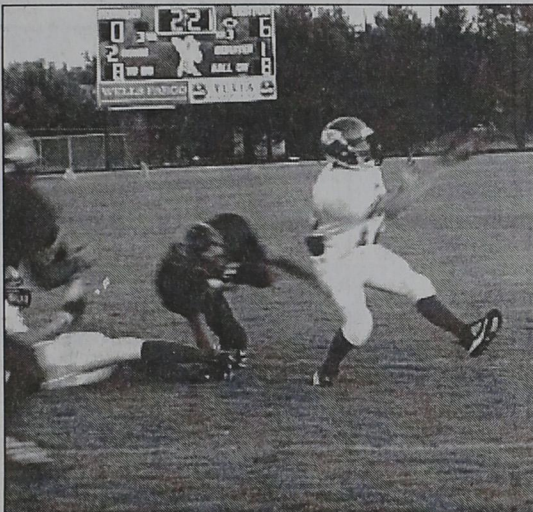
Home field has especially favored the Bobcats, who hold a 24-9 edge (73 per cent) in games played in Castro County. (It was 24-5, 83 per cent prior to Friona's current streak. Friona has just broken even (15-15) in games played at their home field.

# Chiefs Back On Track In 33-0 Win At Tulia

The Chieftains got their offense and defense back on track, and scored a 33-0 win at Tulia last Friday.

Friona was playing a team more their size (weight-wise and enrollment size both), and less talent than the Guymon team they had met the previous week. It all added up to a game in the "W" column.

It took only five offensive plays for Friona to take the lead. The Chieftains received the opening kickoff, and Andy Carthel returned the kick 28 yards, to the Friona 39 for good field position.

Brock Field started at quarterback, and the sophomore showed a lot of poise in his promotion.

The first thing Field did was hit Adam Bandy over the middle for a 27-yard gain on Friona's second offensive play.

Two plays later, Field kept the ball on the option play, and showed some speed in getting around the corner for a 20-yard gain. That moved the ball to the Tulia 15.

On the next play, Nathan Haile crashed through the line and into the end zone. The point try failed, but Friona took a 6-0 lead only 1:17 into the game.

That would have been enough for the win as it turned out, so well did the Chieftains shut down the Hornet offense.

Tulia did put a pair of first downs together after a short kickoff by Friona, and drove the ball down to the Friona 18. But good defensive plays by Dario Hernandez and Carthel stopped the drive, and Friona took over on their 24.

That would prove to be one of Tulia's better scoring opportunities.

The Chieftains responded by covering 76 yards in only seven plays for their second touchdown.

Haile blasted 23 yards for a first down, Field rolled around right end for 17 yards, and Haile had a 15-yard gain. Those three plays moved the fall from their own 24-yard-line to the Tulia 20.

Haile gave Friona a first and goal with a four-yard run, and Bandy got into the scoring column by slashing a yard with good second-effort at the goal-line.

That gave Friona a 12-0 lead as Field was tackled before he could try a pass. There was still 2:11 to play in quarter number one.

Tulia was fortunate that the Chieftains didn't quickly stretch their lead, after Eric Rubio recovered a fumble on the Hornets' first offensive play after the kickoff.

But the Hornets stopped Field two yards short of a first down, and took over at their 30.

Tulia then made its best threat for a touchdown, when they drove from their own 30

to the Friona six. They got a 24-yard run, and gained 11 yards in three plays to move to a first down at the Friona 15.

But on fourth and two from the Friona six, the defense sacked the quarterback for a loss and took over.

It looked as though the 12-0 score would be the halftime score, until the last play of the first half.

Tulia took to the air, but didn't have much success. The Hornet QB completed only one of four tries in the last drive.

And on his last attempt, Nathan Haile intercepted, and with the flow going the other way, raced 72 yards up the field for his second touchdown of the game as the buzzer sounded.

The Chieftains finally converted for the first time, when Field tossed to Haile for a two-pointer and a 20-0 halftime lead.

In their first possession of the second half, Friona duplicated their feat of the first half: driving for a score.

Bandy and Haile took turns toting the pigskin for the Chiefs, with Haile's 18-yard gainer moving the ball to the Tulia 13. Two plays later, Bandy raced in from the eight for the score. A pass try for points failed, but Friona led 26-0 with 6:16 left in the period.

Carthel got Friona's second interception when Tulia took to the air, with the Chiefs taking over on their own 15.

The team then made its longest sustained drive of the young season, covering 85 yards in 18 plays. The drive overlapped the third and fourth quarters, and Friona made eight first downs in the process.

Haile, King and Field all gave the team first downs with runs, as Friona never had to try a pass.

With the ball at the Tulia

28, Coach Mike Scott called his starters out of the game, with reserves taking over, with over seven minutes left to play.

The bench was eager for some action. Osvaldo Almaguer, who has been backup fullback the last two seasons, carried the ball four straight times, with his longest run being 17 yards.

Almaguer crashed in from a yard out, and Nathan Haile's kick was good, as the Chieftains reached 33-0 with 5:38 still to play.

Tulia fumbled the kickoff with Heath Gammon recovering for Friona.

Dario Hernandez was quarterbacking for the reserves. Almaguer gave Friona a first and goal at Tulia's eight, but a penalty and a fumble turned it back to the Hornets with a couple of minutes left.

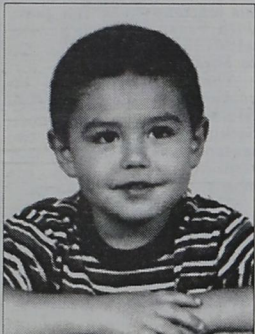

# Out Here

"Do We Have The Will?"

There is only one topic to write about this week.

On the other hand, everything that can be said about the terrorist's murder and mayhem has been said. Over and over again. Twenty-four hours a day all week.

Unless you have been to the Twin Towers in the World Trade Center, you cannot appreciate the magnitude of what has happened.

I have been to the top of the World Trade Center. Ate lunch at the restaurant on the top called Windows On The World. I didn't really enjoy the meal because I don't like heights.

The windows in Windows On The World were floor to ceiling glass. People could walk right up to the window and gaze down almost 1,400 feet to the city below.

I stood back several feet and made a feeble attempt to peer down, but I didn't like it. After a few minutes of tourist gazing, I was ready to get back down to earth.

I have also flown many miles in airplanes like those

used to take down the towers. The entire episode is incomprehensible to me.

Of course we want retaliation. We want our pounds of flesh and retribution and we want to see remorse. What we don't get is this: terrorists do not show remorse. They have none.

Terrorists do not fear retaliation or retribution. Neither do they fear death or any consequences the U.S. might threaten them with.

After all, we are America. We open our arms and our borders and invite the world in because, after all, all Americans descend from immigrants.

Our politicians seem to think that everyone would be better off if they lived in America or at least were more like us. We are a nation of laws (sometimes we make a few exceptions for people in high places). We are a religious and righteous society, setting examples for all the world.

The problem is, to much of the world we are a bunch

of arrogant, pious, hypocrites that meddle in affairs where we don't belong. We flaunt not only our ideology but our wealth and morality (which is getting a little frayed around the edges).

In other words, a lot of foreign folks hate our guts. Like it or not, they just don't like you and me because we are Americans. That extreme hatred should be obvious to people this week.

Let's suit up and go to war they shout. But against who? Terrorists do not have a uniformed military with bases around the world. They do not have an air force or navy.

And when they fight, they don't fight fair. There are no terrorist etiquette manuals.

Only an extreme fanatical belief could hatch a man smart enough to fly a Boeing 757 and stupid enough to fly it into a building and die. America does not understand that kind of passion and commitment.

Our leaders don't seem to understand that. We think that we can sit down with Israel and Palestine and make everything peachy in the Middle East. How many times have we had the little carpet-head Arafat over here to shake hands with another Arab or Israeli leader.

We think we can continue to open our borders to all nations and remain safe by converting the immigrants to American values. Hasn't worked.

The debate seems to center on a "we're good, they're evil" premise. We are the good guys. The Islamic terrorists (and other groups) are evil.

But they think that we are evil. They think they are right and good and that we should all die. This week they

drove the point home in a horrible way.

Terrorists are patient. They tried to take down the twin towers in 1993 with a bomb in the basement. We caught a couple of guys and had a trial and were glad they were found guilty and we applauded American justice.

Since then they practiced by bombing a couple of embassies and the USS Cole in Yemen. We caught a few of them and had trials and found them guilty and we felt really good about American justice.

This week we got a hard look at terrorist justice. Eight long years later, they managed to construct a plan to finally demolish the twin towers. And America didn't have a clue it was about to happen.

Our congress men and women gathered to declare that this is "an act of war." Then they stood on the capitol steps and sang God Bless America and hugged each other.

They vowed to use the untouchable Social Security trust fund if they had to. They vowed to become an even stronger nation.

But I can't help but wonder if they have the will to combat terrorism. I wonder if they have the will to bomb and kill and maim a country or group into submission.

Terrorists have the will, determination and patience to accomplish their mission.

The retaliation that needs to be done is contrary to our fundamental American beliefs of right and wrong, good and evil. Do we have the will?

I hope so.

**NOTICE OF CHANGE IN ELECTION PRECINCTS  
IN PARMER COUNTY**

Pursuant to authority vested in the PARMER County Commissioners' Court, under Section 42.035 of the Texas Election Code, the Court has made certain changes in the boundaries of Commissioners' Election Precincts in order to properly perfect a new redistricting plan for the County.

The new redistricting plan and the changes in the Election Precinct Boundaries were adopted at a Special meeting of the Commissioners' Court on the 29th day of August, 2001.

Therefore, pursuant to the mandatory duty imposed upon the Commissioners' Court, pursuant to the Texas Election Code, to-wit:

(1) In future elections, there will be 9 Election Precincts plus the early voting box.

(2) These Election Precincts will be defined as shown by Exhibit A and the polling boxes in each precinct will be as follows:

**VOTING BOX NO. 101**

This polling place remains at the Calvary Baptist Church, 1500 Cleveland, Friona, Texas.

**VOTING BOX NO. 201**

The polling place remains at the Bovina EMS Building, 109 3rd Street, Bovina, Texas

**VOTING BOX NO. 202**

The polling place remains at the Friona Community Center, 601 W. 15th Street, Friona, Texas.

**VOTING BOX NO. 203**

The polling place remains at Rhea Community Center, 307 FM 2013, Rhea, Parmer County, Texas.

**VOTING BOX NO. 301**

The polling place remains at Farwell Community Center, 207 9th Street, Farwell, Texas.

**VOTING BOX NO. 302**

This polling place remains at the Oklahoma Lane Methodist Church, 645 FM 1731, Parmer County, Texas.

**VOTING BOX NO. 303**

This polling place remains at Bovina Ridgelea School, 1000 Hwy. 86, Bovina, Texas.

**VOTING BOX NO. 401**

This polling place remains at the Lazbuddie School, 673 FM 1172, Lazbuddie, Texas.

**VOTING BOX NO. 402**

This polling place remains at the Friona Fire Station, 623 Main Street, Friona, Texas.

(3) These Election Precinct Boundaries will become effective upon approval by the United States Department of Justice, pursuant to Section Five (5) of the Voting Rights Act of 1965, as amended in 1975.

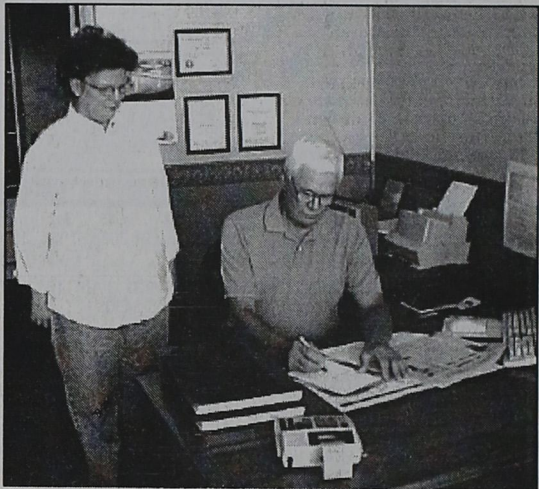
## Class of '86 Reunion At Maize Days

# Next Farm Bill Faces Challenges

The road to the next farm Bill is developing some pretty serious looking potholes. Fortunately, most supporters of the House Agriculture Committee's effort to craft the next Farm Bill aren't ready to throw in the towel just yet. Discussions earlier in the week the increasing press coverage of a shrinking Federal Budget surplus has many reconsidering Congresses ability to pass any type of meaningful Agriculture policy reform this year. That's the bad news.

The good news is the fact that so far the House of Representatives leadership appears to be sticking to its budget agreement based on the last official budget projections completed last April.

A recent meeting between members of the House leadership, Ag Committee Chairman Larry Combest and Budget Committee Chairman Jim Nussle resulted in agreement to stick by the promises made earlier in the year. That agreement supported agriculture programs with an additional \$73 Billion in spending authority from 2002-2011.

Supporters of H.R. 2646, The Farm Security Act of 2001, intend to present a strong case that proposed level of funding is necessary to properly address the serious financial state of the U.S. Ag sector.

They will also point out that the healing of Ag in related industries is also important because it would prevent further harm to the precarious U.S. economic situation.

Arguments for the House Ag Committee's Bill include the fact that it provides a 'safety net' that is much more stable and predictable and more responsive to volatile price and income swings than current policy.

The House Bill provides support at a level that bridges the gap left by current policy, which has partially addressed the situation through a combination of fixed and supplemental payments.

Key to the effort to get a new farm program in place for the 2002 growing season will be passage by the House next week and then a willingness by the Senate to pull together a package in the coming weeks.

The quest to initiate the next Farm Bill is made rougher by the political turbulence being created by possibly lower budget surplus projections in the future.

It is important that agriculture as a whole pull together to support the legislation under consideration in the House. It is also important that agriculture groups strongly encourage the Senate to move quickly to approve its own version of farm policy.

Without strong support, encouragement and quick action in both Houses of Congress, the ability to provide strong 'safety net' for U.S. agriculture in 2002 could be lost.

The Texas Cooperative Extension (TCE) service has released the "2001 High Plains and Northern Rolling Plains Cotton Harvest-Aide Guide".

The guide provides much of the information necessary for producers to begin the

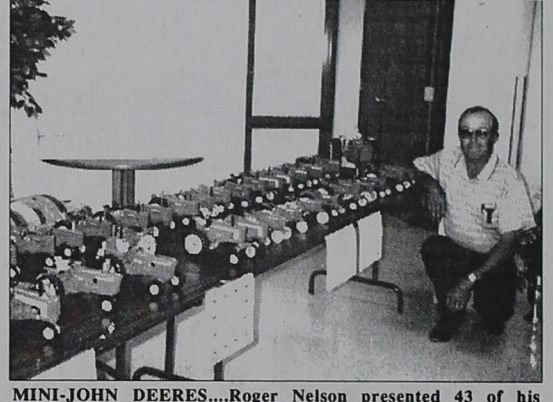

### PROPOSITION 1 (HJR 52)

Proposition 1 would amend the constitution to relinquish the state's claim to certain disputed land in Bastrop County. The amendment would confirm legal title to that land, excluding any mineral interests, to the individuals who hold a disputed title to the land. The amendment would prevent a loss of title by people who bought and paid for property that was never transferred by the state because of faulty surveys.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the clearing of land titles by the release of a state claim of its interest to the owners of certain land in Bastrop County."

### PROPOSITION 2 (SJR 37)

Proposition 2 would amend the constitution to establish the process for issuing up to \$175 million of state general obligation bonds and notes to provide aid to counties for access road projects to serve border colonies. Generally, a colonia is an economically distressed geographic area with inadequate public services (such as water supplies, sewer services, or paved roads) in a county without adequate resources to provide such services. These projects could include the construction of access roads, the acquisition of materials used in maintaining those roads, and projects related to the construction of those roads, such as road drainage. The Texas Transportation Commission, in consultation with the Governor, would be authorized to determine what constitutes a border colony for purposes of selecting the counties and projects that would receive assistance.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the issuance of state general obligation bonds and notes to provide financial assistance to counties for roadway projects to serve border colonies."

### PROPOSITION 3 (SJR 47)

Proposition 3 would amend the constitution to authorize the legislature to exempt green coffee and raw cocoa held in Harris County from property taxes in order to qualify Harris County as an exchange port for coffee by the New York Board of Trade. The authorization of exemption would not apply to any other county.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to exempt from ad valorem taxation raw cocoa and green coffee that is held in Harris County."

### PROPOSITION 4 (HJR 1)

Proposition 4 would amend the constitution by setting the term of the fire fighters' pension commissioner at four years. The constitution currently provides that the duration of all offices not otherwise fixed by the constitution may not exceed two years.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for a four-year term of office for the fire fighters' pension commissioner."

### PROPOSITION 5 (SJR 32)

Proposition 5 would amend the constitution to allow a municipality to donate outdated or surplus equipment, supplies, or other materials used in fighting fires to an underdeveloped country. Current state law does not allow anything of value belonging to the state or its political subdivisions to be donated to another nation.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing municipalities to donate outdated or surplus firefighting equipment or supplies to underdeveloped countries."

### PROPOSITION 6 (HJR 45)

Proposition 6 would amend the constitution to require the governor to call a special session of the legislature so that the legislature can appoint presidential electors when the governor determines that it is reasonably likely that the outcome of the election for a presidential candidate's electors will not be clearly determined in time for the appropriate electors to meet before the federal deadline to cast their votes. Under current law, when the people vote for a particular candidate for president, in reality they are voting for that candidate's electors who will meet to cast their votes for president. If the electors are not determined by the certification date, no electoral votes may be cast for the state. The proposed amendment ensures that the state's electoral votes will be cast.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment requiring the governor to call a special session for the appointment of presidential electors under certain circumstances."

### PROPOSITION 7 (HJR 82)

Proposition 7 would amend the constitution to authorize the Veterans' Land Board to issue and sell up to \$500 million of additional general obligation bonds to finance additional home mortgage loans to veterans. Additionally, the proposed amendment would authorize the Veterans' Land Board to use assets from the land and housing assistance funds to create, operate, and improve veterans' cemeteries.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the Veterans' Land Board to issue up to \$500 million in general obligation bonds payable from the general revenues of the state for veterans' housing assistance and to use assets in certain veterans' land and veterans' housing assistance funds to provide for veterans cemeteries."

### PROPOSITION 8 (HJR 97)

Proposition 8 would amend the constitution to allow the legislature to authorize the Texas Public Finance Authority to issue and sell up to \$850 million of general obligation bonds. The proceeds of the sale of the bonds would pay for construction and repair projects or for the purchase of needed equipment by the General Services Commission, the Texas Youth Commission, the Texas Department of Criminal Justice, the

Texas Department of Mental Health and Mental Retardation, the Parks and Wildlife Department, the adjutant general's department, the Texas School for the Deaf, the Department of Agriculture, the Department of Public Safety, the State Preservation Board, the Texas Department of Health, the Texas Historical Commission, or the Texas School for the Blind and Visually Impaired.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the issuance of up to \$850 million in bonds payable from the general revenues of the state for construction and repair projects and for the purchase of needed equipment."

### PROPOSITION 9 (HJR 47)

Proposition 9 would amend the constitution to authorize the legislature to provide for filling vacancies in the legislature without an election if only one person is a qualified candidate in the election to fill the vacancy. Under current law, a special election must be held to fill a vacancy in the legislature even if there is only one qualified candidate.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the filling of a vacancy in the legislature without an election if a candidate is running unopposed in an election to fill a vacancy."

### PROPOSITION 10 (SJR 6)

Proposition 10 would amend the constitution to authorize the legislature to exempt certain items of personal property from property taxation by political subdivisions of the state if the property is warehoused temporarily in a location in Texas to be assembled, stored, manufactured, processed, fabricated, or repaired and then forwarded to another location inside or outside Texas. The proposed amendment would authorize a political subdivision that imposes ad valorem taxes, at its option, to tax this type of property after a local public hearing on the matter.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to promote equal tax treatment for products produced, acquired, and distributed in the State of Texas by authorizing the legislature to exempt from ad valorem taxation tangible personal property held at certain locations only temporarily for assembling, manufacturing, processing, or other commercial purposes."

### PROPOSITION 11 (HJR 85)

Proposition 11 would amend the constitution to allow a schoolteacher, a retired schoolteacher, or a retired school administrator who serves as a member of a governing body of a school district, city, town, or other local governmental district, including a water district, to receive compensation for serving on such a governing body. Currently, state employees or other individuals who are compensated directly or indirectly from state funds are barred from receiving a salary for such service.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to allow current and retired public school teachers and retired public school administrators to receive compensation for serving on the governing bodies of school districts, cities, towns, or other local governmental districts, including water districts."

### PROPOSITION 12 (HJR 75)

Proposition 12 would amend, repeal, or relocate several sections of the current

constitution to improve the clarity, organization, and consistency of the constitution.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to eliminate obsolete, archaic, redundant, and unnecessary provisions and to clarify, update, and harmonize certain provisions of the Texas Constitution."

### PROPOSITION 13 (SJR 2)

Proposition 13 would amend the constitution to allow the legislature to authorize a board of trustees of an independent school district to donate real property and improvements formerly used as a school campus in order to preserve that property. The board may make the donation if the board determines that the property has historical significance, that the donation will help to preserve the property, and that the school district no longer needs the property for educational purposes.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to authorize the board of trustees of an independent school district to donate certain surplus district property of historical significance in order to preserve the property."

### PROPOSITION 14 (HJR 44)

Proposition 14 would amend the constitution to allow the legislature to authorize a taxing unit, other than a school district, to exempt travel trailers from property taxation as long as the travel trailers are lawfully registered with the state and are not held or used for the production of income.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize the legislature to authorize taxing units other than school districts to exempt from ad valorem taxation travel trailers that are not held or used for the production of income."

### PROPOSITION 15 (SJR 16)

Proposition 15 would amend the constitution to create the Texas Mobility Fund, which would be administered by the Texas Transportation Commission. The Fund would finance the construction, acquisition, and expansion of state highways and would pay a portion of the costs of public toll roads and other public transportation projects. The legislature may reserve specific sources of state revenue for the Fund and may authorize the Commission to guarantee the payment of any obligations or credit agreements with the full faith and credit of the state. The attorney general shall determine the legality of any such obligations or credit agreements.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment creating the Texas Mobility Fund and authorizing grants and loans of money and issuance of obligations for financing the construction, reconstruction, acquisition, operation, and expansion of state highways, turnpikes, toll roads, toll bridges, and other mobility projects."

### PROPOSITION 16 (HJR 5)

Proposition 16 would amend the constitution to reduce the waiting period required for a valid home improvement lien on a homestead from 12 days to 5 days. Currently, a lien may not attach to a homestead for a home improvement loan if the homeowner executed a contract for the improvements less than 12 days after applying for the loan. In addition, the proposed amendment would

authorize the conversion and refinancing of a personal property lien secured by a manufactured home to a lien on a home-stead.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment prescribing requirements for imposing a lien for work and material used in the construction, repair, or renovation of improvements on residential homestead property and including the conversion and refinancing of a personal property lien secured by a manufactured home to a lien on real property as a debt on homestead property protected from a forced sale."

### PROPOSITION 17 (HJR 53)

Proposition 17 would amend the constitution to allow the state to relinquish claim to certain state land and to clear title defects for persons who claim title to those lands. The proposed amendment would apply to land whose owners have disputed title to the land, but for which no patent from the state, giving clear title to the land, was ever issued. Among other requirements, all of the taxes due on the land must have been paid. Under current law, there is no procedure allowing the state to settle title disputes without a constitutional amendment for each piece of land in dispute.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to settle land title disputes between the state and a private party."

### PROPOSITION 18 (SJR 49)

Proposition 18 would amend the constitution to authorize the legislature to create a program to consolidate and standardize the collection, deposit, reporting, and payment of criminal and civil court fees. If the legislature creates such a program, any new fees imposed by the legislature may not take effect before January 1 of the following year, unless an earlier effective date is approved by a vote of two-thirds of the members of each house of the legislature.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to promote uniformity in the collection, deposit, reporting, and remitting of civil and criminal fees."

### PROPOSITION 19 (HJR 81)

Proposition 19 would amend the constitution to allow the Texas Water Development Board to issue up to \$2 billion of additional general obligation bonds. The Board issues bonds to pay for water supply projects, water quality enhancement projects, flood control projects, state participation in water and wastewater facilities, and projects for economically distressed areas. Current law limits the amount of bonds that the Board can issue.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment providing for the issuance of additional general obligation bonds by the Texas Water Development Board in an amount not to exceed \$2 billion."

**Anti-Glare Glasses For Night Driving**

These crystal-clear lenses have an anti-reflective treatment that permits you to see things more clearly and cuts down bothersome reflections and halos from streetlights and automobile headlights, so it is safer to drive at night. The glasses also reduce the amount of eyestrain from TVs, computer screens and other sources.

Anti-reflective glasses require special care. They should be kept in a case when not worn and be cleaned with a special cloth and cleaning solution for best use. The anti-reflective lenses also scratch more easily than regular glasses. Further, dirt or scratches are more noticeable with treated lenses. With the anti-reflective coatings, the lack of glare makes debris on the lenses much more apparent. Ordinary lenses mask dirt and scratches when there is glare so they are less noticeable.

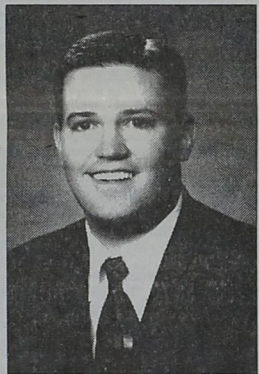

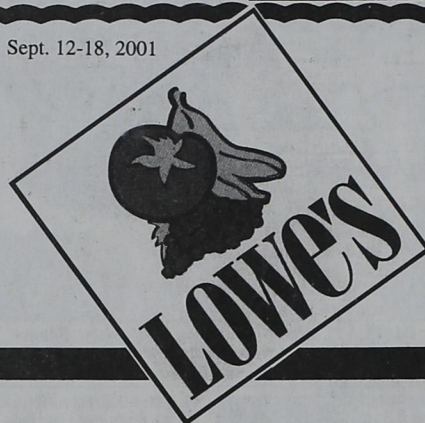
