### Gatesville's Newest Convelescent Home Opens

The Rotunda, new circular-shaped retirement and convalescent facility, made its formal debut to the public in Gatesville Sunday.

The structure was open for public inspection from 1 p.m. until 4 p.m. and greeted scores of interested Coryellites.

Co-owners of the new distinctive rest home are Mr. and Mrs. Delvin E. Marwitz of Evant, Mr. and Mrs. A.K. Arnold of Goldthwaite, and Gary L. Marwitz, administrator.

The facility incorporates every up-to-date advance in retirement home construction and is approved as a Type III nursing home soon to offer Medicare.

Rotunda, located on a large tract at the corner of Osage Road and Lovers Lane, was constructed by Kenneth Brown of Gatesville.

The now 15 member staff of the home is expected to reach 40 employees when the firm gets into full swing.

Mrs. Ted Foote R.N., is director of nurses and Mrs. William Vrendenburg R.N., is assistant director of nurses.

Mrs. Walter Schaub is dietary supervisor and Mrs. Winston Smith is consultant dietician.

The centrally heated and air conditioned home occupies a total of 15,390 square feet of floor space incorporating not only beautiful decor but also most importantly efficient furnishings and safety features.

Patients at Rotunda are able to choose between private and

semi-private accommodations. Among the features found in the 62-bed home are a nurse's call system, nurses stations, examining rooms, therapy rooms, medicine room, dining

and kitchen facilities, a recreational area and a beauty salon.

Safety features include non-skid floors, hand railings and wide halls.

### Patrol Cars Receive New Lights And Sirens



Gatesville's Police Department has aquired new lighting systems and sirens for the patrol cars.

The city equipped the cars in this manner to insure their effectiveness in emergency situations.

Chief of Police, Gene Goins made a special trip to Dallas on Friday 12 to pick up the sirens costing \$87.00. The lighting systems were picked up locally and all equipment was installed by Shephard Motor Company.

Copperas Cove is deciding today whether or not to permit the sale of alcoholic beverages for off premises consumption in the community.

Voting began at 8:00 a.m. and will close at 7:00 p.m. The fire station will be used as in past elections. Estimates are that 1,000 Coveites will help to answer the question this year.

Mr. Bob Royal, Cove realtor, initiated a petition for the election in December and successfully completed the signature campaign prior to the first

Commissioners Court this year.

In pass election on the same issue Coveites have been divided about equally for and against. In last years vote the measure failed by only 379 to 350.

To be eligible to vote a person must have noted in the last gubernatorial election, live in the Cove city limits, be registered for the 1967 election year or not required to register in 1967 because of age being over 60 years.

The absentee voting is termed as very light with only four request for voting forms.

## Navy Man Has Unusual Duty

The Exhibit travels the country displaying 120 original paintings of the U.S. Navy operations. Subjects range from combat art work to Antarctic scenes. The Exhibit is valued at \$300,000 and none of the works can be sold.

Chief Petty Officer Carothers pointed out that the Navy through its mobile exhibit made possible the opportunity for a larger number of people to see and appreciate the works. To date some 40 million people have seen a U.S. Navy Exhibit. The first Naval Exhibit was organized in 1946 and has traveled the country on a year round basis.

The exhibit is presently in Waco at the Lake Air Mall Shopping Center and will be on display through next Friday evening.

Mr. Carothers explained that the exhibit travels from location to location in communities having Naval or Marine Reserve Training Centers. This policy is necessary since the local unit supplies the personnel to maintain the display in each community. Mr. Carothers has complete responsibility for the exhibit, arranges publicity and supervises the exhibit.

Mr. Carothers joined the U.S. Navy in May of 1951 and has traveled the world with the Navy. He accepted his present

post last February.

### Revolving Restaurant reaches Top

Horns blew, sirens screamed and bells rang throughout San Antonio, last week, signifying the completion of the intricate lifting of the 650 ton top house to its perch on the Tower of the Americas.

The massive six-story top house had risen 608 feet in 21 days, and completion put workmen on adddownhill grade towards finishing the tallest observation tower in the western hemisphere for the April 6 opening of HemisFair '68.

The 622-foot tower will offer visitors to the World's Fair a view of 100 miles around the HemisFair city, dining on two levels, and two levels for sight-seeing.

One restaurant will make complete revolution each hour, allowing diners to have their salad on the north side, the main course on the south and wind up with dessert while looking to the north again.

### Don Gladden announces for Lt. Governor



Don Gladden, a Fort Worth attorney, paid his filing fee for this week to become a candidate for Lt. Governor.

Gladden, a four-term member of the Texas Legislature, stated he would carry his campaign directly to the people of Texas, by-passing all special interest and pressure groups.

Gladden further stated that his chief opponents will be the lobby - controlled machine in Austin that tries to hand-pick the elected officials of this

state. The Fort Worth lawyer stated that this machine, opposing his campaign, "are the same people that keep auto insurance rates high; the same people that would do away with our farm road program; in general, they are the people who want to use the government for their own selfish interests.

Gladden, who favors retaining the farm road program and lowering auto insurance rates, stated he considers himself an independent who believes the government should be used for the people and not against them.

## MOHAIR COUNCIL APPROVES LARGER BUDGET

Encouraged by signs that mohair demand is picking up, the Mohair Council of America is approved a \$295,000 budget to allow extra work in product development. Meeting in Sonora, Council members re-elected Dolph Briscoe, Jr. of Uvalde as president. They also named a new vice president, Gail Dudley of Comanche, succeeding Al Dishman of Uvalde. Walter Pfluger of San Angelo was named secretary-treasurer.

The new budget strengthens Council promotion and product development.

Progress was reported in the development of potential new mohair products. Harold P. Faris, President of Prodesco, Inc., Perkasi, Pennsylvania, showed examples of mohair fabrics his firm has developed for the Council in such fields as floor coverings and draperies. In conjunction with Dupont, the firm has also developed a new blend which can be spun on existing equipment to produce a lustrous, lofty yarn for knit goods, blankets and apparel.

"These three things, when they're launched, can pretty

well take care of your mohair problem" he said.

Some of the current year's budget in certain categories is not being used, so the \$25,000 increase for product development does not necessarily mean that much more money spent, said Pfluger. The coming year's budget will allow \$13,000 for promotion, publicity and advertising and \$115,000 for product development. This is more for both categories than in 1967-68. A \$40,000 item spent this year for a mohair use survey will not have to be repeated, allowing more for other work.

An extra \$2,400 was added to the current year's survey budget to allow extension of the survey to England, where a large percentage of Texas mohair has gone in recent years.

A three-man delegation is to leave for South Africa February 1 to study that nation's mohair marketing system, promotion and product development work on the Council's behalf. They are Al Dishman of Uvalde, Armer Earwood of Sonora and James L. Powell of Fort McKavett. They will be gone 26 days.

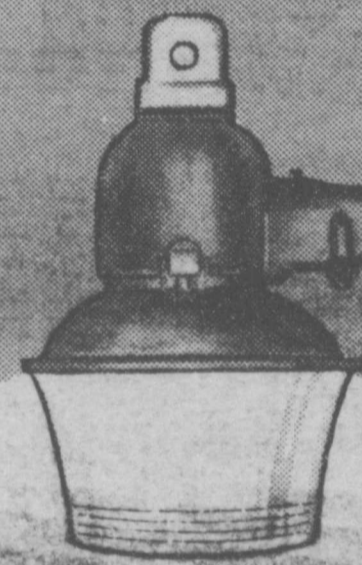

At the morning worship service, Johnnie Evans and L.F. Marshall spoke. Also an all-male choir was featured.

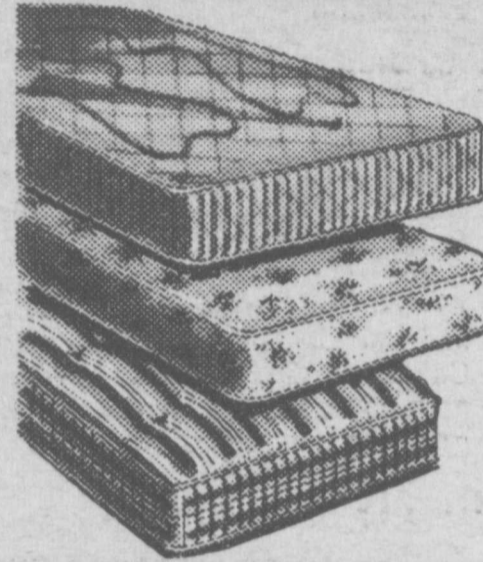

## Governor's Race Has 8 Candidates In Democratic Primary

Political candidates have only a few more days to make up their minds whether they are going to have a share of the action in the slam-bang 1968 races.

Already the governor's column is jammed with impressive Democrats who include former State Rep. Dolph Briscoe, Jr., former Atty. Gen. Waggoner Carr, Secretary of State John Hill, former U.S. Deputy Ambassador to Vietnam, Eugene M. Locke, radion executive Gordon McLendon, insurance executive Pat O'Daniel and Lt. Gv. Preston Smith. Briscoe is from Uvalde, Carr and Smith are from Lubbock, Hill is from Houston, Locke, McLendon and O'Daniel are from Dallas.

Republicans promise a candidate or two for governor--maybe three--in their own primary. Already announced is Dallas Attorney, John Trice.

While the spotlight will be on the Democratic governor's race in the May 4 primary, there will be action in the lieutenant governor's contest also where House Speaker Ben Barnes faces opposition from State Rep. Don Gladden of Fort Worth.

Court races have brought forth the following candidates: For Supreme Court (Place 1): District Judge Sears McGee of Houston and Associate Justice Matt Davis of the Texarkana Court of Civil Appeals. (Place 2): District Judge Tom Reavley of Austin and Chief Justice James G. Denton of the Amarillo Court of Civil Appeals.

For Court of Criminal Appeals: Judge W.A. Morrison, incumbent and State Attorney Leon Douglas of Austin.

**Certification Program moves fast -- Texas Animal Health Commission's crash program for brucellosis certification is picking up steam....before a U S Department of Agriculture regulation makes it impossible to move cattle from uncertified counties out of state. Only 97 of the State's 254 counties remain to be certified.**

In December, the Commission began testing for initial certification in 26 new counties and brought the number in the certification process to 61. To date 36 counties have not started any program.

Federal regulation is expected this year. AHC, in cooperation with USDA animal health authorities, is working toward total certification.

Commission reported that the screwworm epidemic, on the other hand, is well under control. Confirmed cases in Texas dropped from a total of 63 in November to four in December.

**Planning Funds Approved--Governor Connally has approved \$36,000 in grants in 23 counties to aid regional planning by local governments.**

Largest grant, \$22,000, went to the North Central Texas Regional Planning Commission for support of its work program in Collin, Dallas, Denton, Ellis, Johnson, Kaufman, Parker, Rockwall, Tarrant and Wise Counties.

A grant of \$7,500 went to the West Central Texas Council of Governments, made up of Brown, Callahan, Coleman, Eastland, Fisher, Haskell, Jones, Kent, Knox, Mitchell,

Nolan, Runnels, Shackelford, Stephens, Taylor and Throckmorton Counties.

Nortex Regional Planning Commission received a \$6,500 grant for regional planning programs in Archer, Clay and Wichita Counties.

Industrial Award proposed--Until February 5, Texas Industrial Commission is accepting nominations for "The Governor's 1967 Industrial Expansion Award." Nominees should be 1966 manufacturing concerns that expanded in 1967 to the economic benefit of the community at large.

Another point may be won by showing that the nominees contributed to civic and community development in 1967. Award will be presented during the Governor's Conference on Industrial Expansion in Austin's Municipal Auditorium on April 3.

**Parks / Wildlife budget -- Texas Parks and Wildlife Department is proposing a \$22,000,000 budget for the year beginning Sept. 1, 1968.**

That would be a \$7,000,000 increase over the current appropriation and would cover renovation of Fort Leaton in Presidio County, McKavett near Menard, Lancaster near Ozona, Griffin near Albany, Concho at San Angelo and Richardson near Jacksboro, as well as \$2,000,000 for wildlife management area land acquisition.

State files vacancy suit--Atty. Gen. Crawford C. Martin filed suit for the state seeking to recover as much as \$262,000,000 and as many as 315 oil or gas wells if Walter C. Atchley succeeds in his vacancy suit against State Land Commissioner Jerry Sadler.

Atchley filed in the 36th District Court in Sinton to establish that a tract of oil and gas-rich land in the Weider Ranch area is really vacant school land. He filed after the Land Commissioner turned down his vacancy claim.

Martin now is going a step further by filing the petition to intervene. He says he agrees with Atchley, but if he is wrong, and the tract he filed on is not vacant, another is, and the state should recover oil and gas production from the contested area since drilling began in 1942.

Courts speaks -- State Supreme Courts will hear arguments March 13 by Franklin County landowners to abolish the local water district. Also the application for release sought by a Fort Worth man sentenced for contempt of court in a workmen's compensation case.

Same court upheld the right of a city to regulate the sale of liquor and beer within its boundaries when it refused an Amarillo distributor's appeal of a Liquor Control Board license denial.

High court upheld \$11,289 default judgment won by a former Central Airlines President in a suit for vacation time compensation.

By a divided vote, the Court also reversed and sent back to trial courts a Hidalgo County man's suit to establish royalty rights on an oil lease. Lower courts had held against the claim of W.R. Montgomery.

In a cigarette tax counterfeiting case the Court of Criminal Appeals has upheld the 7

year sentence of Mair J. Schepps, Houston tobacconist.

Medical / Dental Schools needed--at least one and maybe two new medical and dental schools should be authorized by the Legislature next year, according to the Legislative Budget Board.

Higher Education Commissioner Jack K. Williams reported need for one new institution in each category.

Lt Gov. Preston Smith said at least two each should be authorized.

Higher Education Coordinating Board has favored putting a medical school in Houston and a Dental school in Dallas. Texas Dental Association favors San Antonio for the dental school since a medical school already is there.

Appointments Announced -- Atty. Gen. Crawford Martin has designated A.J. Carubbi, Jr., formerly of Galveston County and Pampa, as his executive assistant.

Gov. John Connally has elevated B.G. Allen of Hamilton from acting director to director of the Texas Office of Economic Opportunity.

Connally also announced appointment of D.O. Tomlin of Fort Worth to the Texas Air Control Board. And to the Coastal Industrial Water Authority Board, Robert C. Lanier of Harris County, George Henscey of Lively County and John G. Jennings of Chambers County.

Brownsville businessman, Manuel A. Sanchez III is the State Republican Party's new assistant deputy state chairman for Region III (South Texas).

Robert Nail of Albany has been named chairman of general arrangements for a governor's conference on the arts set for Austin on March 31-April 2.

William Allan Robinson of Austin has been named by the governor as supervising art director for the art exhibit and cultural activities display in the Institute of Texan Cultures at HemisFair '68.

LCB/DPS Merger proposed--Former Attorney General Waggoner Carr, now a candidate for governor, suggest merging the Texas Liquor Control Board with the State Department of

Public Safety.

In speaking at a Junior Chamber of Commerce banquet here, Carr said he leared to respect the LCB and its agents when he was an assistant county attorney in Lubbock with the job of helping to enforce liquor laws. Carr says LCB agents are the "step-child" of other law enforcement agencies and are paid less than other officers. He contends they need higher pay and better state transportation and this could be accomplished by merging the two agencies.
