BOLSHEVIK READY TO SURRENDER

BOLSHEVIK TERMED ENEMIES DEMOCRACY BY BRITISH LEADER

ADDRESS IS DELIVERED BEFORE BAR ASSOCIATION AT ST. LOUIS.

ENDEAVOR TO ESTABLISH PROLETARIAT IS CHARGE

Declares Great Britain and United States Are Co-Trustees For Humanity.

ST. LOUIS, Aug. 25.—The bolshevik were pictured as enemies of democracy, of Lincoln's ideal of government, of the people, by the people, in an address by Sir Auckland Geddes, delivered before the American Bar Association's annual convention here today.

The British ambassador declared that the bolshevik were the real reactionaries endeavoring to establish a privileged class called the proletariat; to force on society a great idea, regardless of whether society wanted it.

Sir Auckland declared that Great Britain and the United States "are co-trustees for humanity, that the theory and practice of democracy shall not suffer distortion or annihilation in spite of avalanches of assault loosed upon it by its enemies."

"If the idea is to continue without a serious setback," he said, "we people believe in it will have to stand firmly together, for there are powerful forces opposed to it. So far as we know, the millions of Asia have opposed the idea throughout all their history, although a small number of Asiatics are now loud in their support."

Lead to inequality. "Theocracy and autocracy, forceful application of the law, inevitably lead to inequality before the law and so to tyranny, revolution and chaos. That way lies no hope. Let the bolshevik and their supporters in all lands prate as they will of reactionaries and imperialists. They themselves are the reactionaries. Their admitted doctrine is to establish a privileged class which they call the proletariat, but they mean by that term a select body of men who are to rule over the rest of the world."

"Whatever difficulties might arise between our people, nothing is more important than that you and we stand together to defend the hard-won hope of mankind that through the aid of the people, their own disciplining, man will at last escape from the toils that have snared the feet of his ancestors and will have a great future in the solution of the problem of how he shall live in communities in peace and ordered freedom."

AMBASSADOR DAVIS DENIES REPORT THAT HE PLANS TO RESIGN

NEW YORK, Aug. 25.—John W. Davis, ambassador to Great Britain, accompanied by Mrs. Davis and his daughter, arrived here today on the steamship Olympian to spend two months in the United States.

The body of William K. Vanderbilt, who died in Paris, was brought back to the Olympian. Mr. Davis denied reports current in Washington that he would not return to his post in London after his vacation.

REPORT IS CIRCULATED AROUND THE CAPITAL

WASHINGTON, Aug. 25.—Reports that John W. Davis, American ambassador to Great Britain, who arrived today at New York, would not return to the court of St. James, were current here today.

Some of the ambassador's friends credited the report that he had decided to resign. The post at London is known as the most expensive of all the American diplomatic stations, and in the past has been a drain on the private resources of the men who hold it. Mr. Davis has determined to resign, his friends say this probably was his chief reason for wishing to retire to private life.

PROMISE IS MADE TO PREMIER GIOLITTI BY PREMIER LLOYD GEORGE.

D'ANNUNZIO PROPOSAL RECEIVES ENDORSEMENT

Italian Socialist Party Also Said To Have Approved The Plan As Outlined.

LONDON, August 25.—Premier Lloyd George, during his conference with Premier Giolitti at Lucerne, promised Great Britain would recognize the new free state of Fiume as proposed by Gabriele D'Annunzio, says a Central News dispatch from Rome, quoting Lucerne advices to the Idea Nazionale.

SAYS ITALY ENTERED THE WAR TOO SOON

LUCERNE, SWITZERLAND, August 25.—Premier Giolitti of Italy, before departing today for Rome, after his conference here with Premier Lloyd George, told the correspondent that he was still convinced Italy entered the war too soon and should have entered the same time as America.

Relative to the conference, the Italian premier said there was in perfect accord with Premier Lloyd George on European problems. When the correspondent asked about the D'Annunzio plan, he said, "Oh, don't ask me about a mad man."

BERLIN COMMENTS ON RESULT OF CONFERENCE

BERLIN, August 25.—Commenting on decisions reached at Lucerne by Premier Lloyd George and Giolitti, the Tagesspiegel declared England and Italy have "sung into line with France."

The altered Anglo-Italian attitude, says the independent socialist organ, Freiheit, was "lost dictated by concern for the inevitable internal weakening of the soviet government, which raises fresh hopes of overthrowing the entire bolshevik regime."

"We have to maintain the heritage of freedom, freedom from within and without, the priceless heritage of a great idea now in danger from a popularly elected government which is to conceal their actions behind its phrases."

LEROY IS CAPTURED ABOARD THE BRITISH FREIGHTER "DRYDEN"

PLACED UNDER ARREST ON ARRIVAL OF VESSEL AT RIO JANEIRO TUESDAY.

HAD SAILED RECENTLY AS MEMBER OF CREW

Under Guard Of Marine Police Will Be Returned to the Officials Of Detroit.

RIO JANEIRO, Aug. 24.—Eugene Leroy, wanted by the police of Detroit, Mich., in connection with the murder of a woman supposed to be his wife, was arrested on board the British freighter Dryden, which arrived here late this afternoon.

Leroy was placed under arrest at the request of United States authorities here, and while the Dryden is in port will be guarded by four members of the maritime police. The ship will proceed to Buenos Aires and from there will sail for New York, where Leroy will be turned over to officers from Detroit.

The "trunk murder" mystery has ramifications which extend from New York to Michigan, Mississippi and Alabama. A few minutes after an employe of the American Railway Express company here had discovered the nude and mutilated body of a young woman in a trunk stored in the unloading baggage warehouse, police of New York and Detroit began following the train of evidence which led to the victim's identification as Mrs. Katherine Lou Jackson of Sturris, Miss., and the location of A. A. Tatum, whose name and a Detroit address were found marked on the trunk which concealed the crime for more than a month.

At 105 Harper street, Detroit, Tatum was unknown, but someone there told detectives that a young couple known as Mr. and Mrs. E. Leroy had disappeared from that address about June 16, the date on which the trunk was shipped to New York.

The publicity given these two names, Leroy and Tatum, brought forward Andrew J. Hines, New York expressman, who said he knew Leroy under the name of Fernandez. He told the police he had handled a trunk for Fernandez on the trunk which contained a check for the trunk in which the body was later found. Leroy that it be removed from the express warehouse and stored by Braniff until Leroy should call for it.

Body Identified. A Detroit policeman, Leo Trumbull, then came to the front, declaring that he and his wife knew the young woman who lived with Leroy at the Harper avenue address. When the body of the murdered woman arrived in Detroit, Trumbull and his wife identified it as that of Katherine Lou Jackson.

The town was too small for Kitty Lou and she went away, Jackson said, when asked to tell what he knew of his wife's disappearance. Next Tatum, the man whose name appeared on the mysterious trunk, walked into police headquarters at Birmingham, Ala., and explained his connection with the case.

He told the authorities that he had known Mrs. Jackson in Birmingham, where he works as a linotype operator. At her invitation, he said, he visited her in Detroit, where she told him she had married Leroy and that he was "terribly jealous. Shortly afterward Tatum said, he returned to Birmingham. He declared that the next he heard of the woman was when he read of the discovery of her body.

Reports have poured in from every quarter of the continent indicating that Leroy had been seen in this or that place. A \$5,000 reward offered by the police of Detroit stimulated the search for him. He was reported variously as appearing in Canada, hiding in Mexico, sailing for Brazil and the Bahamas and under arrest in Chicago.

SAILED FROM NEW YORK ON AUGUST THIRTEENTH

NEW YORK, Aug. 25.—The British freighter upon which Eugene Leroy was arrested yesterday at Rio de Janeiro, in connection with the trunk murder mystery, sailed from New York on August 13, ten days after the body of his supposed wife was found jammed in the trunk at a local warehouse.

SUFFRAGISTS HOPE FOR PROCLAMATION TODAY

Official Notice Of Tennessee Vote Was Expected To Reach Secretary Colby.

WASHINGTON, Aug. 25.—Justice Siders of the district supreme court denied today an anti-suffrage application for a restraining order to prevent promulgation of the federal suffrage amendment by the state department.

The application was filed by counsel for the American Constitutional League and Justice Siders' ruling sustains that of Justice Bailey of the same court last month in rejecting a similar application by the same organization.

The taking of a temporary injunction, the justice said, would be unwarranted interference with a purely administrative act of the secretary of state. Dismissal of the proceedings leaves the way open for the appeal to the District of Columbia court of appeals.

WASHINGTON, Aug. 25.—Suffragists today were hopeful that before evening the state department would issue a proclamation formally announcing the ratification of the federal suffrage amendment by enough states to make it effective.

Official notification that the amendment had been ratified, having failed to prevent by court action certification of Tennessee's ratification, would apply to the District of Columbia supreme court for an order restraining Secretary Colby from issuing the proclamation.

Secretary Colby recently announced he was prepared to issue the suffrage proclamation as soon as he received official word of Tennessee's action.

In some quarters it was predicted that anti-suffragists, having failed to prevent by court action certification of Tennessee's ratification, would apply to the District of Columbia supreme court for an order restraining Secretary Colby from issuing the proclamation.

DECLARES RATIFICATION NOT PROPERLY CERTIFIED

DECATUR, ALA., Aug. 25.—Ratification of the woman suffrage amendment by the state of Tennessee has not been properly certified to Secretary of State Colby, according to Representative Robert Roberts, leader of the insurgent legislators, who have come here to break the quorum in the Tennessee house.

Mr. Roberts declared that Governor Roberts had merely certified a copy of the house journal. The legal requirements, he stated, had not been complied with and the document sent to Washington by the governor will not be sufficient to warrant a proclamation from the office of the secretary of state.

ONLY 45 MEMBERS OF HOUSE ARE PRESENT

NASHVILLE, TENN., Aug. 25.—Only 45 of the 99 members of the Tennessee house of representatives were present when the house met today and adjournment until tomorrow afternoon was taken. No announcement was made as to when the members who left the state to break a quorum would return.

LOLD MAYOR TO BE PERMITTED TO STARVE SAYS LLOYD GEORGE

BRITISH GOVERNMENT TO MAKE NO EXCEPTION IN CASE OF MACSWEENEY.

SINN FEIN THREATEN ALL THOSE IMPLICATED

Will Condemn to Death Those Held Responsible In Event of Death Of Lord Mayor.

LUCERNE, SWITZERLAND, Aug. 25.—The British government will not except Lord Mayor MacSweeney from the rule that Irish hunger strikers must be permitted to starve if they refuse to eat, Premier Lloyd George declared today in a telegram to MacSweeney's sister.

"I regret to hear of the pain inflicted on you by your brother's determination to starve, but it is impossible for the government to make an exception in his case," the message said.

WILL CONDEMN TO DEATH THOSE HELD RESPONSIBLE. LONDON, Aug. 25.—Sinn Fein officials who have never failed to carry out the sentences imposed by their courts, will cooperate to death all persons implicated in the expected death of Terence MacSweeney, lord mayor of Cork, they declared today.

"I hold you responsible, who they regarded as responsible, the officials informed that Premier Lloyd George and members of his cabinet "are liable" for the death of the lord mayor.

Starve Sends Telegram. Mary, the widow of the lord mayor, has telegraphed Lloyd George in Lucerne, declaring that her brother's relatives and the people of Ireland will hold you responsible in the event of his death.

The lady weavers visited her husband last night, MacSweeney said, and he was allowed to "take a long look" at her, as "I may not see you the next time." "Terence was terribly weak and his eyes were clouded but he told me he would not regret death if it were helpful to Ireland," Mrs. MacSweeney told her sister.

A thousand former soldiers gathered outside the prison last night and staged a demonstration for MacSweeney's release.

SUGGEST A TRUCE BETWEEN IRISH FACTIONS

DUBLIN, Aug. 25.—Resolutions suggesting a truce between opposing Irish factions and declaring it was "possible for the British government to secure peace in Ireland by an immediate and binding offer of full national self-government, to be accepted or rejected by specially elected representatives of the people of Ireland," were adopted today at the conference of Irish moderates. The meeting was marked by fiery oratory on the part of several speakers, but there was no disorder.

MINE WORKERS MEET TO DECIDE ON SCALE

KANSAS CITY, Aug. 25.—Officials of the United Mine Workers of America from Kansas, Missouri and Arkansas, representing Districts 14, 21 and 25, met here today to decide the amount of a wage increase which they plan to demand.

A new wage scale for monthly and day workers is the business of the meeting. According to Alexander Howell, president of District 14, the increase asked will be approximately \$1.50 a day.

MACSWEENEY WAS STILL CONSCIOUS THIS MORNING

LONDON, August 25.—Terence MacSweeney, lord mayor of Cork, who has been on a hunger strike in prison here since being removed to this city from Cork, and whose condition has given rise to grave apprehensions, was still conscious this morning. Apparently, however, his condition was considered critical, his father, Dominick, his private chaplain, administered the last sacrament.

RUMORS OF PLOT TO KIDNAP AMERICANS

Take Precautions To Protect Congressmen Who Are Touring The Orient.

HONOLULU, Aug. 25.—Rumors of Korean plots to kidnap the American congressmen touring the Orient have caused the governor general of Korea to order out the entire gendarmerie of Seoul and five battalions of troops to guard the hotel houses in which the visitors will stay, according to a Tokio cable to the Nippo Jiji, Japanese language paper here.

NEGOTIATIONS ARE BEGUN BY THE ARMY OR NORTHERN RUSSIA ACCORDING TO VIENNA DISPATCH

PARIS, Aug. 25.—Negotiations looking to surrender to the Poles have been begun by the northern Russian bolshevik army, according to a Vienna dispatch received here.

LONDON, Aug. 25.—Poland's reply to the peace terms presented by the Russian soviet delegation at Minsk amounts to a flat rejection, says the Manchester Guardian's Minsk correspondent in a wireless dispatch filed in this city on Monday.

"Out of the 15 Russian demands," he continued, "only one, that relative to demobilization, is accepted, and that only on condition that the Poles will accept a similar course—that is to say, Russia must demobilize at the same time Poland abandons her forces."

The terms relative to disarmament, the closing of munitions plants and the delivery of munitions to Russia by Poland are indignantly rejected.

BOARD SUGGESTED TO ESTABLISH BOUNDARY

THORN, EAST PRUSSIA, Aug. 25.—Order officers in the Polish army expressed the opinion here today that the event of a decisive victory over soviet Russia along the entire front would be inadvisable to pursue the head-on advance toward the Baltic coast. One declared, however, that war between Poland and soviet Russia would be inevitable.

Military officials variously estimate the number of bolshevik caught in the Polish corridor by the capture of Minsk at between 10,000 and 15,000.

The Poles say the Russians are not equipped for a winter campaign and draw attention to prisoners who have been arriving barefoot and in very scant attire. There are reports, however, that the Russians are well supplied with gold and silver, and that the prisoners are divested of most of their garments by their Polish captors.

The Poles appear to be extremely anxious toward Germany, particularly East Prussians. The Germans are charged with seeking to aid the soviet forces by giving them ammunition and arms.

WARSAW IS CAPTURED BY POLISH TROOPS

WARSAW, Aug. 25.—Kolin, an important town near the east Prussian frontier north of Lomza, has been taken by Polish forces which have been sweeping rapidly northward in pursuit of the retreating bolsheviks. More than ten thousand prisoners who were cut off from the main body of the soviet army have been captured in this region.

Reports from various fronts, particularly the northern sectors of the line, indicate the bolshevik are demoralized and fleeing everywhere in a hasty order. General Solonowski, minister of war, has issued a statement to Polish newspapers, declaring that the soviet army has been broken and that everywhere, adding that of 250,000 bolshevik troops participating in the offensive for the capture of Warsaw, only 100,000 have been captured.

Two Cossack regiments have crossed into east Prussia north of Minsk and are expected today to be ordered to escape capture, according to an announcement by military authorities and there are indications that soviet infantry units numbering many thousands of men, have also taken flight across the frontier at various points.

EXPECT TO DECIDE IN 48 HOURS WHETHER MOST OF EUROPE WILL AGAIN BECOME INVOLVED IN WAR

LONDON, Aug. 25.—Whether most of Europe will again be involved in war is expected to be decided within 48 hours.

Russia has until Friday evening, to reply to the Anglo-American offer of a modification of her peace terms to Poland, Premier Lloyd George has informed the bolshevik through Arthur Balfour, lord president of the council that unless a satisfactory reply is forthcoming within the time limit, Great Britain will change its policy toward Russia.

CHARGE BRITISH ARE AIDING DEMOCRATS

Republican Congressman Makes Statement at National Headquarters.

CHICAGO, Aug. 25.—Charges that the British government is helping finance the campaign of Governor Cox are made in a statement appropriated at Republican national headquarters here.

Referring to the senate committee investigation of campaign expenditures, Mr. Britten says: "The pending investigation will show that the British parliament appropriated \$1,000,000 for the purpose of the British ambassador at Washington for entertainment purposes and that this fund has already found its way to the democratic national committee, where it no doubt will be followed by 10 times that amount, should it be made evident that the new disciple of Wilson can win with money rather than on honest issues."

DECLARES THAT REPORT IS PERFECTLY ABSURD

ST. LOUIS, Aug. 25.—Charges of Congressman Britten of Illinois, that the British government appropriated \$1,000,000 to be expended by the British ambassador at Washington for "entertainment purposes" in furthering the democratic campaign, were declared to be "perfectly absurd" by Sir Auckland Geddes, British ambassador, today, who is here attending the convention of the American Bar Association.

"The British government has not made any contribution of any sort, not any party in any state, for any purpose," Sir Auckland said. "The only fund of \$1,000,000 which the British government has appropriated is for the fund covering the expenses of myself and 10 other persons connected with the embassy. The amount of that fund is \$100,000 a year for each person and as prices now are it is an insufficient amount."

INCREASED RATES ON RAILROADS EFFECTIVE MIDNIGHT TONIGHT

FEW HURRY UP TRIPS BUT NO RUSH IS REPORTED AT UNION STATION.

FREIGHT INCREASE IS SMALL PER ARTICLE

Estimated That Added Cost To Pair Of Shoes Is Less Than Two Cents.

At 12 o'clock Wednesday night the new interstate passenger and interstate freight rates will go into effect and as a result, the man who boards a train with destination in another state will find a substantial increase in the cost of the ticket.

The freight increase affects all freight shipments, but when figured down to the increase on cost of one article it is a very small matter.

The following table regarding a cartload of shoes, 200 in number, weighing 100 pounds gross, shows what the increase would be shipped from Quincy, Ill., to Wichita Falls.

Old rate, \$1.25 per cartload.
New rate, \$1.42 per cartload.
Increase, 17 per cent.

Shoes weighing 25 pounds—increased 25 cents.

The old rate on a case of clothing containing twenty suits from St. Louis to this city was \$1.34 for 2 lbs. per suit. The new rate will be \$2.18 or 12 1/2 cents per suit, an increase of 63 per cent.

The increase on a pair of shoes sent in a box containing four dozen pairs from St. Louis to this city will amount to 1 1/2 to 100 per cent.

These statistics indicate that the new freight rate increase will add but a very small amount to the price paid by the retail dealer and will amount to a very small increase for the average shipper.

Railroad officials state, however, that this small increase will mean a lot to the railroads and they are of the belief that after the new rates have been in effect for at least a half a year that the increased revenue will permit them to put on more motive power and more cars and thereby greatly benefit the public by being able to give more prompt service in shipment, the delay of which they contend help to bring up the cost of nearly every commodity.

FIND BODY OF MAN ON HOLLIDAY ROAD ACCIDENTALLY SHOT

WAS SITTING AT WHEEL OF AUTOMOBILE WHEN DISCOVERY IS MADE.

HAD GONE OUT ON FEW HOURS HUNTING TRIP

Believed Rifle Was Discharged By Joint Of Car While Driving Along Road.

Kissing his wife and two babies goodbye Tuesday evening, promising to bring "baby a rabbit skin," James W. Duffy, an oil man residing at Call Field, went happily on his way for a few hours' hunting trip. This was about 8 o'clock in the evening and at 11 o'clock three oil men traveling on the Holliday road, eight miles from town, found him dead in his automobile.

J. H. Barnett, W. H. Keesh and T. C. Stockton, the three men who discovered the dead body were traveling home, on the road about eight miles from Wichita Falls, they saw a car standing still as they approached, in a position which partially blocked traffic on the road. As they neared they saw a man sitting at the wheel with his head hanging down between the steering wheel and the left door of the car.

Motor Was Running. They stopped and approached the car, calling. But there was no response. A hasty examination showed that the man was dead. The motor of the car was running but the brakes were set. In the bottom of the car were two rabbits. A 22-caliber rifle was standing in front leaning against the seat. There was no bullet in the rifle chamber and no empty cartridge. The three men jumped into the automobile and made a flying trip to Wichita Falls, reporting at the police station. Justice of the Peace R. V. Quinn was called to hold an inquest. The three men who discovered the body testified at the inquest.

The justice of the peace is of the opinion that the man was dead perhaps a half hour when the discovery was made and is also of the opinion that the accident, which resulted in his death, occurred a half hour before the man died.

Discharged at Close Range. Examination of the body at the undertaking parlors showed that a bullet had entered the right chest just below the nipple and came out between the shoulders near the left shoulder blade. The body and the man's shirt where the bullet entered were badly burned by powder, which was fired at very close range. The verdict was that death was accidental and resulted from an internal hemorrhage caused by the severing of an artery. The bullet did not pierce the heart.

CHICAGO MAN IS KILLED IN FORT WORTH TUESDAY

FORT WORTH, TEXAS, Aug. 23.—Richard Parrant, linotype operator for the Fort Worth Record, was under \$2,500 bond, following the death last night of Nicholas C. Dias, 35, Chicago, who was shot late yesterday. Parrant recently married the divorced wife of Dias, authorities declared. The shooting occurred after Dias appeared at the Record building and asked to see Parrant. The latter surrendered following the shooting, police announced.

OUTLOOK AUSPICIOUS SAYS RESERVE BANK

Inflation Of Credit, However, Will Prevent Radical Expansion Of Industry.

DALLAS, August 23.—The outlook throughout the eleventh federal reserve district generally is auspicious, but the present inflation of credit makes it certain that the margin of surplus income from production this year will not be sufficient to support any radical expansion of industry and commerce in the form of new enterprises in 1921, according to the monthly review made public today by the Federal Reserve bank of Dallas. The Dallas Federal Reserve bank's loans to member banks are two-thirds larger than they were a year ago, and the district is drawing extensively upon the surplus funds of other sections, says the statement. That condition was brought about "despite high rates, and every reasonable restriction that the bankers could impose." It is pointed out.

As a result liquidation during the coming fall months should be and is expected to be heavy, according to the review, except in those sections where cotton is being heavily damaged by weevils, worms or grasshoppers, and in certain parts of the extreme western section of the eleventh federal reserve district where weather and market conditions have not been favorable to the cattle and sheep industry.

The extent of general liquidation this fall will depend largely upon the average price commanded by the 1920 cotton crop and the growers' ability to hold in check during the next few weeks the ravages of insects resulting from recent excessive rains, the review indicates.

Under the head of "favorable" indications the review lists: Further improvement in the condition of crops and ranges; increase in volume of wholesale and retail trade; increase in building activity; increase in farm granaries for the storage of wheat awaiting shipment, and an improved movement and supply of freight cars.

On the other hand these developments are listed as "unfavorable": excessive rains in the cotton belt, conducive to depredations of insects; further inflation of credit; increase in business failures; depression in demand for products of the livestock industry and shortage of labor for harvesting cotton.

Regarding the cotton crop, the district's chief reliance for the payment of its obligations, the review says a wonderful response was shown to the best July weather in several years, thus "insuring a fairly abundant and well distributed inflow of new money to enliven fall trade and liquidate fall maturities." The present price of cotton, which is practically level with quotations a year ago, is so close to the 1920 cost line that it is believed, continues the review, that any further decline of substantial proportions, however, would seriously impair the district's ability to show a favorable result on the year's balance sheet.

In Texas during July the grain crops were favored by sufficient moisture for those still growing and sufficient sunshine and dry weather for threshing operations in the case of those ready for harvesting. Rice and cane made good progress and a large and profitable melon crop was produced. Feed crops, late corn and sweet potatoes are in healthy condition.

Early August reports from Arizona and New Mexico show a continuance of favorable crop conditions in the irrigated districts, although a need of rain was beginning to be felt in the dry lands west of the Rio Grande. In southern Oklahoma good progress was registered by all crops and plowing for fall seeding is under way with the soil in excellent condition.

The estimated yields of the eleventh federal reserve district crops for 1920 are: Corn, 260,000,000 bushels; wheat, 25,000,000 bushels; oats, 20,000,000 bushels; and cotton, 2,500,000 bales.

The quality and quantity of the season's calf crop is perhaps the most conspicuous feature of the generally favorable situation in the livestock industry, says the review, with livestock in prime condition everywhere. The ranges, except that portion west of the Rio Grande river, are described as in fine condition. Packer's demands in July were not sufficient to absorb the cattle offerings from over the district, however, particularly from south Texas and many cars of desirable stuff were diverted to northern points. In the stocker division trade was extremely sluggish and the best price for good stocker cows on the Fort Worth mar-

ket was \$6.50 or \$1.50 less than the June top. The hog and sheep market displayed a brisk demand throughout July, due largely to light receipts. Production from eleventh district oil wells increased approximately 150,000 barrels in July over June, although the district's daily average decreased 7,422 barrels. Decreases in daily rate of production and total yield for the month were registered in the fields of north Texas and north Louisiana, the latter showing a loss of 204,125 barrels in total runs for the month. Substantial gains were scored in central west Texas and the Gulf coast fields.

Attention in July readily centered on the West Columbia field on the Gulf coast, says the review, a higher introduction in the latter part of the month, maintaining a daily flow of 25,000 barrels, at the rate of \$50,000 worth of oil a week. July completions showed a greatly enlarged drilling activity in all fields by contrast with the preceding month. The ratio of producers to failures also was more satisfactory.

For the district as a whole 868 wells were completed, compared with 620 in June. The proving up of the Rising star field and the further enlargement of the productive area around Brookridge were among the notable drilling developments of the month. The increased volume of orders booked in July by wholesale dealers in dry goods, hardware, drugs and automobile supplies, as reported to the federal reserve bank by correspondent firms was taken as an indication that retailers were beginning to lay in stocks for the fall trade, with the wholesale apparel trade showing symptoms of renewed strength following a dull summer season. Reports from retail buyers showed larger sales and better deliveries in July than in June. Prices were higher but it also was indicated there was more buying.

PLAN TO PRESERVE THE JEFFERSON DAVIS HOME. MONTGOMERY, ALA., Aug. 23.—An announcement was made today that negotiations were under way for the purchase of a site to which it is proposed to move and preserve the home here of Jefferson Davis, the only president of the Confederate States of America. Negotiations for the purchase of the site are being conducted by the First White House of the Confederacy commission, composed largely of Montgomery women. Governor Killey has advised the commission that he will sign a warrant for \$25,000, authorized by the state legislature for the purchase and removal of the building, as soon as the site is secured.

ROCKWALL MAN DIES RESULT OF ACCIDENT

FORT WORTH, TEXAS, Aug. 23.—Joseph B. Tucker, 26, died this morning as the result of injuries sustained yesterday when hit by a motor truck. He is the second aged man killed here in twenty-four hours by motor trucks. His home was at Rockwall.

WOMEN ORGANIZE A LOCAL BAILEY CLUB

Officers Are Elected and Committee Named—To Conduct Active Campaign.

Women of Wichita Falls, interested in the campaign of former Senator Bailey for the governorship, met at the home of G. Clint Wood Tuesday evening and organized the Wichita County Women's Bailey Club. Attending the meeting were a considerable number of ladies who have in past years taken an active part in civic affairs. Many of the ladies were accompanied to the meeting by their husbands, but the men folks were relegated to the gallery to enjoy their cigars, while the meeting was placed squarely in the hands of the women themselves.

As the meeting had been arranged on the suggestion of the husbands, however, Mr. Kell opened the session and in a few words outlined the very valuable work that the women could do in the campaign through organization and individual effort.

Temporary organization was perfected with Mrs. H. F. Weidon as chairman and Mrs. Luther Hoffman as secretary.

Permanent officers were later chosen, resulting in the selection of Mrs. W. W. Cooke as president; Mrs. M. McGreggor, vice president; and Mrs. V. H. Shepherd, secretary.

The president appointed as an advisory committee to have direct charge of the work of the campaign: Messrs. James H. F. Weidon, E. Spencer, Wm. McGreggor, V. H. Shepherd, Frank Kell, Bentley Bacon, Luther Hoffman, Orville Bullington, R. S. Allen, Mrs. Cooke will be ex-officio chairman of this committee.

How Old Is Mr. Pat Neff?

If He Had Not Passed His Forty-Sixth Birthday on September 12th, 1918. (the day set for registration), He Was Subject to the Draft Law.

Here is an excerpt from Section 3 of the Draft Act approved August 31, 1918:

"Persons shall be subject to registration as herein provided, who shall have attained their eighteenth birthday and who shall not have attained their forty-sixth birthday on or before the day set for registration."

If Pat Neff was born any time after September 12, 1872, he was subject to Registration and the Draft.

HE DID NOT REGISTER

HERE IS SOME OF THE EVIDENCE UPON THE ISSUE OF HIS AGE:

(1) The law requires the Tax Collector or his deputy to swear a voter with respect to his age when he issues a poll tax receipt. Here are true copies of Neff's poll tax receipts issued December 31st, 1918, and January 10, 1920:

The said taxpayer, being duly sworn by me, says he is 46 years old; that he resides in voting precinct No. 2, in McLennan County; that his race is white; that he has resided in Texas forty-six years; that he is by occupation lawyer; that he resides at No. 2110 on Austin street in the second ward and has resided in the city of Waco for the past twenty-five years. All of which I certify.

Neff, as shown by said record.

The above shows that on January 10th, 1920, Neff swore that he was then 47 years of age. His nearest birthday then was November 26th, 1919, and if the affidavit is correct it would fix his birth date as November 26, 1872.

(2) During February, 1920, Neff circulated at Hillsboro a campaign card. On one side of this card appeared his picture and the following: "Pat M. Neff, of Waco, Texas, candidate for Governor, subject to Democratic Primary July 1920. Over" On the other side of the card was a personal sketch, the opening sentence of which reads as follows: "Pat M. Neff IS A NATIVE TEXAN, 47 YEARS OF AGE." Neff's nearest birthday to the distribution of this card was November 26th, 1919. If he became 47 years old on November 26, 1919, HE WAS BORN NOVEMBER 26th, 1872! REMEMBER, this was Neff's own statement.

(3) In the yearbook of Texas published in 1903 by the Librarian of Texas, Honorable C. W. Rains, appears the following statement:

"Pat M. Neff was born near McGregor on November 26th, 1872."

Undoubtedly this date was furnished by Neff.

(4) On page 2081, Volume 11, of "WHO'S WHO IN AMERICA," 1920-1921 EDITION, appears a character sketch of Mr. Neff. The publishers of this book declare that "Sketches for Who's Who in America are prepared from first hand material only." As a matter of fact, the material is furnished by the subjects of the sketches themselves. In said sketch it is said:

"Neff, Pat Morris, Lawyer, born McGregor, Texas, November 26th, 1872, etc."

(5) W. A. Fraser, a high officer of the Sovereign Camp of Woodmen of the World of America, and a supporter of Neff, Omaha, Nebraska, wired a member of a Woodman Lodge in Texas August 21st, 1920, as follows:

"Neff born '72. Policy issued 1905. Hope he will be your next Governor."

This means that Mr. Neff's application for a Woodman policy and for membership in the lodge states his birth date as being November 26, 1872. The telegram was in response to telegraphic inquiry as to what the Woodman records show about Neff's age.

(6) MARTINDALE'S AMERICAN LAWYERS' DIRECTORY is an annual publication in general use by the lawyers of the United States, and each volume contains a brief history of each lawyer. The data for this publication is gotten first-hand, and whenever there is a change in the law partnership, the publishers call upon the particular lawyers affected for correct data. The volumes of this publication can be seen in almost any lawyer's office; they have been examined for the period from 1915 to 1920 and each year Neff is shown to have been born in 1872. Neff has had constant access to these volumes all these years, and if the data about him was incorrect he should have had it corrected.

(7) The Legislative Records during the period of Neff's membership shows his age. The Manual for 1901 states his age as being 28 years at that time. His birthday nearest to the publication of this manual was November 26th, 1900. This fixes his birth date as November 26th, 1872. The Manual for 1903 shows his age then as being 30 years. His birthday nearest to the publication of this Manual was November 26th, 1902, and this fixed his birth date as being November 26th, 1872. The data for these official records was furnished by the various members of the Legislature. Neff was a member of the House in 1901 and was Speaker of the House in 1903 and it was a part of his official duties to see to it that the records were correctly kept.

(8) Congressman Tom Connally was a member of the House when Neff was elected Speaker. In a speech supporting Neff's nomination for Speaker in 1903, Mr. Connally said: "It is hardly necessary to speak of his service. YOU KNOW HOW HE ENTERED HERE AT THE AGE OF TWENTY-SIX, etc., etc." See page 6, House Journal, 28th Legislature, Regular Session. Neff "ENTERED HERE" in January, 1899. The birthday nearest to his entry into the Legislature was November 26, 1898, and this fixed his birth date as November 26th, 1872. Neff, undoubtedly, would have corrected Mr. Connally if an erroneous statement had been made!

(9) In the issue of January 14, 1903 The Dallas News reported Neff's election as Speaker of the House and gave a biographical sketch. Among other things, it said: "PAT M. NEFF WAS BORN AT McGregor, Texas, Nov. 26th, 1872." Neff, in his recent speeches, has repeatedly said that the Dallas News is correct in its reports.

(10) Every man and woman who has attended the State University will remember that he or she was compelled to fill out a detailed report of his or her family history at the time of matriculation and file the same. Neff attended the University and in his report stated his birth date as being November 26th, 1872.

MIND YOU: All of the above evidence came into evidence through a series of years and under circumstances when there was no motive to make incorrect statements and is, therefore, entitled to credibility. Some of it was made under circumstances constituting a violation of the statutes of Texas if it were false; and the rest of it was made when it was of importance for it to be correct.

Neff now says that he was born November 26th, 1871, and relies upon an alleged entry in a Bible to substantiate his statement. According to Neff his Bible has been in the family for "seventy-five years," but according to the Dallas News of August 22nd, 1920, "the date in the front of the book (Bible) shows it was printed in 1867," only fifty-three years ago. In this connection the News of August 22nd, 1920, contains an affidavit showing entries in this book PRINTED in 1867, as follows: Marriage of Noah Neff and Elizabeth Sheppard, October 26th, 1854; birth of Edward Neff, Dec. 31, 1855; birth of Charles Neff, April 7th, 1857; birth of Sam Neff, Sept. 25th, 1858; birth of Ben Neff, Nov. 29th, 1860; birth of Robert Neff, August 21st, 1862; birth of Sallie Neff, Dec. 9, 1864; birth of David Neff, Oct. 28, 1866. The last of these events happened one year and the first happened thirteen years before the book itself was printed! This circumstance, under the rules of evidence, would exclude the book from evidence in a court of justice unless the circumstances was further and properly explained. And before it could be offered in evidence in a court of justice the person, or persons, interested in disputing its accuracy would have the right to inspect it for evidence of alterations. With respect to the credibility to be given Bible entries when a man's age is in question the court in the case of St. L. S. W. Ry. Co. vs. Bowles, 72 S. W., 454, said:

"It is insisted that in proving age the record of births in the family Bible is the best evidence. Such record is hearsay, IT IS NOT THE BEST EVIDENCE." And why it is not the "best evidence" everybody who gives the matter thought will understand.

If the facts stated in Neff's oaths before the Tax Collector are correct; if the facts stated in the other records are correct, then, without question, Neff had not reached his forty-sixth birthday on Sept. 12th, 1918, and it was his duty to register.

If the facts were incorrectly stated by Neff when he took the oaths before the Tax Collector, and if he knew they were incorrect, then another serious criminal offense was committed?

If Neff thought he was stating the facts in his oaths before the Tax Collector, and in his campaign cards, and elsewhere, then, without question, at the time for registration in 1918 he thought he was not forty-six years old and it was his moral and patriotic duty—if not his legal duty—to register on September 12, 1918.

If the facts were incorrectly stated in his oaths before the Tax Collector and in his campaign cards and elsewhere, why did he state them incorrectly?

The conclusion is irresistible that Neff was either not forty-six years old Sept. 12th, 1918, or he thought he was not forty-six years old on that date. If this conclusion is correct, then Neff either violated the draft law (in the event he was in fact under forty-six years old) or he thought he was escaping the draft in violation of law (in the event the Bible entry is correct), or that he was ignorant of the draft?
