

2 MORE INDICTED IN ALLEGED SALTING OF EAST WICHITA WELL

WILLIAM HONAKER AND JOE ZOLADEK ARRESTED LATE TUESDAY ON SWINDLING CHARGE

DRILLER OF TEST JAILED SEVERAL WEEKS AGO

Three Men Are Jointly Indicted—Honaker and Zoladek Make Bond for \$2,500 Each

William Honaker, president of the East Wichita oil company, Joe Zoladek, one time director and owner of land adjoining the East Wichita well, and C. A. Williams, the driller employed by the company in drilling the well, were jointly indicted by the grand jury on the charge of swindling over \$50, if became known late Tuesday.

Honaker and Zoladek were both arrested at midnight Tuesday and brought to the county jail where both immediately made bond in the amount of \$2,500 and were released.

The indictment contains three counts, the first of which alleges that the men conspired to secure unlawful acquisition of money by false and deceitful pretenses from various and diverse persons, the names of whom are to the grand jurors unknown.

The second count charged that the men conspired to secure from Mrs. Emma Stinchamp the sum of \$100 by deceitful pretenses, and the third count all of the aforesaid.

The East Wichita well was located on the Honaker farm three miles east of the city and attracted as much attention as any wildcat test in this county. The stock of the company was given a prominent showing on local stock markets and at one time when excitement ran high the stock sold as high as 300. This, however, was before the last excitement.

The last reported effort to get a well was made during the month of January, 1921, at which time stock was purchased on the local market as high as 150.

The report was circulated that oil had been found and that the well stood 100 feet in oil which, when tested, showed it to be an exceptionally high grade of oil. Different dates were set when the well was to be drilled in, but on the last set the driller, C. A. Williams, did not show up and it was reported that he had disappeared.

A month later Williams was arrested in Duncan, Oklahoma, and returned to this city. An examining trial was held where it was alleged on the witness stand that the well had been "salted."

The driller who was in charge of the well testified that there was no sand at the bottom of the well and that although he did not know how the oil that was in the hole got there, he was positive that it had not come in from the bottom. He also stated that he found gunny sacks and twine near the bottom of the hole.

Honaker and Zoladek were both witnesses at the examining trial of C. A. Williams, whose bond at that time was fixed at \$500. The bond was later reduced in half following a habeas corpus proceeding in the district court.

PLAN RESUMPTION OF OPERATIONS IN TAMPICO DISTRICT

By Associated Press. TAMPICO, July 12.—Resumption of operations in the Tampico district by oil companies is expected by officials here. Drilling permits are being granted daily by the government and some companies have continued work during the last troublesome month without discharging a single man. It was declared yesterday by a government official that the situation here was not a local problem, but was the outcome of world conditions. He said that the new taxes placed on petroleum exports had but secondary influence on operations in this district.

Refineries are working and several companies are storing large quantities of oil in their tanks which had been nearly emptied by the heavy exportations made in June. This was the second most important month of the present year in oil shipments, 1,312,772 tons of oil having been exported. The Huasteca Petroleum company established a record by loading six tankers on June 30.

Since the beginning of July exportation of oil has been greatly reduced, the outgoing tankers averaging but three or four daily compared to 19 or 21 during the preceding months. It is reported, however, that the Huasteca company has ordered its tankers to be made ready to resume operations in the near future. The Texas company intends to load eight tankers this week, this company exporting lighter oils as usual.

PLAN COMMISSION TO PASS ON CLAIMS AGAINST MEXICANS

MEXICO CITY, July 12.—All countries whose nationals have suffered damages from Mexican revolutions have been invited by President Obregon to appoint delegates who will meet Mexican representatives and form a permanent commission to pass on the claims. The invitation took the form of a presidential decree promulgated last night, in accordance with the law passed in May, 1913, at the instance of President Carranza, to give whatever official stamp was necessary to assure a permanent mixed commission dealing with indemnities.

President Obregon is declared to have been authorized by decree to act in accordance with the precepts of international law.

The entire session of the cabinet on Thursday night is said to have been occupied with a discussion of this plan.

KATY'S AFTERNOON TRAIN TO LEAVE AN HOUR LATER STARTING NEXT SUNDAY

Effective next Sunday, the time of leaving of M. K. & T. train No. 44 will be changed from 4:15 to 4:13 p. m. This is the evening train that makes connection for Kansas City and St. Louis at Denison. Improved operating conditions have made it possible for this train to leave an hour later and reach Denison the same time as now.

By leaving at 4:13 o'clock passengers will have an opportunity to eat the evening meal before leaving Wichita Falls.

ARMED RESISTANCE WHEN GOVERNOR NAMES MAYOR

MEXICO CITY, July 12.—Efforts on the part of the governor of the state of Michoacan to impose a mayor of his own choice on the village of Jacoana were met yesterday by armed resistance and in the ensuing clash several persons were wounded. It is said in newspaper dispatches, Catholics residing in the village objected to the mayor chosen by the governor and it is said they still were in control of the place.

Jacoana was recently the scene of a radical demonstration, and Catholics protested against the alleged desecration of their church, and in fighting between the factions there were several casualties.

DEMAND EPULSION OF RUSSIANS HOSTILE TO THE BOLSHEVIKI

LONDON, July 12.—Fiery counter-charges by the Poles in what is described as one of the strongest examples of diplomatic correspondence ever exchanged between two countries at peace have resulted from a note addressed to Poland by the Russian bolshevik foreign minister, M. Chicherin, regarding alleged anti-bolshevik organizations in Poland, says a Warsaw dispatch to the London Times. The Narod of Warsaw compares the Russian note to the Austrian ultimatum to Serbia.

According to the dispatches, M. Chicherin's note demands among other things the expulsion from Poland of all Russians hostile to bolshevism and the disarming of detachments alleged to have been formed by the Poles among the Russian troops to fight communism.

Requests President To Have Monument To Booth Destroyed

LINCOLN, NEB., July 12.—Pelham A. Harrows, national commander of the Sons of Veterans, yesterday forwarded a letter to President Harding asking that he order a monument, reported to be in Troy, Ala., which contains an inscription honoring Wilkes Booth for the murder of Abraham Lincoln, destroyed. Mr. Harrows stated that this was in accordance with resolutions passed by a number of veterans' posts.

MONUMENT IN QUESTION DISAPPEARS FROM TROY

TROY, ALA., July 12.—The monument erected here in the sixties in honor of John Wilkes Booth for the assassination of Abraham Lincoln stood at Star City, near here, until a policeman, until a few days ago, when it disappeared. It was learned today in an investigation prompted by the action of the national commander of the sons of veterans in requesting President Harding to have the monument destroyed.

Only a few days ago the monument was removed from its original site in order of the town council. Carter bought it and tried to put it up on the court house square but was denied permission. It was then taken to the property but since has been removed.

TELEPHONE COMPANY MANAGER EXPLAINS SERVICE CONDITIONS

Replying to an inquiry from Judge W. N. Bonner, public utilities commissioner, District Manager C. C. Kirby of the telephone company has informed the city council that within six months the telephone service and facilities here will be on a normal basis.

Judge Bonner's letter was prompted largely by a request for additional telephones on the north side. Mr. Kirby said that only two requests for service north of the river were at present unfilled, very few residents of that section apparently desiring phones. Mr. Kirby also said that the company's present policy of trying to get new subscribers to go on party lines was a temporary one.

The company had a construction program in Texas amounting to eight million dollars, Mr. Kirby said, and had allotted only three million dollars for the year, necessitating curtailment of the program.

Many of the present requests for connections, Mr. Kirby said, are being met through discontinuances by former subscribers. There were 27 such discontinuances during June, and installation of the automatic equipment is being delayed by the material manufacturers, he declared.

PAID BY RANGERS AT NEWTOWN ENDS IN MANY ARRESTS

Texas Rangers McCormick and Gon-sallus conducted a raid at Newtown Tuesday night that netted them the arrest of an alleged manufacturer of Choctaw beer, two men charged with affray and a number of vagrants.

W. Whitesell was arrested on the charge of manufacturing beer, and an evidence 25 bottles of finished product and equipment were confiscated by the officers.

N. J. Smith and T. E. Taylor were arrested on the charge of affray, it being reported that the two men staged a fight on the streets of the town early in the evening.

The parties who were arrested on vagrancy charges paid fines and were released Wednesday morning.

TO STAGE DEMONSTRATION OF FORDSON TRACTORS AT IOWA PARK CELEBRATION

The Motor Supply company of this city, co-operating with the Lina Motor company of Electra and the Caro Motor company of Burk Burnett, are arranging a demonstration of the Fordson tractor and other power farming implements to be held at Iowa Park July 15 and 16 in connection with the barbecue and celebration which is to mark the opening of the new concrete road between that point and this.

Frank Quieser of the Motor Supply company states that a location for the display has been arranged for on Cash street and that officials of the celebration are heartily endorsing the plan. Several exhibitions of farm work with the Fordson will be given each day, while other implement demonstrations will also be held at various times.

GUTTERS AND CURBING NOW BEING INSTALLED IN RIVERSIDE CEMETERY

Work of installing concrete gutters and curbing in the Riverside cemetery started Tuesday, City Engineer Montgomery announced this morning. 200 feet having been laid the first day. Installation of the work was ordered some time ago.

Between 12,000 and 13,000 feet will be put down in the grounds, it is said. The work is being done by C. H. Foley, local contractor.

\$400,000 BUILDING CONTRACTS MAY BE LET BY A. & M. BOARD

COLLEGE STATION, TEXAS, July 13.—The A. & M. board of directors will meet at College Station Friday, July 15, and will very probably let the contracts for erection of a new agriculture building to cost \$150,000 and a mechanical engineering shops building to cost \$150,000 and replace the one lost by fire the past year.

President W. E. Bissell in announcing the meeting yesterday, said the consideration of bids for erection of these buildings would be the chief thing to come before the board at this time.

An appropriation of \$250,000 made by the Thirty-sixth legislature becomes available for the erection of an agriculture building on Sept. 1 and an appropriation of \$150,000 for the mechanical engineering shops building, made by the regular session of the Thirty-seventh legislature, is now available. It was passed as an emergency.

Plans for the buildings have been drawn up by Professor E. B. La Roche, college architect, and will be submitted to the board for their approval at this meeting.

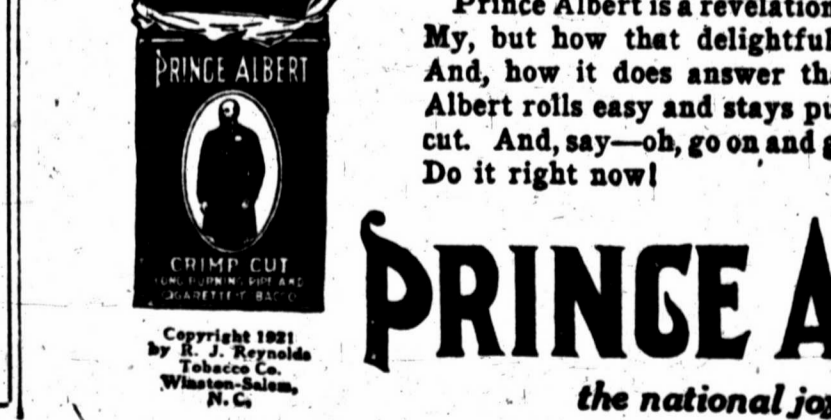

DEMY KNOWLEDGE OF DEATH OF ENGINEER

Two Men Are Arrested and Held by the Authorities at El Centro, Calif.

EL CENTRO, CALIF., July 13.—J. F. Murphy and J. H. Williams, arrested yesterday and placed in the Imperial county jail at the request of El Paso authorities investigating the killing of William Bohman, freight engineer, denied knowledge of the tragedy. TWO BURKBURNETT OFFICERS ARRESTED ON BRIBERY CHARGE

CONSTABLE AND DEPUTY INDICTED ON CHARGE OF ACCEPTING \$100 FROM WOMAN

MAKE BOND PROMPTLY AFTER BEING ARRESTED

Alleged Bribe Declared in Bill to Be in Connection With Sale of Liquor.

Upon the return of a bribery indictment containing two counts, Shannon Lane and L. S. Brannon, constable and deputy constable, respectively, of the Burk Burnett precinct, were arrested at midnight Tuesday at the Texas Rangers McCormick and Gonzales' Bond was perfected at 2:30 o'clock Wednesday morning and both the men were released. Bond was set at \$1,000.

The indictment charged the two men jointly with having combined and conspired and entered into a positive agreement to accept a bribe of \$200 from one Viola Taylor. It is alleged in the indictment that the purpose of the bribe was to permit the said Viola Taylor to sell spirituous liquors containing more alcohol than the law permits.

The second count of the bill alleged that the two defendants did accept the bribe of \$200 from the said Viola Taylor and that at the time both of them were peace officers in the Burk Burnett precinct.

The two men were arrested in Newtown, where it is said they had gone on official business. When the officers arrived at the court house with the two men an attorney was awaiting them with perfected bonds.

Brannon is under indictment at the present time on a charge of murder. It is alleged that he shot and killed a man by the name of W. T. Smith in Burk Burnett while the latter was a prisoner and was being conveyed to the jail at that place.

The two indicted peace officers are widely known throughout the oil fields and the county.
