SAYS KEY TO WHOLE EUROPEAN SITUATION IS FRANCE'S SAFETY

LONDON, Jan. 2.—On the eve of his departure for Cannes to take part in the meeting of the supreme council, Premier Briand gave a statement to the Daily Mail's correspondent in Paris, the gist of which follows:

"The key to the whole European situation is France's safety. Let there first of all be a pact of alliance between Great Britain and France—a pact which we offered and asked for, but have not obtained."

"Such a pact will be the platform upon which the restoration of Europe can be based. It would also be the best proof that our naval building program is not and never can be directed against our English friends."

"To such a pact other alliances, embracing our other allies, might be attached, perhaps in the form of a general agreement on the part of the British government to support the French delegation, declaration was made by Boris St. Savoy, a member of the Chita delegation, that additional documents which he said had been passed between the governments on the subject was in the files of his government."

"Mr. St. Savoy suggested that these documents be inspected by a duly accredited representative of the American government so that the results might be made known to the conference when it takes up consideration of Siberian problems."

OPINION EXPRESSED THAT COUNTRY WOULD NOT CO-OPERATE.

CAUSE GOES BACK TO THE TRIPARTITE TREATY

With Versailles Treaty This Failed Of Ratification in the U. S. Senate.

By COL EDWARD M. HOUSE (Copyright by Public Ledger Co.)

PHILADELPHIA, Jan. 3.—Last August, when the Public Ledger expressed the opinion that the Washington conference could not count upon the co-operation of France in the efforts toward the limitation of armaments, it merely anticipated the events of the past few weeks. The reasons set forth then were based upon conditions which have remained unchanged.

It is useless to deny that France's attitude regarding the limitation of armaments, both on land and sea, has shocked this country, but it should have been known in advance. The cause for her action goes back to the Tripartite treaty, in which Great Britain and the United States guaranteed to come to the aid of France if an unwarranted attack was made upon her by Germany. For this guarantee she gave up her demand for some disposition of the left bank of the Rhine, which would have given, according to her military experts, the security desired. The Tripartite treaty failed of ratification in our senate, going down with the Versailles treaty, which included the league of nations.

Having given up the plans for self-protection on her eastern frontier, and having failed to obtain substantial assurance elsewhere, France feels compelled to fall back upon her own resources. These resources are mainly the army, supplemented by man power from French colonies. Left as she is, France stands today with less than 40,000,000 of people, against whom she visualizes nearly 60,000,000 of Germans. It is a handicap which she is seeking to overcome, and

CONTINUED UPWARD MOVEMENT TOWARD NORMAL CONDITIONS

OPTIMISTIC REVIEW OF BUSINESS BY FEDERAL RESERVE BOARD.

NET IMPROVEMENT IS SUMMARY OF REPORT

Freight Rates Continue As A Disturbing Factor in General Revival.

WASHINGTON, Jan. 2.—Continued upward movement of business and the gradual restoration of normal conditions are indicated in the comparison of reports in the last month with those of the corresponding month of 1920, according to the Federal reserve board.

Net improvement was found by the board despite the recession of business activity in December as compared with the same month last year.

The holiday trade, the board said, "is a test of soundness of preceding business activity." Reports from the various federal reserve districts covering over half of the month show that this year's demand in the eastern districts has registered an increase running as high as ten per cent of that of 1920, while in other districts the situation is pronounced satisfactory.

Manufacturing conditions, however, the board reported as far from uniform, there being a decrease of activity in the iron and steel industry while textiles showed little change from previous months and uncertainty exists as to the future of the clothing industry, due to labor disturbances and the continued demand of consumers for lower prices.

"Freight rates," the board said, "continue as a disturbing factor due to the belief that reducing rates ready announced as affecting some commodities may be much more widely extended in the near future."

Relatively low prices for cereals and cotton, the board continued, discouraged trade in the agricultural districts and also had resulted in retarding the process of liquidating frozen loans. Hardware and related lines were also said to be in an unsatisfactory condition, but wholesale prices "are showing increased stability."

A decided improvement in European exchange rates, the board said, "has tended to some extent to help the foreign trade situation during the month of December, but the extreme caution in the extension of bank credits which was previously so notable a phase of our foreign trade still continues. Export figures indicate a still softer decline of activity in staples, while imports show an advance."

"Disturbed conditions in various countries of Europe still render a maintenance of business relations with them uncertain and hazardous. Rates of interest which had already made a notable decline during the autumn have tended on the whole still further downward, partly owing to the fact that there was no foreign outlet for our capital."

INVESTIGATING THE THEFT OF THIRTEEN POUCHES OF MAIL

FERRY, OKLA., Jan. 2.—Local authorities assisted by postal inspectors from Oklahoma City today began an investigation of the theft of 13 pouches of mail and parcel post from the Miami railroad station here early yesterday.

A check of the loss has not yet been completed, it was announced, and no official estimate can be made at this time. An overcoat, apparently cast aside by one of the robbers as he hurried away with the loot, is the only clue as to the identity of the person or persons participating in the theft.

The coat is about the size ordinarily worn by a youth in his teens, authorities said. The robbery was discovered when the night telegraph operator at the station went through the baggage room where the mail was kept, on one of his nightly rounds at 3 o'clock Monday morning. On his tour at midnight, he told officers the mail was in its accustomed place.

The mail arrived on southbound Santa Fe train No. 408 at 8:45 Sunday night and because the postoffice here is closed at that hour it has been the practice to keep the baggage room locked until the following morning.

Entrance to the building was obtained through a door of the baggage room which had been kept closed with an iron bar.

COMMITTEE FAVORS DEFINITE OFFER ON COLLEGE LOCATION

A recommendation that Wichita Falls offer \$50,000 in cash and 100 acres of land for the church college which contemplates moving here, was adopted Tuesday afternoon at a meeting of the committee which has the matter in charge.

Of the 100 acres to be offered, \$5 would be for a site and the remaining \$45 for endowment, according to the committee's recommendation. It is also made a condition of the proposition that the church furnish \$100,000 toward the building and equipping of the school.

The recommendation of the committee will be submitted to the chambers of commerce directors at an early meeting.

APPROXIMATELY 3,400 COMMERCIAL ENGRAVERS IN 30 CITIES ON STRIKE

CHICAGO, Jan. 2.—Approximately 3,400 members of the Photo Engravers Union in 30 cities of the country went on strike today, according to reports to the American Photo Engravers association headquarters here.

Employers sought to reinstate the 48-hour week at the present rate of pay or to reduce wages \$5, allowing the present 44-hour week to continue. Louis W. Fisher, commissioner of the association, said the wage reduction would have approximated 8 per cent, the average wage being about \$14 a week.

COMMERCIAL ENGRAVERS IN NEW YORK ON STRIKE

NEW YORK, Jan. 2.—Seventy commercial engraving shops employing approximately 1,600 men were closed here today as a result of the failure of the negotiators to reach an agreement ending the controversy between the photo engravers board of trade and the photo engravers union. It was said that shops throughout the country employing members of the union would not be opened until the dispute was settled.

Matthew Wolf, international president of the union, was expected here today to take charge of the situation.

FLAG OF GERMANY FLYES WITH THOSE OF OTHER NATIONS

REAPPEARS IN NEW YORK FINANCIAL AND SHIPPING DISTRICTS.

UNFURLED FROM POLE USED PRIOR TO 1917

Marka Location of Re-Established Consular Offices of the German Republic.

By Associated Press. NEW YORK, Jan. 2.—German's flag today reappeared among those of other nations which fly from the tall buildings of New York's financial and shipping district. It was unfurled from the same flag pole, atop No. 11 Broadway, from which it was hauled down in the spring of 1917, and marked the location of the re-established consular offices of the new German republic.

For more than a week representatives of Consul General Karl Lang—temporarily charge d'affaires of his government at Washington—have been preparing for the reopening of the offices. A score of desks, filing cases and a couple of steel safes were moved across the hall from the former office of the Swiss consul, their custodian during the war. Among the furnishings missing, however, was an oil lamp, the old consular seal had also been discarded and the official stationery took on the new democratic emblem of the new Germany.

The flag today waved over a scene different from that it witnessed at its last appearance. Then the building was the American headquarters of the North German Lloyd steamship line, now occupied by an American steamship firm, and the former Hamburg-American line building a few doors north, is the New York base of the United States shipping board.

Just across Broadway on the facade of the United States customs house the show of the German flag prior to the war fell upon a magnificent statue of "Germania" standing with figures of other great maritime powers. The statue, however, caused "Germania" to disappear and in her place now stands "Belgium," remodeled by the artist's chisel from the same block of marble.

Across the Hudson from the base of the flag pole are the great shipsheds of the former home of Germany's steamship liners and several of their ships, including the \$4,000 ton Leviathan. These have also passed to new ownership and to the protection of the American flag.

he done next if the treaty were rejected. His opponents were not even united on their formulae, some of them talking isolation and others of external assertion. The lives of the Irish people, he declared, were being gambled with.

The opponents of the treaty lacked confidence in the Irish nation, Beasley declared. When the British evacuated Ireland the free state would be just what Irishmen made it, he said, and they ought to make it a great and glorious land of Gaelic culture that would rival Denmark in agricultural development on co-operative lines and have its ideas put into practice.

Beasley, famous for his prison breaking exploits and his life long contributions to the Irish movement, said he had hoped the realities of the situation as affecting the welfare of Ireland would cause the petty political differences in the party to fade into insignificance.

Beasley contended the treaty gave everything Ireland had been fighting for. He laid special stress upon the evacuation of the country by the British army. Michael Collins and Arthur Griffith, he declared, knew the Irish people better "than the opponents of this treaty who care only for dry formulae."

Countess Markiewicz, the next speaker, vigorously denounced the treaty, contending that XVII and XVIII of the document dealing with arrangements for a provisional government and the method of ratifying the same, she said, she did not understand Arthur Griffith's promise to the southern unionists.

"They are getting something special and they are promising it to the workers of Ireland, ruining the small farmers and driving them across the Atlantic."
