SENATORIAL GROUP URGES AN ISOLATION POLICY ON HARDING

HANDS OFF EUROPEAN AFFAIRS CONSTANT CRYS TO PRESIDENT

LEAGUE OF NATIONS IS THEIR CAMPAIGN ISSUE

Want to Fight Fall Elections on Question of Foreign Entanglements

WASHINGTON, May 17.—The occasion is with us once again when the administration is called upon to do something about Europe and appearances indicate that what has happened before on such occasions is likely to happen again. The impression of an observer gets such occasions is that Harding is willing, but the policy that crystallizes during the campaign is still unwilling. Any person following events here in Washington has repeatedly seen signs that the administration has been tolerant of the idea of taking some affirmative step about Europe. But every time the news gets about that Harding is likely to appoint someone to the post of ambassador to the league of nations commission, or is thinking of some other affirmative step about Europe, the old group of irreconcilable republican senators become excited.

Just how they manage to convey their alarm to the president no one knows, but it wouldn't be an unfair surmise to suppose that either of more of the irreconcilables hurry foot to the white-house to say that any departure from the republican policy that they attacked during the debate on the league of nations will split the party, endanger the party's chances in the fall elections, and otherwise land by a large amount of miscellaneous republican calamity.

The normal thing would be for the high feeling that arose during the league of nations debate to have died away by this time, so that we could all consider our relations to Europe in calm detachment. But there is a group of republican party leaders who hold the idea that the best issue and the best method of campaigning that the republican party ever had was the one that were so successful in 1920 to scare the people about the wickedness of Europe, to keep the prejudice of the forest home voters stirred up and to keep the picture permanently before the public mind of a democrat party anxious to take the country into the league of nations and a republican party as the sole dependence against the dangers of international alliance.

Looking to what is ahead. This formula for the republicans is looked upon by some republican leaders in the same way that a business man looks upon his patent. He has his patent of power. There is a group of republican leaders who are eager to force a situation in which this issue will be brought to the front in the fall elections to the obscuring of other things. Of course, this sort of thing will have to end some time. Without pretense of knowing any individual views it is a fair guess that most of the cabinet members and most of the republican senators believe most of the republican proposals which made it prudent for America to stay out of Europe and that the time is at hand when America could use its power in such a way as to be of great benefit to the rest of the world and to America.

Of course, few people are simple enough to think that America ought necessarily to do all the things that Europe asks America to do, nor in precisely the way that Europe asks her to do it, but there is hardly a man of open mind who does not believe that with the Geneva conference out of the way, America could assume the initiative in America's own way and take some steps which would be as successful and even more fruitful of good than was the calling of the Washington conference on the limitation of armaments.

Whether or not the administration will take such a step will be very much to the front during the next few weeks.

LEGAL BATTLE OVER PROCESS FOR MAKING GASOLINE FROM GAS

ST. PAUL, May 17.—Litigation of widespread importance to determine whether or not it is legal to produce millions of dollars worth of gasoline from natural gas are pending, is on the calendar of a federal court.

The Standard Oil company of New Jersey and the Hope Natural Gas company of West Virginia are appealing from a decision on the Oklahoma district which held that the Oklahoma Natural Gas company is not infringing on a patent held by the Standard Oil company. Trial of the case in Oklahoma brought forth the charge that the Standard Oil company and the Hope Natural Gas companies, through demands for alleged excessive royalties from other enterprises using patented methods of gasoline extraction are creating a monopoly of a process, which it is contended, is obvious.

The process is not characterized by features which ordinarily make an invention of discovery patentable, the Oklahoma company successfully contending during the original trial.

The Standard Oil company maintains that the process was a great discovery, novel, useful and legally patented.

"Air-Hole Bill" Is Loser In His Suit To Recover Taxes

PHILADELPHIA, May 17.—William "Air Hole Bill" Carrill yesterday lost his suit in federal court to recover \$757,761.75 in additional taxes which the government compelled him to pay on his alleged enormous profits from the sale of oil lands in Oklahoma. Carrill won his sobriquet of "Air Hole Bill" in the decade before 1912 when he was one of the Oklahoma drilling holes for others and then for himself when he accumulated sufficient money from his labors to do so. The best his holes ever yielded up to 1912 was a low grade of unsalable air. But one day he struck it rich and almost overnight was transformed from a well driller into a millionaire.

LOS ANGELES, May 17.—John Pialogou, Greek tobacco importer and cigarette manufacturer of New York, will not contest the divorce action filed against him here May 9 by Constance Talmadge, motion picture actress. It was announced today by George C. Hupp and Ben J. Gray, engaged as counsel for Pialogou. "We shall not contest the action in any manner," said Mr. Hupp, "if anything at all is filed. It will be merely a general denial of Mrs. Pialogou's charges."

TO BEGIN CONSTRUCTION ON NEW MACHINE SHOP

ELECTRA, May 17.—Construction work will begin at once on the new machine shop of the Magnolia Petroleum company, involving an expenditure of \$150,000. The new plant will be just south of the Magnolia warehouse a short distance west of the town of Electra. Plans call for the removal of the Magnolia wharf now in operation one and a half miles west of town and their consolidation with the new plant. The number of employees will be increased about one-third, adding something like \$2,500 a month to the pay roll in Electra. Rebuilding of the company's warehouse will begin in a short time, it is announced. Steel construction will be used in the shop and warehouse.

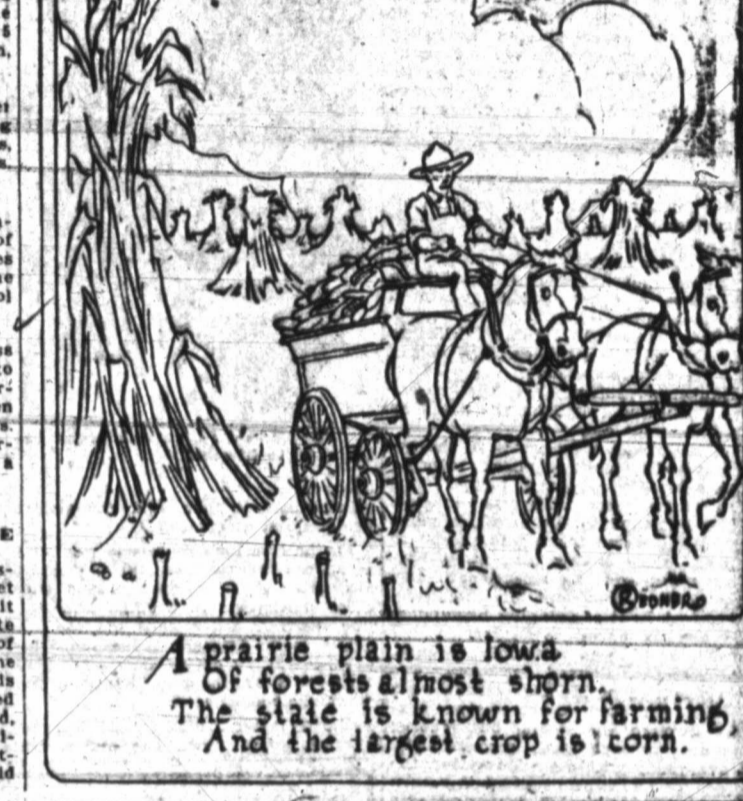

As to sexes the ladies come first in business integrity. Women will not go wrong in money matters as frequently as men do.

Seventy-five per cent of all defaultations and embasements are committed by men under 30. But when the middle aged man does throw off the principles of integrity he usually goes all the way and takes large amounts.

The next man, who is a good surety risk is the "nut" or crank. In contrast to this is the particular is the "good fellow."

It is a strange phenomenon of the surety business that the blatantly profane man is seldom found among the defaulters.

Another man who is a good surety risk is the fat man. One of those fat, sleek, good natured Falstaffs of life.

Concluding, Mr. Whitney says: "I have saved the best until the last, for the greatest truth we learn from our law of averages may surprise the cynical; it is, that the overwhelming majority of men in the business world are men of honesty and integrity. If this were not so, the surety companies could not exist six months. Out of 7,000,000 bonds, representing the integrity and character of 7,000,000 different men, in varying sums in a given period of time, only 70,000, or one per cent, went wrong, and out of that 70,000 only 1,000 deliberately, criminally and intentionally went wrong. The other 69,000 went wrong through hu-

man weakness, indiscretion or various entanglements and alliances that lead men from the path of business rectitude. But the sad part, with the \$9,000, is that whether or not they intended to be criminals they stand before society and their fellow men as criminals with disgraced families and clouded business careers. 'Whatever a man swears that must be also real'.

"One more point. The dangerous age for any young man is that head-strong, susceptible period between the ages of 18 and 25. That is the time when young fellows are more easily led astray by evil companions, or false philosophies. One of the basest of the false philosophies that has placed many a fine young fellow behind the prison bars is a cynical and envious state of mind toward those who have succeeded. 'Yes,' says an evil-minded companion, 'that old guy has a big fortune but he was a crook to get his start and now he can afford to be honest.'

"No more false or misleading suggestion ever entered the mind of a young man. There is no way over the wall of real success. Therefore, the idea that there is a short-cut by way of crookedness has shattered the life of many a fine young man. There may be a few fortunes in this country founded on crookedness as their basis, but gentlemen, as sure as we are here today, the great majority of American fortunes were built up on the age-long plan of honesty, integrity, application and hard work. That is the only route to real or permanent success."

SLIGHT INCREASE IN COST OF LIVING FOR AN AVERAGE FAMILY

WASHINGTON, May 17.—An increase of one-tenth of one per cent in the retail cost of food to the average family for the month ending April 15 was reported today by the bureau of labor statistics of the department of labor. Of the 43 food articles listed, 13 showed a decrease in price, including potatoes, 5 per cent; cheese, 3 per cent; fresh milk, lard, cabbage and bananas, 2 per cent; butter, macaroni and baked beans, 1 per cent.

The articles showing an increase included onions, 19 per cent; oranges, 13 per cent; pork chops, 5 per cent; lamb and granulated sugar, 3 per cent, and round steak, ham and ham 2 per cent.

Among articles showing an increase of 1 per cent or more in the average family expenditure for food during the month were Dallas, Little Rock and New Orleans, 1 per cent; Fall River showed a decrease of 3 per cent and Houston and St. Louis 1 per cent.

HALF DOZEN BLACKS CHASED INTO COUNTRY BY 30 WHITE MEN

WERE BROUGHT IN BY CONCRETE CONTRACTOR

Hired Because Work is Too Heavy for Whites; Warning is Issued

Six negro workmen brought to Mabelle to work for E. F. and M. Davis, concrete sub-contractors, were chased out of the town and warned to stay away by a group of about 30 white men, according to information reaching here Wednesday.

When the negroes got off the train, the white men gathered, and before a truck could be obtained to take the negroes to the dam site, a miniature race riot was in progress. It is understood that the negroes were part of the regularly employed force of the Davis company.

Neither of the Davis brothers was in the city Wednesday. At their office it was stated that negroes were being employed because it was found that white men could not stand up to the heavy work on concrete mixers. White men are being turned down daily, the Mabelle dispatch said.

This is the first actual clash that has taken place in connection with the labor situation on the project, although there has been threats and agitation since the work started.

NEGRO INDICTED FOR FORGERY IS ON TRIAL IN 85TH

John Norris, negro, indicted for forgery and passing a forged instrument, went on trial in the 85th district court before Special Judge George Smoot, Wednesday morning. Selection of the jury was made during the morning session.

The indictment alleges that the defendant did on or about March 1, 1922, forge the name of Holland Tanner, another negro to a check and pass the same.

Special setting of the case was made in view of the physical condition of the defendant who has been ill for several weeks. A continuance was sought by the defense on grounds that witnesses who were subpoenaed had not been served. The motion was overruled.

RAINY DREARY DAY FOLLOWED BY ONE OF WARM SUNSHINE

3 REPORTS MUST BE FILED SETTING OUT ALL EXPENSES

All candidates for county offices for the democratic primaries in July are required by law to file three reports setting forth all expenses incurred in the campaign. This is set forth in the general laws of the state, legislature on page 145.

The law requires that the first report of expenses must be filed not more than 30 days less than 25 days prior to the primary election, including money borrowed and liabilities incurred but not paid. The second one must be filed not more than 12 nor less than eight days prior to the election, and the third one not more than ten days after the election.

The report must be sworn to and filed with the county clerk. Each succeeding report must include all the amounts previously received and disbursed as set forth in the former report or reports.
