### WICHITAN DELIVERS MEMORIAL ADDRESS SUNDAY AFTERNOON

JUDGE SCURRY SPEAKS AT SERVICES HELD AT ARLINGTON CEMETERY.

### MONUMENT AT SITE OF LEE HOMESTEAD

Service Follows Anniversary of the Birth of Jefferson Davis On Saturday.

WASHINGTON, June 5.—Judge Edgar Scurry of Wichita Falls, Texas, commander in chief of the Sons of Confederate Veterans, delivered the memorial oration at Arlington cemetery Sunday afternoon. The service was held at the base of the Confederate monument in the cemetery on the site of the homestead of General Robert E. Lee. It followed the anniversary of the birth of Jefferson Davis on Saturday. Judge Scurry, the orator of the day, is a son of General William Scurry of the Confederate army who was killed in battle in the civil war.

The service was attended by Confederate veterans and some daughters and sons of veterans. The U. S. marine band played at the service. "This should be holy ground," said Judge Scurry, "for it was once the home of the matchless Lee, and this should be a sacred period for it includes the natal day of our president, the immortal Jefferson Davis. I shall not discuss the right of secession; the south had the right to secede, and no honest-thinking man will deny it."

"The cause of the Union?" Judge Scurry touched upon the purposes of the Confederate movement and the trials of its armies in the fields for four years, holding out, contending a force much greater in numbers and resources. While the leadership of President Davis was recognized, he would have been powerless. Judge Scurry said, but for the leadership of such men as Lee, Jackson and Joe Wheeler, and these in turn would have fallen in the hands of the Union army. He wrote two years after the war started, to Horace Greeley, saying that the paramount motive was to save the Union.

"But the time for bitterness has passed," continued Judge Scurry. "The time has come when the American of today should honor the great American on whatever side he fought; and we are reunited anew as we have been for years, by the action of men who fought in Florida, from the south as well as from the north."

"The Unknown Soldier, who lies buried here may have been a northern boy, or he may have been a southern boy, but he was an American boy who gave his life for his country, as did the honest northern soldier or the honest southern soldier in 1861. We claim a portion of that heritage that is now America's; we are here to honor those buried in these hills and elsewhere the Confederate soldier who made history, and when that history is truthfully written there should be glory enough for all. The sons and daughters should see that this is a true history, and that the part the south played is truthfully reported."

A wreath was placed upon the grave of the unknown soldier and a prayer offered by Representative William D. Upshaw of Georgia.

### HARRY T. WARNER OF PARIS CANDIDATE FOR GOVERNOR OF TEXAS

PARIS, TEXAS, June 5.—Harry T. Warner, publisher of the Paris News and one of the best known newspaper men of the state, has forwarded his application to the secretary of state at Austin for a place on the ticket for the democratic nomination for governor. In a preliminary statement Mr. Warner said that he intended to devote his campaign principally to the welfare of the schools, and declared that Governor Neff had fallen far short in other matters and was lacking in the moral courage that should be possessed by the executive of Texas.

Mr. Warner was for many years managing editor of the Houston Post and is regarded as one of the ablest newspaper men of the south-west. Preliminary Statement: In a preliminary statement Mr. Warner says: "I have been hopeful that Judge Napier or some other strong candidate with time to do so would present an active canvass against Governor Neff for a second term and am most regretful that Judge Napier has been compelled to withdraw. I shall be able to make only a very partial canvass, of course. Considering the plight of the schools of Texas—city and rural—I shall devote myself principally to that matter. I am also of decided opinion that Governor Neff has fallen far short in many other matters and that he is lacking in the moral courage that should be possessed by the executive of Texas. The plight of the schools of the state is most pitiful and yet the governor, with petitions, letters, telegrams and memorials piled high upon his desk (unless he has thrown them into the wastebasket), delays in calling a special session of the legislature—the only thing which may be legally done—to find a remedy for the situation. The members of the legislature are fully as patriotic as the governor; and his strictures upon them are not deserved. I am confident that the members of the legislature, would, if called together, speedily find a remedy for the deplorable condition of the schools of the state; and in his stubborn refusal to adopt this course Governor Neff is adding to the perplexities of the dilemma which confronts thousands of teachers, other thousands of trustees and more than a million school children with their parents. There is no issue so pressing at this moment as the future of the public schools of the state—and I charge that Governor Neff is now directly responsible for that condition in that he has without just cause and with no plausible reason refused to take the constitutional step to provide a remedy."

### CHARGES THE USE OF UNFAIR METHODS IN STEEL BUSINESS

WASHINGTON, June 5.—The federal trade commissioner has issued a formal complaint against the Bethlehem Steel corporation and the Lackawanna Steel company, charging that they have been using unfair methods of competition. The complaint grows out of the merger recently effected by the two companies. The commission made this announcement today in a report to the senate in response to the recently adopted resolution of Senator La Follette of Wisconsin, directing inquiry into the merger by the commission and the department of justice. Stating it had the proposed merger of steel companies under observation prior to senate action on the La Follette resolution and had followed developments along that line, the commission in its report said it now had "reason to believe that the language of the constituent act, that the proposed Bethlehem-Lackawanna merger, when consummated" will constitute an "unfair method of competition in that it contains a dangerous tendency unduly to hinder competition and to restrain commerce and that protection of the commission in this respect is in the public interest."

### Peggy Marie Beal Fighting Against a Chance to Recover

KANSAS CITY, June 5.—Asserting again and again that she has no desire to be married, Peggy Marie Beal, trained nurse at Springfield, Ill., and Dayton, Ohio, who early Saturday ended a war romance here by killing Frank Anderson, a department store welfare director, and then turned the pistol upon herself, lay in a hospital today fighting against what attendants said was an excellent chance for recovery. She has a bullet wound in her left lung. The young woman killed Anderson at a hotel where, police said, they had registered as man and wife. According to her story the shooting took place after Anderson had been drinking here for several days with other, told her that he could not love any one woman, and revealed to her that he was not yet divorced from his wife. Papers found among Anderson's effects indicated that he was an officer in the aviation corps during the war, but that he was never sent overseas. His parents live in Colliwood, N. OFFERS TO RETIRE IF GOVERNMENT DESIRES. Make Public Correspondence Dealing With Expenditure of Fund Advanced.

WASHINGTON, June 5.—Recognition of Boris Bakhmeteff as Russian ambassador to the United States, continued despite the collapse of five years ago of the Kerensky government which appointed him, will cease after June 30. Mr. Bakhmeteff has been notified of this decision of the American government in a letter from Secretary Hughes. This was a reply to a communication from the ambassador in which he said his chief function in recent months of liquidating property claims growing out of the war was now about completed. He offered to retire should the Washington government desire it. The correspondence, published today, was dated late in April after Senator Borah had challenged the ambassador's status. In his communication M. Bakhmeteff states that the renewed discussion of the subject had led him to question whether his continuance as ambassador "would serve the best interests of my country and the convenience of the United States."

### DUEL TO DEATH AT DANCE NEAR BORDER THIRD MAN KILLED

BROWNSVILLE, TEXAS, June 5.—Three men are dead at Los Indios, Cameron county, following an attempt by Deputy Sheriff George Carpenter to disarm Martin George. The officer asked George to surrender his pistol and the latter, stepping forward as if to comply, shot Carpenter in the abdomen. Carpenter drew his gun and each man holding the other by the shoulder, emptied their pistols into the other's body. Both were dead when the smoke cleared away.

Andrez Perez, believed to have tried to assist Carpenter in preventing peace at the dance, was later found dead 100 yards from the scene with a bullet through his throat and two empty shells in his pistol. It is not known who fired the shot that killed him. New wall paper at Decorators. 22-710
