COURT HOLDS CHARGE NOT GRADE OF FELONY

Judge Wilson Sustains Motion of Defense That Under Testimony It Was Misdemeanor.

RAILWAY EXECUTIVES RETICENT AND NO FORECAST AS TO WHO WILL TAKE THE INITIATIVE

CHICAGO, Aug. 3.—There was a lull today in peace maneuvers in the railway strike. Railmen were reticent and there was no forecast of where the next peace effort would originate.

Strike leaders turned their attention toward Washington where President Harding had a telegram sent by the shophen last night after their meeting here, accepting his peace proposals upon condition that the union's interpretation of the strikers' suggestions be recognized.

Violence was reported from six cities in as many states during the night. Four of the disturbances assumed the proportion of riots, one resulting in the death of one man.

Carl Spradley was killed during an exchange of shots at Van Buren, Ark., between guards in the Missouri Pacific shops and men said to be strikers.

At Jackson, Mich., several police officers and striking shophen were slightly injured when more than a thousand strikers and sympathizers, including many women and children, attacked the station.

Eighty strike sympathizers attacked more than sixty workers in the Chicago Great Western shops at Dan Mullaney, Ill., where the strikers were severely injured and a dozen of the workers were missing when police stopped the fighting.

There was a riot at the Southern Pacific at East Bakersfield, Calif., where strikers and police were fired on. Police investigated, but made no arrests.

In Ligon, Kan., more than 100 men and boys, said to be strikers and sympathizers, attacked the home of a Burlington route car foreman who was accompanied by a policeman.

At Dallas, Texas, where strikers were beating and pinning a train at Upton, Texas, by hitting men said to be strikers.

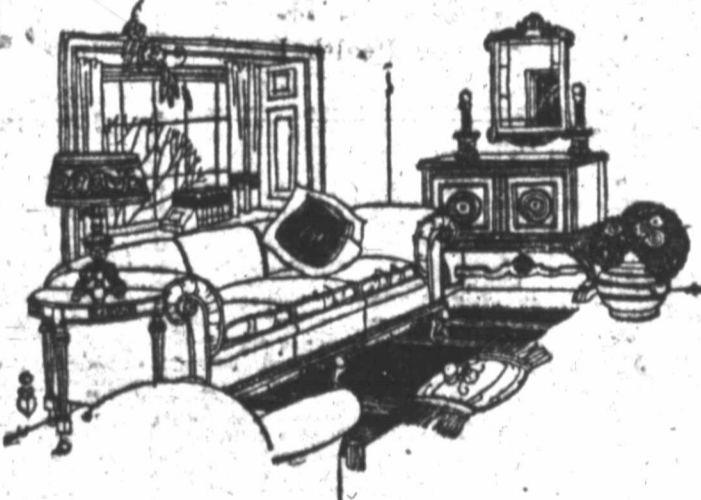

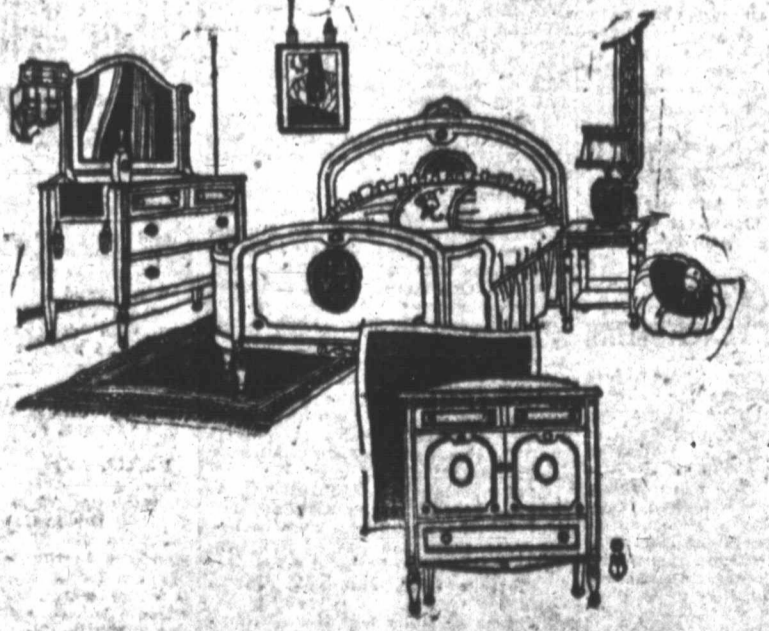

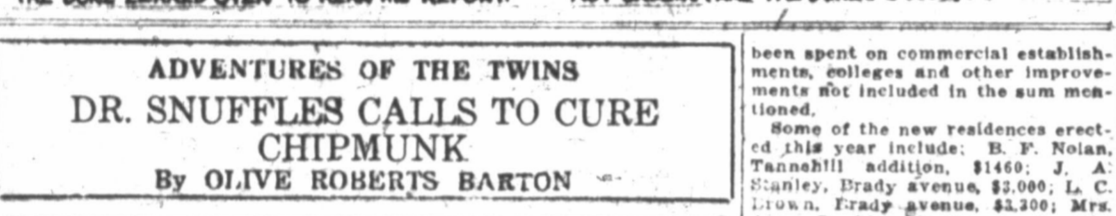

THE STRIKE GOES ON.
The settlement of the railroad strike now hinges
upon the question of the restoration of the seniority
of the strikers. Both sides have accepted President
Harding's proposals for a settlement with the exception
of this issue which the railroads have rejected.
The railroads claim that the acceptance of
President Harding's proposal for the restoration of
the strikers of their jobs with their seniority rights
unimpaired is impossible, first from a point of law;
second, from a point of morality; impossible also
because of the word pledged to old employees that
they would be repaid for their loyalty; impossible in
the last place because of promises made to new employees.
The responsibility for the continuation of the
strike is thus placed upon the railroads who seem
quite willing to accept this responsibility rather than
agree to the seniority proposal, and one can guess
that the railroads believe they can win this point
also and make their victory over the strikers complete.

While transportation has been badly impaired by
the strike and the situation has been more critical at
times than the public has realized the railroads have
not at any time been completely tied up and if reports
from railroad sources are to be credited their situation
is now much better than at any time since
the strike began. The failure of the shippers to tie
up traffic by their strike more completely than they
must have been a blow to their hopes for winning
the strike and must have influenced their leaders
to accept a proposal for a settlement which
failed to give them any of their demands except that
of the discontinuation of contract work by the railroads,
and they doubtless could have won this without
recourse to the strike.

BIRDS AS INSECT DESTROYERS.
There was a time before insect pests multiplied
in such numbers and when there were so many birds
that the number killed didn't seem to make any difference
that nobody thought anything of the value
of birds as insect destroyers. In later years as the
number and variety of insect pests have multiplied
there has been a closer study of bird life and their
insect destroying proclivities.
The United States Department of Agriculture has
been investigating this subject for a number of years
and experts of the department estimate that the birds
of the country save the farmers \$400,000,000 each
year—in other words, if it were not for the birds,
insects would destroy nearly half a billion dollars
more of farm products each year.

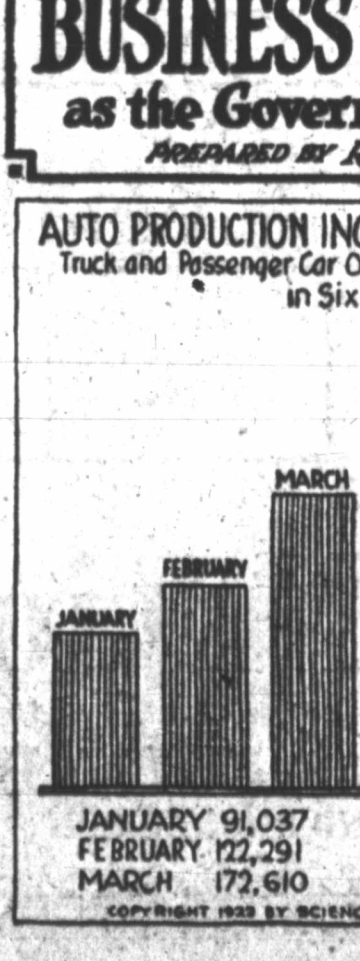

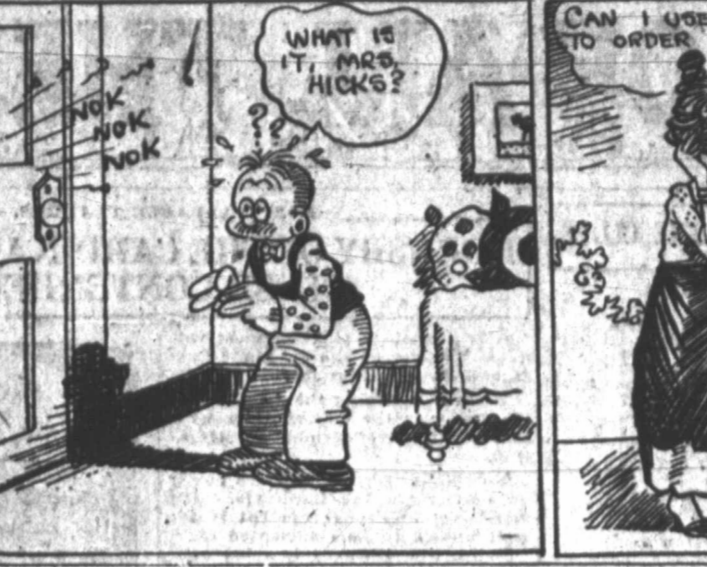

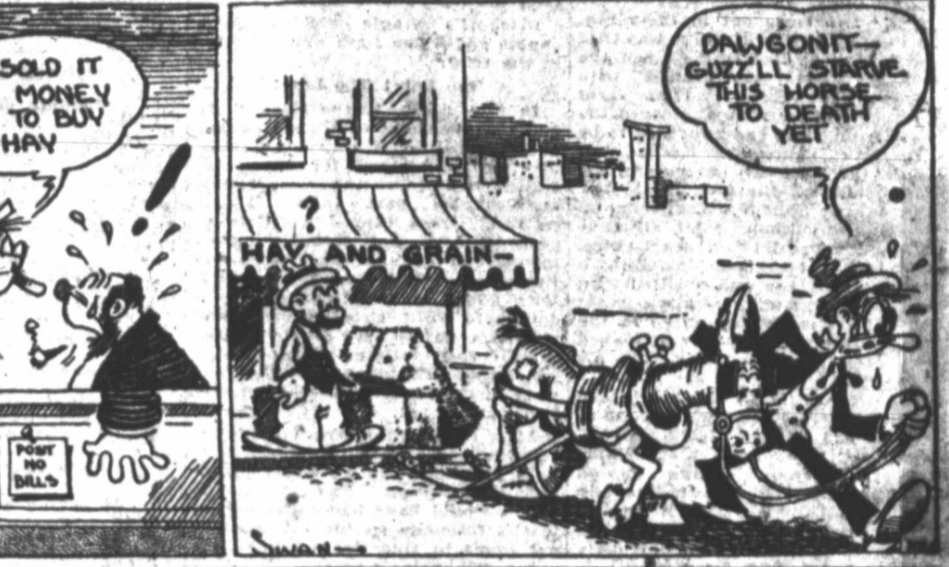
