



The diffi-culty is markedly increased as the culty is markedly increased as the warmth of the controversy climbs. Not infrequently newspapers hand-ling controversial news are con-demned by both sides as being unject as fairly as human mind can deal, but there are many partians who think the truth, if it militates against their side of the controversy, is grossly unfair, and that the truth should be distorted or repressed to agree with their own viewpoint. For the selfrespecting newspaper there is but one thing to do and that, thank goodness, is what most or all of them do—pub-lish the news as accurately as possible, as fairly as possible and let it go at that, even though they know in advance accurancy and fairness have no appeal for the bitter partisan. A newspaper's edi-torial columns are for expression of its own opinions. Selframenting of its own opinions. Selfrespecting or its own opinions. Selfrespecting newspapers express those opinions vigorously, but they do it with de-corum and due regard to the rights of the other side of the controversy as well as to the facts as they appear to the editorial writer. They know those opinions are likely to be unsatisfactory or objectionable to a considerable part of their readers, but give to those objects right to reply if they like. Men fall out with papers for expressing an opinion, just as they criticize those which never express one. They fall out with a paper that prints the news which in their prejudice they think hurtful to their side of the

















