REPORT SHIP IN ICE OFF WRANGELL ISLAND

NOME, ALA., April 14.—Reports received here indicate that Captain Roald Amundsen faced a severe storm today on a dog team journey that he started yesterday preliminary to a proposed flight over the north pole in June. Captain Amundsen, who left Seattle at the head of an expedition last June in the exploration ship Maud and went to Walwright, on the Arctic ocean, 500 miles north of here, in August with Lieut. Oskar Omdal, an aviator, expecting it to take him a month to return to his camp after passing the winter here.

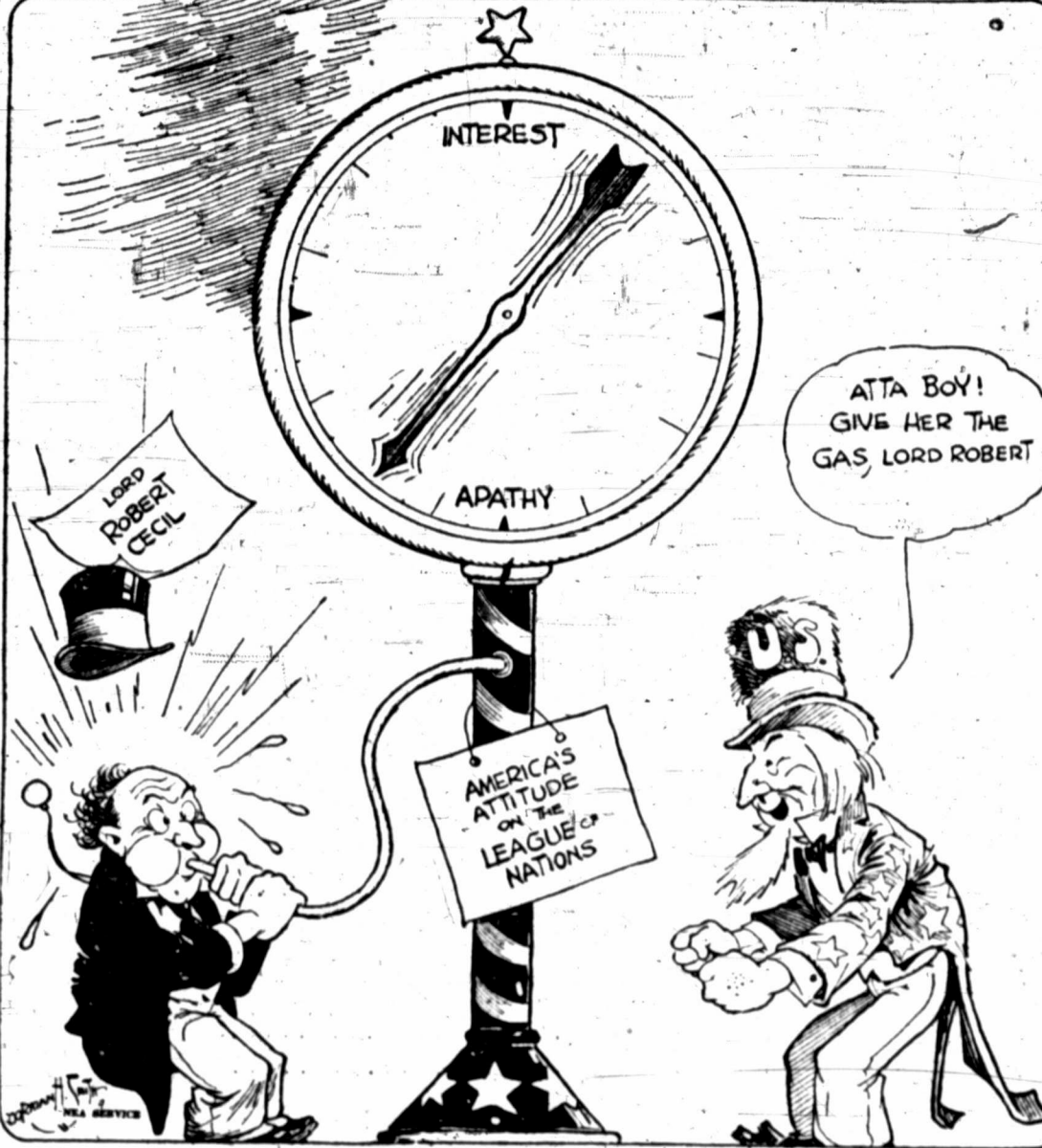

CHICAGO, April 14.—Industrial packing plants of the country have restored directly to 80,000 workers—and indirectly to 120,000 more—the 10 per cent of their wages which the same plant legislatures took away in November, 1921. Announcement last night that the plant assemblies had voted the pay increase marks the second big step by these organizations instituted by the packers as an alternative for industrial unionism.

FOUR HUNDRED ARE MISSING IN STORM

By Associated Press. TOKYO, April 14.—Four hundred persons, including a large number of fishermen, are missing as the result of a tidal wave and storm on the east coast of Korea, according to advices received in Tokyo by the Japanese navy department. The total number of lives lost is uncertain, but it is believed to be large.

AUTOMOBILE WITH NINE PEOPLE RUNS OFF AN EMBANKMENT AND BUT THREE OF PARTY UNINJURED

DENTON, TEXAS, April 14.—Mr. and Mrs. W. A. Martin were injured seriously when their automobile ran off an embankment six miles north of here last night and turned over three times. Martin sustained broken fingers, a fractured arm and internal injuries and his wife had both arms broken. Nine persons were in the car and all were hurt with the exception of three children.

INDICT MINERS' CHIEF COUNCIL IN W. VIRGINIA CASE

CHARLESTOWN, W. VA., April 14.—While defendants and attorneys in the numerous criminal cases resulting from a march of some 8,000 miners against Logan and Mingo counties in the summer of 1921 were preparing to return to Charleston next week of hearings in these cases, the state attorney today took a new turn with the indictment of the miners' chief council, Harold W. Hottel.

FOUR RUM SHIPS AND CARGO WORTH \$100,000 SEIZED

NEW YORK, April 14.—Four rum running vessels, carrying liquor cargoes estimated to be worth more than \$100,000, were captured yesterday by the "dry navy."

COTTON MARKET BREAKS VIOLENTLY OFF \$3.50 A BALE

NEW YORK, April 14.—The cotton market broke violently today with the July delivery selling down to 37.75, or 32.50 per bale below yesterday's close.

By Associated Press. NEW YORK, April 14.—All requests for records in sugar inquiry were refused by the New York office yesterday. Liquidation was further promoted by reports of improving crop weather in the south and complaints of a poor demand for cotton goods. Closing prices were the lowest of the day with the market weak at net declines of 48 to 70 points.

RAMON DE VALERA APPARENTLY ELUDES FREE STATE TROOPS

LONDON, April 14.—Ramon de Valera has apparently eluded the free state troops under General Prout who have been searching for him in the Tipperary mountains, says a Dublin dispatch to the Central News today. The whole district was thoroughly combed yesterday by thousands of soldiers aided by airplane observers. Several prisoners were taken. General Prout expressed the opinion that the region had been cleared of irregulars.

DUBLIN, April 14.—Irish free state troops this morning captured Austin Stack, former minister of home affairs, according to the Exchange Telegraph. The ex-minister was hiding in a ditch in the mountains near Clonmel in the district where Liam Lynch was captured recently, the advices state.

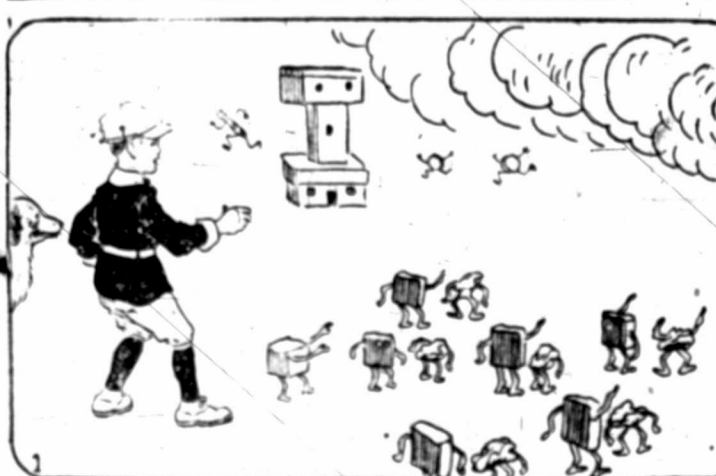

C-B-R-G COMPANY IS SOLD TO ABILENE MEN \$400,000 IS INVOLVED

Announcement was made late Friday afternoon of the consummation of the sale of the Wichita Falls and Quamish holdings of the Carroll-Brough-Robinson-Gates Wholesale Grocery Company to the J. M. Radford Grocery Company of Abilene, Texas.
This is said to be the largest deal of the kind ever made in Wichita Falls, nearly \$400,000 being involved.
The new company will take charge of the business Monday morning, April 16, with E. G. Baster, secretary of the J. M. Radford Company, in charge of the transition of the business.
The old office and sales force will be retained.
The Carroll-Brough-Robinson-Gates Company opened for business here in 1919 and has run with practically the same force since that time. An annual business of approximately \$500,000 has been done, which is one of the largest businesses in west Texas.
Fred M. Gates, who has been in charge of the local house, stated that he will remain in Wichita Falls and devote his time to private interests.
The Radford Company operates a large number of branch houses in west Texas, and is considered one of the strongest concerns of the kind in the southwest.

ARREST OF ESCAPED BANDIT IS EXPECTED TWO MEN ARE HELD

ATHENS, Ga., April 14.—Momentum is expected the arrest of Germain Chapman, escaped mail bandit, indictments were ready here today for Dominick Didato and Abe Silverstein of New York, charging them with aiding in Chapman's escape.
The grand jury action came late yesterday and federal officials announced an effort would be made to have Didato and Silverstein in Athens for trial on April 23 in United States district court. At the same time word was received from New York that Didato and Silverstein had been arrested and would be arraigned before a United States commissioner where it will be determined whether they will be sent here.
The men were identified as having been in Athens on the night of Chapman's escape from a hospital, where he was recovering from bullet wounds incurred when captured after his first escape from the Atlanta federal prison.

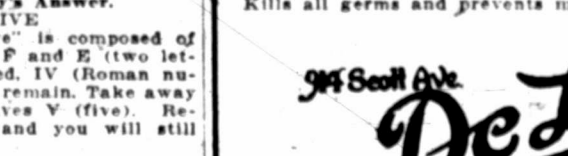

THIRD INTERNATIONALE IS TRYING TO STIR UP REVOLTS IN GERMANY

RIGA, April 14.—Reports from authoritative sources are that the third internationale is trying to effect a series of "putsches" (revolts) in Germany with the intention of establishing Socialist governments.
The corn which the Russians sent to the Ruhr, ostensibly for the workmen, is described in the reports as intended to form a Socialist reserve fund, "thus proving the seriousness of Trotsky's recent declaration that 'during Europe's revolutionary upheaval Russia will feed Europe.'"

EXPENSES FIRST AND THEN DIVIDE SURPLUS IN RUHR

By Associated Press.
PARIS, April 14.—The French and Belgian governments decided today at the conference of their ministers here to reimburse themselves for the Ruhr occupation expenses out of merchandise and money seized from the Germans. The two allies again emphasized their determination to evacuate the Ruhr only as Germany pays.
Any balance left after the military and engineering expenses are paid will be turned into the reparations fund for the benefit of all the allies.
The merchandise seized will first all be applied on orders already placed with Germany under the reparations schedule for German payment in kind, the French and the Belgians filling their own orders by compulsion if necessary.
Once these individual reparations orders are filled, the seized merchandise will be sold under joint Franco-Belgian control and the proceeds will be used with confiscated money, cash obtained from fines and other receipts, to pay the expenses of the occupying force as prior claims, only the surplus going to the reparations commission.
Premier Poincare of France and Premier Thaelens and Foreign Minister Jasper of Belgium with their advisers approved new instructions to the Rhineland high commissioners and to General De Goutte, commanding in the Ruhr, outlining the development of the policy of seizure of coal, coke, merchandise and money and the establishment of an accounting system for the distribution of resulting funds.

CONDITION OF BROWNS' BRILLIANT INFIELDER MUCH MOOTED QUESTION

ST. LOUIS, April 14.—The biggest mystery in baseball today surrounds the case of George Sisler, the best first baseman in the universe.

Whether Sisler will start the season with the Browns, whether he will be shipped to return to his position in mid-season or whether he will never again slip on his mitt are questions worrying the St. Louis club.

Sisler's case is interesting as well as mysterious. It will be remembered that he fell upon his right shoulder in fielding a wild throw at the bag end of last season.

The ligaments were torn and Sis was advised to rest for the remainder of the year. Against the advice of his physicians he played in the series with the Yankees that meant winning or losing the pennant for the Browns.

Adhering to one of the traditions of the game may cost the Browns the 1933 pennant, even more, it may terminate the career of one of the greatest players in the history of the sport.

In baseball no other word carries the sting of "quitter" to be branded as yellow is baseball's greatest disgrace.

Played on Nerve Alone. The word "quitter" kept ringing in Sisler's ears. He played on nerve alone, simply because he didn't want the baseball world to comment on his failure to perform in the big event of the year.

Present indications are that the club and Sisler are to pay a heavy toll. Several weeks ago rumors were heard that everything was not all right with Sisler. A serious case of influenza, contracted during the winter, developed into serious complications of the nose and sight.

Sisler did not go south. Nor will he join the team before it returns to St. Louis. His physicians admit that he has been having trouble with his eyes, and it is reported that he must undergo an operation.
