

MANY CANAL HANDS DYING

Cleanliness Causes Death of
Negroes at Isthmus
FRESH AIR FATAL
Unused to Perfect Conditions
Employs Find Malady More
Deadly Than Yellow Jack

WASHINGTON, July 16.—Perfect sanitation and cleanliness is proving fatal to West India negroes employed on the Panama canal, although Colonel George and assistants have banished yellow fever and other tropical fevers which made the canal country one large burying ground for the French canal builders. They have found that the sanitary precautions taken in the quarters occupied by the workmen make the Jamaican negroes especially susceptible to pneumonia and other lung and throat troubles.

WARNS REPUBLICANS

Letter Advises Members of Party to Keep Away from "Goose-neck Bill"

SAN ANTONIO, Texas, July 16.—Julius Oppenheimer, chairman of the republican executive committee of Bexar county, by virtue of the appointment of Colonel Cecil Lyon, has issued a warning, advising the loyal republicans of Bexar county to have nothing to do with the "Goose-neck Bill" McDonald faction of the party which has called a convention to meet in Houston on the same date as the regular state republican convention is held at El Paso. All republicans affiliating with that crowd will be read out of the republican party, according to the chairman's letter. McDonald has but a few followers here, as the negro population of the county is very small and C. M. Ferguson, deputy collector of customs, is holding them in line for Lyons.

TAFT UNDECIDED AS TO FUTURE

Has Place on Bench and Offered Chance to Make Race

WASHINGTON, July 16.—Secretary Taft contemplates another visit to the Philippine islands next spring, to be present when the Philippine legislative assembly convenes.

Whether or not he will make the trip depends entirely upon a number of important contingencies. Some of these relate to his future and whether or not he will become an avowed candidate for the presidency, or upon the supreme court bench and bury his political ambitions.

Secretary Taft is deeply interested in the welfare of the Philippine islands, especially in the capacity of the natives to govern themselves. He is particularly interested in the popular assembly, which will meet early next summer.

WANTS TO BE CHIEF JUSTICE

If he decides to make the trip, it will mean that he has decided that he will decline appointment as an associate justice of the supreme court and become an avowed candidate for the presidency.

Secretary Taft is not politically inclined, but prefers a judicial life as he is in love with his profession. He will not accept an appointment as associate justice unless the President forces him to do so, but if President Roosevelt should offer him the chief justice, Secretary Taft would bid good-bye forever to his political ambitions.

TO RAISE ANGORAS

Big Company Will Stock Ranch With Goats

The only ray of light in Mrs. Harry Thaw's life day by day is the few moments she is allowed to sit in her husband's company in the Tombs prison. Immediately after her lonely breakfast, her automobile bears her away to the jail. Usually, on account

of the prison routine, she is obliged to wait in the anteroom for some time. The meeting of husband and wife is always affectionate and Mrs. Thaw is always tearful when she is obliged to leave. From the prison she hurries to her lawyer's office, where a consultation follows. After lunch at

the home of Miss McKenzie, where she lives, the reporters begin to arrive, but they rarely get more than a glimpse of her in the window. Part of her afternoon is spent in preparing memoranda for the defense. She does not go out in the evening, but reads a great deal in her room.

SOUGHT TREPPOFF KILLS WRONG MAN

Anarchist Assassinate Gen. Kozlov and Is Captured

ST. PETERSBURG, July 16.—The additional assassination of General Kozlov of the headquarters staff in the park at Peterhoff Saturday proves beyond question the murderer believed he was killing General Treppoff. The tragedy occurred at 9:20 o'clock in the evening in the presence of several thousand people, who were listening to music in the English park, adjoining the park of Alexander palace. A young man dressed in the clothes of a workman, seeing General Kozlov, who resembled General Treppoff, gazed long and earnestly at the general's face and then took a photograph from his pocket to compare it with Kozlov's features to make sure of his identity. The man then drew a pistol and fired four shots point blank at Kozlov, who fell mortally wounded and died on the spot.

DOWIE CLAIMS TO OWN BIG EMPIRE

Says Possesses 60,000 Square Miles in Africa

CHICAGO, Ill., July 16.—John Alexander Dowie is not satisfied with the "little lump of gold" which he claims to have possessed. Today he owns 60,000 square miles on the Gold Coast on the west coast of Africa. Dowie now claims to hold deeds to a tract of land in Africa aggregating about sixty thousand square miles. From this source he declares he expects to derive enough revenue as soon as all of Zion's indebtedness is paid out. This information was contained in a letter written by Dowie himself. Possession of Deeds "News" It was not known that "First Apostle" Dowie held such deeds or had any interest in such a large tract of land anywhere in the world outside of the United States. He declares that had he not been deprived of the use of the "leaves of healing" and the printing house he could have counteracted Voliva's "personal influence."

Expecta Fortune Soon
Continuing he says: "Within the last week I have had a number of letters from the Golden Coast (West African coast), some of which make application for membership and call on me for an officer of the church to come to minister to them. I hold deeds to a tract of land aggregating about sixty thousand square miles, from which source I expect to realize sufficient sums to entirely clear Zion of debt as soon as the present legal entanglements are removed."

TWO NATIONS WAR ON GUATEMALA

Honduras Joins Salvador in Present Struggle

CITY OF MEXICO, July 16.—Advices from Panama say Honduras has declared war on Guatemala. It is also reported that the Salvadorans under Bonilla have defeated the Guatemalans in a battle at Matatlan, forcing them to retreat. The declaration of war by Honduras on Guatemala brings a third state actively into the Central American fighting, which has been going on ever a month or more. Honduras and Salvador are now arrayed against their neighbor, Nicaragua and Costa Rica are the only two countries still passive and it has been said that the former is about to take part in the fighting.

Trouble Long Brewing
Up to today Honduras has seemingly taken no part in the difficulties between her neighbors. Recent reports, however, declared that her territory had been invaded by Guatemalan forces of fugitives from the army of General Regalado, the Salvadoran commander, who was killed in the fight at Jiquere. The present trouble in Central America has been brewing for a long time. For the past five years the revolutionists in that country have been planning and preparing for the overthrow of President Cervera, who is called a despot and usurper.

Guatemalan Army 60,000
The army of Guatemala is in fairly good shape and are some seven thousand professional soldiers in the republic, with 56,000 able-bodied men of suitable age. The reserves amount to about thirty thousand men. It was reported recently that Guatemala had 50,000 men under arms near the Salvador boundary line.

BARELY ESCAPES DEATH

DREYFUS SENT UP ON BOGUS LETTER

Guilt Is Now Fixed Upon Major Esterhazy

PARIS, July 16.—How the proof of innocence of Captain Dreyfus was discovered and the guilt of Major Esterhazy was established, was made public today by Bunau Varilla in brief as follows: He and Dreyfus were students together in 1878. Some time later Dreyfus wrote his friend, saying he desired some information about a scheme to develop the French Congo. About this time Dreyfus was arrested by a secret court martial. In discussing the case with his brother Maurice, proprietor of "The Matin," Maurice informed M. Bunau Varilla of his having in his possession a photographic reproduction of the "bordereau," constituting the only proof upon which Dreyfus was convicted. Handwriting Compared The idea then occurred to M. Bunau Varilla that he would compare some handwriting of Dreyfus with the document. Dreyfus had written him many letters while they were students, besides the one he had received in regard to the French Congo. The letters and documents were placed side by side. M. Bunau Varilla said at first glance they appeared to be the same handwriting. A more careful examination, however, resulted in a startling discovery. It was made when his friend read words containing the double "S."

Proof of Forgery
In Dreyfus' letters were several words containing the double "S." They were all written with the first "S" long and the second "S" short. In the document the first "S" was short and the second "S" long. M. Bunau Varilla's brother also made an examination of the letters and documents and made the same discovery. It was then that the proprietor of "The Matin" decided to publish the document so that its forgery might be discovered.
