on the Zeno Hemphill and Mrs. Carrie Morris Ranch approximately 18 miles northwest of Coleman.

Contract for job will amount to placement of approximately 316,000 cubic yards of compact-

ed earth fill material. Approximately 181 cubic yards of concrete and 7,168 pounds of steel bar reinforcement will be used in the three principal spillways. Approximately 692 feet of 24-inch spun concrete pipe will also be needed for the principal spillways. Salvaging and placement of topsoil in the emergency spillways will amount to about 51,000 square yards. Approximately 14,300 feet of net wire fencing will be required to go around the dams and emergency spillways to protect grass cover that will be established as a part of the project.

Council Argues Gas Bills With Supplier

Cross Plains city councilmen engaged in a verbal sparring match Tuesday night with W. B. Evans of Lubbock, part owner of the firm which supplies the city with natural gas for the municipally-owned distributing system.

Bone of contention was the amount of bills recently tendered the city.

Questions were raised regarding the accuracy of the office meter which measures gas coming into the city mains and also of the correctness of chart readings.

Roy Cox, gas commissioner, told Evans that he had installed a meter on the line to check the incoming quantity of gas and that a discrepancy existed. "Your meter measures more," Cox said, "and I have had ours read by a firm of experts."

Cox told councilmen that the difference over a two weeks period amounted to \$114.

Evans replied that he had his meter installed by a gas engineer and that if a discrepancy existed he was unable to account for it.

"I got the best man I could find to set the meter and have never read a chart myself," Evans declared, "they're always sent to a Breckenridge firm for figuring."

"Meter Didn't Work" Cox told Evans and the council that when he assumed duties as gas commissioner and went down to look over facilities at the city gate, the Evans meter was not working.

"Instead of making a chart or graph," he said, "it moved unvaryingly."

Mayor Ted Souder expressed the opinion that "something is wrong" and pointed out that

the city sales are not enough more than the bill tendered by Evans' firm to pay the salary of one man to look after the municipal distributing system.

Councilmen Otis Purvis and Ira H. Hall also expressed dissatisfaction with the present situation.

"Gas sales during July were \$1,003.20 and our bill was \$939, leaving a profit of \$64.20," Hall said. "This just doesn't make sense, especially during the summer months when the city profits as much as 750 per cent on some minimum consumers."

"We've spent a lot of money removing leaks," Purvis declared, "and our bill hasn't gone down any."

Mayor Souder corroborated Purvis' statement pointing out that all regulators and fittings had recently been replaced within the city and thousands of feet of new line laid.

Evans suggested that his charts for two weeks be taken by the city to a firm of experts of their own selection and that he would take recent charts made by the city meter and have them figured and that they meet again soon.

Mayor Souder set a special meeting of the council for next Monday night and both factions agreed to have charts read and be ready for continued discussion by that time.

Evans was asked by Hall how long his present contract with the city was to run and was told that the termination date is May 1, 1964. He said that he first began supplying the city Jan. 1, 1960.

In accordance with statutes, petition blanks were issued and proponents have 30 days to return to the Commissioners Court. The official request for an election, however, must be signed by at least one-fourth the number of voters who balloted in the governor's race in 1960.

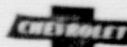

Dockery's 26 Points Leads Santa Anna Past Buffaloes

Santa Anna Mountaineer fullback T. Ker Dockery scored 26 points and rolled up 104 yards rushing in leading Santa Anna to a 28-0 victory over the home-standing Cross Plains Buffaloes Friday night.

Dockery, a 170 pound senior, scored all the Mountaineer touchdowns on runs of 23, 1, 11 and 24 yards respectively, and tallied a two-point conversion following the first TD.

Although Dockery hogged scoring honors, right halfback Randy Brown set up two of the visitors' six-pointers, and he was the night's leading ground gainer averagewise. He rushed for 83 yards on 10 carries for an 8.3 yards per rush. Dockery's average on 14 tries was 7.4 yards.

Fullback Jim Hargrove was the top gainer for the Bison, averaging 4.9 yards per carry

on 12 lugs for an aggregate of 59 yards.

Mountaineers Score

The first time Santa Anna had the pigskin Dockery capped an 81-yard, 10-play, drive with a 23-yard skirt of right end on a fourth and six gamble. Dockery then slammed over right tackle for the two-point conversion.

Three and one-half minutes later in the first quarter, after an exchange of fumbles with left tackle Terry McIver gaining possession for Santa Anna on the Buffs' 25, the Mountaineers scored again. Dockery got the tally on a one yard blast at left tackle. Halfback Brown set up the two-play spurt with a 24-yard sweep of right end. A pass was incomplete on the two point conversion try.

After a defensive second quarter, Mountaineer right tackle John Dillingham inter-

cepted a pop-up pass on the Cross Plains 40, and five plays later Dockery circled right end for the final 11 yards. Left halfback Bill Horne was stopped short of pay on the conversion try.

With 4:15 remaining in the final quarter Dockery ripped off 24 yards and the final tally, shrugging off a host of Buffaloes along the way.

Dockery's last goalward thrust came on a fourth down with four yards to go situation. Brown then broke into the scoring column with a reverse around left end. Brown's tally came after a half-the-distance penalty was assessed Cross Plains on a rules infraction on an attempted kick following the touchdown.

The thundering herd's deepest penetration of Santa Ann's territory came early in the third period when the Buff defensive line forced a hurried punt which fell short on the Mountaineer 35. But a penalty shoved the locals back, and on the second play of the series Dillingham swiped the "mistake pass."

Cross Plains offensive machine showed sign of life, but could not spark a sustained drive. Both elevens picked up eight first downs, but Santa Anna outgained the Buffs on the ground 265 to 110 yards. Bison passes constituted the air game connecting on six of 13 attempts for 58 yards, but two strayed into enemy hands.

The Buffaloes' longest march of the contest was a 39 yard spurt in the latter minutes of the third and early portion of the fourth quarter. The locals picked up two first downs in the 15-play drive, but it bogged down on the visitors' 36 yard line.

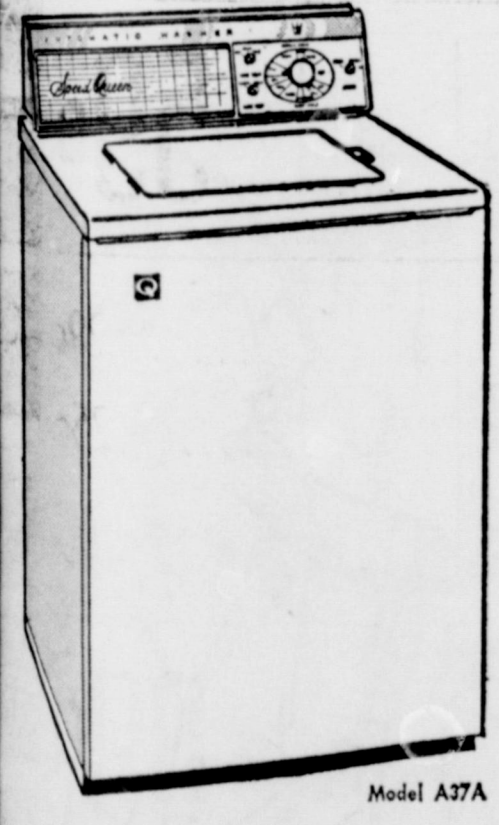

Putnam Rolls To 44-0 Decision Over Mozelle

The Putnam Panthers rolled to an easy 44-0 victory over the puncheonless Mozelle Mustangs here Saturday night in the first six-man grid battle ever played on the local field.

Although it took the host team Panthers approximately half the first quarter to find vulnerable spots in the Mustang defense, Putnam late in the first and early in the second quarters blitzed for three touchdowns while Mozelle had the pigskin only five plays.

A few minutes later Panther right halfback Marvin Henry pounced on a loose ball to set up Putnam's third TD. Isenhower then rambled 22 yards to the Mozelle one before Henry cracked into the end zone. Hock's kick was blocked by the Mustang's Ken Allen, a 220-pound halfback.

Quarterback Buchanan lofted a 34-yard pass to halfback Henry for the final first half TD. The play covered 34 yards. Hock again booted the two-point conversion, and Putnam left the field at intermission with a 30-0 lead.

Pad Lead
Midway through the third period left halfback Conrad Buchanan circled right end for five yards and another touchdown. Ricky Isenhower kicked the two-point conversion.

Mozelle then countered with their only sustained drive which carried to the Panther five before Henry smothered a loose ball at that point. On the first play quarterback Buchanan's pass found Henry at about the 25, and the fleet halfback outran the pursuing Mustangs the final 55 yards.

The Panthers will test seven more six-man teams this season, next week traveling to Abilene to do battle with St. Joseph's Academy.

Putnam will then take on McCaulley and Mattson in non-conference tilts before play for keeps begins Oct. 18, with Strawn at Baird. They will finish the season with three straight weeks of district contests against Lueders, Moran and Carbon, beginning Nov. 1, at Baird.

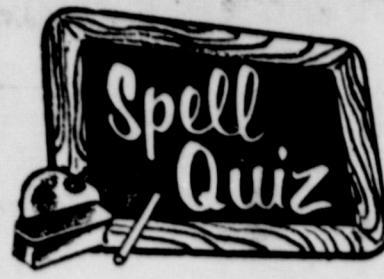

Feed Grain Acres Least In 60 Years

"Farmers' participation in the feed grain diversion programs of the past two seasons is having definite results," Tommie Harris, chairman, Agricultural Stabilization and Conservation County Committee said recently.

Following a steady increase during most of the preceding decade, the 1962-63 marketing season will mark the second year of declining supplies of feed grains, based on current estimates. The total feed grain supply now is estimated at 211 million tons, or about seven per cent less than in 1961-62.

Harris points out that the smaller supply in prospect, in the words of the Department of Agriculture's latest report on the fed situation, "is the result of smaller carryover stocks and a further reduction in the acreage of feed grains" — both objectives of the feed grain diversion programs.

The carryover of feed grains into 1962-63 now is expected to total about 73 million tons, 12 million less than a year earlier. Farmers planted about 5 million acres less feed grains this year than last, bringing total feed grain acreage down to the lowest level in more than 60 years.
