Vera Pearl Oliver Bunnell, 87, of Rising Star, passed away Wednesday, January 5, 2000, at Columbia Brownwood Regional Hospital.

Services were held at 2:00 p.m. Friday in Higginbotham Funeral Chapel with Dr. Richard Chaffin officiating. Burial was in Burkett directed Cemetery by Higginbotham Funeral Home of Cross Plains.

Austin firm to perform county commissioner precinct redistricting

Callahan County Commissioners voted to accept a proposal from an Austin firm to perform the county commissioner precinct redistricting.

Commissioners took the action Monday, January 10 during a regular monthly meeting. On a motion by Bryan Farmer and second by Tommy Holland, commissioners voted to accept the proposal from Allison, Bass & Associates, LLP of Austin to perform the county precinct redistricting.

According to County Judge Roger Corn, the company will compare the 2000 census population data with the present county precinct data to determine if a more thorough redistricting needs to be performed. If the population differs by 10% from the highest to the lowest of the four commissioners' precincts, the county is legally obligated to reapportion.

Judge Corn said the 2000 Census survey will take place in April 2000 and the redistricting firm will accomplish its preliminary findings in late 2000 or early 2001. It will not be known until April 2001 if Callahan County must reapportion its four commissioner precincts. The date necessary to reapportionment, called the 5th County, which contains racial and age profiles,

will be available in April of 2001. The county judge said when the redistricting findings are completed, the results will be brought to the commissioners' court during an open meeting.

The cost to perform the preliminary redistricting will be \$9,000 and if the county precincts must be realigned, there will be an additional \$6,000 cost.

According to the Texas Constitution requires the Texas Legislature periodically reapportion. Likewise, each county shall be divided into four "commissioners precincts" from which one commissioners is elected to a four-year term. These four Commissioners, together with the County Judge, constitute the County Commissioners Court. This Commissioners Court exercises such powers and jurisdictions over all county business. The Texas Election Code vests

responsibility to periodically reapportion County Election Precincts, Commissioner Precincts and Justice of the Peace Precincts with the Commissioners Court.

Commissioners Courts are permitted, under proper circumstances, to consolidate election precincts to avoid burdensome election costs.

Pruning Trees

How often does a tree have to be pruned? Is it done at regular intervals? It depends on the type of tree, the space available and the ultimate size you desire. Basically, your better off to leave the tree alone until you see a real need for pruning. It's like answering the question, "How often do you get your hair cut?"

Small limbs that knock off your hat or poke you in the eye can be cut back as needed. Larger limbs that are rubbing or hanging over your house and causing problems should be removed in January or February.

Be sure the limb is sound for climbing, remove small branches first. Begin by undercutting. Cut one-third of the way through, beyond the undercut and cut through the limb from top down. As the weight of large limbs cause it to fall and split the bark, it will tear only as far as the undercut. Finish the removal by cutting almost flush with the main trunk. Seal the open wound with black tree pruning paint.

Reasons Not to Top Trees


Top a tree and it will regrow vigorously, with three or four times as many shoots as before. Those new limbs will be weak and easily broken by ice and wind. The tree will be more subject to

insect and decay. Topping also ruins the natural shape and beauty of the tree. Maybe you should consider removal and replace the tree with one more to your liking.

parents who smoke can take steps to lessen the ill effects on their children.

"Sometimes we are quick to condemn or blame parents who smoke. I think we need to be sensitive to people struggling with how to deal with this problem," said Dr. Marianna Sockrider, an assistant professor of pediatrics at Baylor College of Medicine.

Many studies have described the health risks to children of secondhand smoke, such as respiratory problems and the increased chance of ear infections. Fewer studies have looked at ways to intervene with smoking parents to reduce or eliminate exposure, Sockrider said.

She outlined several steps that parents who smoke can take to reduce the risks to their children:

 Smoke only outside the home, whether that means outdoors or in another setting.

· Parents who have not been successful in smoking outside should designate a well-ventilated smoking room where there is fresh, outside air exchange. A ceiling fan or small air filter is not effective.

 Smoke in the home only after children are asleep.

· Never smoke in a car with children.

· Choose to sit in the non-smoking sections of restaurants. tic

The steps listed won't eliminate 20 exposure to tobacco smoke, but will F limit it. The lower the exposure, the less the risk, Sockrider said.

A Parents who smoke and who limit their children's smoke exposure may A also be helping themselves, she said. Fund limiting steps make them cut down S on smoking. Often, they have a Pot & greater chance at success in the ul-Texa timate goal to quit smoking for Sockrider said.

"Having a smoke-free home is Ele at good for the whole family and it rel sends a strong message to kids about pu valuing good health for all," she said. ani

23.023 barrels of crude. June with 23.322 barrels of oil. July with 23.231 barrels of oil and August with 22.238 barrels of crude.




