## County Commissioners Court Approves Expenditures

During last Monday's County Commissioner's Court meeting, commissioners approved expenditures that included \$13,110 for a security system from Guardian Security that includes panic buttons in offices, Ports-to-Plains dues for 2006 totalling \$459.21, and a radio component that is a part of Homeland Security that will be reimbursed by the federal program. In the Public Hearing portion of the meeting, there were no comments by anyone in the audience concerning the taxation rate for the new fiscal year.

Commissioner John Wade asked about the status of the Courthouse Open House. Judge Garner responded that she was not pleased with some areas of the wooden floor and the carpeting. She also stated that the alarm system in the Courthouse was not working properly. Wade also inquired about the Sutton County Arena upgrade and renovation project. Garner stated it will most likely begin in the end of September after the Junior Rodeo. Commissioner Caviness reported he had met with an architect and will present some sketches or ideas for a cemetery entrance for all the members of the court to view at a September meeting.

Judge Garner commented on the county facilities' grease traps. She has received a bid from Robinson Plumbing in Junction for \$8,500 in order to comply with TCEQ requirements and the City of Sonora's Grease Trap Ordinance. The Civic Center, the Rodeo Arena Concession Stand, and the County Jail's kitchen will have the required equipment in place by the end of September.

Pastor Joe Hernandez of a local church requested permission to use the Courthouse grounds for an Outreach program on September 23rd from 10:00 a.m. to 10:00 p.m. The commissioners granted permission as long as the City of Sonora approves the street closure. The next regular Commissioners Court meeting is September 11, 2006.

## Hwy 277 Collision Claims Two Lives

A 2003 van driven by Leslie Allan Cox of San Angelo was driving south on highway 277

about 4 miles south of Eldorado. Antonio Esparza of Eldorado was traveling north and drifted into the south lane. Neither vehicle took evasive action, and they struck head-on. The van

driven by Cox came to rest facing northeast in the north lane. Esparza's car ended up facing south in the south lane. Melanie Cox, 64, who was riding in the front seat of the van was

killed instantly. Charlotte Reynolds, 70, who was riding in the back seat without a seatbelt, also died.

Leslie Cox suffered five breaks to his right leg and a broken pelvis. He was initially treated at the Eldorado hospital before being transported to Shannon Medical Center in San Angelo. Antonio Esparza was brought to Sonora until he could be taken to Brooke Medical Center in San Antonio.

## Fugitive Polygamist Sect Leader Arrested in Las Vegas

SALT LAKE CITY (AP) — The fugitive leader of a polygamist Mormon sect has been arrested in southern Nevada, the FBI said Tuesday.

Warren Steed Jeffs, 50, was taken into custody after he and two other people were pulled over late Monday by a Nevada Highway Patrol trooper on Interstate 15 just north of Las Vegas, FBI spokesman David Staretz said.

The other two people in the vehicle were identified as one of Warren Jeffs' wives, Naomi Jeffs, and a brother, Isaac Steve Jeffs, both 32, Staretz said. They were being interviewed Tuesday morning by the FBI in Las Vegas, but were not arrested.

Jeffs was being held in fed-

eral custody in Las Vegas pending a court hearing on a federal charge of unlawful flight to avoid prosecution, Staretz said. It was not immediately clear if Jeffs would face extradition to Arizona or Utah.

The traffic stop came about 9 p.m., after the NHP trooper noticed a red Cadillac Escalade on the freeway with temporary license tags, Staretz said.

Jeffs, the leader of the Fundamentalist Church of Jesus Christ of Latter Day Saints, was indicted in June 2005 on an Arizona charge of arranging a marriage between a 16-year-old girl and a married man, and unlawful flight to avoid prosecution.

He is also charged in Utah with two felony counts of rape

as an accomplice, for allegedly arranging the marriage of a teenage girl to an older man in Nevada.

Jeffs has been on the FBI's Ten Most Wanted list since May, with a \$100,000 reward offered for information leading to his capture.

The FLDS Church, which embraces polygamy, split from the Church of Jesus Christ of Latter Day Saints when the mainstream Mormon Church disavowed plural marriage more than 100 years ago.

The FLDS Church also maintains a multi-million dollar compound in Eldorado, TX. The ramifications of the arrest to the Eldorado compound are yet unknown.

## Broncos Open Against Harper Longhorns

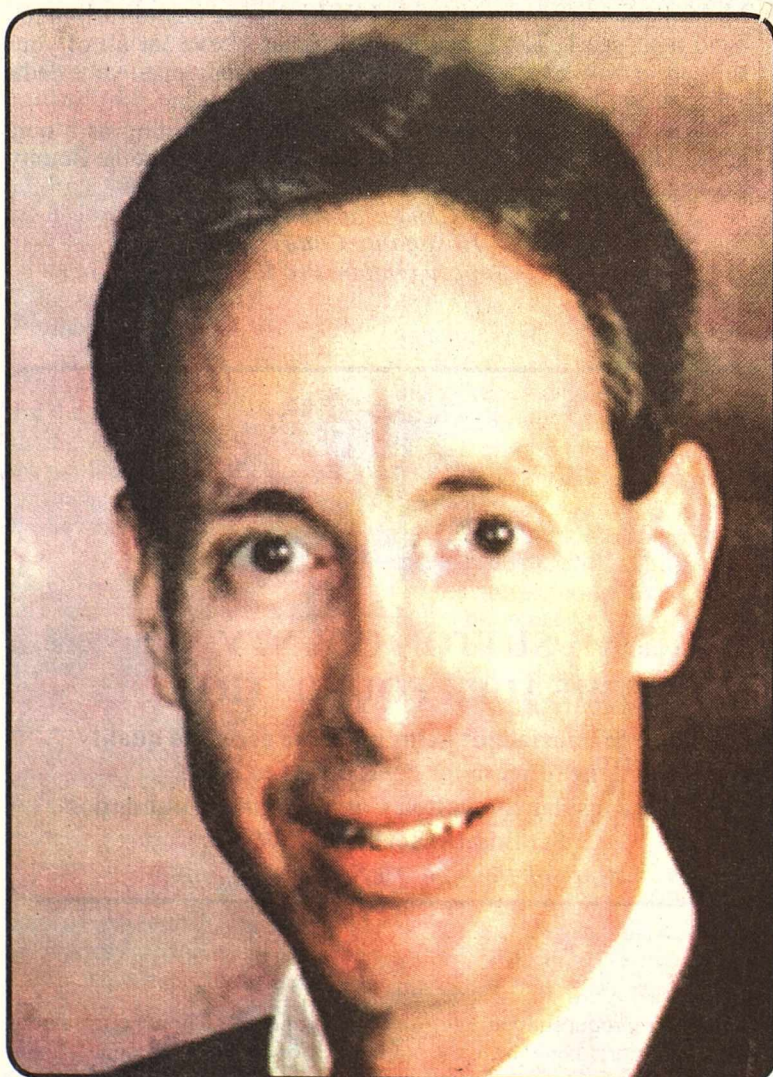
The Sonora Broncos open the 2006 football season away on September 1 at Harper. The 1A Longhorns should provide a good opening matchup for the Broncos. They finished in first place in their district last season. As we were going to press, we learned that the Longhorn quarterback was lost for the season during a scrimmage. Coach Herring's nephew will be playing tight end and linebacker for the Longhorns.

The Longhorn's stadium capacity is listed at 500. To get there, take the HWY 290 exit off I-10. The school and the stadium are a little more than halfway through town on the left as you are driving east on 290.

**Opening kickoff is at 8:00 p.m.** The last time we drove the route a month ago, it took us 1 hour 20 minutes to get to Harper. As in Sonora, most of the restaurants in Harper do not have a dress code or require reservations.

Both JV teams play their first games this Thursday. The JV White team will face the Grape Creek Eagles at 5:00 p.m. at Bronco Stadium. The JV Red team will play the Harper JV Longhorns at 6:30 p.m. following the JV White game.

## Warren Jeffs Religious Visionary or Sexual Predator?



Warren Jeffs' official title in the FLDS Church is "President and Prophet, Seer and Revelator". He also holds the title of "President of the Priesthood".

He was ordained to these positions in the Church after his father, Rulon Jeffs' death on September 8, 2002. There had been no official process for replacing Rulon as the President (Rulon had thought

he would live to the Second Coming). However, Warren had been ordained as "First Councilor" to his father.

When his father died, he appointed himself the new leader of the church. One of his first statements after his father's death was directed at high ranking officials in the church: "I won't say much, but I will say this—hands off my father's wives." Then addressing the recent widows, he said, "You women will live as if father is still alive and in the next room." Within a week, Warren had married all but two of his father's several dozen wives. After this, he continued to wed himself to many more women.

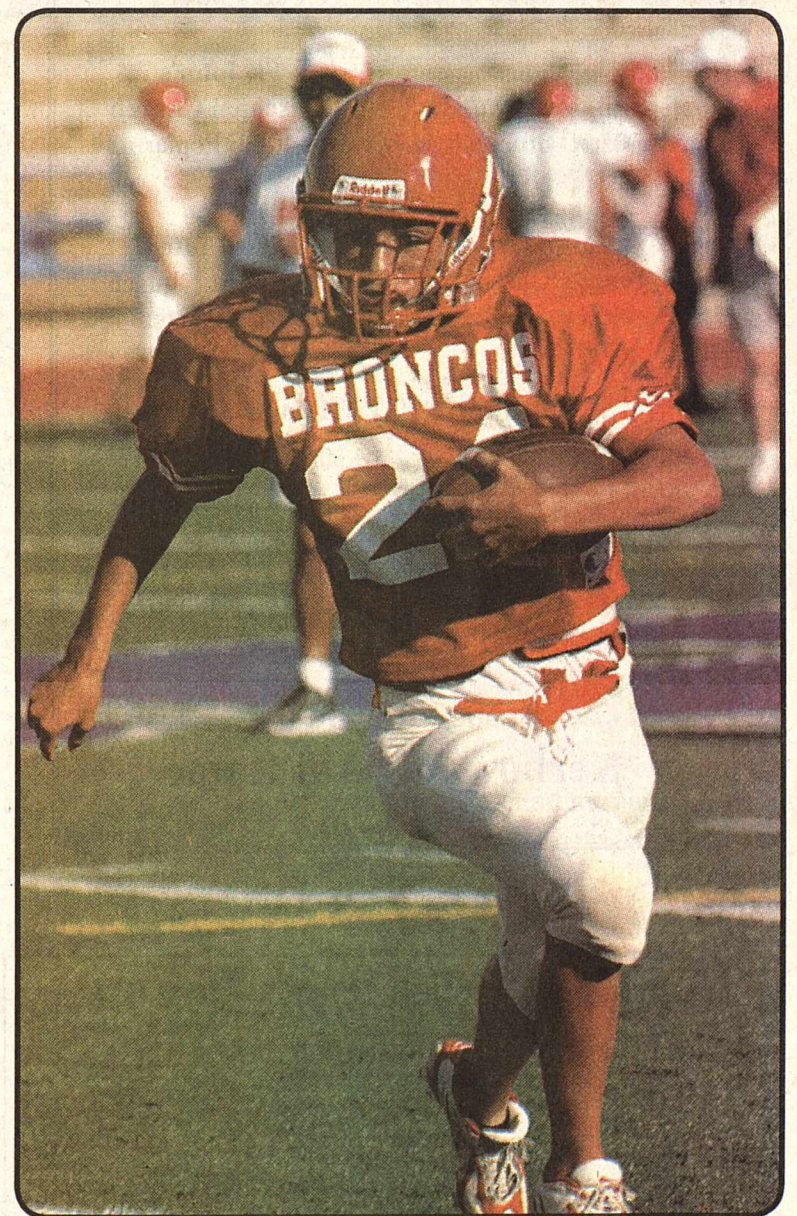
Warren Jeffs as prophet and leader of the FLDS, has a considerable amount of control over members of the church and private behavior.

He has instituted rules that segregate and isolate FLDS members from news and society. A group of men called the "Sons of Helaman" were assigned to check that homes only contained approved literature. The Church owns essentially all of the homes and real estate in the areas where its members reside and members who did not abide by the rules can be removed from their homes and cast out of the society. Jeffs is the sole individual in the church who can perform marriages, and is responsible for assigning wives to husbands. If on good terms with Jeffs, a member of the FLDS can be assigned more than one wife. Jeffs also has the ability to punish men by reassigning their wives, children, and homes to another man.

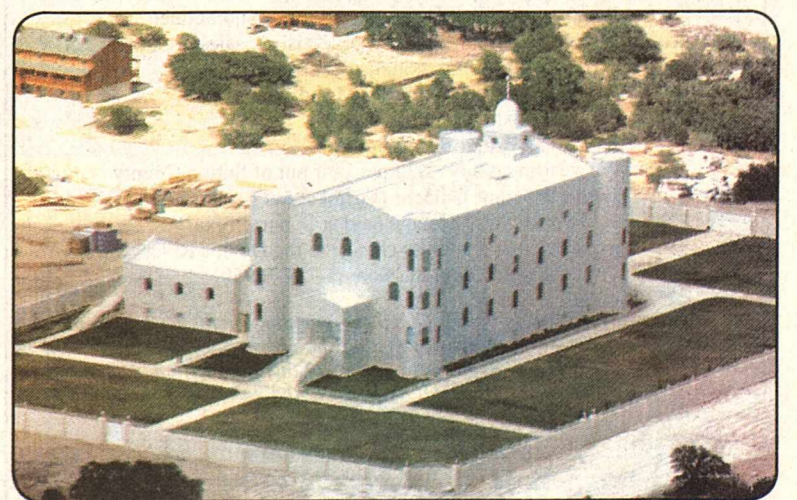
Until courts in Utah recently intervened, Jeffs controlled almost all of the land in Colorado City, Arizona, and Hildale, Utah, part of a church trust, the United Effort Plan (UEP), which is estimated to be worth over \$100 million. Currently, all the assets of the UEP are in the custody of the Utah court system pending further litigation. In January 2004, Jeffs exhibited his power by expelling a group of 20 men from Colorado City, including the mayor, and reassigning their wives and children to other men. Jeffs teaches that a man has to have at least three wives in order to get into heaven; former church members claim that he himself has seventy wives. (Egan 2005)

Before his 2006 arrest, Jeffs was last sighted on January 1, 2005 near Eldorado, Texas at the dedication ceremony of the foundation of a large and elaborate new temple on an area of land called the YFZ Ranch. The media has reported that the FLDS may soon or already have taken the area as their new home base.

On June 10, 2006, the Arizona Attorney General told the Desert Morning News that he had heard from several sources that Jeffs had returned to Arizona, and had performed marriages in a mobile home that was being used as a wedding chapel.

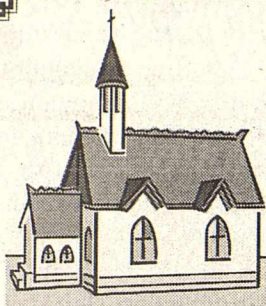

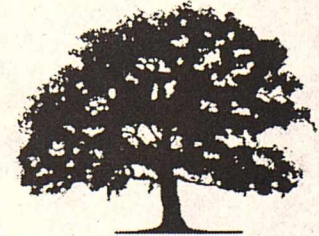

Next thing you know, you're suffering from a full blown case of Nutrition Procrastination. The good green stuff sitting in the produce bin of your refrigerator becomes a drawer full of green sludge, your jeans are too tight and your face looks puffy. And yet you still keep procrastinating about eating healthy...why?

Time for an intervention! I don't have to give you all the gory details on obesity, heart conditions, cancer and diseases implicated by poor nutrition. You know it! It's time to stop living in the fast food lane and get a reality check—you need real food to feed real people, yourself included.

Real food is easily identifiable. It comes with a minimum of packaging—if any, you know what it is at first glance without a TV commercial selling you on it (an apple, for example) and you know also, that not only does it taste good, it's good for you too!

Apples are starting to come in season—watch for falling prices and the announcements in your grocery store flyers letting you know they have a fresh crop in. There is really nothing like the snap of a crisp apple when you bite into it. Here is a very simple recipe utilizing the bounty of apples and making your house smell wonderful!

### CrockCooker Applesauce

Smells and tastes like Mom's homemade apple pie!  
 Makes 1 quart  
 3 pounds apples, peeled and quartered (I use gala or another sweet apple so I don't have to add sugar)  
 1 cinnamon stick, broken in half (or use 1 1/2 teaspoons of cinnamon powder)

In a crock-pot, place prepared apples and cook on high for about 3 hours, or until fork tender. Make sure the apples fill your crock at least half way so there is no burning. Serve in bowls warm.

For an extra special touch, sprinkle with a little bit of brown sugar and a splash of cold milk. YUM!

This week, try to add two healthy foods to your nutritional arsenal and give Nutritional Procrastination the heave ho! Baby step your way to better nutrition and add an apple to your snack list a few times this week (or make the applesauce recipe above and snack on that this week). Throw a salad on the table at dinner time, too (skip the Iceberg lettuce—it's just about devoid of any nutrition) and watch how much better you feel when you love your body with good food.

**TECHNOLOGY CHANGES GOLF**

Nearly all golfers have seen the picture of Ben Hogan hitting a one iron to the eighteen green in the 1953 U.S. Open. He used the one iron to reach a green that was 200 yards away. Today, Tiger Woods uses an eight iron for 200 yard shots.

I just want to go over some of the new technology that can improve your golf game. It is important to look good when you play. I recommend that you buy better slacks (BS), better shirts (BS), better shoes (BS) that come with the new plastic and better spiker (BS).

Once you look good, you need the newest clubs. The newest clubs all come with advanced materials in the shaft of the club. Be sure you investigate the better shafts (BS) that are available.

This 6185 yard public course is very inexpensive to play. 18 holes on a weekday is \$14.00 and on weekends is \$16.00. You can't beat that, plus having a fun time in San Antonio, and playing the same course that Ben Hogan and Byron Nelson played.

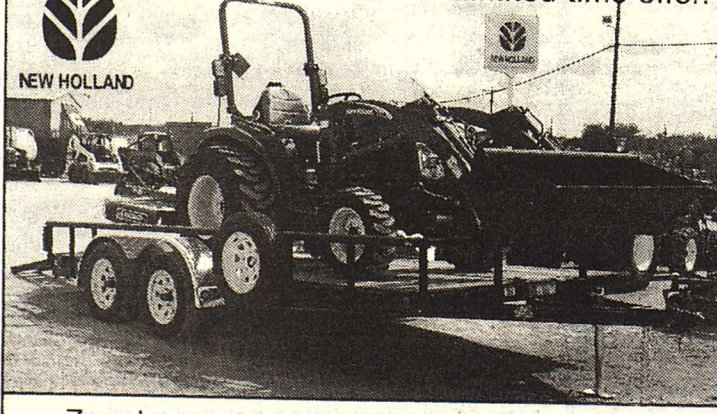

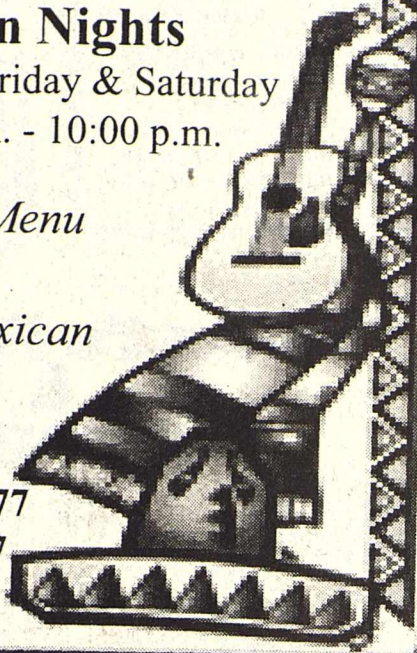

## Troopers Target Drunk Drivers for Labor Day

Texans who drive while intoxicated should expect extra attention during the Labor Day weekend. All available Texas Department of Public Safety troopers will be on the lookout for speeders, seat belt violators and drunk drivers from Friday, September 1 through Monday, September 4.

"It's against the law to drive when your blood alcohol content is 0.08 or above, and you should know that Texas Highway Patrol troopers will be looking for you," said Col. Thomas A. Davis Jr., director of the DPS.

"In addition to the criminal penalties, it's important to remember that there is a \$1,000 per year surcharge for three years that is assessed on drivers who are convicted of driving while intoxicated."

DPS supports the "Over the Limit. Under Arrest" campaign, a nationwide anti-DWI effort aimed at reducing alcohol-related deaths and injuries during the Labor Day holiday period.

DPS also is a participant in Operation CARE—Combined Accident Reduction Effort—a nationwide effort by police

agencies to reduce fatalities on major interstate highways during holiday weekends.

The punishment for a DWI conviction: First offense: a fine not to exceed \$2,000 and/or a jail term of 72 hours to 180 days; participation in an alcohol education and treatment program even if probation is granted; license suspension from 3 months to 1 year

Second Offense: Fine up to \$4,000 and/or jail term of 30 days to one year; mandatory 72 hours in jail even if probation is granted; license suspension from six months to two years.

Third Offense: Fine not to exceed \$10,000; prison term of two years to 10 years; mandatory jail term of 10 days even if probation is granted; license suspension from six months to 2 years.

Intoxication manslaughter: fine of up to \$10,000, prison term of two to 20 years, license suspension of six months to two years.

Last year, DPS troopers arrested 751 people for driving while intoxicated during the Labor Day weekend.

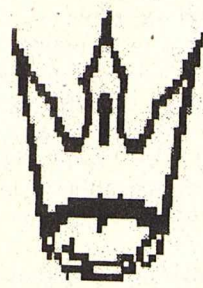

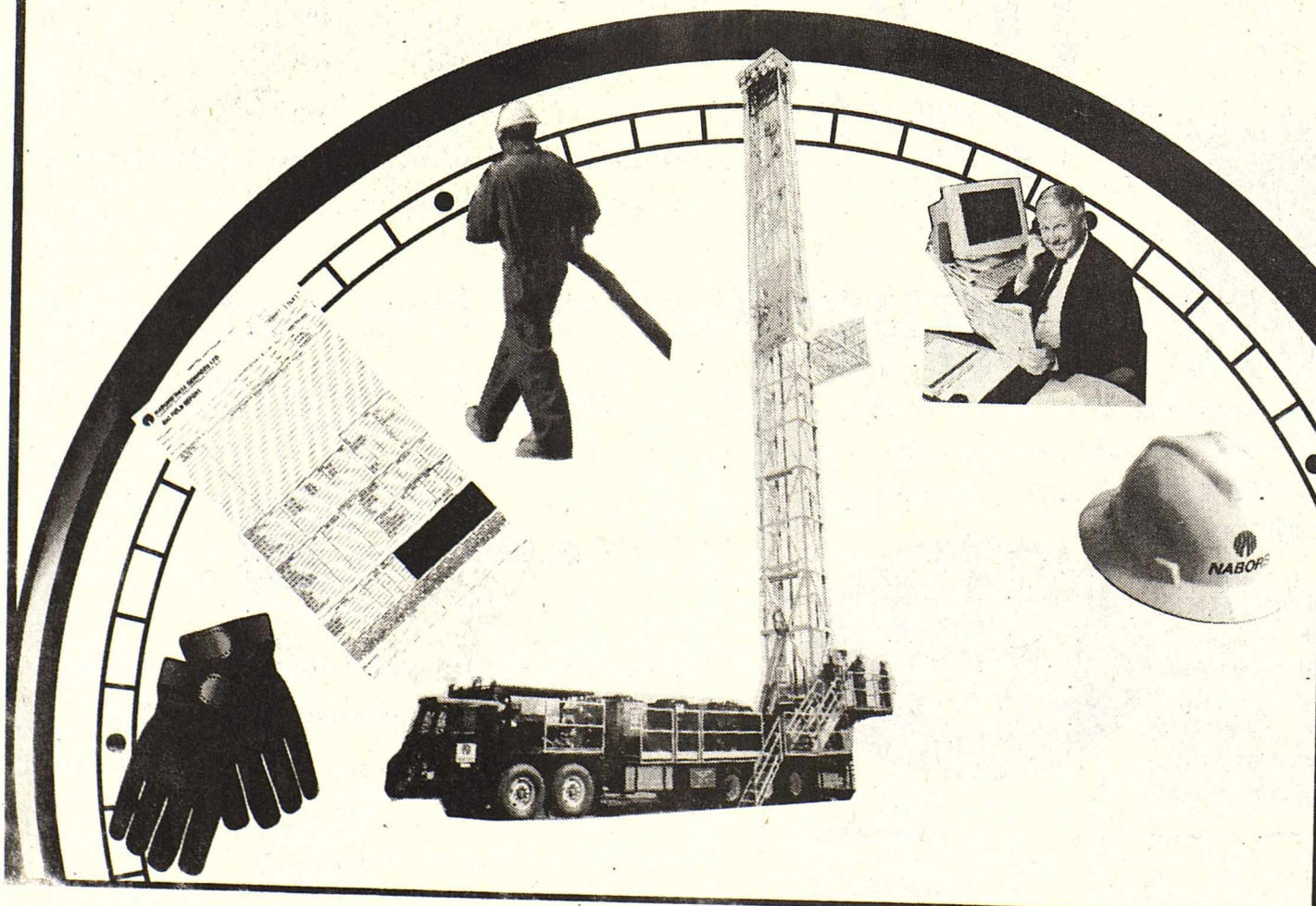

### TFS Confirms Texas Drought Has Reached Milestone

It has been hot and dry for months, and a recent drought assessment by Texas Forest Service confirms what most farmers, ranchers and firefighters have already seen. Thanks to persistent hot, dry weather, the average Ketch-Byram

Drought Index (KBDI) for the state has now climbed into the top three percent of the historical average drought readings, according to Tom Spencer, fire risk assessment coordinator with Texas Forest Service.

"This situation does not bode well for agricultural interests or firefighters in the state," declared Spencer. "In recent history, there have been only two other years that the average state

KBDI index reached this same level: 1998 and 2000. In both of these years, Texas experienced severe summer fire sieges."

Wildfire responses in the state since June support the growing concern among firefighters. From June 1 through Aug. 20, TFS fire personnel battled 578 wildfires that burned an estimated 101,774 acres across the state. Fire departments using the Texas Forest Service on-line fire reporting system to record their fire responses reported 2,884 fires that burned an estimated 70,587 acres over this same period.

Gary Laco, wildfire prevention chief for TFS, urged strict compliance with outdoor burning bans and proper disposal of smoking materials. He also said that use of welding and grinding equipment around dry

vegetation should be avoided if possible and closely monitored for accidental fire starts. Even driving through tall, dry grass and weeds should be avoided, as hot catalytic converters could ignite wildfires.

### Feeding Deer- Supplementing or Baiting?

Wildlife biologists are often asked what and when deer should be fed. Usually, the best way to feed deer is to let them find their own groceries on the range. We can ensure deer are getting adequate nutrients for optimal growth, reproduction, and antler development through good land stewardship. This means sound-grazing practices and well-planned brush management. The first step then in feeding deer is to have the range in top shape through proper use and proper stocking of livestock and wildlife.

Land managers with properly-stocked range and high-quality pasture who still insist on feeding should consider three important factors before proceeding. First, assuming that feeding deer will produce more fawns, the manager must plan to thin the herd to avoid overstocking and cause degradation of the habitat. Second, unless 'money is no object', plans must be made to somehow recover the feeding expense which will be considerable, especially if done year-round. And third, examine the effect of abruptly halting a feeding program if it becomes neces-

sary. Will the deer have become dependent on the supplement for their existence? If so, they will suffer because more deer are present than what the habitat can support. Simply put, once started, you may become locked-in to a feeding program.

Specific goals must be set before committing to a deer feeding program. Bucks with larger, more massive antlers are often a major factor. Sometimes a greater number of fawns are sought. Or the objective might be to help carry the animals through a particularly stressful dry time or extremely cold period. Maybe the need is simply to attract deer for observation or hunting.

Managers should decide whether they want to feed a dietary supplement or just use feed as an attractant or bait. The two feeding methods are not the same, and require considerably different feedstuffs. True supplementation involves feeding nutrients that are lacking in the diet. These feeds commonly contain sources of energy and/or minerals, and protein. Protein is usually the primary nutrient of concern. A level of 16-20 percent crude protein in the deer diet supplement is generally considered best. There are many quality deer feeds that will meet this protein level.

Baiting is what is practiced by many Texas deer hunters and wildlife observers to draw deer within range. Since shelled corn is highly palatable to deer and is thus a strong attractant, millions of pounds of "deer corn" are sold every year for these purposes. If you want to just attract deer and not necessarily increase their nutritional plane, shelled corn will probably do.

However, you should avoid using corn to fill a large portion of the deer's diet because it's basically a source of starch, or energy, and it's quite short on protein and mineral content. As white-tailed deer are ruminants, their digestive system requires at least an eight percent protein level to enable the rumen's digestive bacteria to break down the plant material for further digestion. Corn's protein content isn't high enough to maintain rumen function.

All things considered, balancing a well-managed habitat with a proper stocking rate is the most gratifying and cost-effective way to provide for a deer herd's dietary needs. Managers who remain convinced that supplemental deer feeding is advantageous should carefully weigh all the options and consequences they'll face before ordering that first truckload of feed.

### Pre-Season Whitetail Scouting

By T.R. Michels, Trinity Mountain Outdoors

When you are getting ready for the whitetail season you should begin scouting in late summer by watching likely food sources. Does, fawns and bucks will be loading up on succulent grasses, clovers, ripening grains, berries and sedges at this time. Bucks don't always use the same food sources as the does, they often stay closer to their bedding areas. If they use the same food sources as the does they may appear either earlier or later than the does. By cruising roads with a good set of binoculars near agricultural crops and meadows during the morning and evening you can learn which fields the bucks use.

If you are there early enough in the evening you may see the bucks arrive and be able to determine where they came from. If you stay late enough you may be able to see them go to either another food source or back toward the bedding area. Because buck's don't travel very far at this time of year their bedding area should be nearby.

When you see bucks at early morning food sources stay long enough to see which way they leave. In the morning deer usually work their way slowly from open areas, to high grass or brush and finally into heavy brush or woods where they feed and bed intermittently throughout the day. Once you know the route they take back to the bedding area you can setup along it during the hunting season.

The buck's rub route usually winds through several doe use areas before ending up at a night time food source, then through other doe use areas as the buck moves back toward the bedding area early in the morning, before daylight. You should find several rubs along the evening rub route, and scrapes in transition zones, near food sources, along field edges and near doe bedding areas.

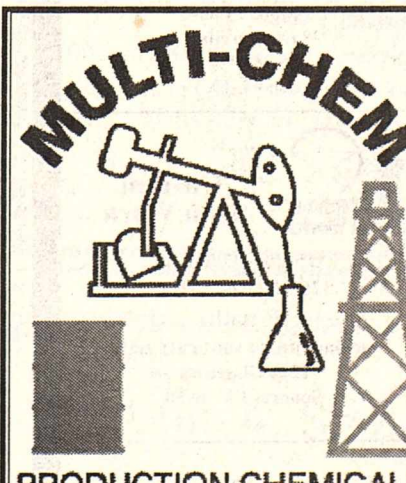

## Perry Calls Special Elections for Delay, Luna and Madla Seats on Nov. 7

AUSTIN - Gov. Rick Perry today ordered special elections to be held concurrently with the Nov. 7 general election for the U.S. congressional seat vacated by Congressman Tom Delay, R-Sugar Land, who has resigned and removed his name from the ballot; and for state Rep. Vilma Luna, D-Corpus Christi, and state Sen. Frank Madla, D-San Antonio, both of whom have resigned their positions in the Texas Legislature.

In his proclamation setting the special election for Delay's seat, Perry noted that the U.S. Constitution requires that a special election be held and state law requires that it be held on the next uniform state election date, which is Nov. 7. Delay represented the 22nd Congressional District, which consists of parts of Brazoria, Fort Bend, Galveston and Harris counties.

Luna represents the Texas House of Representatives District No. 33, which consists of part of Nueces County. Madla represents Texas State Senate District No. 19, which consists of Bandera, Brewster, Crockett, Culberson, Edwards, Hudspeth, Jeff Davis, Kinney, Loving, Maverick, Medina, Pecos, Presidio, Real, Reeves, Sutton, Terrell, Uvalde, Val Verde, Ward, Winkler and parts of Bexar and El Paso counties.

Candidates who want to place their names on the ballot for Delay's, Luna's or Madla's district must file with the Secretary of state by 5 p.m. Friday, Sept. 1.



## ARE YOU READY FOR SOME LOTTO?

The Texas lottery has been around for a while. It was voted in by a margin of two to one in November of 1991. It began on May 29, 1992. Tom Clowe, Chairman of the Texas Lottery Commission, says the first five years the revenues from the lottery went to the state's General Revenue Fund. Since 1997, they have gone to public schools in Texas.

"Revenues to school systems in Texas have totaled over 8 billion dollars," says Mr. Clowe, who lives in Waco. He told me he does not know how the money gets to the schools. The scratch-off, those lottery cards you get at convenience stores, brings in the most money: more than 75 percent of lottery ticket sales.

"Our instant tickets are growing. We're constantly changing them, getting all kinds of variations. I think a big part of the attractiveness to the scratch-off tickets is the instant gratification. People really like to take their ticket and scratch it off, see whether they won or not."

The Texas Lottery has some 16,000 licensed retailer locations statewide and can pay prizes up to \$599. There are 16 claim centers across the state where prizes up to \$999,999 can be claimed. Anything over a million has to be picked up at Lottery Commission Headquarters in Austin.

of the jackpot and what the percentage of payout is." Mega Millions also accounts for 6 percent of sales. The odds there are one in 176 million. Pick 3, Cash 5 and Texas 2-step bring in a combined total of 11 percent of sales.

"The annual revenue from lottery is about three and a half billion. This year we're projecting 3.8 billion dollars, so the return to the foundation school fund is over a billion dollars annually."

The lottery has generated a total of 42 billion dollars in sales. 13 billion went to the state, 24 billion went to players, and 2 billion went to retailers. Tom says gaming is big business in the US, bringing in more money than the movie industry and broadcasting combined.

Not everybody plays the lottery. "I have numerous people who tell me they play the same numbers every week and they just know they're going to win. I have other people tell me they've never bought a lottery ticket and never will."

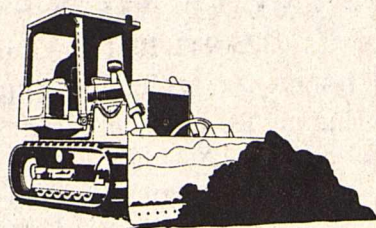

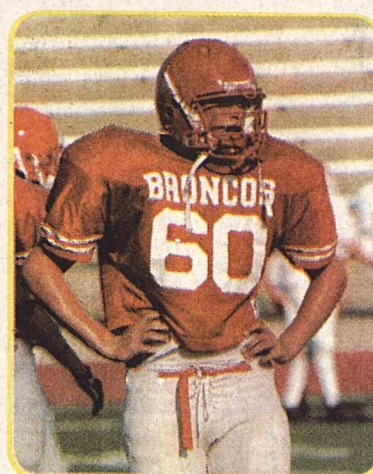

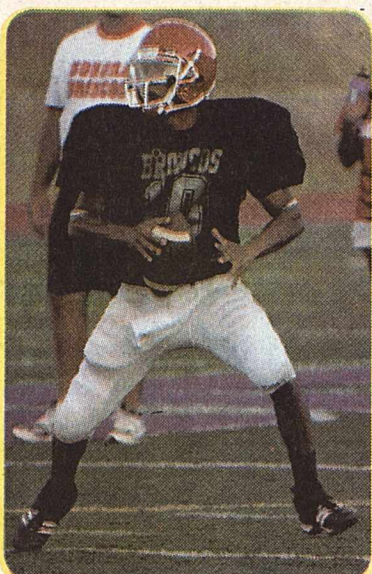
