#### Sonora Schools Evacuated for Second Bomb Threat; Administration Serious About Catching Callers March 2, 2006

Sonora ISD is offering a \$250.00 reward to any individual who gives information that will lead to the arrest and conviction of the person(s) responsible for the bomb threats made to the school district on February 9, 2006 and February 24, 2006.

"We're going to do everything we can to catch these people and we will prosecute to the fullest," said Sonora ISD Superintendent Doug Bawcom. Bawcom had just left the Sonora Police Department where an ongoing investigation is being handled by local law enforcement, as well as school administration.

The call came in to the Sonora Middle School on Friday, February 24, around lunch time. Sonora ISD staff, having been instructed on new protocol for answering all calls since the first bomb scare on February 9, 2006. It is reported that the caller was a female this time, and sounded young. The schools were immediately evacuated again, with the safety of the children and staff being the main concern. The same efficiency and cooperation as the previous evacuation was carried out, with all schools moving to the secure designated locations. Students were again transported to the Sutton County Civic Center where they could be out of the cold rain until parents could pick them up. Bawcom and Chief of Police Mike House again commended the teachers, aides, students and parents on their assistance and cooperation in insuring that all students were moved quickly and safely.

Thorough sweeps of all the campuses were once again held, with no trace of any suspicious activity being located, however school was dismissed for the day.

New phone systems have been installed in all the Sonora ISD buildings, allowing for all numbers to be identified. If a number is anonymous it will not be connected to a staff personnel, but will be transferred to an automated answering system. A message can be left, but all numbers will be traceable. Set procedures have also been set for answering all calls, with select personnel being allowed to answer the calls.

"Bomb threats are no joking matter and we're going to do everything we can to avoid such situations again," said Bawcom.

#### State Champions - One Act Play



#### One Act Play Wins State

In the performance of a lifetime, the Sonora High School one act play, "Unexpected Tenderness", swept the 2A State Championship in Austin on May 5th. The performance marks the fourteenth time Sonora High School has appeared at the State competition since 1949, and the fourth time Sonora High School has taken their performances to a first place finish. In 1971, Sonora High School won State with "Madwoman of Chaillot," directed by James Buchanan. A mere two years later, in 1973, John Tedford directed "The Apollo of Bellac" to a State title. Twenty years later, in 1993, "The Marriage of Bette and Boo," directed by Paula Rodriguez, brought home the honors.

"Unexpected Tenderness," under the stage direction of Renee Casey and Jerrilyn Miller, bested the other seven 2A school productions in the highly competitive State meet. Cast members included: Nash Traylor as both the elder Roddy Stern, and Archie Stern, Kayla Fields, in the role of Molly Stern, Nick Favela as the younger Roddy Stern, Kathy Pacheco portraying Sylvie Stern, Starlyn Chadwick in the role of Hattie Stern, Jose Casillas as Jacob Stern, and the role of Willie being portrayed by Brandon Munn. The stage crew consisted of Laura Martin, Kaci Chavarria, Erin Newton, Stacy Sanchez, Spencer Hall, and Alex Kenney.

Best Actress honors went to Kayla Fields for her wonderful performance as Molly. Earlier this spring Kayla, as a Sonora High School Junior, took the Best Ac-

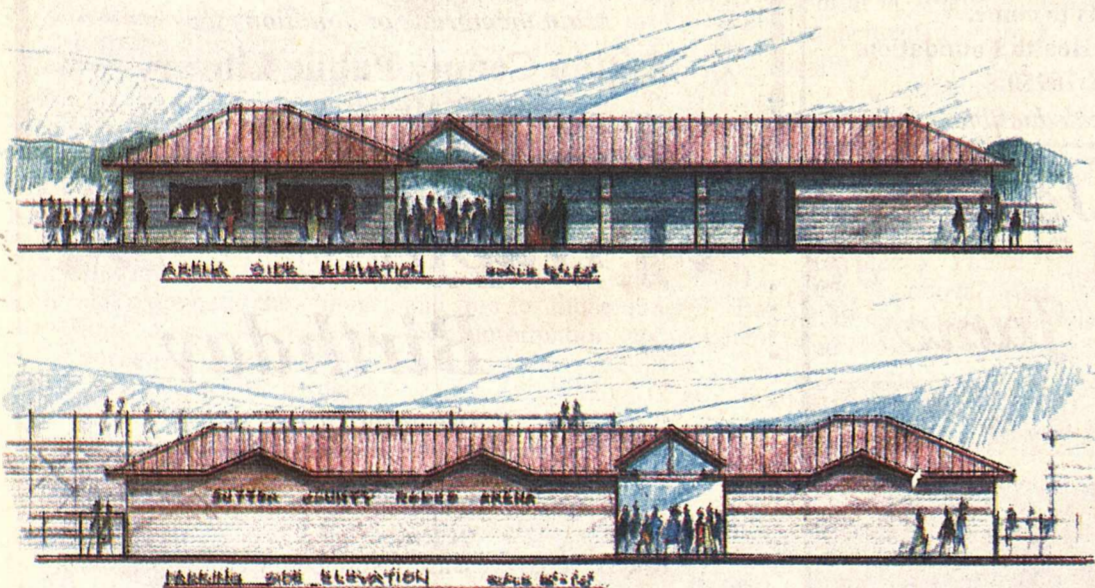
tress award at the Regional Competition.

Nash Traylor, in his dual role, brought home both Best Actor and the Samuel French Awards. The Samuel French Award is the most prestigious award an actor can receive in the University Interscholastic League State competition. The award is given for the Outstanding Performer within the performer's school classification.

Another highly sought after award is to be named to the All-Star Cast. Starlyn Chadwick's performance of Hattie, earned her the honor in the production of "Unexpected Tenderness."

In other 2A U.I.L. State competition held in Austin, Embre Smith competed in Computer Application, and placed fourth in the event.

#### Arena Improvements Set to Begin After Rodeo

The Sutton County arena improvements will begin after this year's Outlaw Pro Rodeo. A portion of the first phase of the project has been financed by the Sonora Industrial Development Corporation, the John and Mildred Cauthorn Trust, Town and Country Food Stores, Multi-Chem Group, Sutton County Days Association and individuals. Contributions from these entities will help to provide the new lighting, and sound system installations to the arena.

In 2004 an arena improvement committee was formed with Curry Campbell, president; Sharon Holman, vice-president; Elizabeth Schenkel, treasurer; and Suzanne Huddleston, secretary. Other committee members include Santiago Faz, Virginia Epps, Frank Wamble, Jessie Lem Wardlaw, Kelly Thorp, Danny Hardin and Rick Cearley. This committee has compiled an outstanding arena improvement packet that explains the obvious need for the upgrade of the arena. It also contains architect plans, donor categories, and a pledge form for contributions. This committee has been working with Chamber director Greta Ramsdell on grant requests and they are in the process of obtaining other funding.

The arena improvements are planned in two phases. Phase I will be new lighting, and sound

system repair, raising and reworking the existing bleachers and box seating, and erecting a canopy over the existing bleachers. In addition, construction of a new ADA compliant restroom facility with a connecting new state-of-the-art concession building will be a highlight of this project. The breezeway between these two facilities will be the new arena entrance and will also include a wall of honor, recognizing all contributors of the arena improvement project.

Phase II will provide new bleacher seating as well as more box seats between the existing bleachers and the bucking chutes. These projected arena improvements have an estimated cost of \$800,000.

The benefits of improving this facility are tremendous. The tax revenues generated from additional use of the arena due to the improvements will benefit our community for years to come. #### Jailer Assaulted at County Jail June 15

Sheriff Joe Fincher reported that on Wednesday, June 7th, 2006, at approximately 9:30 p.m. Jailer Bob Hartman, age 63, was assaulted in the Sutton County Jail.

Fincher reported the assault was the result of an attempted jail escape. The Sheriff stated when the jailer entered the cell, inmate, Freddie Chavez, age 26, hit the jailer and continued to hit him until he was unconscious.

Another jailer living in the apartment behind the jail heard noises and went to check the area. Upon entering and seeing an inmate

in the corridor, requested additional officers to come immediately.

Jailer Hartman was found unconscious, and the two inmates, Chavez and Tim Michael Holt, III, age 28, of Jacksonville, Florida, were both secured. Holt was being held on car theft charges from Florida. Chavez was being held for burglary charges.

Hartman was transported by Sonora EMS to Hudspeth Hospital and then transferred to Shannon Hospital in San Angelo, but was released Thursday afternoon.

Both inmates were charged with Aggravated Assault on a Pub-

lic Servant and bond was set at \$1,000,000.00. Aggravated Assault on a Public Servant is punishable by life imprisonment, or any term of not less than 5 years to not more than 99 years.

This marks the second incident involving inmates at the county jail in as many weeks. At 11:20 a.m. Monday, May 29, 2006 a Mississippi inmate walked away from the jail, sparking a manhunt that lasted until 2:00 am Tuesday. The escapee was taken back into custody in Lake Charles, LA.

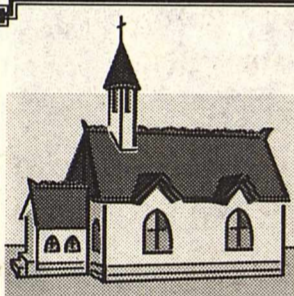

"Oh Grandma, It's BIG!" That's what Alyssa said in response to the new billboard located on Crockett Avenue in Sonora (near the bridge by the City Swimming Pool). But she was smiling from ear to ear.

And what a smile to share with Sonora! Exactly one year (March 15) after being diagnosed with Acute Myeloid Leukemia (AML), Alyssa Collins, 4, is home and doing well. She was released from Cook's Children's Hospital on November 14, 2005, after going through months of

chemotherapy and treatment for the cancer of bone marrow cells that is very rare in children.

American Cancer Society Board Member and Relay for Life Committee person, Kelly Thorp contacted Alyssa's family earlier this year about having the little ray of sunshine represent Sonora on the billboard, since so many people followed her experience over the last year. Everyone agreed that she would make a great spokesperson for Sonora's event that is scheduled for May 19 - 20, 2006 at Bronco Stadium. The annual fund raiser

## Bronze Star Awarded to SSG Justin King 10/12

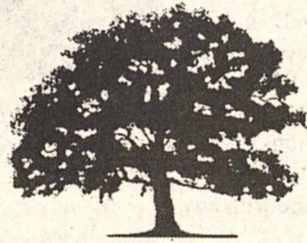

Staff Sergeant Justin King, son of Krista Brooks of Sonora, distinguished himself through exceptionally meritorious service as a Squad Leader and Convoy Commander for the 812th Quartermaster Company, from 04 November 2005 to 30 September 2006. SSG King proved to be an essential element in the restructuring of the 812th QM CO towards executing Convoy Security gun truck missions. He quickly developed into one of the most dependable and professional soldiers although he is a junior Staff Sergeant. As a convoy commander, SSG King began his tour as an E-5. Since that time, he has completed over 50 Combat Logistic Patrols with a total of 47,000 miles on some of the most treacherous roads in Iraq and even a few in Kuwait. With SSG King's motivation and take charge attitude, he volunteered to take a convoy farther

than any other to Kurkuk, Iraq. This particular mission turned out to be 20 days long. When SSG King accepted this mission no one could tell him how to get there, but that did not stop him from charging on. The convoy was on the road for 2 days before SSG King found out how to get to Kurkuk. SSG King consistently displayed sound decision making and courage in the midst of chaos. On several occasions he displayed exemplary leadership while being engaged by the enemy. On this 20 day mission SSG King got the opportunity to fine tune his Land Navigation skills and tactical procedures during enemy attacks. Therefore, with confidence and precision tactics, he led his convoy and many others through the danger zone.

Not only has SSG King played an integral role in convoy execution, but also at the Forward Operating Base. With a solid reputation as a valuable convoy

commander and squad leader, the unit relied heavily upon him to conduct Convoy Protection Platform recertification training, rules of engagement, escalation of force, communication equipment and procedures, weapons and other tactics, techniques and procedures. As a squad leader, SSG King not only trained his squad on their individual role in a gun truck, but made sure they were proficient in every other position. His dedication to his soldiers and the command's mission can be seen daily in the extra efforts put forth, going above and beyond mission requirements. SSG King's repeated success and dedication to duty are indicative of a superior combat leader. ## Historical Society

Q. Do you have any information on Fred Berger?

A. Fred Berger, son of Mr. and Mrs. Anton Berger, was born August 13, 1864 in Heinzen-dorf, Austria. He married Helen Brehm, daughter of Phillip Brehm on November 21, 1896 in San Antonio. He died July 26, 1934. Helen was born March 18, 1876 at San Antonio and died November 7, 1951 in Sonora.

There is a good outline of the life of Fred Berger in his obituary in "The Devil's River News," of July 27, 1934. Fred Berger, 69, pioneer resident died yesterday. He came here from San Antonio before the county was organized. His funeral is today.

Death at noon Thursday claimed Fred Berger, pioneer Sutton County citizen who has lived in this county before it was organized in the latter part of 1889. He had been in ill health four years.

### Historic 1859 St. Joseph's Church To Be Open For Public Tours On New Year's Day

The historic 1859 St. Joseph's Catholic Church, the oldest wooden church building in Galveston and the oldest German Catholic church in Texas, will be open to the public on New Year's Day, Monday, January 1, 2007, from noon to 3 p.m.

Although it has been and continues to be open by arrangement and for special events, the church is not regularly open for tours. GHF volunteer Leslie Burgess, who attended the church as a child with her aunt, will serve as docent for the New Year's Day tour, to communicate her knowledge of and affection for the building, one of the four oldest churches in Galveston, and the oldest constructed of wood.

Galveston Historical Foundation (GHF) operates St. Joseph's as an event venue for concerts, meetings, weddings, lectures and other private events. Upon its de-sanctification by the Diocese of Galveston-Houston in 1968, GHF took on the building's stewardship, raising the funds and organizing the volunteer efforts to keep the building at the northwest corner of 22nd Street and Avenue K in good

repair and available for community use.

A native of Heinzen-dorf, Austria, m. Berger, who would have been 70 years old August 13, emigrated to this country when he was 22 years of age. He spent a few months in St. Louis and then came to Schulenberg, Texas, and later to San Antonio.

The next year (1887) he came, with Jim Barton, who lived here for many years, to what was soon to be Sutton County. Mrs. J. W. Mayfield who lives here now recalls that she and her husband had their first meal in this section at Mr. Berger's tent. At that time there were not many houses and no fences. Grease was not available and beans, cooked with a leg of mutton, constituted a meal.

For many years he was employed on ranches owned by John Reiley, George S. Allison, J. N. Taylor and Jim Barton. He worked on the Fort Terrett Ranch for E. E. Sawyer for nine years and in about 1903 went into the boot making business in Sonora. He worked at this trade

for fifteen years.

Sonora people recalled yesterday his industry and his pride in the work turned out. His shop was located in a one room building between the J. W. Trainer store and the Craddock Building. (This would be approx. 221 NE Main St.) So adept was he that he conversed with visitors without missing a stroke of his hammer or a stitch of his needle.

In 1896 he was married in San Antonio to Miss Helen Brehm. Mrs. Berger survives him.

Since 1912 Mr. Berger and his nephew, Joe Berger, who has lived with him twenty-eight years have operated a ranch 1 1/2 miles west of town. Mr. Berger was a member of the Episcopal Church and has been a Mason for about forty years.

Mr. Berger is survived by Mrs. Berger; his nephew Joe; a brother, Frank, and a half sister, Mary, both of whom live in Heinzen-dorf, Austria; and a number of nephews in San Antonio.

Funeral services were conducted at the home at 3:30 in the afternoon. They were in the charge of Dee Ora Lodge No. 715 A.F. & A.M. The Rev. E. P. Neal conducted the services. Burial was in the Sonora Cemetery, Block G, lot 22, grave 3.

A small hole in the crank case and scratches on the car body, caused by barbed wire of the fence, were the only damage to the Spell vehicle.

A little extra tidbit from the 1934 papers: Beer can be bought and drank in a British graveyard. The only Inn in the country, which has this unique location, was 600 years old in 1934. It is the Mug house at Claines near Worcester. Ancient gray tombstones come within a few feet of the front door of the tavern, and the church itself is only 30 yards

away. When a villager calls for his evening pint, he must pass through the graveyard. There is no other entrance to the "pub." At one time the church held its vestry meetings in the tap-room of the tavern, and some centuries back the church received a portion of the profits from the sale of ale in return for granting a license. The Inn was established to "provide refreshment for lords and ladies after the church service."

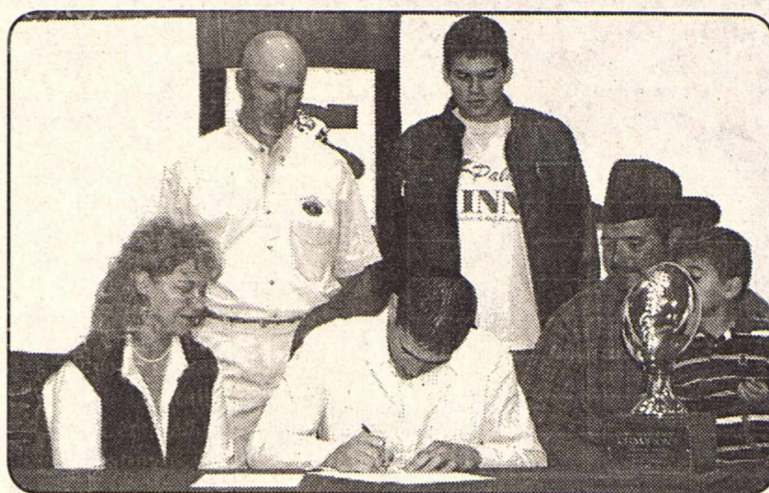

### Making His Move... Sonora Standout Duhon Signs Letter of Intent with ASU

SONORA - In Sonora's final regular season game, senior linebacker Steven Duhon went down with a knee injury near the end of the first quarter with his team leading 14-0. The initial prognosis was a torn ligament in his knee, and it looked as if Duhon's season - and aspirations to play college football - were over. He sat out the entire second quarter and watched District 2-2A foe Junction score twice to tie the game at 14-14.

At halftime, Duhon's injury was downgraded to a strained anterior cruciate ligament, and the three-time all-state player was determined to go back into the game. He returned in the second half, dropped Junction quarterback Weston Nieman for a 3-yard loss on his first play back and helped rally the Broncos to a 34-27 victory in a game they had to win to make the playoffs.

Wednesday morning, Duhon signed a letter of intent to play football at Angelo State University. The signing, which was held before the entire Sonora High School student body, also became one of Sonora head football coach Jason Herring's greatest moments.

"The trainer said he was done," Herring said of that fateful game. "Even when we found out it was just strained, it would take most kids three to four weeks to come back from it."

"After halftime, he was running sprints in the end zone to show me he could do it. When he made that first tackle, it was one of the greatest moments I have been a part of. He carried

the team on his back with one leg."

Duhon became the fourth Sonora player to sign a letter of intent in Herring's seven years at the school. Duhon is the third of those four to go to ASU, following in the footsteps of Tom Valliant (2004) and Bill Renfro (2002).

A letter of intent commits a recruit to attending a university that has sought him. Sonora, a town of roughly 2,900, has about 300 students at its high school. By comparison, ASU has about 6,000 students in a city of 88,000, give or take.

"At the end of the season, the last couple of games they had been calling," Duhon said. "They called me to visit two weekends ago. I went and visited with eight other recruits. The coaches and the players were real nice. I fell in love with the college. It sounded perfect."

"I talked to coach (Dale) Carr and told him I was coming. He sounded real excited. He has a tremendous nose for the football," Herring said. "He lives to play football. He runs track every spring just to make himself better. I can remember him talking about wanting to play at LSU. He is a very fierce hitter. He has tons and tons of heart. ... He will fit in well!" Angelo State's second-year coach said Duhon should be a good fit for his program. "He is a very good football player," Carr said. "I mean very good."

Duhon made his decision official at a gathering of students inside the high school. He sat at a table draped with a red Sonora High School banner and two golden footballs on each end, and signed his letter of intent. "There are so many thousands of high school athletes at so many small schools," Herring said. "Any time you have a player go on to college, it is a special occasion." It also helps that ASU is a mere 65 miles from Sonora. Duhon attended several ASU games this past fall. "I always wanted to play in college," Duhon said. "I am just real excited. I went to a lot of their home games. They never gave up. I also play with a lot of heart and never give up and let it all come out in the end."

### Lady Broncos Dominate 2006 All-West

The Sonora Lady Bronco Softball Team coming off a 2006 season with a record of 25-1 placed five players on the All-West Texas team, including Most Valuable Player, and Coach of the Year honors. Junior Meghan Krieg, with a phenomenal year both on the mound and in the batters box, was a shoe-in for MVP honors. Krieg's pitching statistics for the 2006 season was highlighted by striking out 249 batters in 132 innings, with an earned run average of only .079 percent. As a hitter, Krieg's batting average was a tremendous .588 percent, with 22 extra base hits and 8 home runs.

Coach Thomas Hanson, leading the Lady Broncos to a school record 25 wins, garnered Coach of the Year honors.

In addition to MVP and Coach of the Year, the Lady Broncos fared well in the First-Team selections. Infielders Heather Hughes and Kayla Fields, catcher Kimble Luna, and outfielder Azeneth Villanueva all received First-Team honors.

During the entire 2006 softball season, District 2-2A Defensive Player of the Year Sophomore Heather Hughes committed only four errors and had a batting average of .388 percent.

As a junior, Kayla Field's hitting percentages for the year saw a batting average of .397 and a slugging percentage of .584, as well as strong defensive play, throughout the season.

Sophomore All-District catcher Kimble Luna, finished the 2006 season with a batting average of .488 and a slugging percentage of an amazing .619. Defensively behind the plate, Luna's season was very effective, as well.

Freshman outfielder Azeneth Villanueva committed only one error during the entire season of play, and had a .409 batting average.

## High Speed Chase Yields 400 Lbs. of Marijuana (10/05/06)

Carlos Guerrero, 37 of Uvalde, is being held in federal custody in Val Verde County, following a high speed chase involving law enforcement agencies from Sutton and surrounding counties, Border Patrol, and the Texas Department of Public Safety officers.

Guerrero allegedly ran a Border Patrol checkpoint near Comstock in a maroon Chevrolet half-ton pickup truck.

Scattered throughout the truck was a large quantity of marijuana. It is not known if weapons, cash or other illicit items were found in the truck.

The chase began near Comstock, and ended as law enforcement agencies spiked Juno Road. Guerrero lost control after losing tire pressure, coming to rest in a pasture within a mile and a half of U.S. Highway 277.

This arrest is the latest in a

string of drug related arrests in West Texas in the past few weeks, in which law enforcement agencies are cracking down on the possession, sale, and/or the manufacturing of illegal drugs.

On September 13, an undercover operation in Crockett County resulted in twenty one drug related arrests. The arrests were related to the sale of marijuana, cocaine and methamphetamine. In a related undercover operation in Upton County, thirty people were jailed on drug related charges.

The Crockett County operation came on the heels of the September 12, 2006 arrests in Big Lake, Texas, of twenty four individuals on similar drug charges. Of the twenty four, ten remain in custody, with the rest either deported to Mexico or out on bond, awaiting trial.

## Fugitive Polygamist Sect Leader Arrested in Las Vegas (8/31/06)

SALT LAKE CITY (AP) — The fugitive leader of a polygamist Mormon sect has been arrested in southern Nevada, the FBI said Tuesday.

Warren Steed Jeffs, 50, was taken into custody after he and two other people were pulled over late Monday by a Nevada Highway Patrol trooper on Interstate 15 just north of Las Vegas, FBI spokesman David Staretz said.

The other two people in the vehicle were identified as one of Warren Jeffs' wives, Naomi Jeffs, and a brother, Isaac Steve Jeffs, both 32, Staretz said. They were being interviewed Tuesday morning by the FBI in Las Vegas, but were not arrested.

Jeffs was being held in federal custody in Las Vegas pending a court hearing on a federal charge of unlawful flight to avoid prosecution, Staretz said. It was not immediately clear if Jeffs would face extradition to Arizona or Utah.

The traffic stop came about 9 p.m., after the NHP trooper noticed a red Cadillac Escalade on the freeway with temporary

license tags, Staretz said.

Jeffs, the leader of the Fundamentalist Church of Jesus Christ of Latter Day Saints, was indicted in June 2005 on an Arizona charge of arranging a marriage between a 16-year-old girl and a married man, and unlawful flight to avoid prosecution.

He is also charged in Utah with two felony counts of rape as an accomplice, for allegedly arranging the marriage of a teenage girl to an older man in Nevada.

Jeffs has been on the FBI's Ten Most Wanted list since May, with a \$100,000 reward offered for information leading to his capture.

The FLDS Church, which embraces polygamy, split from the Church of Jesus Christ of Latter Day Saints when the mainstream Mormon Church disavowed plural marriage more than 100 years ago.

The FLDS Church also maintains a multi-million dollar compound in Eldorado, TX. The ramifications of the arrest to the Eldorado compound are yet unknown.

## City Council Updates Fee Schedule (7/27/06)

In a 3 to 1 decision, the Sonora City Council voted last week to institute a new fee schedule. Councilman Thomas Adkins voted against the decision. He expressed his concern that the increased fees would discourage people from purchasing, building, or moving homes into the city. City Manager Jim Polonis stated that we have fees for water, sewer taps and inspections, but they are out of date. Sonora's fee/permit schedule has not been reviewed or revised for quite some time, years. He cannot give an exact number of years since the last update, because it differs from person to person. Polonis said, "We have numbers that support the increases and I backed it up with a comparison to other communities. We are charging what it costs us and not a penny over it." The new fee schedule will be effective immediately and can be viewed on the City of Sonora's website.

During the meeting, two public hearings were held. There were no comments at either the hearing about the annexation of 20 acres of land off East 2nd Street or the hearing to discuss plans to file an application for Texas Community Development Grants funds. The council also passed a resolution to hold two public hearings on the possible annexation of .80 acre of land near 313 Railroad Street. The hearing dates will be published in the Devil's River News.

The council approved quarterly reports for the Fire Department, the Sonora Industrial Development Corporation, Historic Main Street, and the Sonora Chamber of Commerce. The council also approved both the Chamber of Commerce and the Main Street annual audits performed by Armstrong Backus.

The next regularly scheduled Sonora City Council meeting is August 15, 2006 at 4 pm at City Hall.

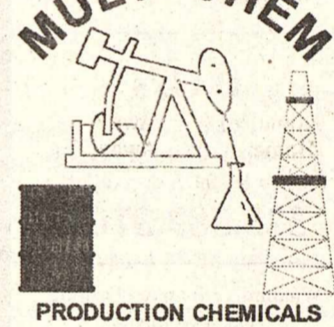

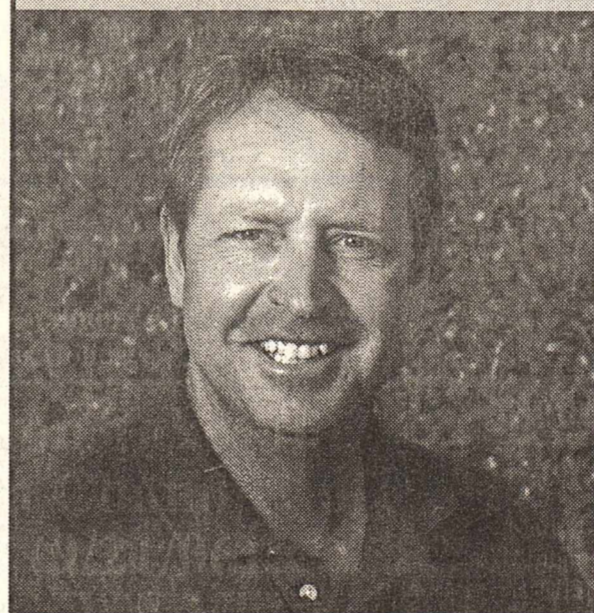

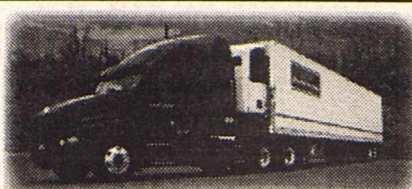

## Nowhere to Hide for Drug Dealers

(9/28/06)

Two years of investigation came to a climax in two hours as law enforcement agents made 21 arrests early on Sept. 13 throughout Ozona. Coordinated by Crockett County Sheriff Shane Fenton, officials started at 5 a.m. and were finished around 7:30 a.m.

The early morning round-up allowed the arrests to be made while people were still sleeping or preparing to leave for work, according to a press release from the Crockett County Sheriff's Department. All of the arrests occurred without incident.

The arrests are all related to the sale of dangerous drugs, such as marijuana, cocaine and methamphetamine. The charges range from state jail to second-degree felonies, which means if convicted punishment can range from two to 20 years.

There was limited space in the Crockett County Jail, which required prisoners to other facilities to assist with inmate hous-

ing, the release stated.

This month, the results of the two and half years of undercover investigation were presented to the Crockett County Grand Jury.

The Grand Jury issued 35 sealed felony indictments, ordering the arrest of 27 people for selling drugs in Ozona, the release stated.

"We wanted to make sure we had done everything exactly right," said Ron Hawthorne, investigator with the Crockett County Sheriff's Department.

Those assisting the Crockett County Sheriff's Department, Reagan County Kirt Pullig, Texas Ranger Brooks Long, 112th District Attorney Laurie English, Val Verde County Sheriff's Office, agents of the United States Drug Enforcement Administration and federal prosecutors.

English will coordinate the prosecution of the indicted drug dealers, and federal authorities will also be involved because some of the offenders may be prosecuted in federal court.

"We want to remove these dealers from our county. They sell poison that has destroyed the lives of the people who use it and the lives of those friends and family members who care about them."

Fenton also said that while this undercover operation will cause the arrest of many local drug dealers, others have gone undetected.

Citizens are encouraged to continue their support by reporting drug related activity to the Crockett County Sheriff's Department with the location of suspicious activity and, when possible, give vehicle license numbers and descriptions.

Another arrest was made last week in the

two-year drug investigation, while one man was sentenced to prison in district court.

Jimmy Roland Sanchez was arrested in Odessa on Sept. 19 and transferred to the Crockett County Sheriff's Office.

He is charged with delivery of a controlled substance. Sanchez is now the 24th person to be arrested is what is the result of a two and a half year investigation coordinated by Crockett County Sheriff's Office.

Earlier this month, a Crockett County Grand Jury issued 35 sealed indictments ordering the arrest of 27 people for selling drugs in Ozona. Three still have warrants out for their arrest.

Also last week, Luis Roberto Perez, 35, pled guilty in district court and was sentenced to seven years in prison.

Perez was one of 23 people that were arrested Sept. 13 in the drug investigation.

Perez pled guilty to two counts of delivery of a controlled substance. One of the incidents occurred on Feb. 14 and the other occurred on May 12, according to court documents.

Both offenses are third-degree felonies, which are punishable up to 10 years in prison with a maximum fine of \$10,000.

Perez was sentenced by District Judge Brock Jones to seven years in prison for each charge, with both charges to run concurrent.

District attorneys Laurie K. English and Stephen Smith prosecuted the case. Perez's defense lawyer was Gonzalo Rios.

The arrests are all related to the sale of dangerous drugs, such as marijuana, cocaine and methamphetamine. The charges range from state jail to second-degree felonies, which mean if convicted punishment can range from two to 20 years.

Law enforcement agents started an undercover sting of drug traffickers in July 2004 in Crockett County.

Also on Sept. 13, Upton County arrested 30 people on drug-related charges.

At 11:20 a.m., Monday, May 29, 2006, Jimmy Callahan, a 29 year old Mississippian, escaped the Sutton County Jail by prying off a hasp of the locking system on the recreation area door, walked across the courthouse lawn, waved at Mary Ann Kay, and stole Ed Mayfield's truck.

Even if you cause what seems to be only minor damage to the pipeline, notify the pipeline company immediately. A gouge, scrape, dent or crease to the pipe or coating may cause a future break or leak. It is imperative that the pipeline owner inspect and repair any damage to the line.

**HOW TO RECOGNIZE A PIPELINE LEAK**

**LOOK** - A pool of liquid on the ground, a white cloud or fog, persistent bubbling in standing water, or discolored vegetation are signs of a possible leak. Fire or explosion occurring near a pipeline facility should be reported.

**LISTEN** - Listen for any unusual noise like a hissing or roaring sound.

**SMELL** - Notice any unusual odor.

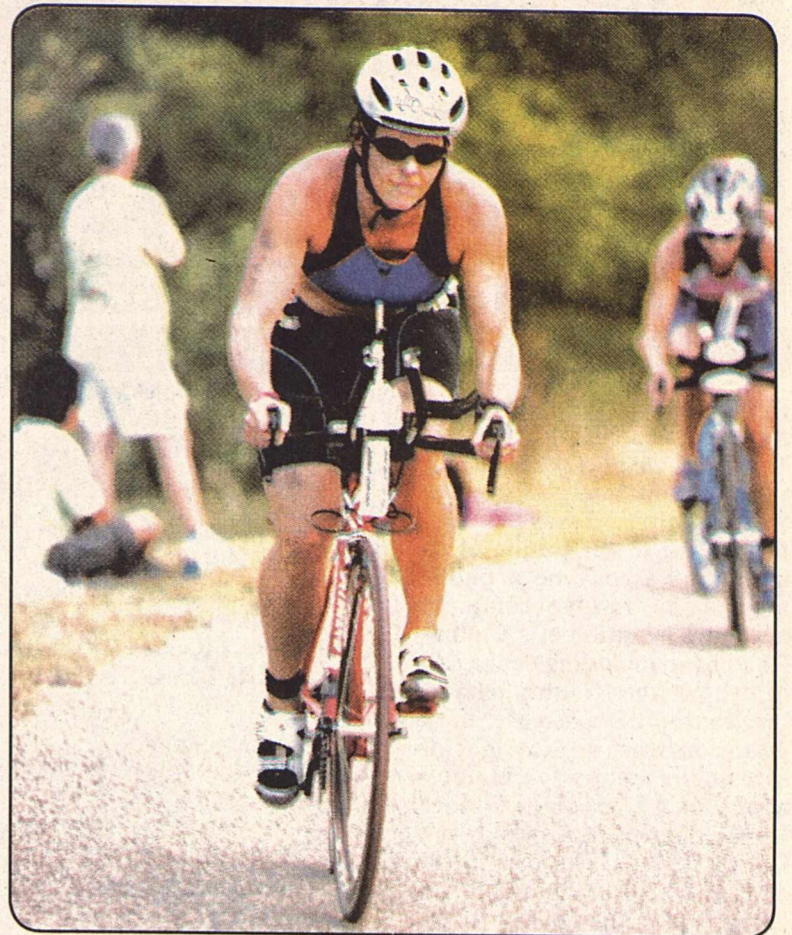

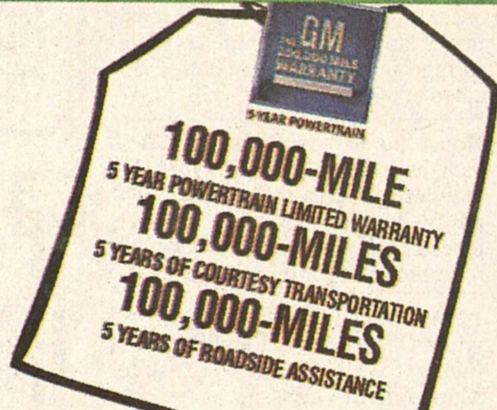
