Altercations Keep Police In Tahoka, Wilson Busy

Police officers in Tahoka and Wilson investigated reports of altercations during the last week, with one of the incidents also resulting in property damage to the extent that any charges filed would be a felony.

Ruston Jennings of Austin reported his 1988 Ford Mustang was pounded by several black males wielding a steel bar following a confrontation between Jennings and two other persons with "five or six" persons in a car at Allsup's in Tahoka on Saturday night.

Damage to the car was estimated at \$1357. Tahoka Police said suspects in the case were from out of town, and that investigation is continuing in the case.

In the same incident, the side mirror of a pickup owned by Joseph Paul Glisson of Lubbock reportedly was broken when someone in the group from out of town threw a beer bottle.

Wilson Police Dept. investigated a report early Saturday that three persons had been injured in an alterca-

tion at a party at a Wilson residence.
No one was hospitalized, but a woman reportedly suffered a cut on the hand, and two young men reportedly were injured by an object or by the fists of a young Tahoka man named as a suspect.

The Wilson officer said when he arrived at the scene about 2:30 a.m. Saturday "30 to 35 people were out in the yard" at the residence. Later the Tahoka man was questioned and he denied being the aggressor in the incident. His story was corroborated by a companion who was present.

No charges were filed.

Two persons pleaded guilty of felony charges before District Judge George Hansard in Tahoka Tuesday.

Jimmy Castro, 25, of O'Donnell, pleaded guilty of felony possession of cocaine and was assessed a 10-year prison term, probated, plus a fine of \$2,000 plus court costs and 60 days in county jail.

Robert Salazar Huerta, 27, of O'Donnell, was given a three-year probated sentence on a charge of felony driving while intoxicated, plus a fine of \$1,000 plus costs and 10 days in county jail.

In jail during the week were four persons for DWI first offense, and one each for DWI subsequent offense, public intoxication plus application to revoke probation on DWI charges, DWI subsequent plus driving while license suspended plus application to revoke probation on DWI charges, possession of cocaine, issuance of bad check plus theft plus striking a fixed object while operating a motor vehicle.

No doubt there were similar attacks in back yards and other places in the city, and in other locations across the South Plains, following a good rain about a week earlier, but none of those attacks were as vicious or terrifying as the ones on the golf course. The difference, of course, was that I was personally involved in the golf course bite festival.

The mosquitoes were as large as flies. Their stingers were an inch long. Some of our shots were deflected into the rough by hitting big mosquitoes in the air. By midafternoon golfers who had managed to struggle through nine or more holes were lined up outside the hospital, awaiting transfusions.

We used lots of insect repellent, but this only helped for a few seconds. Soon the mosquitoes returned, with all their relatives, whom they had gone after, telling them, "Hey, come on over here with me. There're some juicy people spraying some really great-tasting stuff for us to use as sauce on our meals!"

Every time a mosquito was swatted and killed, it was replaced by six more. About 7,000 mosquitoes died, 189 from being swatted and the rest from over-indulging and from the incompatibility of drinking Type O and Type A blood.

Okay, so I am exaggerating. But not much. It really was the worst I have ever seen mosquitoes since one year in the early 70s in Plainview, when they finally had to use airplanes to spray the city for the pests.

Tahoka Head **Start Registration** Slated June 11

The South Plains Head Start will take applications for those interested in enrolling their four year-old children in the Tahoka Home Base Program. Registration will be held Tuesday, June 11, from 9 a.m. to 4 p.m. at the Lynn County Community Action Building.

In a home base program, the teacher comes to the home one day a week to work with the parent and child. This preschool program is offered to eligible families of children who will be four years on or before Dec. 31, 1991.

Eligibility is based upon income and/or handicapping condition. For eligible children there will be no cost for the services.

For enrollment, the parent must bring child's birth certificate, immunization card, medicare number, child's social security number and parents' proof of income.

If your child is three or four years old and has a handicapping condition and or special needs, she/he can receive services through the South Plains Handicap Consortium, P.O. Box 4170, Texas Tech University, Lubbock, TX 79409.

The services include educational diagnosis, visual treatments and aids, speech and dental treatment, referrals, on-site teaching, and travel to and from service sites.

No child seeking admission to

this program will be discriminated against because of his/her race, creed, color, sex, national origin, or handicapping condition.





The Custom Calling Services affected by the Company's application are optional telephone service arrangements that provide the following features: Call Waiting, Call Forwarding, Three Way Calling, Speed Calling 8 and Speed Calling 30.

The Company's proposal would increase the monthly rate for the individual Call Waiting feature from \$2.10 to \$3.10 for residence customers. Also, the rates for certain combinations of Custom Calling Features (Call Waiting, Call Forwarding, Three-Way Calling and Speed Calling-8) would increase or decrease depending upon the combination of features. 





Growing Turf in Shade Is **Perennial Problem**

Shade is desirable in the landscape, but is the number one problem in growing turf grass.

Many people just do not understand that grasses do not do as well in shade as they do in full sunlight. There are a lot of situations where you just can't grow grass in the environment that you have. Environmental changes caused by shade have a major effect on grass. Reduced light, less extreme temperatures, increased humidity, restricted air movement, competition from trees, increased disease problems and shallow root systems are all products of shade. Grass in shade has less ability to use nitrogen, less photosynthetic activity, less growth, less wear tolerance. more susceptibility to pre-emergent herbicides and less tolerance to cold.

To grow turf in the shade you must have a shade-tolerant grass. Bermuda grass and Buffalo grass have little shade tolerance. San Augustine is probably the most shade-tolerant warm season grass, followed closely by Centipede and Zoysia. Tall Fescue, a cool season grass, will grow in moderate to heavy shade where San Augustine fails.

Suggestions for growing grass in filtered shade:

1.Start with a grass variety suit-

able for shade. 2. Raise the mowing height.

3. Water deep and infrequently. 4. Apply nitrogen moderately in

fall and spring.

5. Avoid high nitrogen applications in the summer.

In many heavily shaded areas, it is best to use ground cover plants or other landscape materials rather than wasting time and money trying to go

Renewable resources are nonfossil fuels which will be available as long as the sun continues to shine. The major renewable resources that can be used as energy sources are biomass, wind, solar thermal, solar electric, and hydropower, according to Craig.

"Each resource has its niche to fill, and although renewables are not the total answer to our energy needs, they are a significant part of the answer and are environmentally benign relative to other energy resources," added Craig.

He says that Cratech is focusing on biomass, which is anything that grows. "Trees are biomass. Cotton is biomass. Even garbage is composed mainly of biomass," says Craig. "It's interesting to note that all fossil fuels were at one time biomass."

Biomass that can be considered for an energy resource includes wood chips, sawdust, rice hulls, bagasse, corn stover, wheat straw, cotton gin trash, etc., according to the Cratech president. Even preprocessed garbage appears to be a usable energy

To convert biomass resources to usable energy sources, biomass can be burned directly, converted to liquid fuels such as alcohol, decomposed into an oil, or converted to a fuel gas. Cratech's process converts the biomass to a burnable gas (somewhat similar to natural gas) which will then be used as fuel in a gas turbine (an example of a gas turbine is a jet engine). The gas turbine will turn a generator for producing elec-

"Participating in the development. of renewable energy sources is exciting," says Craig. "This renewable energy project is a fairly complex process which Cratech must make into a simple and economical commercial power plant."

Texas Cotton, Rice Producers Reminded Of Planting Changes

Texas State ASC Committee, reminds Texas cotton and rice producers that the rules for 1991 prevented planting for cotton and rice are different from previous years.

Producers now have the option of crediting the acreage they were prevented from planting to either prevented acreage of cotton or rice or they may choose to use the acreage as Conserving Use (CU) for payment acreage under the 50/92 provisions of the Food Agriculture, Conservation, and Trade Act of 1990.

Harris says, "If producers choose to credit the acreage as prevented planting for cotton or rice, the acreage may then be devoted to acreage of another crop which would be considered as ghost acres for program purposes. These prevented planted acres will not be eligible for any deficiency payment for 1991."

A new provision of the 1990 Farm Bill would allow producers who were prevented from planting cotton or rice because of drought, flood, other natural disaster, or other condition beyond the producers con-

Jerry D. Harris, Chairman of the trol to devote the acreage to CU for payment. This acreage must be planted to another crop for harvest. Cotton producers who choose this option would be eligible for the 10 cent per pound guarantee without regard to the 50 percent planting requirement if the sum of the prevented planting and actual planting totals at least 50 percent of the maximum payment acres for the farm.

> Harris wishes to remind producers that if the acreage is planted to cotton or rice in order to qualify the acreage for crop insurance that the acreage would be considered as the crop to which it was planted and would not be eligible for the guaranteed deficiency payment under the 50/92 provisions.

Planted acreage of the crop which failed is eligible for deficiency, however, this would not be at the guaranteed rate.

The Texas State ASC Committee strongly recommends that producers contact their local ASCS County Office if they have any question concerning the prevented planting provisions of the 1990 Farm Bill.

Take Food Safety To The Grill By Donna Peters

If you're planning a cookout, it's better to be food safe than sorry. Take food safety from the kitchen to the grill. Tips to help prevent food-borne illness include:

If meat or seafood is frozen, allow plenty of time for thawing in the refrigerator at 40 degrees or below. Never thaw meat on the kitchen counter at room temperature. Outer layers of the meat may reach a temperature that promotes bacteria growth before the inner layers are thawed.

CHICKEN & DRESSING

If you marinate the food, do it in the refrigerator. Do not use leftover marinade as sauce on the cooked meat. Marinade may have picked up bacteria from the raw meat that could contaminate the cooked meat.

Be sure to wash with hot soapy water and sanitize cutting boards used with raw meat. Use different cutting boards for meats than for raw fruits or

Once the meat has been placed on the grill, wash dirty dishes or utensils before using them again. Bacteria on dirty utensils can contaminate cooked meat. Cooking kills bacteria, but foods can be recontaminated.

Always wash your hands after working with raw meat or poultry. Handle raw foods and cooked foods separately. Use clean dish towels or potholders for handling cooked foods.

Cook meats thoroughly to kill

bacteria. If you like steak rare or medium rare, remember that all bacteria may not have been killed if the food was not cooked thoroughly. After cooking, eat as soon as possible and refrigerate any leftovers.
