# Wilson motorcyclist hits deer, passenger injured when thrown

Lynn County Sheriff's deputies investigated three accidents during the past week, two involving collisions with deer. A woman was injured after she was thrown from a motorcycle that hit a deer, a 17-year-old O'Donnell female was injured in a one-vehicle rollover, and another vehicle hit a deer on Hwy 380.

Kenneth Mark Melvin and his wife, Kimberly, of Wilson were on his motorcycle riding down FM 1328 just after midnight Saturday when the motorcycle struck a deer. Mrs. Melvin was thrown from the motorcycle and was said to be lying on the road and "barely conscious" when her husband called 9-1-1 asking for help. Lynn County EMS was called to the scene, but no report was given as to the extent of her injuries.

Abbie Franklin, 17, of O'Donnell was the driver in a one-vehicle rollover that occurred at 7:55 p.m. last Monday, Aug. 28. She was driving a Chevrolet pickup in the northbound lane of US 87 about 7 miles south of Tahoka when the rollover occurred. Lynn County EMS responded to the scene for treatment of unknown injuries.

Another vehicle hit a deer early Sunday morning. Maria Gallegos of Lovington, NM was the driver of a 2014 Chrysler 4-door that hit a deer at 2 a.m. about 10 miles west of Tahoka on Hwy 380. The vehicle was reportedly damaged to the point that it was not drivable, but no injuries were reported.

Lynn County deputies were in-

reported as a missing juvenile from Amarillo. The vehicle was observed at 3:10 p.m. on US 87 at County Road 29 traveling southbound. When deputies attempted to stop the vehicle, the driver reportedly took off at a high rate of speed, and officers followed the vehicle throughout Lynn County. The vehicle wrecked in Dawson County, and EMS was called to the scene for treatment of unknown injuries.



# New parade route to end up at Mini-Park, not Courthouse, for pep rally: Tahoka Homecoming events set next week

The parade will not go down Main Street or the downtown area this year.

The Tahoka High School 2017 Homecoming will be held next week, with events slated for next Thursday and Friday, and the Lynn County Harvest Festival to be held on the following Saturday.

This year's Homecom-

ing Parade will follow a different route than in the past, since the downtown homecoming pep rally cannot be held on courthouse grounds due to their renovation project that is underway. This year, the parade route will travel East down N. 4th from the school, turning South on Ave. J and finishing at the Tahoka Mini-Park on Ave. J and N. 1st. The parade will not go down Main Street or the downtown area this year.


Jim was preceded in death by his mother and father and two sisters.



# Price of admission: Donations to Harvey victims **Bulldogs open season with** 21-13 win over Crosbyton

The Tahoka Bulldogs opened their 2017 football season with a very solid win at home against Crosbyton Friday night, 21-13. Tahoka ISD also opted to allow free entry to the game, asking for donations of items to give to the victims of Hurricane Harvey instead of paying the admission price to the game. THS Cheerleaders also "passed the hat" (a football helmet) in the stands during the game to collect monetary donations for the victims. Two large bins of items were collected, as well as monetary donations. The school district is working with Education Service Center Region 17 to get the items to the victims.

"We would like to thank each of you and our friends from Crosbyton for the support you showed us both on the field, but more importantly thank you for answering the call to help the victims of Hurricane Harvey," said Stephen Overstreet, AD/Head Coach. "The bins at the gates showed that

we all understand we play for and represent something bigger than ourselves. We got to enjoy a game on Friday night while those people are truly fighting and rebuilding their lives. Thank you for showing up and winning the game of the night and that's the game of life," he added.

Overstreet said that Friday night's game was against a wellcoached Crosbyton team and that he was "super proud of our kids" and the way they played for four quarters.

"The game was kind of back and forth early on and we went up 6-0 in the second quarter on a 1-yard touchdown run by Matthew Diaz. Javier Zuniga missed the extra point but we went in at halftime leading 6-0. Our offense was doing a great job of moving the ball in the first half, but we just couldn't cash in. We turned the ball over two times on plays that I really felt like were just extra effort, but we made up for it by getting 6 of our own," said the coach.

"I have told the kids all year if you can end the season plus 20 in turnover ratio you have a chance to be playing for a long time. With our 2 that we gave away we ended the night plus 4 and place ourselves in really good spot heading forward. Malik Hamilton led the way with 151 yards on 16 carries. I felt like Malik ran the ball about as hard as I have ever seen him run. He was patient and then he exploded when he hit the hole. Braden Stone did an excellent job of leading the offense and finished the night 3-4 for 34 yards and 1 touchdown to Tristen Stice on a 21-yard completion.

"Our offense isn't going to be very flashy, we are just going to line up and try and Grind it out. We will throw when we feel like we need to but we are going to put the ball in the hands of our running backs and let our super smart offense line lead them down the field," explained Overstreet.

For the night, Matthew Diaz had 2 TD's, Tristen Stice had 1

TD Receiving, Braden Stone had 1 Passing TD, Malik Hamilton had a 2-pt conversion, and Javier Zuniga made 1-2 PAT's. "This was an excellent night

for us all the way around. Obviously I am super excited that we got the win, but the thing that makes me even more proud than that was the way we fought and kept our composure. We have been known around here the last few years for letting adversity get the best of us and quitting. These kids played from behind in the second half and found a way to respond to everything Crosbyton threw at them.

"Like I have said many times, this is a marathon and not a sprint. If you could win the game in the first quarter or even the first half that would be great, but you play for 48 minutes. 




