This amount will do but little to aid in sustaining schools; the proportion to this county will probably be about \$400, which, when divided between Indianola, Lavaca, the Island and Green Lake, will not be an object worthy of much attention.

**TEXAS OWNERS.**

It occurs to us that, as the State refuses to loan money to railroads, the school fund should be raised to \$4,000,000, and the U. S. bonds on hand and which yield only 5 per cent should be converted into means that will pay 8 or 10 per cent. This can be easily done. Four millions at 8 per cent will yield annually \$320,000, and this amount will probably pay the entire balance of the State in common schools for six months in the year. Then when our county school lands shall come into market, we will be able to keep up free schools perpetually throughout the State, and probably allow a portion of the four millions to be appropriated to other purposes.

**IMPORTANT TEXAS DECISION.**

The Galveston News says that the Supreme Court has decided the case of Agony & Smith vs. James Power, from Refugio county, in favor of the former. Power claimed an eleven league grant, Agony & Smith under locations. The court decided that it was necessary for Power to show the permission or approval of the Supreme Government as it was in the ten league grant—that its approval could not be presumed—nor was it contained in the colonial grant. The lawyers at Galveston consider it one of the most important decisions ever made by our court.

It is well known that Great Britain and France have, for a long series of years, been looking upon the growing power of Russia with much uneasiness. They feel that the results of such a growth would be such to check it, or see it checked. They would be glad to check it, or see it checked by others. They would care but little whether the instrument for humbling the Czar were found in Turkey, Japan, or the Barbary States, and whether it were under the direction of Mahometan, Jew or Christian. If he is humbled, and if his power, that now menaces all Europe, be signally checked, it is all they ask. France remembers the blow which Napoleon and the grand army received at Warsaw, and would be glad to return the blow she then received.

When planted on rich ground, in drills, when nearly waist high, it may be cut down, in small patches, from day to day, to feed horses on by cultivating the crop. It may grow up and be cut down three successive times, and then it would produce seed abundantly. Such food is very necessary for teams in the cropping season. It is too hard on horses to work diligently all day, and then spend the night in gathering green food. They would last longer and do better service to the green food and place it before them, that they may eat at night.

**CHEESE CASES.**

Last season several experiments were made in this county in raising cheese cases, or as some call it, Gulesan case. It grows on a large heavy stalk, with broad leaves, somewhat like a heavy growth of Spanish corn. The seed is of the size of small peas, and grows in a bunch like broom corn.

**LAVACA FROM MEXICO.**

The principal item of news in the paper is the announcement of the loss of another great steamer in Mexico, the death of Don Jose Joaquin Herrera, Ex-President of the late Republic, and General of Division, which occurred in the city of Mexico on the 15th inst., after a long and severe illness. We take the following account of his death, and a brief sketch of his life and character, from the Signal of the 16th February.

It is with a feeling of the most profound sorrow that we announce the death of this illustrious citizen, brave old soldier of independence, and hero of Orizaba and Cordova, (where he gained triumphs which are memorable in our history) after a long and painful illness. Senor Herrera consecrated his entire life to public service, and his honesty was proverbial. He had occupied positions of the highest importance in the political government, and was twice constitutionally elevated to the Presidency of the Republic. Sincere patriot, rectitude of intention, and great personal valor, were the ruling traits in the character of this great man. He died very poor—very poor; and this is the highest eulogium that can be pronounced over the mortal remains of a virtuous citizen who has this day descended to the tomb. The only legacy he has to bequeath to his children was an honorable and unsullied name; but to his fellow-citizens he has left a memory to be revered, and an example of true civic virtues to be followed by them. His remains were accompanied to their last resting place, in the Cathedral of San Fernando, by a numerous concourse of his fellow-citizens, military and civil bodies, and were interred with the usual pomp that marks the funeral honors paid the great dead in Mexico.

**PROCEEDINGS OF THE DANUBE.**

A severe encounter has taken place between the two armies on the Danube, in which neither could claim the victory. The Russians had not yet made the attack on Katsala, but it was daily expected that they would do so.

**ALLIED FLEETS.**

The combined fleets were ordered to re-enter the Black Sea. The Ambassadors were much displeased with its return to Bosphorus.

**AFFAIRS IN RUSSIA.**

At the last accounts the Emperor of Russia was ill, and had not appeared in public for several days. It was reported that a change in the Russian Ministry was about to take place.

**ENGLAND AND FRANCE.**

The English and French Governments continue their preparations for war on an extensive scale, and France is making new financial arrangements, in order to meet the expenses of the war.

**SHIPWRECK AND GREAT LOSS OF LIFE.**

The ship "Wm. H. Davies," bound from Liverpool for New Orleans, was lost on the island of Bard, west coast of Scotland, on the 27th January. The ship was a total loss and all on board perished except the steward of the ship.
