## Ozona-Barnhart wagon train reflects Texas history

The Crockett County Sesquicentennial Wagon Train started from the fairgrounds arena at 9:00 a.m. Thursday, March 20, on a once in a lifetime adventure for many of the participants. The cold clear morning saw many unhitching their trailers and saddling horses.

The first day included 113 registered participants with the number swelling to 130 for the final push into Barnhart Friday.

As if on cue, the weather started to warm up following registration at 8:40 p.m. Participants, including three wagons, lined up and slowly started the long trip to Barnhart.

One team of horses, used to pull Clayton Robinson's wagon, at first balked at the idea, but, like the modern pioneers making the trip, soon fell into line.

Wagon train boss Brock Jones gave the "Wagon Ho!" shout, and the journey began by winding down various Ozona streets. The first parade site was in front of the Ozona Primary School. Students and teachers stood, some behind a mesh fence, and gazed at the long parade, with giggling anticipation and excitement.

The wagon train then traveled a short distance on Highway 163 before turning down the street adjacent to the Ozona Intermediate School. Students waved at the travelers and held signs encouraging them on their way. A banner proclaiming "It's a long, long, long way to Barnhart", was handed to the occupants of a passing wagon.

The last on site inspection of the wagon train before it left Ozona was at Ozona High School. Students stood on the steps pausing a moment before returning to their studies.

By 10:00 a.m., the wagon train had finally reached the outskirts of Ozona. The group paralleled the highway until it reached the four mile hill outside Ozona around 10:45 a.m. Then the real journey through pasture land and down the old Barnhart highway began.

The entourage arrived at the water and lunch camp site on the J. B. and Ann Parker Ranch about 12:15. The dust and tiring 8.5 mile trip from Ozona served to whet the appetite. Never did a cold can of Vienna sausage or cold chili or Beanie Weenies taste so good.

The lunch break was short, as there was another eight miles to the Midway Lane campsite. By lunch, for some youngsters, the new had worn off, and a sense of boredom had set in. For the parents, the fun was still meshed with an anticipation and admiration of the settlers who first came to Crockett County.

The wagon train finally arrived at the Midway Lane campsite around 3:40 p.m. Most were tired and ready to rest, but there was much to do. Wood had been gathered in advance by Ed and Betty Martin, and now campfires had to be started. The

winds were strong, and the temperature would drop to 24 degrees F before morning.

Approximately 517 persons feasted on 11 goats, 50 pounds of frijoles; one crate of onions, 20 gallons of tea and four gallons of pickles at the Lions Club barbecue.

Ranchers Sonny Henderson and Tom Cameron provided the goats, while Harvey Hill, Floyd Hokit, Bill Glasscock and Jerry Lay cooked the food.

"Others too numerous to mention assisted with serving the food," said Lions' Club president Dorris Haire.

T & T Supermarket donated the beans; Thornton's Supermarket provided the paper products; Sonny's Drive In the ice and M&M Cafe the biscuits.

"The Lion's Club would like to thank everyone who assisted with this project, and the community for its support," said Haire.

Local square dancers entertained the group, despite the dust raising platform of dirt. The dancers, after performing several numbers, were joined by members of the audience.

Troy Williams entertained the shivering crowd with stories of sheep drives from Ozona ranches to Barnhart. The drives would last one-half of the day, and the second half of the day would be devoted to watering the livestock.

The Ozona-Barnhart Trap Com-

pany was first organized in 1924, and Jones Miller served as its first president. W. R. Baggett and Elo Baggett provided financial backing and leadership for the OB Trap Company during the formative years, Williams explained.

To raise monies for the organization, founders Joe Davidson, V. I. Pierce and Wayne West agreed to sell shares in the OB Trap Company. The 112 ranchers who originally bought the \$100.00 share, helped the trap company get a solid financial footing. "Will and Monroe Baggett, especially Mr. Will, would buy shares every time the organization ran short of funds."

Barnhart, during the 1920's, was the largest shipping point in the United States for livestock according to Williams. "As late as 1931, 300,000 head of livestock were put on railroad cars."

Bill Baggett and B. B. Ingham laid out the holding pens in Barnhart. At the Buckhorn Trap, a Mr. Choate had a small grocery store and filling station. The Buckhorn Trap, which was located four miles from Barnhart, was the last trap before the livestock reached Barnhart.

Other important watering holes and traps were Twin Lakes, which dried up during the 1950's drought, and the MacNutt Trap, often referred to as "the heart of the OB

Melinda Hokit was hospitalized in guarded condition in St. John's Hospital in San Angelo after a Sunday traffic accident. The 23-year old Ms. Hokit was listed in stable but guarded condition at the time of her admission.

The accident occurred about 8:00 p.m. March 23 when the pickup she was driving veered off the road and hit an embankment 20 miles south of Ozona on Highway 163.

Reports indicate that Ms. Hokit had not regained consciousness as of Tuesday morning.

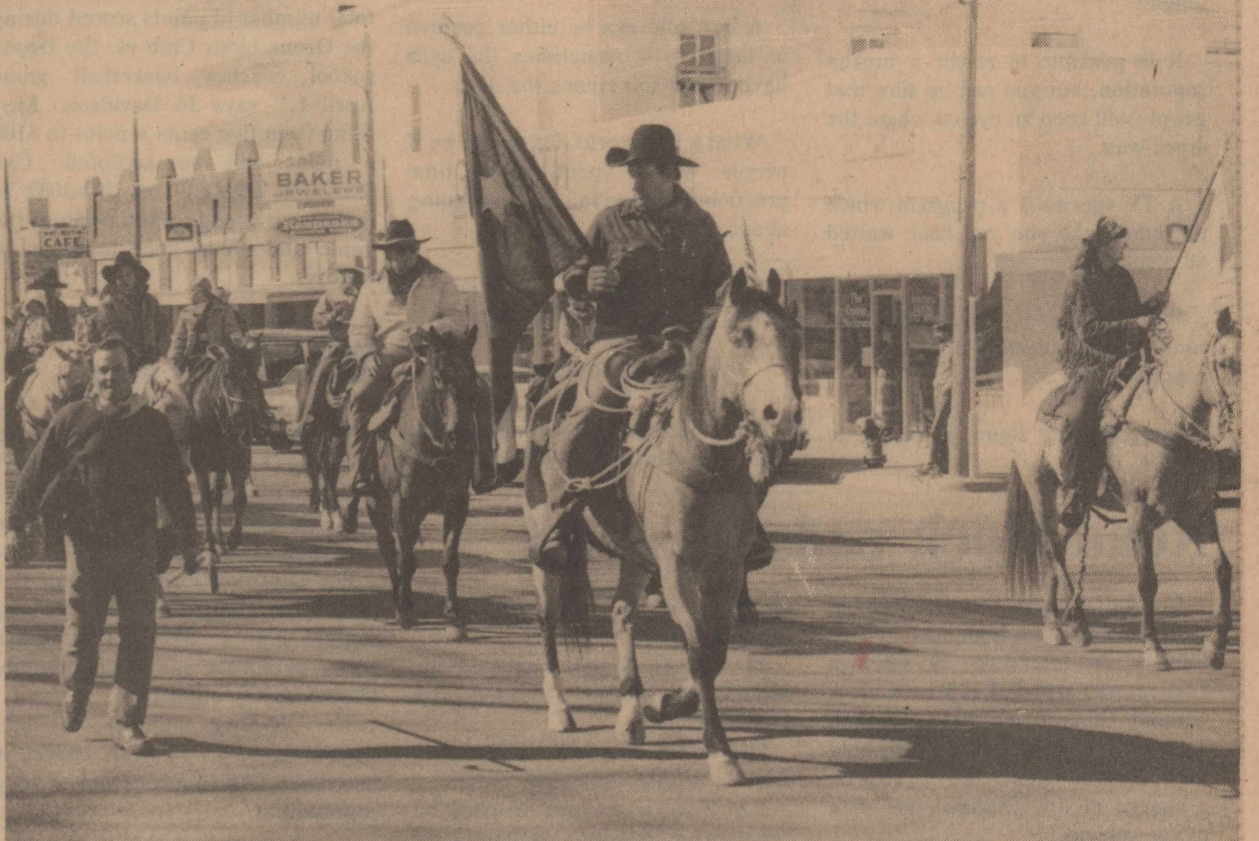
### Childress service

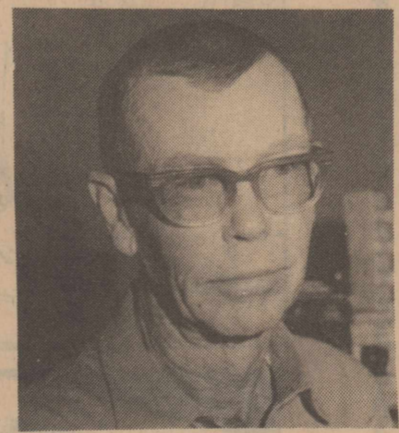
## Sewell to be inducted into Hall Of Honor

The Texas High School Coaches' Association Board of Directors has voted that Rip Sewell be inducted into their Hall of Honor at the Houston Coaching School. The induction will take place at the Astro Hall Ballroom at 12:00 noon, Thursday, July 31, 1986.

The Hall of Honor is the highest award given by the Texas High School Coaches' Association.

Rip Sewell has been a member of the association for 33 years and has coached football, girls' basketball, boys' basketball, track and golf.

He has had 17 district championship teams and four regional championship teams during his career. He is now the athletic director and golf coach at Ozona High School.



During his 17 years as a football coach, Sewell has a 109-75 record with three district championships, two co-championships, two district and one regional championship.

A 254-148 record during his 14 years as a basketball coach has produced six district championships, two regional championships with the fourth place in state in 1958 and the second place in state in 1959.

As a track coach for 13 years, Sewell produced seven district champions, one co-champion and one regional champion team.

### Del Rio rites for brother of Ozonan

Nelson Campbell Schauer of Comstock died March 22, 1985 at his home. He was 61.

Schauer was born October 10, 1924 in Ozona. He was a veteran of World War II and served on the Comstock school board 16 years. He was a member of the AFC board and had been in ranching in the Comstock area for the past 38 years.

He is survived by his wife, Josephine Kelly Schauer of Comstock; a son, Nelson Cody Schauer of Comstock; a daughter, Jo Kelly Rutherford of Brady; a sister, Ellen Ward of Ozona; one brother, Charles Schauer of Lakewood, Colorado; and three grandchildren, Jody Kae Schauer and Nelson Cochran Schauer of Comstock and Chelsea Georgeann Rutherford of Brady.

## Candidates discuss county, school issues

David Hunsicker, Democratic candidate for the 21st Congressional District, told Ozonans that the country needs a national energy policy last week when he spoke at a "meet the candidates" forum sponsored by the Knights of Columbus.

The San Antonio resident believes that such a policy should give back at a ratio of six to one every dollar spent in industry.

The U. S. needs to graduate more technicians, engineers and mathematicians, said Hunsicker, comparing the U. S. to Japan which is turning out more people in these fields.

A decrease of the national deficit and less money for defense were among the concerns expressed by Hunsicker.

He closed by saying that a good congressman needs to be loyal and a

friend to his constituents, coming to his home district often to know the situations facing the people he represents.

Knight Elliott Barrera introduced Hunsicker and local candidates for school board and county offices at the Wednesday night meeting held at the parish hall of Our Lady of Perpetual Help.

Six candidates for county offices and four of the six candidates for

school board were present to make brief comments on behalf of their candidacies.

Incumbent Justice of the Peace Raymond Dave was unable to attend due to illness.

## Road block ends in arrest

Crockett County law enforcement personnel ended a high speed chase Sunday on Interstate 10 when a suspect was arrested at a road block without shots being fired. Darnell Jones, 26, of Arkansas is being held in the Reeves County Jail in Pecos on a charge of unauthorized use of a motor vehicle.

A 35-mile chase began 10 miles west of Sheffield when Troopers Jess Malone and Joe Munoz of Sheffield saw a 1986 two-door Mercury that had been reported stolen in Pecos. Assisting the troopers in the apprehension were sheriff's office personnel from Crockett and Pecos counties and U. S. Border Patrol agents.

A male arrested by sheriff's deputies March 22 was found to be wanted on five warrants from the states of Delaware, Florida and Connecticut. All three states want him, and he was awaiting extradition Tuesday.

## Accidents investigated by Trooper Barton

DPS Trooper Richard Barton was the investigating officer of three accidents during the week.

Gilberto Lombrano was not injured in a March 20 accident at 10:00 p.m. near the intersection of Couch and Avenue K.

Lombrano is reported as having passed the intersection, and while backing to make the turn, backed into a utility pole. His 1973 Oldsmobile suffered substantial damage.

A horse belonging to Randy Upham had to be shot March 21 after a flat on a horse trailer caused the trailer to break the hitch and

overturn. Minor injury was reported to three other horses in the 8:50 p.m. accident which occurred on Highway 290 1 1/2 miles east of Ozona.

On March 22 at 12:15 p.m., a 1978 Ford pickup with no driver was in collision with a 1982 GMC pickup which was legally parked on Maple Street west of Pine.

The officer's report indicates that the Ford was parked in a parking lot and the GMC was parked across Maple Street. The Ford apparently jumped out of gear and rolled across the street causing minor damage to both vehicles.



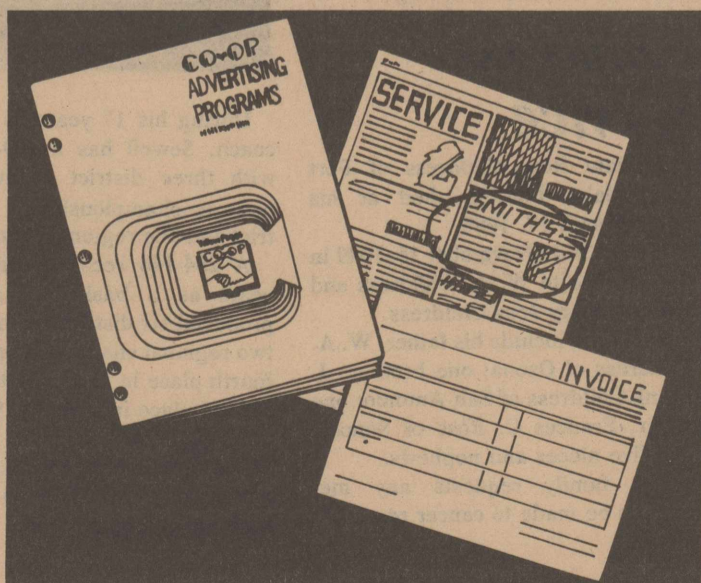

## Garbage in - garbage out

"Garbage In - Garbage Out" has been a familiar warning to the computer industry for quite some time. Nutritionists, for years, have been telling us, "You are what you eat". From the gasoline pump to the television set, we are reminded that what we put into our cars, or our minds, effects their output.

The Scriptures address this concept in a couple of ways: first, "As he thinketh in his heart, so is he" (Prov. 23:7); second, "Whatever a man sows, this will he also reap" (Gal. 6:7). Put garbage in - get garbage out!

Studies indicate that school age children spend more time in front of a TV set than they do in receiving wholesome instruction from a parent, guardian, or teacher. They see violence of every sort - oh, yes - "garbage in - garbage out"; Crime at an all-time high and increasing, prisons filled to overflowing, disrespect for authority, rebellion, etc., etc.

Television is not all bad, but the majority of programs mock morality, pervert reality, and give a steady dose of corruption - all in the guise of entertainment. Sports and soaps get more of our hours than do service and sacrifice.

Our society likes to ride one horse to death. We get on to something, and we grow addicted to it, indulge ourselves with it and exclude everything else. Too much of anything - including religion - is not good for you. Haven't you known fanatics that overstepped their good by demanding that you spend all your time with their product? Jesus increased in wisdom and stature, in favor with God and man (Lk. 2:52). He took good in, and put good out, in many realms.

Religionists who demand that every waking hour be spent in pious attire form cults that lose touch with reality and end up hurting rather than helping people. Some coaches

keep students so busy with sports that they can't study, and they end up with young people who can run and throw, but who can't read and think. Garbage in - garbage out!

So what is the answer? First, set a decent priority. God says, "Seek first His Kingdom and His Righteousness..." (Mt. 5:33). Doing that, one will find other things falling into place. Second, commit quality time to the good. The Apostle Paul says present suffering to get the good can't be compared to the glory that will follow (cf. Rom. 8:18). In other words, don't major in minors.

"Garbage in - garbage out" is a lesson we learn by observation. Don't let your mind, your life, or your effort be ruined by putting in low grade product. Above all, don't let your soul be lost because you fill your days with evil.

"Set your mind on the things above, not on the things that are on earth" (Col. 3:2). Whatever is true, honorable, right, pure, lovely, of good report - think on these things and practice them (Phil. 4:8-9). Put quality in - you will get quality out. How about it?

This study program uses structured reading and writing materials that allow steady progress and appeal to adult interests. There is NO CHARGE for this service to the student.

## Rachel's reviews

Easter time usually requires some type of egg, especially when children are present. Hard cooked eggs commonly suffer from several problems: 1. They don't peel easily (or cleanly) 2. The yolk is not centered or 3. There is a black line or division between the yolk and the white.

Overcooking toughens the yolk and causes the dark surface between the yolk and the white. A thin layer of mineral oil preserves egg freshness, but causes eggs to not peel easily. Storing eggs with the small end up generally centers the yolks better.

Humidity and egg handling prior to the consumer's purchase are critical. These conditions are so important that an egg one week old, held under refrigerated conditions (35-55 degrees) can be fresher than an egg left at room temperature for one day.

When the consumer takes eggs from the supermarket, again refrigeration is necessary to preserve freshness. Storing eggs in the special tray in refrigerator compartments is not recommended. Frequent opening and closing exposes the eggs to air. This hastens the loss of carbon dioxide, which increases the air cells that flatten egg yolks and thin whites and decrease flavor.

Hard-cooked yolks can be frozen to use for toppings or garnishes, while hard-cooked whites become tough and watery if frozen. Fresh egg whites can be frozen without any

added ingredients, while fresh egg yolks require special treatment to retard gelation. Gelation can be retarded by adding 1/8 teaspoon salt, 1 1/2 teaspoon sugar or 1 1/2 teaspoon corn syrup per 4 egg yolks or 2 whole eggs.

### SPINACH QUICHE

- 1 (10 oz.) pkg. frozen chopped spinach
- 1 (9 in.) frozen deep-dish pie shell, thawed
- 5 beaten eggs
- 1 c. (4 oz.) shredded Swiss cheese
- 1 can (2-2 1/2 oz.) drained, sliced mushrooms
- 3/4 c. light cream
- 1/8 tsp. pepper

Cook spinach according to package directions and drain, pressing out excess water. Set aside. Brush the inside of the pie shell with a small amount of the beaten eggs. Prick bottom and sides with fork. Bake shell in preheated 425 degree F. oven five minutes or until golden brown. Set pie shell aside. Reduce oven temperature to 350 degrees F. Stir together spinach, cheese and mushrooms. Turn into pie shell. To the beaten eggs, add remaining ingredients. Beat until well blended. Pour over spinach mixture. Bake in preheated oven 45 to 50 minutes or until knife inserted near center comes out clean. Let stand 5 minutes before serving. Serves 4-6.

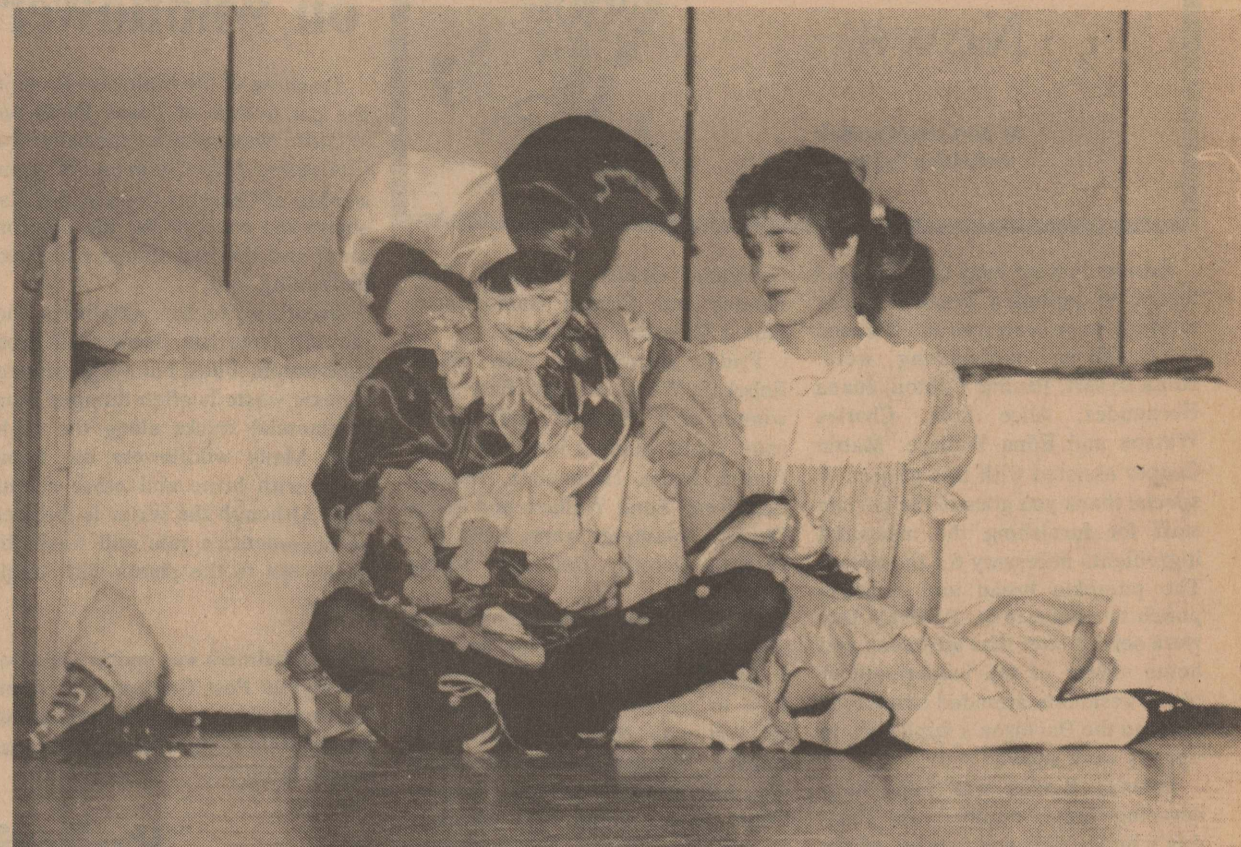

## High speed chase nets aliens

On two different occasions during the past week, Border Patrol agents were led on a high speed chase while attempting to stop vehicles containing illegal aliens.

March 18 a pickup containing 11 illegal aliens attempted to evade the Border Patrol by reaching speeds of about 95 mph and finally crashing through a fence and travelling into a pasture on the Pfluger Ranch on the Pandale Road.

On March 23, another pickup, again containing 11 illegal aliens led Border Patrol agents on a high speed chase through Ozona, finally ending the chase on the east side of town south of Interstate 10.

Sheriff's deputies turned over three persons to the Border Patrol for questioning March 22. The subjects, illegal aliens, were en route to Chicago, Illinois where at least one was returning to former employment.

A routine traffic stop Monday

morning led to the discovery of seven illegal aliens being transported by two U. S. citizens.

The U. S. Border Patrol in Ozona reports an increase of 24 percent in apprehensions for the month of March as compared to March of 1985. As of March 23, 274 deportable aliens have been apprehended.

Since October 1, 1985, 1,193

persons have been arrested. This is a 55 percent increase in total apprehensions over last year.

Smuggling activity through the Ozona area has increased with three cases intercepted within the last week.

A total of 28 aliens were apprehended while being transported to various points within Texas.

Fines paid by persons convicted of littering will be kept within the county, says Mrs. Boyd.

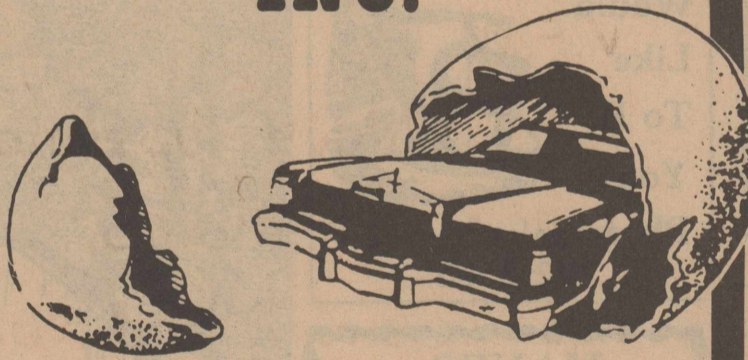

## SCS helps with productivity

One of the primary objectives of the Soil Conservation Service is to help ranchers maintain or improve the productivity of their rangeland. Understanding what the water cycle is and how it influences the productivity of rangeland is very important for properly managing rangeland.

The water cycle is the never ending movement of water from clouds to soil, through plants, and to clouds again. The cycle begins when precipitation strikes the land and ends when the water leaves rangeland either through runoff or evapotranspiration. During this time, livestock producers should store as much water as possible within the soil for use in forage production.

Water is usually the limiting factor in rangeland productivity. The moisture in every raindrop, snowflake, or hailstone may be used productively on the site where it falls, or it may go downstream as clean water or it may carry parts of the soil on which it fell. When runoff water is dirty, it is taking a little of the potential of the land.

When falling raindrops strike bare soil, the impact causes both splash

erosion and soil compaction. This results in faster runoff and increased erosion. A good plant cover breaks the force of the raindrops and allows the water to move into the soil. The soil affords a large reservoir for moisture storage, reducing flooding, enhancing water quality and promoting a greater and more consistent supply of forage.

A healthier, more productive water cycle is the result of proper grazing management that increases plant cover and vigor and reduces soil erosion. Plants and the litter they produce affect the water cycle in several ways. They break the impact of raindrops on the soil surface. Litter acts as a sponge and slows runoff, which gives moisture more time to move into soil. Plant roots increase soil porosity so water moves more readily into and through the soil. They also hold the soil particles in place and reduce erosion. A vigorous plant cover is an important part of influencing the water cycle and making effective use of the precipitation falling on rangeland.

The local Soil Conservation Service office working through the Crockett Soil and Water Conservation District can help ranchers increase the benefits of a healthy water cycle on their ranch.

## Seminar for women landowners

How to help women generate more income from farm and ranch properties while saving taxes -- that's the purpose of four regional seminars by the Texas Agricultural Extension Service in the coming weeks.

Called "Farm and Ranch Business Management for Women Landowners," the seminars are slated as follows: March 24-26, Holiday Inn, 4440 W. Airport Freeway, Dallas; April 1-3, Holiday Inn, 1-20 and Estes Parkway, Longview; April 14-16, Holiday Inn, 6201 E. Hwy. 80, Odessa; and May 6-8, Marriott Hotel, 6121 I-35, Austin.

"This is the third year we have conducted these seminars, and interest has grown each year," points out Dr. Wayne Hayenga, Extension Service economist and coordinator of this educational effort.

"The seminars are about the business of owning land -- buying it, keeping it, making it profitable and disposing of it by sale or through your estate," explains Hayenga, a member of the Texas and American Bar Associations and the American

Agricultural Law Association. Major topics covered in the three-day seminars are income tax, leases, business organization and estate planning.

Discussions the first day of each seminar will center on mineral estates; agricultural investments; buying, selling and trading land; and selling part of the business.

Various forms of business organization, including corporations and partnerships, will be discussed the second day along with income and estate tax planning.

Further details about estate planning will be presented the third day, including special benefits of corporations, special farm land valuation, deferred estate tax payments, life insurance and "flower bonds".

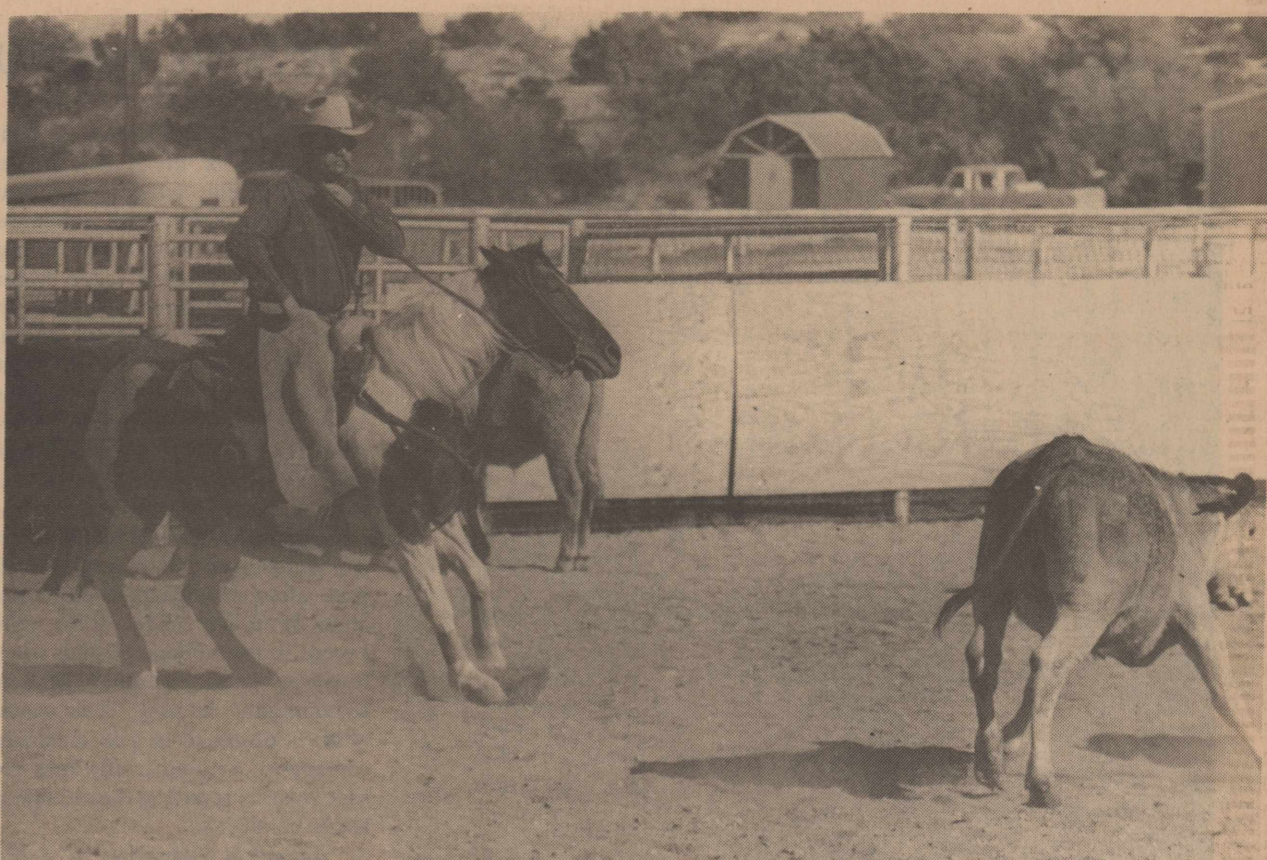

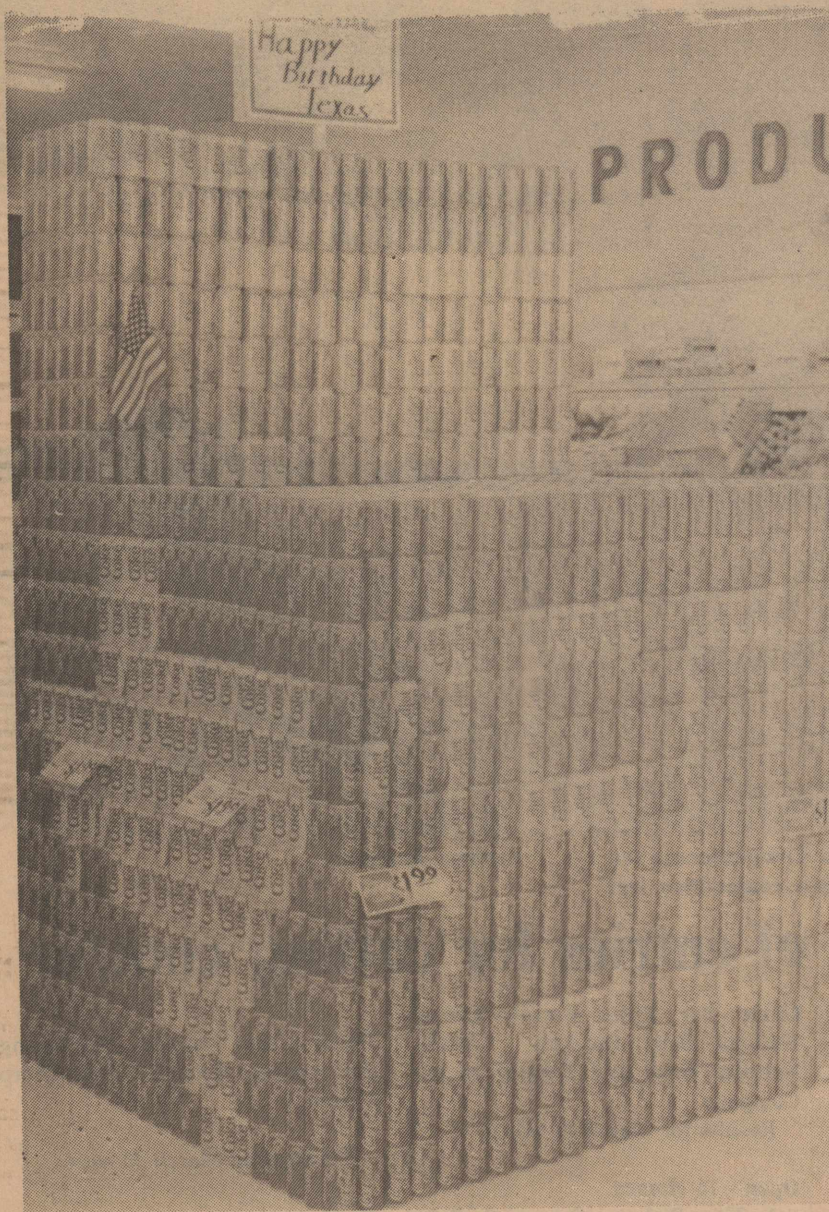

## DPS to conduct special patrol March 27

Major Dudley Thomas, Regional Commander of the Texas Department of Public Safety's 49 County West Texas Region has announced "that the DPS will conduct a high visibility patrol effort called **Operation Plain-View II** on March 27. The special emphasis program on this day will be focused on Interstate Highway 20 from the Louisiana State Line to the intersection of Interstate Highway 10 in Reeves County and extending on IH-10 to the New Mexico State line."

"**Operation Plain-View II** will be conducted from 10:00 a.m. to 7:00 p.m. along Interstate 20 and Interstate 10 in all areas of the state except in the Abilene District where it will be conducted from 12:00 noon to midnight," he said. "This special effort is designed to gain maximum compliance with all traffic laws and save lives by reducing the number of traffic collisions."

"**Operation Plain-View** is a program designed to make the officers

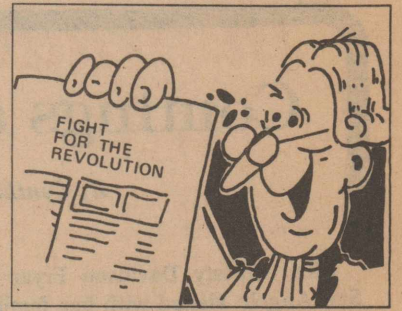
of the DPS highly visible by having a DPS unit located about every 10 miles along the highway," Thomas said. "In the far western part of the state, where IH-20 and IH-10 merge, the same effort will continue to the new Mexico State line." DPS officers on IH-10 in the area of Ozona and Sonora will be conducting the same operation.

"**Operation Plain-View** was first conducted on December 19, 1985 on IH-20 from the Mitchell-Howard County line east of Big Spring to the intersection of IH-20 and IH-10 in Reeves County, a total of 206 miles, and on IH-10 from Sheffield on the east to the New Mexico State line for a total of 325 miles," Thomas said. During the nine hours of the December 19 operation, 760 citations were issued for violations of the speed law, 10 citations for following too closely, 17 citations for seat belt violations, one person was arrested for driving while intoxicated, three wanted fugitives were apprehended,

95 arrests for other violations were made and one stolen vehicle was recovered. A total of 78 officers were involved in the original operation.

"**Operation Plain-View II** will involve 158 uniformed personnel with the DPS and will utilize 130 marked enforcement vehicles and 28 unmarked units," Thomas said. "The unmarked vehicles will mainly be used as radar cars. Officers of the Drivers License Service, License and Weight Service, Motor Vehicle Inspection Service and Safety Education Service will assist the highway patrol officers in this effort.

"Officers will be looking for all violations of the traffic laws with special emphasis given to the speed limit, following too closely, seat belt violations and driving while intoxicated. Special attention will also be given to commercial vehicle violations since they comprise a large percentage of the traffic on the highway," Thomas said.

Trap Company."

The OB Trap Company set aside 11 one half section traps.

The usage of the traps declined following the usage in the late 1930's and early 1940's of pickup trucks. Auctions in San Angelo killed the Barnhart livestock shipping industry.

Soft guitar music provided by Ollie Sudduth, Brock Jones, Rod Chalmers, Jim Wilson and Don Killgore was performed around the constantly stoked campfire. The tunes played included familiar cowboy songs such as "Red River Valley", "San Antonio Rose" and "I Walk the Line". "We really had a good time," Sudduth said.

By 9:30 p.m., all but the hearty pioneers who would brave the cold and spend the night left the campsite. The trip would continue March 21 at 9:00 a.m.

A hearty breakfast of scrambled eggs, bacon, sausage, biscuits and strong black coffee greeted the early risers. Many 4-H mothers supplied the fixings, and Mrs. Thelma Janes scrambled the eggs. Marilyn Chalmers prepared the biscuits.

Excitement and near tragedy abounded that morning. Just prior to vesper services, participants were reminded how quick disaster can strike, when Toby Childress of Big Lake was thrown from his mount. Though injured, Toby's leg was unbroken, according to Dr. Carlisle, who had just arrived for the trip.

The 8:40 a.m. vesper services had a new meaning following the injury to Toby Childress. Ken Harrison, United Methodist minister from Ozona, led the modern day interdenominational group in songs. Jim Furr, a fulltime cowboy and parttime minister at the Barnhart Baptist Church, spoke movingly on the importance of religion to the early settlers and to modern day pioneers.

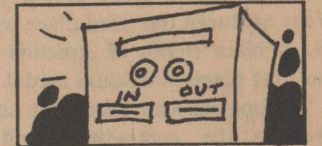
