# School Lunch Program

The Sterling City Independent School District has announced a free or reduced price lunchbreakfast policy for Sterling County school children unable to pay the full price.

Local school officials have a policy that allows families with few children to receive free or reduced school lunches or breakfasts with income going from \$2190 for the smallest family to a high of \$8700 per year income, if children total 12 in number.

# Two Wildcats In Sterling County

Sterling County drew locations for two wildcats this week.

E.B. Brown, Dallas will drill an 8,800-foot wildcat in Sterling County, 10 miles northwest of City, five miles east of the Credo, East (Wolfcamp) field and 33/4 miles northwest of the McEntire (Fusselman oil and gas) field, but separated from both by failures. It is the No. 1 Wilkinson Estate.

Location is 2,635 feet from the south and 1,600 feet from the east lines of 12-23-H&TC.

It is also \(^{8}\) mile east-northeast of an 8,777-foot failure, Southland Royalty Co. No. 1 Wilkinson-McEntire, abandoned June 29, 1965. which recovered gascut mud, oil and gas-cut sulfur water and salt water on a test at 8,629-31 feet; and mud on a straddle-packer test at 6,704-975 feet.

Fusselman production in Mc-Entire field is at 8,590 feet; and Wolfcamp in the Credo, East at 7,064 feet.

Taurus Petroleum, Inc., Midland. will drill the No. 1 Ainsworth, an 8,100-foot wildcat in Sterling County, 12 miles north of Sterling City, 23/8 miles south of the two-well Triple C (Ellenburger) field and a 1/2 mile northeast of the depleted one-well Iolanthe (Strawn) field.

Location is 660 feet from the north and 1,980 feet from the east lines of 39-2-H&TC.

The Iolanthe field, opened in 1940, produced from approximately 8,235 feet.

Social Security Tips

Effective January, 1973, a child disabled before age 22 may now qualify for social securty benefits on the account of a retired, disabled, or deceased parent-warker, accordding to J. M. Talbot, social security manager. Previously, a child had to be disabled before age 18 to qualify for disability benefts on a parent's record.

In many cases, a child's dependency on the parent is extended beyond age 18 because the child spends additional years in school and has no regular earnings before his twenties. Extension of the age to 22 recognizes this dependency.

For more information, contact the Social Security Office at 3000 West Harris Ave. (P.O. Box 3808) in San Angelo, or see the representative when he is in your area. Persons who are unable to meet with him are encouraged to call the office in San Angelo at 949-4608.

"Processing time can be cut in half if people are prepared when the time comes to apply for social security benefits," says J. M. Talbot, social security manager.

. . . . .

Being prepared is not as difficult as many people believe. Remember to take along your social security card or the card of the person on whose record you are filing. For a widow, this would be the social security card of her late husband. This may sound hard to believe, but many people do come in to file their application and leave their number at home.

The third thing that is needed in all claims is evidence of the worker's last year's earnings and an estimate of this year's earnings. Your W-2 Form or tax return for last year will give the information for last year. Be sure to bring these with you.

The next most important document to take with you is your birth certificae, if available. Proof of age is needed to qualify for nearly all social security benefits. If your birth was recorded when you were born or if you were baptized before age five, you will need one of these documents. If you don't have a copy, make arrangements now to get one, Mr. Talbot advises.

If you birth was not recorded and you were not baptized before age five, there are other documents you can use. In most cases, the earlier the record was made the better it is for helping to establish


"How do I know my work under social security is being credited to my record, and how do I find out about it? This is one of the questions most frequently asked," says J. M. Talbot, social security manager.

In explaining the process involved in reporting social seccurity, Mr. Talbot said, -'When you work for wages, your employer deducts social security tax from your paycheck each pay day. At the end of each calendar quarter, he submits your name and number with payment for these taxes to Internal Revenue. Internal Revenue forwards copies to social security's main office in Baltimore, Maryland. Your wages are then posted to your record. The same process is followed for a self-employed person except that his earnings are recorded yearly."

Mr. Talbot states that the possibility of an error being made in the process does exist. He recommends that you request a statement of your earnings at least every three years

All you have to do to secure the statement is to send a post card request available at your social security office to Baltimore, Maryland. If the reply you receive is incorrect in any way, contact the Social Security Office at 3000 West Harris Avenue (P. O. Box 3808) in San Angelo, Texas, or see the representative when he is in your area.

# Social Security

The San Angelo Social Security Office is now taking applications for supplemental security income payments, a Federal program scheduled to start in 1974 that will establish an income floor for people in financial need who are 65 or over, or blind, or disabled, according to J.M. Talbot, social security manager.

But, people already getting State old age assistance or State aid because they are blind or disabled don't have to apply, he said. They'll be geting more information later this year about how the program will help them.

"The first monthly payments under the Federal program will be made in January, 1974," Mr. Talbot said. "Until then, State and local public assistance offices will continue to make payments in the usual way."

People not getting public assistance now who think they may be eligible for the new Federal payments should call or write social security to find out if they should apply, according to J.M. Talbot.

"Federal supplemental security income payments will be made by the Social Security Administration," Mr. Talbot said. "But the program will be financed by Federal general revenues-not by social security contributions from workers and employers. It's not the same as social security."

The aim of the new program is to provide supplemental payments in cases of need so that people 65 or over, or blind, or disabled will have a basic cash income of at least \$130 a month for one person and \$195 a month for a couple.

"This doesn't mean that every eligible person or couple will be getting that much from the Federal Government every month," Mr. Talbot said. "The amount of the Federal payment any person gets will depend on how much other income he has."

"Eligibility for Federal payments will depend not only on the amount of income people have but on the value of their assets," Mr. Talbot said.

"If you're single-or married but not living with your husband or wife-you can own things worth upto \$1500 and still get Federal payments," he said. "A couple can own things worth up to \$2250 and get payments. Not everything you own has to be counted toward your total assets, however."

"A home of reasonable value will not be counted as an asset," Mr. Talbot said. Personal effects and household goods won't count in most cases. Insurance policies or a car may not affect eligibility either, but it will depend on their value.

Certain income will be disreded in deciding on an application for supplemental security income. The first \$20 a month of income generally won't affect the Federal payment at all, Mr. Talbot said. "In addition, people

who are working part time should know that the first \$65 a month of earnings won't be included in counting their income and only half of the rest of their additional earnings will be counted, he said.

Apart from earnings, other income above the first \$20 a month generally will reduce the Federal payment. This includes social security checks, veterans payments, workmen's compensation, pensions, annuities. and gifts, Mr. Talbot said. And. if you live in someone else's household, your basic Federal payment will be reduced by one-third before other income that may affect your payment is deducted.

For more information, contact your Social Security Office at 3000 West Harris Avenue (P.O. Box 3808) in San Angelo, Texas. The telephone number is 949-4608. Even though payments cannot start until January, 1974, we're starting to take applications now so we can process them ahead of time and avoid delays that might occur if there's a rush of applications right at the end of the year, Mr. Talbot said.

Sterling County joined the list of counties in Texas that had confirmed cases of screwworms as noted in the article in last Friday's paper. The case, on the William Foster Ranch, was the first in the county in 1973.

Thus far this year, confirmed cases are running far behind the total last year. According to the last report issued by the Mission laboratory, there were fewer than 700 cases thus far in 1973.

All producers are urged to be especially watchful now. Check your livestock as often as possible. Take a sample of all suspected screwworms and treat the wound. Mailing tubes and vials for the samples are available at the feed store and the county agent's office. If you find an animal with worms but do not have a vial handy, take a sample and put the worms in any kind of container you have available in plain water. Then, put the sample in the mailing tube and vial as soon as posible.

During the phone conversation last Thursday, Dr. Novy at Mission said the confirmed cases have been spotted this year. There is no one area where they seem to be more evident than another. The majority of the counties in this immediate area now have had confirmed cases. The only county in this region that had not had a case last week was Coke County. \* \* \* \*

What happens to the thousand pound steer that leaves the feedlot? How much of him actually ends up on the table as edible beef?

The thousand pound steer that grades choice will produce about 600 pounds of carcass. When the fat, bone and other waste is taken away, about 444 pounds of edible beef remains.

This 444 pounds is then broken down into the various cuts ranging from steak to hamburger and stew meat. A thousand pound steer will produce about 48 pounds of sirloin steaks.

More and more people are going to learn what the live animal yields. Many of the packing plants. especially smaller ones, are going to a custom slaughter operation in the face of the ceiling on beef. They say that they cannot buy the beef and merchandise it as they did in the past. The retailer or consumer is buying the beef on the hoof, paying for the slaughtering and processing, and then retailing the meat or placing it in the family freezes. Many retailers are also refusing to accept orders for beef for the freezer which will force changes in purchasing meat for the freezer. Other packing plants are shutting down completely until after the freeze is lifted.
