# **Hospital-Nursing Home Board Reviews Year**

The Sterling County Hospital and Nursing Home board of directors met and elected officers for 1974 Tuesday evening.

They reviewed figures showing the operation of the institution for the past year.

Dr. Wm. J. Swann was reelected chief of staff. F. S. Price was named chairman of the board and Finis Westbrook was elected vice chairman. H. L. Hildebrand was elected secretary. E. L. Bailey was excused — as he is in a Temple hospital for treatment. Worth Durham is the outgoing chairman.

Also present at the board meeting and dinner were county judge Roland Lowe and county commissioner Cledis Smith, Danny Stewart, and Bill Bynum. Also hospital administrator Mrs. Mildred Emery and Jack Douthit.

Figures showing the year's activities were handed out by Mrs. Emery. It cost \$215,562.11 to run the combined institutions in 1972 and that figure was \$216,091.81 in 1973. The biggest cost factor is salaries - which was \$131,-534.67 in 1972 and was \$141,-947.10 in 1973.

The largest item of income is for rooms-which was \$31,758.00 in 1972 and \$28,500.00 in 1973.

Groceries for the institution in 1972 were only \$18,056.23 and had jumped to \$23,069.02 last year (1973).

The nursing home pays its way better than the hospital. Slightly higher room rates for the hospital were put into effect January 1, 1974.

Consensus of opinion is that the hospital and home is a wellrun and operated institution and a credit to the county and area.

### Sterling Stock Show Set for January 21

John Brock received his ribbons from the West Texas Regional Pecan Show held in Odessa in mid-December. Five varieties of pecans raised by John were entered in the show by reason of their placing at the Trans Pecos Pecan Show in Rankin.

John earned one blue ribbon, one red ribbon. and one white ribbon in the Regional Show. His first place ribbon came on a John Garner entry. His entry in the Mahan class won him a red ribbon. The white ribbon was awarded to his entry in the variety seedling class—this means no one knows what variety it actually is.

The three ribbon winning entries will be entered in the State Pecan Show to be held in El Paso, July 9-11, 1974.

Excellent meeting facilities on the campus of Texas A&M University have made possible the combination of all animal and forage production shortcourses into one. Formerly, shortcourses for beef cattle, swine, dairy cattle, horses, and forage were held at different times.

The completion and opening of the new J. Earl Rudder Continuing Education Center provides ample meeting facilities for this type group now. The Texas Animal Agriculture Conference will be held January 21, 22, 23, 1974 in the new center.

The five areas—beef cattle, dairy catle, swine, horses, and

forage production—courses will be arranged so that those attending can hear the ones of their choice. 'Full information on the shortcourses is available in the county Extension agent's office.

The FARMER'S TAX GUIDE, 1974 EDITION, for use in preparing the 1973 itncome tax returns is now available. Anyone desiring a copy of the guide can have one by coming by or calling the county Extension agent's office.

The guide provides information on the preparation of farm income tax returns, self employment tax, and social security. Different methods to achieve the best way of handling the many items associated with an agricultural operation are illustrated in the guide.

New brucellosis regulations become effective in Texas on January 15, 1974. Texas was the last state in the union to qualify as a Modified-Certified area. The new regulations will move the state toward the brucellosis free designation which- has already

been granted thirty-one states.

The new program is designed to (1) locate infection; (2) contain the infection, and (3) assist the owner of infected herds to eliminate the disease. This will be accomplished through ring testing of dairy herds, market cattle testing of all breeding cattle going to slaughter, and
