Here are the legal voter guidelines for the Democratic Party Primaries this year as put out by the Texas Democratic Party:

1. Register to vote at least 30 days prior to Democratic Primary, which is May 4, 1974.

2. All registered voters, 18 years and older, are eligible to vote in all Democratic Party elections.

3. Present registrations are valid if you have voted in a Democratic Primary or General Election within the last three

4. Register to vote at your County Tax Assessor-Collector's office or with a properly deputized person allowed to register voters.

5. Notify your County Tax— Assessor--Collector of change of address 5 days prior to election day so that you are registered in the proper precinct, if you have moved within the county.

6. On moving from one county to another, you must re-register 30 days prior to the election. if you wish to vote in your new place of residence.

7. An April 14, 1974, the absentee voting for the first primary by personal appearance at the County Clerk's office begins and goes through the fourth day preceding the election.

8. Applications for absentee voting for the first primary must be received by the County Clerk not later than the close of business on April 30, 1974.

9. Marked absentee ballots for the first primary must be mailed back to the County Clerk and postmarked not later than midnight, on May 3, 1974.

NEW TEXAS ALMANAC

1974-75 Almanacs

THE PEOPLE OF TEXAS, a study of the many nationalities and ethnic groups that have combined to make up the state's population, is one of many new features in the 704 pages of the 1974-75 Texas Almanac, published by A. H. Belo Corporation, publishers of The Dallas Morning News.

The article is by R. Henderson Shuflfer, executive director of the University of Texas Institute of Texan Cultures at San Antonio.

Texans have always come in assorted sizes, shapes and colors, with a wide variety of mother tongues and hereditary customs and traditions, Shuffler writes. He has capsuled this variety of cultures in the special Almanac feature.

The new edition also contains a comprehensive history of the livestock feeding industry in Texas, which now leads the nation in numbers of cattle fattened in feedlots. The article was written by Sam A. Thomas Jr.. manager of agricultural development for Southwestern Public Service Company of Amarillo.

Two reports are of special interest to ecologists. One is a list of endangered plants and animals in the state, prepared by the Texas Organization for Endangered Species. The other is a list of state agencies responsible for pollution control.

Election results, listings of county, municipal and state officials, amendments to the Texas Constitution, appointive boards and commissions, officials of state and regional civic and trade organizations and many other listings are expected to make this edition widely used as a reference for offices, schools, public agencies and homes.

A new Texas map, in color, with major highways, distances and other information supplements 254 county maps. updated from maps prepared by the Texas Highway Deparment.

The county maps are published with information about each Texas county supplied by chambers of commerce, county agricultural agents and others.

LEGAL NOTICE

Pork Referendum and Producer Board Election

Being certified by the Commissioner of Agriculture of the State of Texas for this purpose, the Texas Pork Producers Association, 2422 Taho, Sherman, Texas 75090, proposes a ref-erendum election on May 14, 1974 under provision of Article 55c, Vernon's Civil Statutes, on the proposition of whether or not the pork producers in the State of Texas shall assess themselves a maximum amount of 10 cents per head on all slaughter animals to be collected at the point of first processing or sale and to elect members of a 15 member commodity producers board to administer proceeds of such assessment to be used for research, predator control, disease and insect control, education, and promotion designed to encourage the production,

marketing, and use of pork.

The referendum and election will be held by mail ballot which will be provided to all eligible voters not later than 15 days prior to the election. Ballots

must be mailed to the polling place at Sherman, Texas before midnight on the date of the election.

Any person within this state

Any person within this state engaged in the business of producing, or causing to be produced slaughter hogs for commercial purposes is eligible to vote, including owners of farms and their tenants and sharecroppers, if such person would be required to pay the assessment proposed.

Any person qualified to vote at the referendum may place his name in nomination for membership on the proposed commodity producers board by application to the above organization signed by himself and at least ten other persons eligible to vote in the referendum. Such applications must be filed at least 30 days prior to

Any person qualified to vote who does not receive a ballot prior to April 30, 1974 may obtain one at his local County

Agent's Office.

The hearing in the Federal District Court in Washington, D. C. regarding the use of the M-44 and sodium cyanide for coyote control has been postponed until March 27. First scheduled to be heard on March 12, it was postponed to March 21 and now to March 27.

The hearing concerns the injunction that the Humane Society brought against the Environmental Protection Agency and its experimental program using the M-44 in forty-four counties in Texas. Training meetings were held in a few counties in the state on the use of the device prior to the injunction. Sterling County's meeting was held on Monday, March 14, the day the injunction was granted. As a result of the suit, all meetings and the use of the device was halted immediately.

The Texas Department of Agriculture is keeping the Agricultural Extension Service at College Station informed on the matter. As information is received, we will pass it on,

High food costs have brought about renewed interest in home gardens. To furnish information on home gardening, the Agricultural Extension Service of Texas A&M University has printed several new bulletins on the subject. They include information on planting dates, rates, seasons, and the do's and don'ts of gardening. These bulletins are free. Anyone desiring copies of them can have them by contacting the county Extension agent's office.

Dealers handling the small garden tillers are unable to meet the demand for them in most areas of the state. They say that their shipments are sold out as fast as they receive

The mild winter has resulted in an early migration north of screwworms this year. Confirmed cases of the livestock pest were found near Brownwood and Stamford last week. This is the earliest that screwworms have been found this far north in the

The eradication program officials as Mission have gone to a ground release of sterile flies in areas where confirmed cases have been found. This was done because high winds were making the air drops of flies difficult. The flies were being blown far from the intended areas and the ground release program will put them where they are needed.

With shearing season approaching, all livestock producers are urged to take all precautions this year. This would be a good time to spray your sheep out of the shearing pen.

Check your livestock regularly. Treat all wounds after taking a sample, if there are worms in the wound. Keep a couple of collection vials and mailing tubes in your pickup. If you need vials, they are available at the county agent's Extension of-

A sample sent in from the H. L. Hildebrand River Ranch last week was identified as nonscrewworm. This is the first report on a sample in Sterling County in quite some time. It was taken from a sheep's head. * * * *
