

Robert (Bob) Krueger took the lead over Nelson Wolff in the Demo runoff race for the 21st Congress seat in Sterling County and the district. Bob polled 48 votes here to Wolff's 40. District wide the figures were 29,284 for Krueger and 27.510 for Wolff.

Both men were vying for the spot being vacated by veteran Congressman O.C. Fisher.

In the race for the 63rd district legislative seat, Michael Ezzell of Snyder got 61 votes here to 24 for opponent C. Glenn Toombs of Borden County.

District wide Ezzell got 6,629 to Toombs 4,577. The seat is being vacated by veteran Renal Rosson of Snyder.

There were no other races on the ticket in Sterling County. All voting boxes had been consolidated into on big box at the courthouse for voting.



### Social Security Tips

Social security checks should be cashed within a reasonable time to prevent loss or theft, even though there's no time limit on cashing them, according to social security officials here.

'If your check is lost or stolen, get in touch with your nearest social security office at once,' a spokesman said. 'The check can be replaced, but it takes time. Handle your check carefully when you get it and you won't have to wait while it's being replaced.'

Social security pays over \$4 billion a month in benefit checks to almost 29 million peopleeligible retired and disabled workers and their families and families of deceased workers who worked long enough under social security.




