There have been some requests for the RECIPE for making the paper logs that produce the varied color flames in the fire-place during the holiday season. Since it does take a couple of weeks to make and dry the log newspaper rolls, here is the way its done.

Rolls newspaper into logs and tie with heavy twine. Soak them in a solution of four pounds of copper sulfate and three pounds of rock salt dissolved in one gallon of water. Place the solllution in a plastic, glass or enamel container to soak the logs. The solution will 'eat' holes in galvanized or metal containers. Allow to soak for several days, turning the logs periodically. Dry the logs for several days they are ready for use by ad-ding to the fire in the fireplace just as you would any logs.

The Tom Green County Pecan Show dates for this year are December 3-4. Sterling County Pecan growers have again been invited to make entries in the show.

An entry will consist of 42 pecans from the 1976 crop. The divisions are the same as in the past: In-Shell, Shelling, and Native Pecans. These are further broken down into the vaarieties. Each exhibitor is asked to end in some surplus pecans which are sold to help defray the iost of the show.

#### Social Security

Social Security benefits were being paid to residents of Sterling County at a rate of \$30,913 a month at the start of 1976, Frank Upp, social security manager in San Angelo, said.

Of the 194 social security beneficiaries living in Sterling County, 104 are retired workers and 7 are disabled workers. Another 83 are receiving benefits as the dependents of workers who are retired, disabled, or deceased.

In Sterling County, 47 people under age 65 and 147 people age 65 and over are receiving monthly social security benefits. Of total beneficiaries 74 are men, 93 are women, and 27 are children. The children receive payments because a working father or mother has died or is getting social security disability or retirement benefits.




