THE BEGGAR AND TRAMP.
What shall be done with beggars and tramps, is an old question, one that has perplexed the minds of law-makers for ages past. The New Hampshire legislature last year attempted to solve the problem by passing an act very severe upon the tramping and begging fraternity, and its effects have been reported so beneficial that our own legislature have passed a bill before it embracing the main features of the New Hampshire act. Tramps begging about the country, or found concealed on any railroad car, shall be liable to imprisonment at hard labor for from six to fifteen months, and imprisonment in the penitentiary for from one to five years is the punishment for a tramp who enters a house without the consent of the owner, or builds a fire on the highway or on private property, or who threatens to do injury or damage to any person or his property. Under this law tramps would be thrown from their defaulting stables on the high houses they have been riding over the country for the past few years, and be compelled to be meek and submissive, or their victims would turn and clap them into the hands of the law. Some law of unusual stringency is a necessity in connection with the tramp nuisance.
For the benefit of the tramping fraternity who may think the proposed law against them too severe, and to enable them to seek comfort by contrasting their position in relation to the law with their ancestors of the same stripe, we give a synopsis of an old English law against beggars. By a statute of England, for an able bodied man to be caught a third time begging, was held to be a crime deserving death, and the sentence was intended on fit occasions to be executed. If a man out of employment preferred to be idle he might be demanded for work by any master of the craft to which he belonged, and compelled to work whether he would or no. If caught begging once, he was whipped at the cart's tail. If caught a second time, his ears were slit. If caught a third time, being thereby proved to be no use upon earth, but to live upon it only to his own hurt and to that of others, he suffered death of a felon. So the law of England remained for sixty years. First drawn by Henry, it continued unaltered through the reigns of Edward and of Mary, showing that it existed with the approbation of both the parties then dividing the country. Reconsidered under Elizabeth, the same law was again formally passed, it being, therefore, the expressed conviction of the English nation, even from the reign of Henry to that of Victoria, that it was better for a man not to live at all than to live a pestilent or worthless life. The vagabond was a sore spot on the commonwealth, to be healed by wholesome discipline, if the gangrene was not incurable; but to be cut away with the knife if the mild treatment of the cart-whip failed to be of profit. Our own legislature might get some profitable hints from the old English laws.
