Report was made at the Times office yesterday that a most remarkable phase of mental phenomena presented itself at the residence of a patient of Dr. Thomas, once a physician of that place, but now of Kansas City.

A Times man was immediately dispatched to Rosedale, a small town four miles south of Kansas City, to inquire, very particularly into all details of the case and to thoroughly test its merits.

Mrs. Diana Powell, widow of the late Thos. Powell, resides upon land rented from Mrs. William Powell, near the town of Rosedale, Kansas City. She is 41 years of age and the mother of nine children.

NATURE OF THE CONSTITUTIONAL PROVISION THAT ALL PROSECUTIONS SHALL COMMENCE AGAINST THE PEACE AND DIGNITY OF THE STATE.

Use of the Word "State" Instead of the Word "State."

Argument of Thomas Bell, Assistant Attorney General, on the motion for rehearing in the above case.

After this case has been affirmed, appellant filed a motion for a writ of habeas corpus, the first time attack the sufficiency of the indictment, because the last word therein is "state" instead of "state."

It is only a technicality of the motion any authority will be referred to in answer to said motion, as all the other points relied upon are settled by the opinion of the court for the state.

Section 13, Article 5, Constitution of 1875, says: "All prosecutions shall commence against the peace and dignity of the state."

Because this is the constitutional direction, it has no more weight and is no more imperative than if it were an act of the legislature. Whether of the constitution or of the statute laws make no difference, it is the same in either case.

But in order to avail a defendant of this defect in an indictment, the exception or motion to reach it must be made at the proper time. Article 204, P. D., says that the motion must be made before the indictment or information, except:

1. That it does not appear from the face of the same that any offense against the law was committed by the defendant.

2. That it appears from the indictment or information that a prosecution for the offense is barred by a motion in arrest of judgment.

3. That it contains matter which is a legal defense to the prosecution.

From this, the conclusion is beyond question, that all other exceptions are for matter of form, and that to set aside the motion, Article 205, P. D., defines what is matter of form, and everything not included in Article 204 is matter of form.

And, therefore, a motion in arrest of judgment is good on a motion in arrest, but an exception to an indictment for matter of form is not good on a motion in arrest, in the trial court, on appeal, the court will not consider any question which would not be good on a motion in arrest, in the trial court.

Thus, as this conclusion of an indictment is a matter of form, and made so by the law of Texas, and by the decisions of the courts of last resort in the state, and no judgment shall be arrested for want of form, P. D., Art. 205, it is not a matter of form, and the motion to set aside the indictment is not good.

But this article 214 may be taken as the legislative declaration of the constitutional formula in an indictment, and the further construction of what kind of plea will not reach it.

After a careful and thorough investigation of the whole question, the conclusion is, that it is determined by the rules applicable to pleading and the great weight of authority sustains the indictment.
