

### CONVENTION AT SANTONE Hanger is Named for Temporary Chairman-Committees are

Chosen.

San Antonio, Texas, Aug. 13-Operated by a howling mob, the Colquitt steam roller flattened the opposition in short order this morning when the temporary organization of the convention was perfected with W. A. Hanger of Ft. Worth as temporary chairman and Dayton Moses as secretary.

Pandemonium broke loose when Cullen Thomas of Dallas, a Ramsey man attempted to put-in nomination for the temporary chairmanship, the name of O. S. Lattimore of Ft. Worth.

Howls, catcalls and cries of "we don't want to hear him" drowned the speaker's voice for forty minutes. Thomas, smiling, still held the platform, finally addressing his re-

marks to the newspaper reporters. Trouble was threatened at one stage of the game, when an attempt was made to pull Thomas off the platform by a threatening delegate.

The name of Lattimore was finally placed before the convention, followed by the nomination of Hanger. The roll call showed a vote of 522 3-4 for Hanger and 274 1-4 for Lattimore.

After naming the committees, the convention adjourned until eight o'clock tomorrow morning.

The Engineer's written report will be filed for the consideration of the Commission within the next few days. It is understood that the condition of the road will be report ed as being generally "fair."


