Junior High Parents To Hold Meeting Wed.

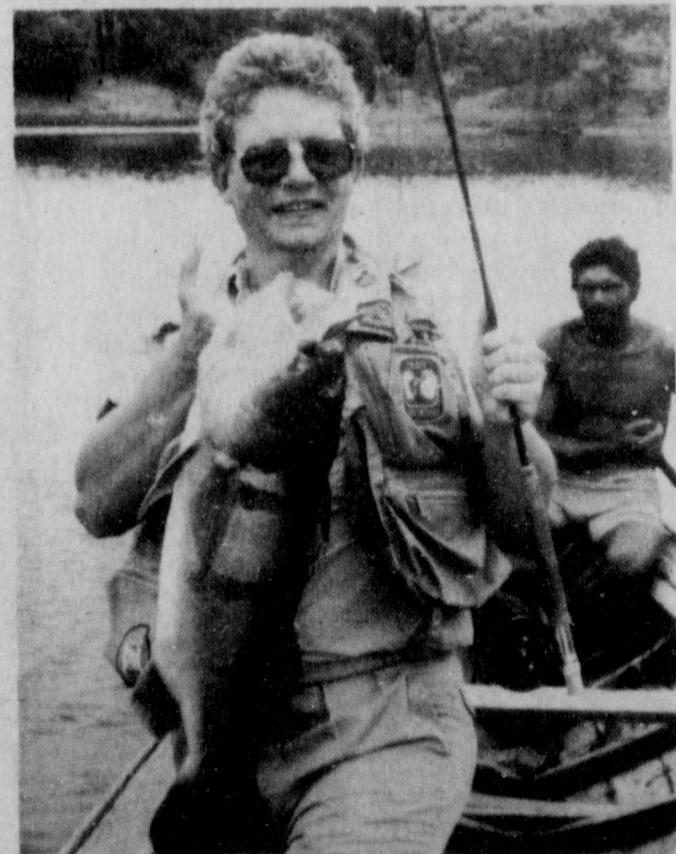
There will be a meeting of all junior high school parents at 5:30 p.m. Wednesday, January 17, 1990, at Cisco Chamber of Commerce.

The late Virgil Love was my mentor in recording legal instruments. In the following years after I left Mr. Love's employment, courthouse "giants" as Stanley Webb, Edgar Altom, J. C. Allison and A. M. "Ot" Hearn taught me various legal recording skills as I worked in their offices. I maintain excellent typing skills, I have a working knowledge of computers, and I feel I have expertise in office and managerial responsibilities.

I hold memberships in professional organizations, as in the Texas State Teachers Association, Delta Kappa Gamma, International, and Texas Classroom Teachers Association. I have served as local president of all three and also on state committees of all three. At the time TCTA was under the umbrella of National Education Association, I was on the TCTA Executive State Board.

As a member of the Eastland County Historical Society, I worked as a volunteer on Eastland County History from the beginning through the delivery of the book.

For over 10 years I have maintained a sustaining membership with the Texas Democrat Party. Regional 9-1-1 Implementation Is Underway

With the beginning of fee collection in January, implementation of a 9-1-1 system has begun in the West Central Texas Council of Governments' region, according to Sue Smith of Abilene, WCTCOG 9-1-1 Director.

"Residents in 12 regional counties will see the first \$.50 per month per customer line fee appear on their January telephone bills," said Smith, "with the remaining five counties phased in during February, March and April." Both Eastland and Callanan Counties are among the counties where the fee begins in January.

System activation will occur approximately 24 months after the beginning of fee collection with assistance from state surcharge funds, a pool of funds collected for this purpose from a surcharge on customer bills in the state's largest counties since last July. "Policy across the state has been to collect fees for a planned time period, while the 9-1-1 system is being installed, so that when the system goes on line, all initial costs are paid," stated Smith. "With the help of approximately \$450,000 in surcharge monies," Smith continued, "our regional system can start operations in the black." To cover ongoing costs, the \$.50 fee will continue after the system begins operation.

During the implementation phase, many telephone switching offices will be modified, equipment purchased and field-tested for each answering point, call-takers trained, and in many places, rural addresses developed for individual citizens.

Smith stated, "9-1-1 can help to save lives and property and we are excited about the prospect of this service being available in all rural areas of our region."

The Eastland County Commissioners will hold special meetings with Southwestern Bell Telephone Co., to phase in the service as smoothly as possible. The first such meeting will be on Feb. 1, and will deal with a data base for the County.

The County will need to be totally mapped before the sophisticated system planned for Eastland County can be activated.

The Cisco Hospital District has called for a Rollback Election to be conducted Saturday, January 20, 1990, from 7 a.m. to 7 p.m. The polling place will be in the Corral Room at 400 Conrad Hilton Avenue.

The purpose of the Rollback Election is to vote

on whether or not to reduce the adopted tax rate of .2800 to the rollback rate of .14135 per \$100 of property valuation.

All registered voters in the Hospital District are eligible to vote in the election. Absentee voting by mail ended Friday, Jan. 12, and in

person at 5 p.m. Tuesday, Jan. 16.

The election Judge will be Mrs. Thelma Smith, and the alternate Judge will be Mr. Donald Gorr. The absentee

voting clerk is Debbie J. Martin.

A large turnout is expected for this election, which has created a lot of interest in the Cisco area.

Mainline Denominations Could See New Growth

(Editor note: The following article was written by Dr. Joseph Stamey, Professor of Philosophy, Chairman, Department of Philosophy, McMurry College, Abilene, Texas. He is a former resident of Cisco. The article was entitled: "Mainline Denominations Could See New Growth.")

Recent publications by sociologists of religion may give hope to those in mainline Protestant denominations. A much discussed book is American Mainline Religion by Wade Clark Roof and William McKinney (Rutgers University Press, 1987). Roof and McKinney document membership decline in

mainline groups. Most affected are the "liberal" denominations - Episcopalians, Presbyterians, and U.C.C. Also affected are the "moderate" churches - United Methodist, Disciples of Christ, American Baptist, and Lutheran.

"Conservative" churches - Southern Baptist, Assemblies of God, Seventh Day Adventist, Nazarenes (as well as "others" including Jehovah's Witnesses and Mormons) - have grown. There is some question about lumping these "conservative" groups together as nonmainline. Southern Baptists have been a part of the Southern and Southwestern mainline for a long time. Their current in-

ternal "holy war" may show that some Baptist leaders do not like some consequences of being a mainline denomination.

Mainline denominations, as sociologists describe them, are those that represent the values of the affluent majority of modern societies, the middle and upper middle classes. Some of them, including Methodists and Disciples of Christ, began as sectarian groups appealing mainly to the poor, those alienated from the mainstream of society's economic, political, and cultural leadership. As their membership became affluent, these groups affirmed mainstream values and became more tolerant toward other religious groups.

Joe E. Barnhart's Jim and Tammy (Prometheus Books, 1988), sheds light on

this process, explaining the Jim Bakker phenomenon as a result of the growing affluence of some American pentecostals who respond favorably to a version of their tradition that no longer condemns material prosperity and a lavish life style.

Methodists will remember Wesley's fear of what would happen as Methodists became affluent through conversion to disciplined living. His concern was that if Methodists "became mainline" they should "take responsibility" for Christianizing the values and practices of society rather than regarding their members as "exploit-accepted social patterns for prestige and selfish gain."

This concern is shared by thoughtful persons in conservative denominations today. According to Barnhart, Jim Bakker is a horrible example of what Wesley did not want Methodists to teach and practice. Nonmainline

groups have been authoritarian toward their own members and exclusive with respect to other groups. Usually they have rejected participation in major areas of society's cultural and political life.

Roof and McKinney destroy the myth that large numbers of members have left mainline denominations to join conservative groups. Rather, the cause of membership decline is twofold. Mainline members tend to belong to "responsible" socioeconomic groups (middle class and upper middle class) with society's lowest birthrates. Also, as members of the socially, culturally, and politically involved segment of society, they tend to give less time and energy to church participation and more to professional and public service activities. Large numbers of the children of mainline members dropped out of church participation entirely during the 1960's in favor of secular involvement in work and community.

Some sociologists believe that some of these drop-outs and their young adult children are now beginning to return to their mainline traditions, seeking a deeper spiritual orientation in the nonauthoritarian setting of the liberal or moderate denominations. The challenge to the mainline denominations may be to present a message and programs that will draw on their religious heritage, clearly biblical and Christian in interpreting the liberating power and claims of Christ, while preserving the tolerance, inclusiveness, and concern for society's good that have marked the religious mainline.

Boris Slutsky To Open Abilene Philharmonic's Season

Lavishly praised by critics and audiences in both the United States and Europe, the 24-year-old internationally known pianist, Boris Slutsky, will open 1990's half of the Abilene Philharmonic's fortieth season at 8:15 p.m. Saturday, January 27 in the Abilene Civic Center.

Since coming to the U.S. from Russia and becoming an American citizen in 1977, Moscow-born Slutsky has appeared at Carnegie Hall, the Kennedy Center for the Performing Arts, the Phillips Collection in Washington, D.C., in concert with the Baltimore and Utah Symphonies and the Orchestra della RAI di Milano. Other performances included Canada, Spain, and Italy. In addition, Slutsky repeatedly has won top competition prizes throughout the world. In 1985 he was the only American among winners of the International Bach Competition in Toronto and last year was winner of the San Antonio International Competition.

For Abilene and West Texas, he will join the orchestra as guest artist in the lyrical and popular Chopin Concerto No. 1 which, after

its first performance by the composer in 1832 was hailed as showing "an abundance of original ideas of a kind to be found nowhere else - a part of that which we have so long sought in vain."

In addition to performing, Slutsky also serves on the faculties of the International Institute of Music in Taos, New Mexico, and the Hebrew Arts School in New York.

Rounding out the January 27 concert, the orchestra and Musical Director-Conductor George Yaeger will perform Rachmaninoff's familiar Symphony No. 2 plus "Poems of the Sea" by the American composer of Swiss birth, Ernest Bloch. Bloch's work is known for its rhapsodic and melodic qualities and is described in Grove's Dictionary of Music as "heavily laden with combinations of color which match his subject in glowing intensity."

The work will anticipate and pay tribute to the Philharmonic Guild's Thirtieth Anniversary Ball, "Jewels of the Sea," scheduled March 10 at the Civic Center.

Direct Deposit Makes Sense

Direct deposit of Social Security and supplemental security income (SSI) benefits makes even more sense than ever before, thanks to recent advances in the direct deposit program. Glyn Hammons, Social Security manager in Abilene, said recently.

All financial institutions involved in the direct deposit program are now required to have computer facilities to allow electronic transfer of benefits. In addition, benefit payments which cover more than one month can now be sent by electronic transfer rather than by paper check.

This insures that payments will be made quickly and safely to Social Security and SSI beneficiaries, Hammons said.

To switch from paper checks to direct deposit, call Social Security at 1-800-234-5772. Have available your Social Security claim number and a check or account statement from your financial institution.

The Abilene Social Security office is located at 142 South Pioneer. The office is open 9 a.m. - 4:30 p.m.

Low-income households may be eligible for energy assistance

AUSTIN—Some low-income Texans may be eligible for help in paying heating bills this winter through the Home Energy Assistance Program, according to Texas Department of Human Services Commissioner Ron Lindsey.

Lindsey said the one-time payment is available to many low-income households. Applications for energy assistance were mailed to households that received food stamps, Aid to Families with Dependent Children, or Supplemental Security Income in December. Other low-income individuals may request an application by calling the toll-free number 1-800-252-8060 during the enrollment period of Jan. 22 through Feb. 28.

Eligibility is limited by gross income and resources. Aid is available for a one-person household having less than \$589.49 gross income per month. The gross income limits are \$781.49 for households of two persons, \$973.49 for

three, \$1,165.49 for four, \$1,357.49 for five, and \$1,549.49 for six.

Households are eligible if the cost for heating is included in the rent payment or if the household pays a portion of its home energy costs.

Energy assistance checks are sent directly to the people who are eligible for assistance. However, the checks are made payable to the energy provider.

People receiving one of these energy assistance checks should mail it or take it in person to the energy provider business office with their regular energy bill. The check can be cashed only by the energy provider. If the HEAP check is more than the energy bill, the additional amount will be credited to the person's account for the next month's bill. If the energy bill is higher than the check, the person is responsible for paying the difference.

AUSTIN—Declaring there was method in his madness, Gov. Bill Clements last week set the special session for Feb. 27, which will run over the last two weeks of the March primary campaign.

But the confusion was stabilized a bit when a federal appeals court postponed court-ordered new elections for state district judges.

Why is it madness? Because instead of campaigning back home, legislators will be in Austin voting to restructure public school financing and judicial elections.

Clements knows exactly what he is doing. With no place to hide and little time to explain, every vote cast by lawmakers will be noted by voters back home.

No one, not even veteran observers, is willing to predict how this is going to turn out. Perhaps the membership of the Legislature will be altered irreversibly.

Decade's Realignment

The losers? It's difficult to predict, but more Democrats face primary challenges than Republicans. As liberal Democrats push conservatives and moderates out, the Republicans pick up strength in November.

The winners? The ones who vote right — the way folks back home want them to — liberal or conservative, Democrat or Republican.

Few have ever doubted that Clements, a lame-duck, had the guts to call their hand in such a manner, but he was pushed into it by two expensive court orders.

Nevertheless, he must be getting some small measure of satisfaction, for not so long ago a handful of state senators held his feet to the fire and forced a tax hike down his throat.

It will be interesting to see what strategy those senators serve back.

But beyond court orders and political grudges, Clements has dumped all the chips on the table and dealt the cards.

It's the last and biggest installment of the rapid voter realignment that has occurred in Texas in the 80s.

Texas will sail into the 90s a true two-party state, and we will find out in March which party will be steering the ship.

Lewis' Ethics Memo

House Speaker Gib Lewis drew a Republican opponent, Fort Worth businessman Edward Gore, and all eyes are watching that race.

Lewis sent a memo to fellow House members urging them not to be stampeded by media pressure overdoing legislative ethics as a campaign issue.

"I strongly support a reasoned, balanced approach to ethics reform," Lewis said in his memo. "However, strengthening the ethics laws is a difficult assignment which requires a meticulous, detailed analysis."

His opponent intends to use the ethics issue against Lewis in the campaign.

Lewis went through this same scenario last election, which didn't stop him from winning a fourth term as speaker.

Mattox Reverses Stance

After Attorney General Jim Mattox reversed himself and asked the 5th U.S. Circuit Court of Appeals to stay a ruling that state district judges in nine urban counties run in non-partisan elections in May, the court agreed.

The elections will proceed under current state laws.

Clements, who had earlier asked Mattox to seek the stay on behalf of the state, blamed Mattox for wasting time.

Republican Camp

Some regular party Republicans

are upset with what they see as a dirt probe of Clayton Williams by his gubernatorial opponent, Kent Hance.

Hance said he hired Gary Maloney, a national party official, to investigate Williams' claims that he created 100,000 jobs for Texans, and that Maloney dug up dirt on his own regarding Williams' drinking and brawling.

Williams is sticking to his guns about his entrepreneurial boast. The other stuff apparently happened in younger days.

Meanwhile, Hance announced that former Marine Lt. Col. Oliver North, a key figure in the Iran-Contra scandal, will appear at two of his fund-raising events in February.

Democratic Camp

Those interested in the aftermath of the workers compensation wars are watching the Pasadena-Galveston senatorial race, where incumbent Chet Brooks is challenged by labor's Rep. Lloyd Criss.

Labor union bosses and trial lawyers, angered that Brooks broke a stalemate against them in the recent special session, are apparently determined to defeat Brooks.

But Brooks, dean of the Texas Senate, is hard on the campaign trail, backed by no less than former state Sen. Babe Schwartz, a power himself.

Nevertheless, the area is rife with oil refineries and other industrial plants with high labor union membership.

For the aficionado, this remains the race to watch.

Other Highlights

State Sen. Craig Washington, D-Houston, will resign his seat Jan. 23, the same day he will be sworn in to replace the late U.S. Rep. Mickey Leland. Clements set Feb. 13 for the special election to fill Washington's seat.

Midland oilman Robert Holt, a former part-owner of Ruidoso Downs, is reported in line to be the next Department of Public Safety chairman, which would automatically seat him on the Texas Racing Commission.

(ED. NOTE: Mr. and Mrs. Ferrell Newton recently visited Germany and this is their account of the traffic.)

I have always considered myself a very average, late middle-aged American male, no more faint-hearted nor no braver than any other. Now I am convinced I qualify for some kind of medal for valor because I survived an experience that tries men's souls - coping with German traffic.

I was chauffeured around Germany by my mild-mannered and unassuming son-in-law, Michael Haley. Now, Michael had a typical small town mid-America background, and I had no idea his experiences of driving on German highways would turn him into a combination of A. J. Foyt and Chuck Yeager.

The revelation began when Mary, Michael and Leah met us at the Frankfurt airport with their car, an innocent-looking Volvo 4-door sedan. We loaded the luggage, fastened our seat belts and entered the nightmare world of German traffic.

Not far from the airport we entered Autobahn A5, and the race was on. I know you have probably heard about, or maybe even have experienced first-hand, the fact that there are no speed limits on German autobahns except in extreme cases. Unless you have experienced the thrill of entering the autobahn at a remarked that we were lucky it was about noon on Christmas Eve so the traffic was light. I thanked the Lord for this and all other small favors.

We traveled north on A5 toward Bad Vilbel and home at a leisurely pace with about 80% of the traffic passing us in the left hand lane. You know the feeling you get when nearly all the traffic passing you, one of a leisurly wrong; the inside ring registered 148 KM, and that meant the 80 was MPH. From then on my bravery began to be apparent.

I was relieved when we turned off the autobahn and entered the village streets. My relief was short-lived, however; these streets are where driving skills and bravery become even more essential. The streets in some places are

only 3/8 of an inch wider than two cars and you are expected to negotiate the narrow places at the same speed at which you left the autobahn - wide open. To make a long story short, we made it home due to Michael's driving skills and my bravery.

On Christmas night we decided to drive to downtown Frankfurt to see the lights and other sights. You realize that Frankfurt is a city older than any of our American cities, and many of the streets were laid out before the modern automobile was designed. It was on this trip that I learned some of the basic rules of German traffic and added a battle star to my medal for valor.

Did you know? You always start on yellow after a stop signal...

You always pass the car in front of you regardless of how far you have to go.

You always signal the driver in the other car with a hand signal that is considered offensive in polite society.

U-turns are permitted anywhere in the street regardless of signs.

After the conditioning we had received in city traffic, Michael deemed us ready for an extended road trip. On

Wednesday we loaded into that Volvo that I now considered a cross between a Sherman tank and an Indy 500 racer. We headed for Wachtelsbach, Fulda and the East German border. This trip was primarily along Autobahn A66.

An autobahn can best be described as one of the world's premiere roadways, usually consisting of three lanes going each direction. The quality of the construction and maintenance on these roads is equal to our interstate system before we ran out of money for maintenance.

The thing that is unique about the German system is the caste system that has evolved that determines the use of the lanes. To use the two right hand lanes no special status is required except that the foot on the accelerator must be the heaviest part of the body. But to use the inside lane, you must have large veins in the forehead that almost burst when your

speed drop below 160 KMH or 100 MPH. You must drive one of the powerful prestige cars with the Mercedes or BMW label. You must have developed the uncontrollable urge to pass every car ahead of you. You must look down your bulbous nose at anyone driving a lesser car.

Once in a while a lesser car will venture into the left hand lane. Even if it is travelling at the required speed of sound, the pack of Mercedes and BMWs will soon put it back in its place on the right. Michael dared to put the Volvo in the left lane a few times, and I even opened my eyes while in the left lane - bravery in the presence of peril.

A new element has been introduced into German traffic that may have a far-reaching and devastating effect. This is that after so many generations of discipline, orderliness and attention to detail, the Germans have discovered a way to vent all their

frustrations and thumb their noses at convention. That way is to jump in their cars and arrive at their destination without much time elapsing. I was in the midst of it, and thanks to my bravery and Michael's skill, I survived.



Eastland County Resource Assoc. Members Meet

The Eastland County Resource Association members Jan. 9 heard reports on work for the needy. Director Corrie Cowley reviewed some of the activities in December, saying this had been a very active month.

The County Resource Association is a group of citizens attempting to meet criti-

cal needs not covered by other agencies. The group works in cooperation with the Department of Human Services and the Multipurpose Center, including the Clothes Closet and County Food Pantry.

A report from Becky Boswell, Treasurer, stated that generous contributions had been received in response

to an appeal which went out by letter in early December. She added that more funds could certainly be used, however. Persons wishing to help may still mail contributions to the ECRA at 210 S. Lamar, Eastland, 76448.

Corrie Cowley reported that the Children's Travel Fund was used to help four families in December. This is a fund which assists chronically ill or disabled children to go to medical facilities for treatment.

The money used from this

fund is reimbursed by government agencies to the County Resource group, so it is actually a revolving fund.

On other assistance in December, a County Resource Association voucher was used to purchase propane for a needy family during the severe cold spell before Christmas. Other vouchers were used for a utility deposit and utility payments.

There was news from the Food Pantry - Lois Robinson, volunteer worker for the Pantry, reported that generous people had kept it well-stocked, right on through the severe weather and Holiday season. A lot of people had been served by the facility, which is located at the Multipurpose Center on North Lamar.

"Of course we would like to continue to keep a good supply of canned goods," Mrs. Robinson said. "Right now we could also use household cleaning supplies, such as soap and the like."

Mrs. Robinson reported that meat is usually in short supply at the Pantry. But recently four large roasts were

donated, and then distributed to needy families.

Lois Robinson also discussed the up-dating of the list of resources available for people in the county. She is gathering material on this right now, and as soon as the new list is available it will be published in the Eastland County Newspapers.

Any Church or Organization which has not been contacted on the up-dating-but which has help available - may call Corrie Cowley at 629-1813 or Viola Payne at 629-1707.

Before the meeting ended January 9 the group made plans to give assistance to a disabled person in the city. This help had been recommended by staff member of the Department of Human Services.

Before I report on this tournament there's some bad news from T. P. & W. officials concerning Trinity River Fish.

Tissue samples from Trinity River fish collected during 1987 and 1988 revealed concentrations of the pesticide chlordane that exceeded warning levels established by the U. S. Food and Drug Administration, according to Texas Parks and Wildlife Department researchers.

River studies biologists Roy Kleinsasser and Gordon Linam of the department's Resource Protection Division said fillets of nine of the 41 fish collected from the river and its tributaries were above acceptable levels.

Chlordane has been used for termite control, as an insecticide for homes and gardens and as a control for soil insects a complete ban on sales in the United States was initiated in April of 1988. Chlordane is a persistent pesticide and elevated concentrations have often been correlated with urban and suburban runoff.

Inquires concerning the health risks of eating fish should be directed to the Texas Department of Health.

QUESTION: Throughout 1989 I paid the \$4.00 a month basic Catastrophic Premium. Now that Law has been repealed will I get this money back?

ANSWER: No, The basic \$4.00 a month premium you have paid since January 1989, has been used to pay for the benefits in effect during that year and therefore will not be refunded.

Young Men Turning 26 In 1990

Young men who will turn 26 in 1990 will be reaching an important milestone, according to the Selective Service System.

Beginning on January 1, 1990, men who were required to register with Selective Service in 1982 will be turning 26 and will no longer be eligible for induction should a draft be reinstated. Selective Service does not have the authority to accept late registrations after a man reaches his 26th birthday.

Selective Service State Director Harold D. Doyle warned that, with few exceptions, a man who fails to register before turning 26 will permanently forfeit his eligibility for certain benefits such as federal student aid, job training, and most federal employment in addition to facing possible prosecution as a felon.

Some states also require registration for state student aid, entrance to state-supported colleges and universities, state employment, and permission to

practice law. Doyle points out that men age 18 through 25 who have not yet registered can avoid the risk of prosecution and loss of benefits by registering promptly at any local post office. Failure to register is a felony punishable by a fine of up to \$250,000, up to five years in prison, or both.

Over 14 million men, age 18 through 25, are currently registered with Selective Service. Over one million of those registered are from Texas.

Hourly rates begin at \$3.80. No experience is necessary.

During the Job Fair each of the park's operating departments will have displays and there will be personnel on hand to answer questions about specific job opportunities.

On January 19, the event will be held from 4 p.m. until 8 p.m. Hours the following day will be 10 a.m. until 5 p.m.

A native of Eastland County, he was particularly interested in preserving these accounts. There's a lot of information here that sheds light on events - giving a new deminsion to history, Smith says.

"The book tells of the life of the pioneer, the joys and sorrows," he notes.

"Ron Bailey and the Book Committee were great help in getting this all together. There's no way I can give enough credit to them. But I would also like to say that without the Eastland County Newspapers there would have been no book. There was no way we could have paid for the publicity O'Brien gave us."

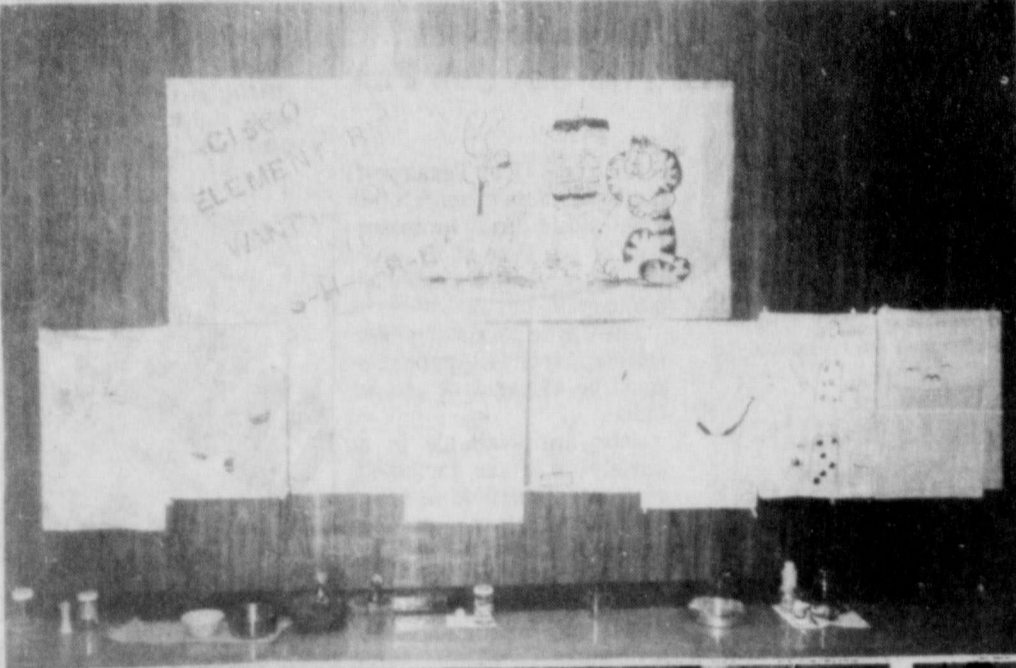
Carroll Scott CJC administrator who supervises the Abilene programs, explained "The additional students, to begin as early as May, will help relieve the serious nursing shortage."

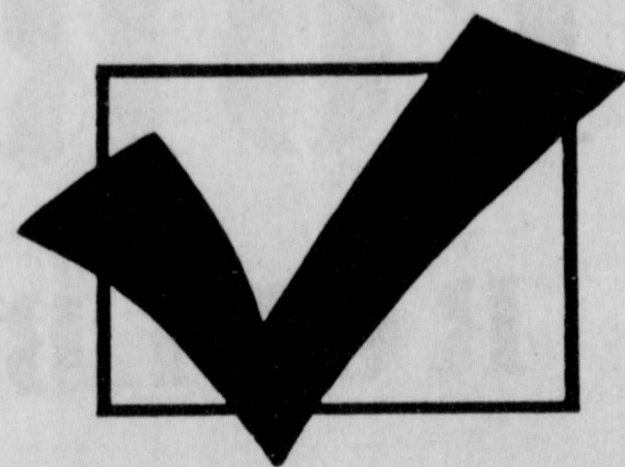
