### Great Plains CASA for Kids, Inc. seeks leader

The board of directors of the Great Plains CASA for Kids, Inc. organization of volunteers is ready to take a very important step—the hiring of an executive director to oversee the organization through its first and ongoing days of service to foster children in the four counties (Bailey, Deaf Smith, Oldham, and Parmer) involved in this great step for foster kids.

Great Plains CASA for Kids, Inc. joins 59 other Court Appointed Special Advocates (CASA) organizations in the state of Texas whose volunteers are currently active in representing children in foster care in 159 counties of the state. Both the executive directors and volunteers in the field from these organizations are sanctioned and welcomed by the juvenile court system where they are under the authority of the juvenile judge or judges in the counties they serve.

Great Plains CASA for Kids, Inc. was started by a steering committee formed of both lay leaders and public officials of the four counties involved in this effort. The juvenile judge serving these four counties also encouraged the steering committee through their many hours of groundwork to get the job done and put volunteers in the field for foster kids.

Now, through the steering committee's effort, the board of directors has been formed, the charter has been granted from the state headquarters and there is start-up money available with which to hire an executive director. The local CASA board encourages anyone interested in becoming the executive director of this kid-oriented group to send a resume to: P.O. ## West Nile cases increase

More tests for the West Nile Virus have been sent off this week by the Muleshoe Area Medical Center laboratory.

According to Dr. Bruce Purdy of Muleshoe Family Medicine, two patients of his have had tests that have come back positive for the virus. "I sent more tests off today," he said on Monday.

Dr. Thomas Smith of Smith Medical Clinic said he had only one case come back positive for the virus but he had sent more off this week.

"The lab says it takes two weeks just to get the tests back," said Dr. Smith. "Testing is optional. The confirmed diagnosis doesn't change the treatment. We can only treat the symptoms—fever, dehydration and headaches."

Dr. Smith is giving handouts printed from the Texas Department of Health website to his patients to inform them about West Nile Virus. "People are concerned," he said.

According to the handouts, only 1 out of 150 people infected with the virus will develop encephalitis or meningitis, which is the most serious form of the disease. The

incubation period for West Nile Virus is three to 14 days and the symptoms may last one to three weeks.

"Most infected people will not show any symptoms, a few will develop fever and/or a rash, and very few will get sick enough to require a hospital stay," said Dr. Smith. "The main reason for hospitalization is for severe dehydration."

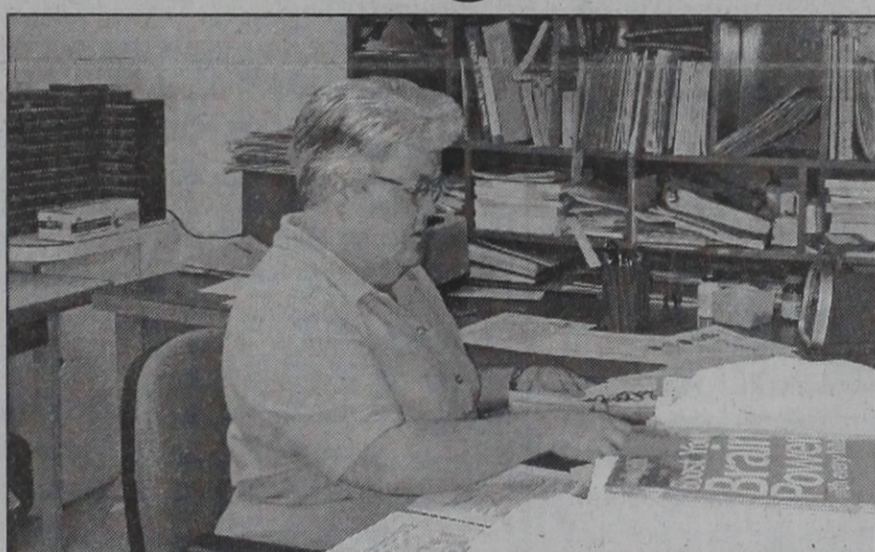
It is rare for the disease to cause death, although in cases of encephalitis or meningitis it is possible. Encephalitis is inflammation of the brain and meningitis is inflammation of the spinal cord.

There have been no fatalities in this area due to the virus, according to Jim Bone, hospital administrator. "I've been told that the state hasn't classified any confirmed cases in Muleshoe as of today [Tuesday]," he said. Apparently, it is a long process for the state to officially classify an outbreak.

Dr. James Alexander of Texas Department of Health said "We have been inundated with reports but the confirmation procedure requires that a blood test be sent to our lab in Austin. Many hospitals

## Extension agent retires

Gail Gladden, Bailey County Extension agent, is retiring August 31. A retirement reception is being held in her honor for her 33 years of service to the Texas Cooperative Extension Service on Sunday, August 24 from 2 to 4 p.m. at the Bailey County Coliseum. The public is invited.

Gladden's work was in the area of family and consumer sciences. "What used to be home economics," she said. The extension office serves as a means of community development, as advisors for 4-H clubs and extension education clubs, according to Gladden.

"If you can make a difference in someone's life, if they have learned something through education, such as a life skill, then you feel you have helped," said Gladden.

The extension office offers adult and youth education in money management, nutrition and parenting. "Our priority is helping new young parents," said Gail.

The office also runs a program called Better Living for Texans (BLT), which is a health and nutrition program. Gladden said, "Sometimes we have people call and ask questions about canning

and we send them [instructional] handouts and bulletins."

According to Gladden, programs that are popular with the youth are foods and nutrition and clothing. Other youth programs offered are photography, public speaking and leadership.

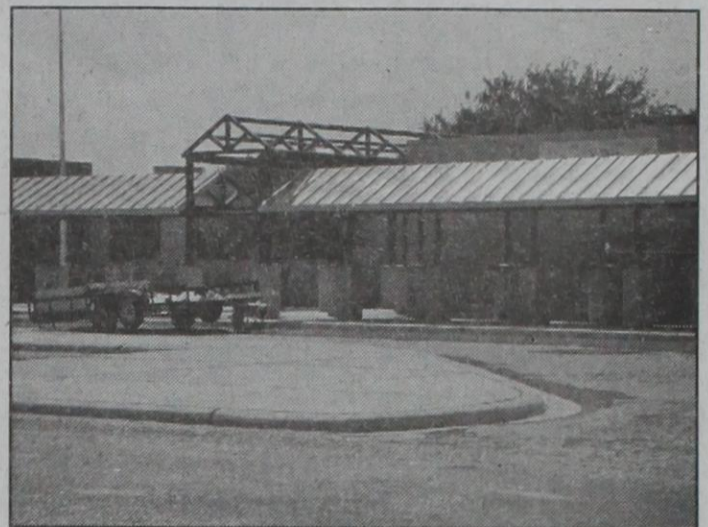
"We try to teach them community service in order to develop a sense of citizenship to help the community," said Gladden.

The newly created Muleshoe Community Foundation is related to Gladden's work at the extension office. She serves as the organization's secretary and its goals are similar to those of the extension office.

"The extension office has resources to help with economic development, which in turn helps community development. It's a big circle. The new community center will profit everybody. It will provide activities for the youth and give input into the community," said Gladden, who will continue her work with the foundation.

When asked what she will do with her newly acquired free time, Gladden shrugs and says "I don't know. I don't really have a plan but

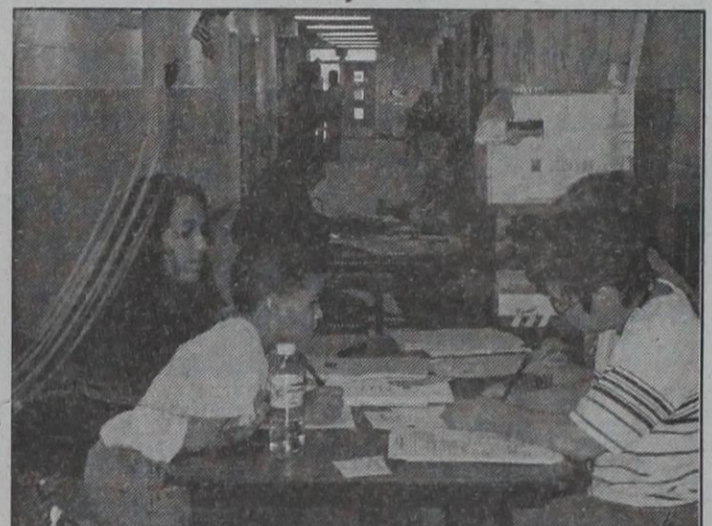

## Back to school

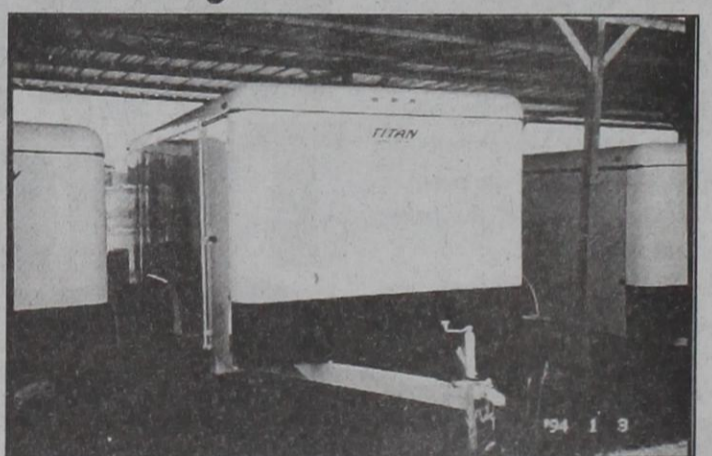

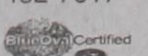

use private labs and they must send part of the sample to us to verify. This delays the confirmation."

According to Dr. Alexander, an outbreak is considered to be "anything that is above what is expected for a certain area. Last year, we had 12 cases in the area. If the cases were to exceed 15, then it would be considered an outbreak or epidemic. But the cases must be confirmed by the lab in Austin."

Currently, the department has four confirmed cases in Lubbock County, one in Terry County, one in Randall County, one in Hemphill County and one in Deaf Smith County.

Kay Swint, nurse practitioner at the Muleshoe Area Medical Center Outpatient Services Clinic, said she has not sent anyone to be tested. "The test is too expensive (about \$170) and the positive test doesn't affect the treatment at all."

Since the symptoms are similar to the influenza virus, or the "flu," parents may wonder when they should take

I guess I'll do whatever I want to do—organize the house, go visit family, etc."

"I will miss working here. It's been fun and I have made good friends," said Gladden. "I am starting to get a little excited to not have to be anywhere. I can do whatever I want."

their sick child to the doctor.

"Fever over 100 degrees is a big indicator," said Swint.

"If the child has persistent high fever, is not taking fluids and is not active, then he or she should see a doctor," said Dr. Smith.

Dr. Purdy said, "If it's to the point where the parent is concerned, the child should be brought in. Also, there are multiple therapies and medications for the influenza virus and other illnesses. Even if it's not West Nile, the child could be helped."

# City council convenes

The Muleshoe City Council met Tuesday morning for their regular meeting. A motion was made by Councilman Black and seconded by Councilman Behrends to approve the minutes of the meeting of July 24, 2003 and the motion carried.

The council voted that the City of Muleshoe would accept solid waste from the City of Sudan for a one year period, beginning September 1, 2003 and ending August 31, 2004. The cost would be at \$24 per ton not to exceed three tons per day for the municipal solid waste disposal. This agreement is the same as the current agreement.

Police Chief Don Carter recommended that two intersections be made into three-way stops: East Hickory and Joliet and East Juniper and Joliet. He stated that this would help to reduce speed and control traffic. This action was approved by the council.

The council also voted in favor of granting a right of way easement to West Plains

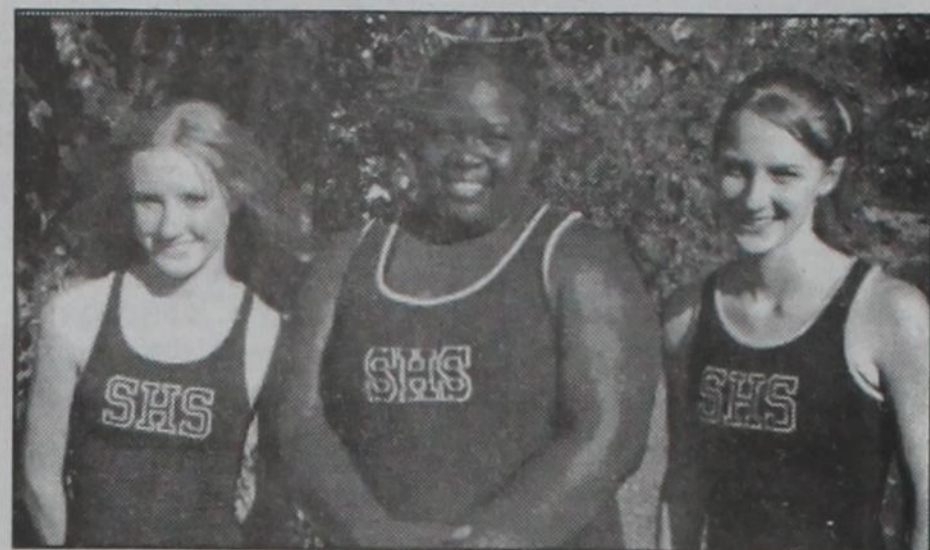

## "It Was a Dark and Stormy Night . . ."

Fear and faith. Both color our journey in this life.

In Mark 6:45-52, the disciples of Christ have gotten into a boat to go ahead of the Lord to the village of Bethsaida. Jesus himself has stayed behind to dismiss the crowd of 5,000 which he had just fed, and to go up on a mountainside to pray. Out on the lake, in the middle of the night, a storm has come up, and the disciples are

simply upon us and the most experienced sailor in the world could not have seen it coming. But come it did.

Several of the disciples on the Sea of Galilee that night were experienced sailors who knew its every league, every fathom, every eddy. From the sea, they had made their living, but suddenly they are faced with the prospect of dying there.

At around 3:00 a.m., in the middle of that dark night, Jesus goes "where no man has gone before" (at least not without a boat), walking on the water. He hears their cry for help, and he gets into the boat.

That's the Incarnation, folks. That's the Lord of the sea saying, "Don't be afraid; I'm with you on the journey."

On the sea that night, the disciples had lots of fear, precious little faith—just enough to let their Lord get into the boat. Maybe his gift to them was that on that day, when that was all the faith they had, that was all the faith required. Maybe that is his gift to us, too, that as we're tempted to be paralyzed by fear in the face of all that has happened and all that might happen on our journey, the Captain of our souls comes to you and to me and says, "I'll never ask you to take a journey that I won't take right by your side. Just let me into your boat."
